**Sub: Volatile Situation in 93-Munugde Assembly Constituency – Violations by the ruling party TRS and State Government**

Bharatiya Janata Party and its local election managers have continually updated the Commission and also the CEO Telengana from time to time. The situation in 93 – Munugode AC in Telengana is only worsening by the continuing violation of electoral laws and MCC by the ruling party, the TRS. We wish to bring the following to your notice;

1. Representations were made to the commission on several occasions wherein registration of fake votes were reported by BJP. The Commission and local DEO had, on the directions of the high court, deleted around 12,000 fake voters. But there still remain around 14,000 newly registered voters of which more than 1,800 are bogus votes as per our random verification.
2. There is rampant distribution of Money and Alcohol to the voters by the ruling party MLA's, MP's and Ministers. The TRS has deployed thousands of vehicles without due permission from the RO/DEO. Large number of out of Munugode TRS political workers are all over the constituency. Buses have been hired from RTC, a public sector undertaking for transportation of voters and persons for their rallies and meetings. All of this is in gross violation of the MCC and electoral laws. 3. In addition to all sorts of abuse of resources and allurement to voters, the ruling party, TRS and its ministers have even threatened the voters. Shri Jagadish Reddy, Minister of Energy, Telangana Government threatened to withdraw all welfare and other development schemes from the villages that do not vote the ruling party candidate.

5. There is serious threat to BJP contesting Candidate Mr Rajgopal Reddy as his convoys, meetings and rallies are disturbed and attacked by the TRS activists and his political campaign is being disrupted.

**In the wake of above, we request the Commission to;**

1. Check the free movement of unauthorized persons of TRS in the constituency.
2. Check the free movement of unauthorized vehicles, not specifically permitted to ply by the RO/DEO.
3. Reverify the bogus votes and ensure only the genuine voters remain on the electoral roll.
4. Appoint and position micro general observers and also micro police observers in addition to extra expenditure observers.
5. Central Armed forces be deployed at the police checkpoints to ensure that no cash or liquor or other gifts are distributed by the ruling party as bribe to the voters.
6. Personal security of the BJP candidate, Shri Rajgopal Reddy be strengthened.
7. 100% coverage of all polling stations by CAPF.
8. Videography and Webcasting of 100% polling booths.
