

Ironically both OCCRP and FDL-AP are getting funded by controversial US billionaire George Soros who openly works to destabilise India, attempts to interfere in its democratic process and seeks to affect India's international relations. The OCCRP has collaborated with many Indian news outlets to write critical articles about Indian businesses and Indian government which have been extensively quoted by the opposition leader, Shri Rahul Gandhi and other Congress leaders to attack the Indian government even at the cost of harming national interests. His repeated alignment with foreign-funded entities and narratives undermines India's sovereignty and national interest has been exposed on several occasions when he quoted from these contentious reports, met controversial figures who are known India baiters and propagated anti-India narratives even in the foreign lands. The OCCRP and its funding organisations are notorious for destabilising long-standing governments in many countries, and endorsing reports from such a questionable organisation, which has repeatedly targeted India, shows that Rahul Gandhi is involved in a deeper, sinister conspiracy to destabilise India and derail it from its promising trajectory towards 'Viksit Bharat'. Mrs. Sonia Gandhi, Shri Rahul Gandhi and Congress owe an explanation to the nation on their links with anti-India organisations and individuals who continuously act against India's national interest to the extent

of undermining its sovereignty and threatening its internal and external security.

DEVENDRA FADNAVIS TE STOT VIES OAT HAS GM FORTHIRD TIME IN MAHARASHTRA

Eknath Shinde and Ajit Pawar sworn-in as Deputy Chief Ministers

n an impressive and glittering ceremony attended by Hon'ble Prime Minister Shri Narendra Modi, the leader of the Mahayuti Shri Devendra Fadnavis took oath as the 18th Chief Minister of Maharashtra on 05 December 2024. Shri Fadnavis, who was elected from Nagpur South-West constituency and unanimously elected as the state BJP Legislative Party leader at a meeting held in Mumbai on 04 December, took charge as the Chief Minister of the state for the third time. LIFE SKETCH OF SHRI DEVENDRA FADNAVIS

- Shri Devendra Sarita Gangadharrao Fadnavis (Devendra Fadnavis) was born on 22 July 1970 in Nagpur, Maharashtra to Shri Gangadhar Fadnavis and Smt. Sarita Fadnavis.
- He holds an L.L.B degree from Nagpur University, completed in 1992. He also has a postgraduate degree in Business Management and a Diploma in Methods and Techniques of Project Management from the Free University of Berlin, Germany completed in the year 1998.
- Shri Fadnavis began his political career in the mid-nineties. As a college student, he was an active member of the RSS and Akhil Bharatiya Vidyarthi Parishad (ABVP).
- In the year 1992 at the age of 22 he became a Corporator. 5 years later, in 1997, Shri Fadnavis at 27 became the youngest mayor of the Nagpur Municipal Corporation.
- Marking his formal entry into state politics Shri Fadnavis elected to the Legislative Assembly in 1999.
- Since 1999, Shri Fadnavis has been representing Nagpur in the Legislative Assembly of Maharashtra State (Vidhan Sabha).
- He became the President of Bharatiya Janata Party, Maharashtra from 11 April 2013 6 January 2015.
- Shri Fadnavis for the first time became Chief Minister of Maharashtra for a period of five years from 2014–2019. He became Chief Minister at the age of 44, making him the second-youngest



in Maharashtra's history.

- For the Second term he became the Chief Minister on 23 November 2019; however, this government only lasted for a few days.
- On 30 June 2022, Shri Fadnavis took oath as the 9th Deputy Chief Minister of Maharashtra with Shri Eknath Shinde as the Chief Minister.
- Following a massive victory on 23 November, Shri Devendra Fadnavis was elected as Maharashtra BJP Legislative Party Leader on 04 December 2024.
- He took oath as the Chief Minister of Maharashtra for the 3rd time in Mumbai on 05 December 2024.

that the Constitution was showing us the right path as a guiding light. Emphasizing that now the path of India's future was of achieving big dreams and big resolutions, Shri Modi remarked that today the goal of every citizen was to build a Viksit Bharat. Explaining further, he said that a Developed India meant a place where each and every citizen was ensured of getting a quality of life and dignity of life. This, he said, was a great medium of ensuring Social Justice and was the spirit of the Constitution as well. Therefore, the Prime Minister stressed, many steps were undertaken to ensure socio-economic justice in the past few years like opening more than 53 crore bank accounts of the people, in the last decade, who did not have access to the banks. He added that in the past decade, four crore people were ensured of pucca houses, 10 crore gas cylinder connections were given to women of the household.

Shri Modi underscored that there were only 3 crore houses in India which had household tap connections even after 75 years of Independence. He added that the central Government had given more than 12 crore household tap water connections in the last 5-6 years which had eased the living of citizens and women in particular.

Shri Modi remarked that the Original copy of the Indian Constitution had pictures of Lord Ram, Goddess Sita, Lord Hanuman, Bhagwan Buddha, Bhagwan Mahavira and Guru Govind Singh. He added that these symbols of Indian culture were given place in the Constitution to ensure that it constantly keeps us aware and mindful of human values. "Human Values are the basis of today's Indian policies and decisions", exclaimed the Prime Minister. He added that the Bharatiya Nyay Sanhita was enforced to ensure speedy delivery of justice to the citizens. He further said that the punishment based system has now changed to a justice based system. The Prime Minister stressed that the historic Women's Reservation Bill was introduced to increase the political participation of women. He added that steps were undertaken to ensure the identity and rights of the third gender people and facilities to ease the living of Divyang people.

ndia commemorated a historic milestone on the 26th November, 2024, marking the 75th anniversary of the adoption of the Constitution of India. On November 26, 1949, the Indian Constituent



LINKS OF CONGRESS WITH GEORGE SOROS: 'GRAVE CONCERN FOR INDIA'

What is the RELATION between GEORGE SOROS and CONGRESS Party: JP Nadda

B National President Shri JP Nadda said, "Organised Crime and Corruption Reporting Project is one of the organizations that is being tried to destabilize the government. We all know that the opposition leaders have raised those issues in the House which were released by OCCRP. The Opposition leaders trying to bring instability in the country. I want to ask what is the relationship between George Soros and Congress"?

Congress is playing with national security



Leaders in Asia Pacific Foundation which is financed by the Soros Foundation. "This link is a matter of concern...". "This maligns India's image and raises concern about national security. The people are concerned... Congress is playing with national security. Therefore, we want a discussion, he said."

OCCRP, bent on destabilising international relations

Shri Nadda said, "There is one international organisation, Organized Crime and Corruption Reporting

Referring to Soros and his links to the opposition party which is trying to destabilise India, Shri Nadda charged the Congress of acting as a tool of foreign forces. Further elaborating, he said Mrs. Sonia Gandhi is the co-president of the Forum of the Democratic Project [OCCRP], which is bent on destabilising international relations. Whatever was reported by OCCRP, Lok Sabha's Opposition leader has brought up in Parliament and proven that he has become the tool of external forces and is trying to destabilise the country. They are trying to bring instability in the country."

Dangerous to the internal and external security of the country

Shri JP Nadda added Congress party's senior leader is a co-chairperson of 'Forum of Democratic Leaders of Asia Pacific'. This organisation thinks Jammu and Kashmir is a separate entity. The Congress is in collaboration with such organisations which bring instability to the country. This is dangerous to the internal and external security of the country. The funding for this sort of activity is being done by Geroge Soros. I want to know what is the relationship between the Congress party and George Soros?".

He said we are answerable to the common man. They are asking us in this situation if we are standing up for the country. I want to promise them that under the leadership of Prime Minister Shri Narendra Modi, the NDA government is firmly committed to protecting India's interests. Those still dreaming of bringing change in India based on foreign influence will not succeed.

Attempting to influence "India's democratic process"

Earlier, Union Minister Shri Kiren Rijiju also expressed concerns over the links between Sonia Gandhi and businessman George Soros. He said George Soros, the founder of the Open Society Foundation, has been an outspoken critic of PM Shri Narendra Modi and attempted to influence "India's democratic process".

Did Soros pay for Rahul Gandhi's Bharat Jodo Yatra?

On 06 December, BJP MP Shri Nishikant Dubey said, "Congress is hand in glove with George Soros, did Soros pay for Rahul Gandhi's Bharat Jodo Yatra or not? Soros paid for 1000 Indian children to study abroad, and how many of them are children of Congress leaders?"

CAN CONGRESS ANSWER?

- Why is it that whenever a Parliament session is about to start, an issue from abroad emerges, and the Congress begins disrupting the session over that issue? Is this just a coincidence or a systematic anti-India experiment?
- Sonia Gandhi is the co-chairperson of the Forum of Democratic Leaders in Asia Pacific (FDL-AP), which has been a platform for anti-India and pro-Pakistan statements. It is also funded by the architect of the anti-India agenda, George Soros.
- BJP wants to directly ask Congress and the opposition about the relationship between the Congress, Sonia Gandhi, and the FDL-AP. Why did Sonia Gandhi accept the post of copresident in this organization?

- It is disheartening that Congress is seen supporting the mysterious questions being raised about the country from abroad. Supporting them is like joining hands with antinational forces.
- Congress has a history of aligning with foreign powers. This is the same Congress that accepted oil coupons and received money from Saddam Hussein, as revealed in the 2005 Volcker Report.

He said it was previously revealed that whenever a Parliament session starts, some foreign reports or incidents occur, disrupting the Parliament proceedings.

- For example, a report on farmers was released on February 3, 2021, coinciding with the Parliament session that began on January 29, 2021.
- The Pegasus report was released on July 18, 2021, coinciding with the Monsoon session of Parliament.
- The Hindenburg report was published on January 24, 2023, just before the Budget session began on January 30, 2023.
- On January 17, 2023, the BBC released a documentary, coinciding with the Parliament session that started on January 30, 2023.
- A Manipur video surfaced on July 19, 2023, just as the Parliament session was about to begin on July 20, 2023.
- On May 10, 2024, a vaccine report was released during the peak of the Indian elections.
- A report on the SEBI Chairperson was released in August 2024, during an ongoing Parliament session. Most recently, on November 20, 2024, a report was published in the USA, just days before the Parliament session began on November 25, 2024.

Dr. Trivedi asked "Is this just a coincidence or a systematic anti-India experiment?" He said the BJP wants to clearly ask the opposition and the Congress and expect an answer from them -

- What is the relation of the Congress and Sonia Gandhi with FDL-AP?
- The way anti-India and pro-Pakistan things are being said from the platform of FDL-AP, is it happening with the consent of Congress?
- Congress members are holding positions alongside traitorous forces. Those who openly said that they want to create instability in India what is Congress's connection with them?

GEORGE SOROS AND RAHUL GANDHI ARE "TWO BODIES AND ONE SOUL"

Addressing a press conference at the BJP headquarters in New Delhi, on 05 December 2024, BJP National Spokesperson Dr. Sambit Patra cited an article published in the French newspaper 'Mediapart', which revealed a triangle conspiring against India involving American billionaire George Soros, the news portal OCCRP and Congress MP and Leader of Opposition in Lok Sabha, Rahul Gandhi.

- On July 1, 2021, OCCRP published an article aimed at undermining the Indian vaccine Covaxin and on July 2, Congress held a press conference targeting the government and Covaxin. OCCRP directs and Rahul Gandhi follows.
- OCCRP has repeatedly targeted India's top industrialists with unfounded reports, aiming to disrupt the economy, crash stock markets, and undermine investor confidence. The goal was to stir public discontent and push for a regime change.
- Whenever reports against the country emerged, Rahul Gandhi targeted the government. After OCCRP's Pegasus report on July 18, 2021, he held a press conference on July 19, stirring disruption in Parliament.
- When the ED questioned Sonia Gandhi and Rahul Gandhi in the National Herald case, OCCRP published an article alleging the proceedings were politically motivated. Despite accusations of embezzling Rs. 5,000 crores, the US-based OCCRP effectively exonerated them.
- When OCCRP faces a setback, Rahul Gandhi shows concern, and when Rahul Gandhi faces challenges, OCCRP reacts similarly.
- George Soros and Rahul Gandhi are considered two faces of the same ideology. They are "two bodies and one soul." The agenda of Soros is the same as that of Rahul Gandhi
- During his US visit, Rahul Gandhi met Bangladeshi journalist Mushfiqul Fazal Ansarey, linked to OCCRP and known for publishing anti-India articles. Critics remarked, "Wherever there is harm to the country, Rahul Gandhi is present."
- During the 2020 Delhi riots, Anand Maganale, an OCCRP journalist and close associate of Rahul Gandhi, allegedly brought funds from China and handed them to Sharjeel Imam, a key figure in the riots.

43,30,121 ACCOUNTS OPENED UNDER MAHILA SAMMAN SAVINGS CERTIFICATE SCHEME

The Mahila Samman Savings Certificate Scheme (MSSC) was launched on 31 March 2023 to commemorate the 'Azadi ka Amrit Mahotsav' exclusively for the women and minor girls, and so far, 43,30,121 accounts have been opened under it till 31.10.2024.

This was stated by Union Minister of State for Finance Shri Pankaj Chaudhary in a written reply to a question in Rajya Sabha on 3 December.

The scheme was launched by the Government to promote financial independence of the woman of the country by allowing attractive rate of interest and to also help in achieving objectives of financial inclusion as set by Government of India. The account under this MSSC shall be opened by a woman for herself, or by the guardian on behalf of a minor girl, on or before 31st March, 2025.

Some of the salient features of the schemes include:

- The account may be opened with a minimum deposit of 1000/- and maximum deposit of 2 Lakhs for a tenure of two years only.
- The interest rate for MSSC is 7.5% p.a. which is compounded quarterly and credited to the account.
- The facility of partial withdrawal and premature closure on compassionate grounds are also available under this Scheme.

6.39 CRORE INDIVIDUALS TRAINED UNDER PRADHAN MANTRI GRAMIN DIGITAL SAKSHARTA ABHIYAN

Pradhan Mantri Gramin Digital Saksharta Abhiyan (PMGDISHA) was launched by the Government of India to promote digital literacy in rural India. The aim was to reach 6 crore rural households (one person per household) nationwide. The scheme has ended, as against 6 crore, 6.39 crore individuals were trained across the country as on March 31, 2024. The State/ UT-wise achievement is given at the bottom.

MeitY, Government of India launched the India BPO Promotion Scheme (IBPS) and North East BPO Promotion Scheme (NEBPS) to create jobs and promote IT/ITES in small towns by offering financial support of up to Rs 1 lakh per seat. The schemes also provide incentives for promoting local entrepreneurs and hiring women and disabled individuals through BPO/ITES units across the country operating in States/UTs.

GRAM NYAYALAYAS FUNCTIONING ACROSS THE Country have disposed of more than 2.99 Lakh cases during december 2024

As per website of e-Committee, Supreme Court of India https://ecommitteesci.gov.in/service/ district-courts-portal/), there are 688 District Courts across the country. Further, the Gram Nyayalayas Act, 2008 which was enacted to establish Gram Nyayalayas at the grass-root level aims to provide access to justice in rural areas ensuring opportunities to secure justice to citizens. As on October, 2024, 313 Gram Nyayalayas are functioning across the country which have disposed of more than 2.99 lakh cases during December, 2020 to October, 2024.

Further, Lok Adalats are organized by Legal Services Institutions at such intervals as deemed fit in order to reduce the pendency of cases in the courts and to settle the disputes at pre-litigation stage. Lok Adalats handle pending court cases as referred to it by the respective courts. Since Lok Adalats are not permanent in nature, all unsettled cases, are reverted to the respective courts and hence do not remain pending with Lok Adalats. During the year 2024-25 (upto September, 2024), 5944 benches of State Lok Adalats were constituted which disposed of 10,11,912 cases. In addition, 98,776 cases were settled through 17,309 sittings of Permanent Lok Adalats (Public Utility Services) during the same period.

This information was given by the Minister of State (Independent Charge) of the Ministry of Law & Justice, Shri Arjun Ram Meghwal in a written reply in Lok Sabha on 29 November.

CABINET APPROVES CONTINUATION OF THE ATAL INNOVATION MISSION

The Union Cabinet, chaired by the Prime Minister Shri Narendra Modi on 25 November approved the continuation of its flagship initiative, the Atal Innovation Mission (AIM), under the aegis of NITI Aayog, with an enhanced scope of work and an allocated budget of Rs.2,750 crore for the period till March 31, 2028.

AIM 2.0 is a step towards Viksit Bharat that aims to expand, strengthen, and deepen India's already vibrant innovation and entrepreneurship ecosystem.

The approval underscores the government's commitment to fostering a robust innovation and entrepreneurship ecosystem in India. With India at rank 39 on the Global Innovation Index and home to world's third-largest start-up ecosystem, the next phase of Atal Innovation Mission (AIM 2.0) is expected to further enhance India's global competitiveness. The continuation of AIM will directly contribute to creating better jobs, innovative products, and high-impact services across sectors.

CABINET APPROVES INVESTMENT FOR CONSTRUCTION OF 186 MW TATO-I HYDRO ELECTRIC PROJECT IN AP

The Cabinet Committee on Economic Affairs, chaired by the Prime Minister Shri Narendra Modi on 25th November approved investment of Rs.1750 crore for construction of Tato-I Hydro Electric Project (HEP) in Shi Yomi District of Arunachal Pradesh. The estimated completion period for the project is 50 months.

The project with an installed capacity of 186 MW (3 x 62 MW) would produce 802 Million Units (MU) of energy. The Power generated from the Project will help improve the power supply position in the state of Arunachal Pradesh and will also help in balancing of the national Grid.

The state would be benefitted from 12% free power and another 1% towards Local Area Development Fund (LADF) besides significant infrastructure improvement and socio-economic development of the region.

There will be significant improvement in infrastructure, including the development of around 10 kilometres of roads and bridges, for the project which shall be mostly available for local use. The district will also benefit from the construction of essential infrastructure such as hospitals, schools, vocational training institutes like ITIs, marketplaces, playgrounds, etc. to be financed from dedicated project funds of Rs.15 crore. Local populace shall also be benefitted from many sorts of compensations, employment and CSR activities.

CABINET APPROVES ONE NATION ONE SUBSCRIPTION

The Union Cabinet, chaired by Prime Minister Shri Narendra Modi on 25th November approved One Nation One Subscription, a new Central Sector Scheme for providing country-wide access to scholarly research articles and journal publication. The scheme will be administered through a simple, user friendly and fully digital process. This will be a "One Nation One Subscription" facility for the government higher education institutions and R&D laboratories of the central government.

A total of about Rs.6,000 crore has been allocated for One Nation One Subscription for 3 calendar years, 2025, 2026 and 2027 as a new Central Sector Scheme. One Nation One Subscription will build on and further enhance the scope and reach of the range of initiatives undertaken by the Government of India over the past decade in the domains of education, for maximizing access to quality higher education for the youth of India. This will supplement the ANRF initiative to promote research and development and foster a culture of research and innovation throughout government universities, colleges, research institutions, and R&D laboratories.

The benefits of One Nation One Subscription scheme will be provided to all Higher Educational Institutions under the management of the Central or State Government and Research & Development Institutions of the Central Government, through a national subscription coordinated by a central agency, namely the Information and Library Network (INFLIBNET), an autonomous inter-university centre of the University Grants Commission (UGC). This list covers more than 6,300 institutions, translating into nearly 1.8 crore students, faculty and researchers, who will be able to potentially avail benefits of One Nation One Subscription.

This is in line with the goals of Viksitbharat@2047, National Education Policy (NEP) 2020 and Anusandhan National Research Foundation (ANRF). The initiative will expand access to scholarly journals to a vast diaspora of students, faculty, researchers and scientists of all disciplines, including those in tier 2 and tier 3 cities, thereby promoting core as well as interdisciplinary research in the country. The ANRF will periodically review the usage of One Nation One Subscription and publications of Indian authors of these institutions.

The Department of Higher Education will have a unified portal "One Nation One Subscription" through which the institutions will be able to access the journals.

EMPLOYMENT INDICATORS SHOW POSITIVE GROWTH; WORKER POPULATION RATIO RISES TO 58.2%, UNEMPLOYMENT RATE DROPS TO 3.2%

The data on Employment and Unemployment is collected through Annual Periodic Labour Force Survey (PLFS) which is conducted by Ministry of Statistics and Programme Implementation (MoSPI) since 2017-18. The survey period is July to June every year.

As per the data available in latest Annual Periodic Labour Force Survey (PLFS) Reports, the estimated Worker Population Ratio (WPR) indicating employment during the last 7 years including the COVID period has increased from 46.8% in 2017-18 to 58.2% in 2023-24. During the same period, Unemployment Rate (UR) on usual status for persons of age 15 years and above has decreased from 6.0% to 3.2%.

The Annual Survey of Unincorporated Sector Enterprises (ASUSE) exclusively measures various economic and operational characteristics of unincorporated non-agricultural establishments in manufacturing, trade and other services sector.

As per the available ASUSE reports, the estimated number of workers has increased to 10.96 crores in 2022-23 from 9.79 crores in 2021-22.

Further, more than 7 crore net subscribers have joined Employees' Provident Fund Organization (EPFO) between September 2017 and September 2024 indicating increase in formalization of the job market.

Further, Government announced in the Budget 2024-25, the Prime Minister's package of 5 schemes and initiatives to facilitate employment, skilling and other opportunities for 4.1 crore youth over a 5-year period with a central outlay of Rs. 2 lakh crores.

This information was given by Union Minister of State for Labour & Employment, Sushri Shobha Karandlaje in a written reply in Rajya Sabha.

OVER 30.43 CRORE UNORGANISED WORKERS REGISTERED ON E-SHRAM PORTAL

The Ministry of Labour and Employment launched eShram portal (eshram.gov.in) on 26th August 2021 for creation of a comprehensive National Database of Unorganised Workers (NDUW) seeded with Aadhaar. eShram portal is meant to register and support the unorganised workers by providing them a Universal Account Number (UAN) on a selfdeclaration basis. As on 1st December 2024, over 30.43 crore unorganised workers have registered on eShram portal.

CABINET APPROVES OPENING OF 85 NEW KENDRIYA VIDYALAYAS AND EXPANSION OF ONE EXISTING KV

The Cabinet Committee on Economic Affairs on 6 December chaired by the Prime Minister, Shri Narendra Modi has approved opening of 85 new Kendriya Vidyalayas (KVs) under Civil/Defence sector across the country and expansion of one existing KVi.e. KVShivamogga, District Shivamogga,

Karnataka to facilitate increased number of Central Government employees by adding two additional Sections in all the classes under the Kendriya Vidyalaya Scheme (Central Sector Scheme). The list of these 86 KVs is annexed.

The total estimated

requirement of funds for establishment of the 85 new KVs and expansion of 01 existing nearby KV is Rs. 5872.08 crore (approx.) spread over a period of eight years from 2025-26. This includes capital expenditure component of Rs. 2862.71 crore (approx.) and operational expenditure of Rs. 3009.37 crore (approx.).

As on date, there are 1256 functional KVs, including 03 abroad viz. Moscow, Kathmandu and Tehran and a total number of 13.56 lakh (approx.) students are studying in these KVs.





ZERO CASE: INDIA'S POLIO ERADICATION SAGA

India's achievement of polio-free status in 2014 represents one of the most significant successes in global public health. The eradication of polio was not a singular event, but the culmination of decades of dedicated efforts, starting with India's participation in the Global Polio Eradication Initiative (GPEI) and complemented by the robust national immunization efforts under the Universal Immunization Programme (UIP). The strategic integration of new vaccines, innovative surveillance systems, and government-led immunization campaigns played a crucial role in making India polio-free. This achievement was made possible through the tireless efforts of the Government of India in partnership with key global organizations, including UNICEF, the World Health Organization (WHO), the Bill & Melinda Gates Foundation, Rotary International, and the Center for Disease Control and Prevention (CDC). Together, they mobilized resources, provided technical expertise, and created widespread public awareness about the critical need to vaccinate every child under five against polio.

Immunization in India

India's immunization efforts can be traced back to 1978, when the Expanded Programme on Immunization (EPI) was launched. This program aimed to provide vaccines to children against various diseases. In 1985, this program was renamed the Universal Immunization Programme (UIP), broadening its reach to rural areas beyond urban centers. Over time, the UIP became an integral part of several national health initiatives, including the National Rural Health Mission (NRHM), launched in 2005 to improve the health of rural populations.

Today, UIP is one of the world's largest public health programs, targeting over 2.67 crore newborns and 2.9 crore pregnant women annually, providing free vaccines for 12 vaccine-preventable diseases. Polio was one of the first diseases targeted under UIP, and its elimination became a key public health milestone.

KEY MILESTONES IN POLIO ERADICATION

Pulse Polio Programme Launch (1995)

India's fight against polio took a significant step forward in 1995 with the launch of the Pulse Polio Immunization Programme. The first large-scale vaccination campaign, held on 2nd October 1994 (Gandhi Jayanti) in Delhi, was the precursor to the national Pulse Polio campaign. The campaign used an Oral Polio Vaccine (OPV) strategy, reaching over 1 million children and ensuring every child under five was vaccinated. This model was subsequently scaled up nationwide.

The campaign became iconic, with the slogan "Do Boond Zindagi Ki" (Two drops of life) becoming synonymous with India's efforts to eliminate polio.

Routine Immunization and System Strengthening

While Pulse Polio campaigns were essential for mass immunization, India also strengthened its routine immunization efforts under the Universal Immunization Programme (UIP). The UIP provided free vaccines against polio, diphtheria, pertussis (whooping cough), tetanus, measles, hepatitis B, and tuberculosis, ensuring that children received vaccinations as per the national immunization schedule. Through these routine efforts, India aimed to maintain high immunity levels and prevent the re-emergence of vaccine-preventable diseases.

India also made significant strides in cold chain management, ensuring that vaccines were stored and transported at the correct temperatures. The establishment of the National Cold Chain Training Centre (NCCTE) and the Electronic Vaccine Intelligence Network (eVIN) played crucial roles in improving vaccine storage and distribution logistics.

Inactivated Polio Vaccine Introduction (2015)

In line with the Global Polio Endgame Strategy, India introduced the Inactivated Polio Vaccine (IPV) in 2015 as part of its commitment to polio eradication. IPV provides additional protection against polio, especially against type 2 poliovirus, and was gradually introduced in six states before being expanded nationwide by 2016. This switch was essential after the global shift from trivalent OPV (tOPV) to bivalent OPV (bOPV), which excludes the type 2 strain, and IPV ensured continued protection.

Surveillance and Monitoring

India's success in polio eradication was largely due to its rigorous surveillance systems, including Acute Flaccid Paralysis (AFP) Surveillance and Environmental Surveillance. The focus on surveillance helped India detect and respond to any potential outbreaks guickly.

AFP Surveillance: This system involves monitoring cases of unexplained paralysis in children under 15, as this is a common symptom of polio.

Environmental Surveillance: Monitoring sewage water to detect poliovirus strains also helped identify pockets where the virus may still be circulating.

By maintaining a high level of sensitivity in surveillance, India could track and control any residual poliovirus transmission.

Political Will and Community Engagement

One key factor behind India's polio eradication success was the unwavering political will demonstrated by the central and state governments. Political leaders at all levels provided consistent support, ensuring that resources were allocated and the program received the needed attention.

Additionally, community engagement played a pivotal role. Health workers, volunteers, and local leaders helped raise awareness, provided information on the importance of vaccination, and ensured that children in even the most remote areas were immunized. The Pulse Polio campaigns also relied heavily on doorto-door efforts, reaching children in difficult-to-reach areas.

Certification and Final Leap

In 2011, India saw the last case of wild poliovirus in Howrah, West Bengal. Following that, the country ramped up its surveillance efforts, and no further wild poliovirus cases were reported.

For India to be certified as polio-free by the World Health Organization (WHO), the country had to meet stringent criteria. These included three years of no wild poliovirus transmission, robust surveillance systems, and the destruction of any remaining stocks of the virus. The certification process was rigorous, involving comprehensive checks and evaluations by the Regional Polio Certification Commission.

On 27th March 2014, India was officially declared polio-free, a milestone celebrated not just within the country but globally as an example of successful public health intervention.

Beyond Certification: Staying Alert & Safe!

Even after being declared polio-free, India continues to take several preventive measures to maintain its polio-free status:


Annual Polio Campaigns: India continues to conduct National Immunization Days (NID) and Sub-National Immunization Days (SNID) annually to keep immunity levels high and ensure that no child is missed.

Surveillance and Border Vaccination: Continuous surveillance through AFP and environmental monitoring remains critical. Vaccination at international borders continues to mitigate the risk of polio re-importation from endemic regions.

New Vaccines and Expansion: In addition to IPV, India has introduced several new vaccines under its immunization program, including Rotavirus, Pneumococcal Conjugate Vaccine (PCV), and Measles-Rubella (MR) vaccine, as part of broader efforts to prevent other vaccine-preventable diseases.

Mission Indradhanush: Launched in 2014, Mission Indradhanush (MI) aims to increase immunization coverage to 90%. Special attention is given to hard-to-reach areas with low immunization rates. In its Intensified Mission Indradhanush phase, the program has significantly increased immunization coverage, further reinforcing India's commitment to child health.

The success of the Pulse Polio Programme and the Universal Immunization Programme serves as an inspiration for other nations and highlights the transformative power of public health interventions when supported by effective systems, robust policy, and community involvement.

Russian President praises PM Modi's "India-First" Policy and "Make in India" Initiative at VTB Russia

President Putin highlights Russia's willingness to set up manufacturing operations in India

President Vladimir Putin praised Prime Minister Shri Narendra Modi's "India-first" policy and the "Make in India" initiative at the 15th VTB Russia Calling Investment Forum. President Putin acknowledged India's efforts to foster a stable environment for growth, emphasising how these policies have contributed to India's development.

The "Make in India" initiative, aimed at boosting manufacturing and attracting foreign investment, has played a key role in strengthening India's position in the global economy, he stressed. President Putin's remarks underscored India's economic progress under PM Shri Modi's leadership. He lauded the Indian government and its efforts in creating "stable conditions" for small and medium-sized enterprises (SMEs), particularly highlighting the economic initiatives spearheaded by Prime Minister Shri Narendra Modi, with a special focus on the "Make in India" program.

President Putin drew parallels between Russia's import substitution program and India's "Make in India" initiative, expressing Russia's willingness to establish manufacturing operations in India. Investments in India are profitable, he added. He also emphasised that India's leadership has focused on prioritising its national interests.

"Prime Minister Modi has a similar program called Make in India. We are also ready to set up our manufacturing operations in India. We believe that investing in India is profitable," stated the Russian President. He also said that Russian company Rosneft invested \$20 bn in the country recently.

President Putin also highlighted the significance of Russia's import substitution program in the context of BRICS's evolution, focusing on the growth of SMEs and the necessity for a rapid dispute resolution mechanism to facilitate smooth business transactions for SMEs in BRICS+ countries.



He pointed out the rise of new Russian brands that are replacing Western brands that have exited the market, noting the success of local Russian manufacturers in sectors such as consumer goods, IT, high-tech, and agriculture.

"For us, this is particularly important as part of our import substitution program. The emergence of new Russian brands is helping replace those of Western companies that have voluntarily left our market. Our local manufacturers have achieved significant success, not only in consumer goods but also in IT and high-tech industries," he said.

President Putin also urged for greater cooperation among BRICS nations to support the growth of SMEs and encouraged member countries to identify key areas for collaboration at the upcoming summit in Brazil next year. Referring to the investment platform Russia is developing with BRICS, President Putin said that it has the potential to benefit all partner countries and is expected to become an important instrument for supporting our economies and providing financial resources to the countries of the Global South and East.

"I urge my BRICS colleagues to evaluate the current situation in key areas of cooperation, and we will certainly bring this to the attention of our Brazilian counterparts, who will be leading BRICS next year," he added.

corporations, and communities — must collaborate to make this campaign a grand success.

To complement expanded diagnostic efforts and to support a complete recovery of TB patients, India conceptualised and operationalised a nutritional support scheme, Nikshay Poshan Yojana (NPY). Since April 2018, we have disbursed Rs 3,295 crore to 1.16 crore beneficiaries through Direct Benefit Transfer under NPY. In what is a major reinforcement of India's commitment to TB elimination, the monthly support under the scheme has been doubled from Rs 500 to Rs 1,000 per month from November 2024.

The Pradhan Mantri TB Mukt Bharat Abhiyaan (PMTBMBA)

has not only helped address the challenge of nutrition but also enhanced community mobilisation. lt has united various community stakeholders creating а mass movement to increase awareness and to provide nutritional. vocational, and psychological support to TB This governmentpatients. citizen symphony anchored

in the spirit of Jan Bhagidari has inspired 1.75 lakh Nikshay Mitras to provide 21 lakh food baskets to patients across the country.

Over the years, India has introduced newer drugs such as Bedaquiline and Delamanid to improve treatment success rates. Considering the challenges



in treatment completion for patients with drug-resistant variants, we have allowed a new shorter regimen, BpaLM, which is more effective than the existing regimens. While we have a shorter 9–11-month regimen available alongside the conventional 19–20-month regimen, with the BPaLM regimen, patients will now complete treatment in just six months!

We have consistently strived to ensure that advanced tools are available at the grassroots levels to find and treat all patients at the earliest. To enable this, we introduced more efficient and accurate diagnostic tools — molecular tests. From a few hundred machines in 2014-15, we now have 8,293 molecular diagnostic machines available in all districts.

In fact, taking a cue from the Make in India initiative, indigenous molecular tests have been fieldtested and introduced. We have

been able to not only reduce the time taken for TB diagnosis at district and block levels but have drastically reduced the costs of testing and treatment. Our indigenous molecular tests have received endorsement by the WHO. These initiatives have positioned India as a true leader in global TB response.

We must also take great pride in the fact that the Indian Council of Medical Research (ICMR) has consistently been among the top public funders of TB research worldwide since 2018. We will continue making investments to quickly develop and roll out newer tools, including more efficient PoC diagnostics.

India's journey toward TB elimination is a testament to its leadership. From pioneering research that has led to advanced diagnostics and treatments, to the introduction of universal social support provisions, India stands at the forefront of the global TB response. The need of the

hour is to ensure a massive Jan Bhaqidari in the identification. diagnosis, treatment and prevention of TB. The intensified 100-day campaign is another testament to our collective commitment to eliminate TB. I am confident that under the PM's leadership and with the participation of all stakeholders, we will defeat this great enemy of humanity and create a healthier future for all.

example of the cooperative movement. Presently, 35L families avail employment, and women of these families play key roles. As a result, today, Amul's annual turnover has reached 80k cr. Interestingly, none of these women made an initial investment of more than Rs 100.

Under PM's leadership, GOI has introduced over 60 initiatives to revitalise and strengthen the cooperative movement. Years of neglect and administrative irregularities had left most primary agricultural credit societies (PACS) financially weak, inactive. To address this, govt expanded PACS's scope, making them economically viable. With new bylaws, PACS can now engage in over 30 diverse activities, including dairy, fisheries, grain storage, and running Jan Aushadhi Kendras.

Three new national-level multi-state cooperative societies have enhanced the cooperative ecosystem. National Cooperative Exports Ltd opened global market opportunities for farmers. National Cooperative

Organics Ltd provides

Three new national-level multi-state cooperative societies have enhanced the cooperative ecosystem. National Cooperative Exports Ltd opened global market opportunities for farmers. National Cooperative Organics Ltd provides platforms for organic certification and market access to organic products

platforms for organic certification and market access to organic products. Bharatiya Beej Sahakari Samiti Ltd ensures availability of high-quality seeds to farmers. Additionally, govt's financial assistance, tax relief, and ethanol blending programme have rejuvenated cooperative sugar mills.

To strengthen the cooperative banking system, policy emphasis has been on channelling cooperative institutions' funds into cooperative banks. Efforts to enhance transparency, such as creation of a National Cooperative Database, have streamlined. and extended the operations cooperative movement to underdeveloped regions. Further, a comprehensive and forward-National lookina Cooperative Policy is being developed to provide a robust framework for the sector's growth.

ICA General Assembly and Global Conference 2024 will serve as a global plat- form to showcase India's remarkable strides in advancing financial inclusion, eradicating poverty, ensuring gender equality, and

contributing to achieving UN's Sustainable Development Goals through its dynamic cooperative movement. А central agenda is to create a resilient ecosystem that cooperatives enables to address emerging challenges and seize new opportunities. It is imperative that cooperatives worldwide unite and contribute towards building a better. more sustainable future.

As we host this historic event, I extend an invitation to the world's cooperative leaders, policymakers, and advocates of human development. Let's embrace the spirit of learning, sharing, and collaborating to strengthen the global cooperative movement. INDIAN CONSTITUTION AS AN AESTHETIC DOCUMENT

It is difficult to express history in simple terms. It is even more daunting a task to express more than 5,000 years of civilisational history visually on the founding document of the Indian Republic. But Acharya Nandalal Bose was not just another artist, and illustrating the Constitution was not just another project

he art in the Constitution of India is a tribute to the sociocultural, mythological, spiritual, regional, and physical landscape and influences.

It is difficult to express history in simple terms. It is even more daunting a task to express more than 5,000 years of civilisational history visually on the founding document of the Indian Republic. But Acharya Nandalal Bose was not just another artist, and illustrating the Constitution was not just another project.

All the illustrations are listed on the last page of the Constitution. They can be categorised under 12 heads — the Mohenjodaro period, the Vedic period, the Epic period, the time of the Mahajanapadas and the Nandas, the Mauryan period, the Gupta period, the Medieval period, the Muslim period, the British period, the Freedom Movement, the revolutionary movement for freedom, and India's natural features.

Illustrations begin with the National Emblem. Bose was very particular about the lions of the Emblem looking realistic. So, Dinanath Bhargava, who designed the Emblem (as a young student at Kala Bhavan, the fine arts institution in Shantiniketan where Bose taught) visited Kolkata Zoo several times over many months, observing the regal animal. The page bearing the

Preamble, as well as many other pages of the Constitution, bear the art of Beohar Rammanohar Sinha, another of Bose's proteges. Bose endorsed Sinha's artwork for the Constitution without any alteration whatsoever.

The Preamble page bears Sinha's signature, a short Ram in the Devanagari script, in the lower right corner. The page features text bounded by a rectangular border. Four animals are depicted in the four corners of the border, taken from the National Emblem. The lotus motif is prominently featured in the border artwork.

Each part of the Constitution begins with an illustration, and pages have distinct border designs. The artists' signatures are carried along with the illustrations, indicating the collaborative nature of the project.

Many pages bear multiple signatures, in Bengali, Hindi, Tamil or English. Part 19 features a portrait of Netaji in military attire, saluting, surrounded by his troops. Nandalal Bose's signature appears here, and A Perumal's signature is visible on the left bottom corner of the page.


Perumal would go around the villages of Shantiniketan and decorate the walls of the Santhal homes with nature themes. He lived and worked with great artists such as Bose for over four decades in Kala Bhavan and was affectionately called Perumalda.

Part VI, which deals with The States in Part A of the First Schedule, begins with a richly coloured painting of the meditating Mahavira. Two trees are in bloom, one on each side of Mahavira, and there is a peacock too, indicating harmonious coexistence in nature. This is one of the few coloured images in the Constitution. The illustration bears the signatures of Jamuna Sen and Bose. The border design bears the signature of an artist named Rajniti.

Part XV, which focuses on Elections, features Chhatrapati Shivaji Maharaj and Guru Govind The illustrations Singh. are by Dhirendra Krishna Deb Barman, a member of the Tripura royal family, who had close ties with Rabindranath Tagore and Bose. The border design carries the signature of Kripal Singh Shekhawat, a renowned artist and ceramist known for reviving the iconic Blue Pottery of Jaipur. Kala Bhavan attracted students and artists from all corners of India and the world, functioning as

a melting pot of artistic influences while, in the end, creating a uniquely Indian style and narrative of artistic vision. Many of the artists who worked on the Constitution project went on to scale great heights in their careers, but at the time of this project, they were students and collaborators, eager to bring to life the vision of their revered "master moshai", Bose.

Part XIII deals with trade, commerce, and intercourse within the territory of India, and is marked by a scene from bas-relief forms at the group of monuments at Mahabalipuram, a Unesco World Heritage Site. Descent of the Ganges is a large rock relief depicting the holiest of rivers, the

Ganga, descending from heaven to Earth. Bose's signature appears on the illustration, and Sen's name appears at the bottom left corner of the border.

Part III, which deals with Fundamental Rights, features a scene from the Ramayana. The border bears Sen's signature. Part IV (Directive Principles of State Policy) features a scene from the Mahabharata. The names of Bani Patel and Bose appear at the bottom right, and Vinayak Shivram Masoji's name appears on the left corner of the border.

Part VII deals with The States in Part B of the First Schedule. The primary illustration depicts Emperor Ashoka riding an elephant adorned with livery, surrounded by Buddhist monks. The illustration is in the style of Ajanta, with the monks depicted bare-chested, wearing jewellery. This illustration was by Bose, whose work was deeply influenced by the artistic traditions of the Ajanta frescoes.

Perumal's name is also visible on the lower left portion of the illustration. The border design carries Sinha's signature. Here, he signs as Rammanohar. This is one of the few pages in the

Constitution that carry the names of both Bose and his most senior student, Sinha.

The Constitution is unique as it was originally a handwritten document, calligraphed in English by Prem Behari Narain Raizada and in Hindi by Vasant K Vaidya. Raizada used a flowing italic style, having learnt calligraphy from his grandfather. Working in a room in the Constitution Hall (now the

Constitution Club of India) for over six months, he used hundreds of pen nibs. Raizada's signature (as Prem) appears on every page of the document. This was his only request before undertaking this monumental project.

Today, efforts are being undertaken continuously to strengthen NCC in the country. In 2014, about 14 lakh youth were associated with NCC. Now in 2024, more than 20 lakh youth are associated with NCC.

- Apart from youths of around 12 villages getting the facility to read books from this library, this library is also providing other important facilities to the people. Some libraries are such that they are very useful for students in preparing for competitive examinations. It is indeed very heartening to note that the library is being used in the best possible way to strengthen the society. You too should develop friendship with books and see how it brings a change in your life.


