

The initiatives taken towards launching river linking projects, particularly Ken-Betwa project will bring huge relief to Bundelkhand region. The special initiatives in the area of MSME, education and health along with programmes for 'Saksham Anganwadi', 'Har Ghar, Nal se Jal', Housing for All, vibrant village programme makes the Budget comprehensive and inclusive in its approach and commitments.



The government also have programmes for ensuring financial inclusion and direct benefit transfers and a commitment to strengthen the abilities of poor to tap all opportunities.

The Finance Minister informed that the Productivity Linked Incentive in 14 sectors for achieving the vision of AtmaNirbhar Bharat has received excellent response, with potential to create 60 lakh new jobs, and an additional production of Rs 30 lakh crore during next 5 years. Dwelling on the issue of implementation of the new Public Sector Enterprise policy, She said, the strategic transfer of ownership of Air India has been completed, the strategic partner for NINL (Neelanchal Ispat Nigam Limited) has been selected, the public issue of the LIC is expected shortly and others too are in the process for 2022-23.

RAILWAYS

In Railways, the Finance Minister said that 'One Station-One Product' concept will be popularized to help local businesses & supply chains. Moreover, as a part of Atmanirbhar Bharat, 2,000 km of network will be brought under 'Kavach', the indigenous world-class technology for safety and capacity

augmentation in 2022-23. She also informed that four hundred newgeneration Vande Bharat Trains with better energy efficiency and passenger riding experience will be developed and manufactured and one hundred PM GatiShakti Cargo Terminals for multimodal logistics facilities will be set up during the next three years.

AGRICULTURE

Agriculture front. the Finance Minister informed that Chemical-free Natural Farming will be promoted throughout the country, with a focus on farmers' lands in 5-km wide corridors along river Ganga, at the first stage. Use of 'Kisan Drones' will be promoted for crop assessment, digitization of land records, spraying of insecticides, and nutrients. She said, to reduce dependence on import of oilseeds, a rationalised and comprehensive scheme to increase domestic production of oilseeds will be implemented.

As 2023 has been announced as the 'International Year of Millets', the government announced full support for post-harvest value addition, enhancing domestic consumption, and for branding millet products snationally and internationally.

S m t . Nirmala Sitharaman s a i d . implementation of the Ken-Betwa Link Project, at an estimated cost of Rs 44,605 crore will be taken up aimed at providing irrigation benefits to 9.08 lakh hectare of farmers' lands, drinking water supply for 62 lakh people, 103 MW of Hydro, and 27 MW of solar power. Allocations of Rs 4,300 crore in RE 2021-22 and Rs 1,400 crore in 2022-23 have been made for this project. Moreover, Draft DPRs of five river links, namely Damanganga-Pinjal, Par-TapiNarmada, Godavari-Krishna, Krishna-Pennar and Pennar-Cauvery have been finalized and once a consensus is reached among the beneficiary states, the Centre will provide support for implementation.







PEOPLE-FRIENDLY AND PROGRESSIVE BUDGET: PM



small enterprises, are yet to regain their pre-pandemic level of business and after considering these aspects, the ECLGS will be extended up to March 2023. She informed that its guarantee cover will be expanded by Rs 50,000 crore to total cover of Rs 5 lakh crore, with the additional amount being earmarked exclusively for the hospitality and related enterprises.

SKILL DEVELOPMENT AND QUALITY EDUCATION

Dwelling on the subject of Skill development and Quality the Finance Education. Minister said that Startups will be promoted to facilitate 'Drone Shakti' through varied applications and for Drone-As-A-Service (DrAAS). select ITIs, in all states, the required courses for skilling will be started. In vocational courses, to promote crucial critical thinking skills, to give space for creativity, 750 virtual labs in science and mathematics, and 75 skilling e-labs for simulated learning environment, will be set-up in 2022-23.

A Digital University will be established to provide


access to students across the country for world-class quality universal education with personalized learning experience at their doorsteps. This will be made available in different Indian languages and ICT formats. The University will be built on a networked hub-spoke model, with the hub building cutting edge ICT expertise. The best public universities and institutions in the country will collaborate as a network of hub-spokes.

HEALTH

Under Ayushman Bharat Digital Mission, an open platform for the National Digital Health Ecosystem will be rolled out and it will consist of digital registries of health providers and health facilities, unique health identity, consent framework, and universal access to health facilities.

HAR GHAR, NAL SE JAL

Smt Nirmala Sitharaman announced an allocation of Rs 60,000 crore to cover 3.8 crore households in 2022-23 for Har Ghar, Nal Se Jal. Current coverage is 8.7 crores and of this 5.5 crore households were provided tap water in last 2 years itself.



PM AWAS YOJANA

Similarly, in 2022-23, 80 lakh houses will be completed for the identified eligible beneficiaries of PM Awas Yojana, both rural and urban and Rs 48,000 crore is allocated for this purpose.

DEVELOPMENT INITIATIVE FOR NORTH-

A new scheme, Prime Minister's Development Initiative for NorthEast, PM-DevINE, will be implemented through the North-Eastern Council to fund infrastructure, in the spirit of PM GatiShakti, and social development projects based on felt needs of the North-East. An initial allocation of Rs 1500 crore

will enable livelihood activities for youth and women, filling the gaps in various sectors.

BANKING AND FINANCE

In 2022, 100 per cent of 1.5 lakh post offices will come on the core banking system enabling financial inclusion and access to accounts through 11 net banking, mobile banking, ATMs, and also provide online transfer of funds between post office accounts and bank accounts. This will be helpful, especially for farmers and senior citizens in rural areas, enabling interoperability and financial inclusion.

To mark 75 years of independence, the government has proposed to set up 75 Digital Banking Units (DBUs) in 75 districts of the country by Scheduled Commercial Banks to ensure that the benefits of digital banking reach every nook and corner of the country in a consumer-friendly manner.

DEFENCE

On the Defence front, the Government remain's committed to reducing imports and promoting AtmaNirbharta in equipment for the Armed Forces. 68 per cent of the capital procurement budget will be

earmarked for domestic industry in 2022-23, up from 58 per cent in 2021-22. Defence R&D will be opened up for industry, startups and academia with 25 per cent of defence R&D budget earmarked.

Referring to Sunrise Opportunities, the Finance Minister said, Artificial Intelligence, Geospatial Systems and Drones, Semiconductor and its eco-system, Space Economy, Genomics and Pharmaceuticals, Green Energy, and Clean Mobility Systems have immense potential to assist sustainable development at scale and modernize the country. They provide employment opportunities for youth, and make Indian industry more efficient and competitive.

To facilitate domestic manufacturing for the ambitious goal of 280 GW of installed solar capacity by 2030, an additional allocation of RS 19,500 crore for Production Linked Incentive for manufacture of high efficiency modules, with priority to fully integrated manufacturing units from polysilicon to solar PV modules, will be made.

FISCAL DEFICIT

Concluding the Part A of her Budget speech, the Finance Minister said that the revised Fiscal Deficit in the current year is estimated at 6.9 per cent of GDP as against 6.8 per cent projected in the Budget Estimates. The Fiscal Deficit in 2022-23 is estimated at 6.4 per cent of GDP, which is consistent with the broad path of fiscal consolidation announced by her last year to reach a fiscal deficit level below 4.5 per cent by 2025-26. While setting the fiscal deficit level in 2022-23, she called for nurturing growth, through public investment, to become stronger and sustainable.

The Union Budget 2022-23, while continuing with

the declared policy of stable and predictable tax regime, intends to bring more reforms that will take ahead the vision to establish a trustworthy tax regime. Smt. Nirmala Sitharaman said that proposals relating to taxes and duties will further simplify the tax system, promote voluntary compliance by taxpayers, and reduce litigation.

TAX

On the Direct Tax side, the budget allows taxpayers to file updated income tax return within 2 years for correcting errors. It also provides tax relief to persons with disability. The budget also reduces Alternate minimum tax rate and surcharge for cooperatives. As an incentive for startups, period of incorporation of eligible startups has been extended by one more year. The budget proposes to increase tax deduction limit on employer's contribution to NPS account of state government employees to bring parity with central government employees. Newly incorporated manufacturing entities will be incentivized under concessional tax regime. Income from transfer of virtual assets will be taxed at 30%. The budget proposes better litigation management to avoid repetitive appeals.

On the Indirect tax side, the Union budget says that Customs administration in Special Economic Zones will be fully IT driven. It provides for phasing out of concessional rates in capital goods and project imports gradually and apply a moderate tariff of 7.5%. The budget underlines review of customs exemptions and tariff simplification, with more than 350 exemptions proposed to be gradually phased out. It proposes that customs duty rates will be calibrated.

Prime Minister Narendra Modi on 02 February, 2022 addressed a conclave on 'Aatmanirbhar Arthvyavastha' organized by the Bharatiya Janata Party in New Delhi. Addressing the gathering virtually, PM Shri Modi said, "There is a possibility of a new world order post-COVID pandemic. Today, the world's perspective of looking at India has changed a lot. Now, the world wants to see a stronger India. With the world's changed perspective towards India, it is imperative for us to take the country forward at a rapid pace by strengthening our economy."

Talking about the striking features of the Budget 2022, the PM said, "Union Finance Minister Nirmala Sitharaman comprehensively explained the Budget in a timely manner given its vastness. The budget has been appreciated from all the corners. Even country's forex

reserves have increased to \$630 billion from \$200 billion. All of this due to our government's effective policies."

POOR. MIDDLE CLASS AND YOUTH

The Prime Minister asserted, "This Budget focuses on the poor, middle class and youth and aims to provide them basic necessities. Our government is working on the saturation of basic facilities. With efforts from our government, nearly 9 crore tap water connections in rural households have already been installed. Out of this, over 5 crore connections have been installed under the Jal Jeevan Mission in the last 2 years."

Citing that the budget was more poor friendly, he said, "In this year's budget, there's provision for 80 lakh pucca houses for the poor. For the same, Rs 48,000 crore has been allotted. This will help them overcome poverty and take them forward. Our Government's housing project will make the poor lakhpatis."

"Last year, FDI in India has crossed 80 billion dollar. In 2013-14, India's exports stood at Rs 2.85 lakh crore. Today, it has achieved Rs 4.7 lakh crore," he added.

ASPIRATIONAL DISTRICTS

Highlighting the Union government's vision behind Budget 2022, Shri Modi stated, "In this budget, an announcement has been made that in Aspirational Districts, Aspirational Blocks will be worked upon in coordination with states. This will take developmental work to the lowest level of the society and empower them."

MODERNIZATION OF INDIAN AGRICULTURE

Expressing his happiness on the budget, the PM said, 'The budget also focused on modernizing Indian agriculture with a focus on organic farming. This will make farming more lucrative. Kisan drones and other machinery will be made available to the farmers at reasonable prices."

Also, the Prime Minister talked about India having a new corridor for natural farming, he asserted that the natural farming corridor will run along the bank of River Ganga. The corridor for natural or organic farming will be 2,500 km long and 10 km wide. "We import edible oil worth Rs 80,000 Lakh. Hence, we have started a national project to stop the outflow of funds. This will help farmers. We have also started solar energy and Van Dhan Yojana for farmers. The Budget has boosted these efforts," he added.

MULTIMODAL LOGISTICS PARKS

Shri Narendra Modi said, "Multimodal Logistics Parks will be set up at 4 places in the country. 100 PM Gatishakti Cargo Terminals will be developed for multimodal logistics facilities. This will reduce the time taken to transport anything for industries, trade and will also help in increasing exports from India.

BJP FULFILLS ALL PROMISES MADE IN 2017: JP NADDA

HATHRAS RALLY

haratiya Janata Party National President Shri JP Nadda conducted a door-to-door campaign and addressed the 'Prabhavi Matdata Samvad' in Hathras, Uttar Pradesh on 30 January, 2022. Addressing the rally he said the BJP government in the state has fulfilled all its promises to the people and the basis of development has been "Sabka Saath, Sabka Vikas, Sabka Vishwas" in the state.

"One thing about the BJP, I can say, is that whatever the BJP has said in 2017, it has fulfilled. The party has not turned back in any way. All other political parties keep changing according to the seasons," Shri Nadda said during the rally.

Prior to the rally, the BJP National President held a door-to-door campaign in the constituency and distributed pamphlets to the residents there, seeking support for the party's candidate.

SIRATHU (KAUSHAMBI) RALLY

'Samajwadi Party is a supporter of anti-nationals'

BJP National President Shri JP Nadda on 03 February, 2022 addressed a huge rally at Kaushambi's Sirathu after Deputy Chief Minister Shri Keshav Prasad Maurya submitted his nomination papers for the state Assembly polls. The CBI arrested seven people in the case but Akhilesh Yadav tried to withdraw the case against them in the direction of Samajwadi Party leader Azam Khan, who is currently fighting the elections from jail.

"Of the seven, four were awarded capital punishment and three got life imprisonment. If such people rule state, there will be mafia raj," Shri Nadda said. "Their leaders are resting either in jails or are out on bail," he added.

SHAHJAHANPUR AND BAREILLY RALLY

'BJP is committed for the welfare of farmers'

In Shahjahanpur and Bareilly Shri JP Nadda highlighted the pro-farmers' schemes launched by the BJP government at the centre and in the state in the 'Prabhavi Matdata Samvad' organised on January 28, 2022 in both the districts. Shri JP Nadda also gave momentum to the party's election campaign in western Uttar Pradesh by organizing door-to-door campaigns in Shahjahanpur and Bareilly.

Terming the Samajwadi Party (SP) and the Bahujan Samaj Party (BSP) as anti-farmers, Shri Nadda said farmers were harassed under the governments of both parties whereas under the BJP government, the minimum support price of crops was increased and subsidy was given on fertilizers.

SHIKOHABAD RALLY

'SP giving tickets to candidates who are in jail or out on bail'

BJP National President Shri Jagat Prakash Nadda on Sunday conducted a door-to-door campaign in Shikohabad, Uttar Pradesh ahead of Assembly elections in the state on January, 30. Massive crowds had gathered to welcome him.

"Over 11 crore farmers are registered under the PM crop insurance scheme in the country while 2.70 crore farmers in UP are associated with the scheme. Soil health card has been distributed among 3.70 crore farmers in UP." he said.

Shri Nadda said 45 lakh farmers in UP were getting pension while 36,000 crore loans of farmers had been waived. "The Yogi government has made Rs. 1.40 lakh crore payments to sugarcane farmers. Under SP and BSP governments, sugar mills were sold and closed, but new sugar mills have been set up under the Yogi government and farmers are getting 50% discount in power supply. Today, UP is number one in crop production," he said.

The BJP President said the SP was giving tickets to candidates who were in jail or out on bail however, criminals, gangsters and mafia have been severely punished under the BJP government," he added.



AKHILESH YADAV'S REGIME WAS KNOWN FOR RIOTS: AMIT SHAH

Inion Home Minister Shri Amit Shah targeted the Samajwadi Party chief Akhilesh Yadav, accusing him of fielding criminals in the Uttar Pradesh Assembly polls. Addressing public meetings in Baghpat and Amroha on February 06, 2022 Shri Shah said the upcoming state election is being fought to put an end to the patronage of criminals.

He also praised Yoqi Adityanath-led state government for action against criminals. "Todav. criminals mafia are seen either in jail, outside the boundary of UP



or in the list of candidates of Akhilesh Yadav. Today, Azam Khan, Atiq Ahmed and Mukhtar Ansari are in jail and it is so because there is a BJP government in the state," he said.

Shri Shah also claimed that not a single riot took place during the Adityanath government in UP while Akhilesh Yadav's regime was known for riots. The people of UP have not forgotten the sting of riots at the time of Akhilesh Yadav. At that time, owing to politics of appeasement and to please people of one section, the government had made the victim an accused and the accused a victim," he said.

He said the upcoming elections are being contested between two sets of ideologies. "On one side, it is an election to save a family and on the other side, it is to keep the country safe under the leadership of Prime Minister Shri Narendra Modi," he said.

KEY HIGHLIGHTS OF ECONOMIC SURVEY 2021-22

he Union Minister for Finance & Corporate Affairs, Smt. Nirmala Sitharaman presented the Economic Survey 2021-22 in Parliament on 31 January, 2022. The highlights of the Economic Survey are as follows:

STATE OF THE ECONOMY:

- The Indian economy is estimated to grow by 9.2 percent in real terms in 2021-22 (as per first advanced estimates) subsequent to a contraction of 7.3 percent in 2020-21.
- GDP projected to grow by 8-8.5 percent in real terms in 2022-23.
- The year ahead is poised for a pickup in private sector investment with the financial system in a good position to provide support for the economy's revival.
- Projection comparable with World Bank and Asian Development Bank's latest forecasts of real GDP growth of 8.7 percent and 7.5 percent respectively for 2022-23.
- As per IMF's latest World Economic Outlook projections, India's real GDP projected to grow at 9 percent in 2021-22 and 2022-23 and at 7.1 percent in 2023-2024, which would make India the fastest growing major economy in the world for all 3years.
- Agriculture and allied sectors are expected to grow by 3.9
 - percent; industry by 11.8 percent and services sector by 8.2 percent in 2021-22.
- On the demand side, consumption is estimated to grow by 7.0 percent, Gross Fixed Capital Formation (GFCF) by 15 percent, exports by 16.5 percent and imports by 29.4 percent in 2021-22.
- Macroeconomic stability indicators suggest that the Indian Economy is well placed to take on the challenges of 2022-23.

 Combination of high foreign exchange reserves, sustained foreign direct investment, and rising export earnings will provide an adequate buffer against possible global liquidity tapering in 2022-23.

FISCAL DEVELOPMENTS:

- The revenue receipts from the Central Government (April to November, 2021) have gone up by 67.2 percent (YoY) as against an expected growth of 9.6 percent in the 2021-22 Budget Estimates (over 2020-21 Provisional Actuals).
- Gross Tax Revenue registers a growth of over 50 percent during April to November, 2021 in YoY terms. This performance is strong compared to prepandemic levels of 2019-2020 also.
 - During April-November 2021, Capex has grown by 13.5 percent (YoY) with focus on infrastructureintensive sectors.
 - Sustained revenue collection and a targeted expenditure policy has contained the fiscal deficit for April to November, 2021 at 46.2 percent of BE.
 - With the enhanced borrowings on account of COVID-19, the Central Government debt has gone up from 49.1 percent of GDP in 2019-20 to 59.3 percent of GDP in 2020-21, but is expected to follow a declining trajectory with the recovery of the economy.



EXTERNAL SECTORS:

- India's merchandise exports and imports rebounded strongly and surpassed pre-COVID levels during the current financial year.
- There was significant pickup in net services with both receipts and payments crossing the pre-pandemic levels, despite weak tourism revenues.
- Net capital flows were higher at US\$ 65.6 billion in the first half of 2021-22, on account of continued inflow of foreign investment, revival in net external

- commercial borrowings, higher banking capital and additional special drawing rights (SDR) allocation.
- India's external debt rose to US \$ 593.1 billion at end-September 2021, from US \$ 556.8 billion a year earlier, reflecting additional SDR allocation by IMF, coupled with higher commercial borrowings.
- Foreign Exchange Reserves crossed US\$ 600 billion in the first half of 2021-22 and touched US\$ 633.6 billion as of December 31, 2021.
- As of end-November 2021, India was the fourth largest forex reserves holder in the world after China, Japan and Switzerland.

MONETARY MANAGEMENT AND FINANCIAL INTERMEDIATION:

- The liquidity in the system remained in surplus.
 - Repo rate was maintained at 4 per cent in 2021-22.
 - RBI undertook various measures such as G-Sec Acquisition Programme and Special Long-Term Repo Operations to provide further liquidity.
- The economic shock of the pandemic has been weathered well by the commercial banking system:
 - YoY Bank credit growth accelerated gradually in 2021-22 from 5.3 per cent in April 2021 to 9.2 per cent as on 31st December 2021.
 - The Gross Non-Performing Advances ratio of Scheduled Commercial Banks (SCBs) declined from 11.2 per cent at the end of 2017-18 to 6.9 per cent at the end of September, 2021.
 - Net Non-Performing Advances ratio declined from 6 percent to 2.2 per cent during the same period.
 - Capital to risk-weighted asset ratio of SCBs continued to increase from 13 per cent in 2013-14 to 16.54 per cent at the end of September 2021.
 - The Return on Assets and Return on Equity for Public Sector Banks continued to be positive for the period ending September 2021.

PRICES AND INFLATION:

- The average headline CPI-Combined inflation moderated to 5.2 per cent in 2021-22 (April-December) from 6.6 per cent in the corresponding period of 2020-21.
 - o The decline in retail inflation was led by easing of

- food inflation.
- Food inflation averaged at a low of 2.9 per cent in 2021-22 (April to December) as against 9.1 per cent in the corresponding period last year.
- Effective supply-side management kept prices of most essential commodities under control during the year.
- Proactive measures were taken to contain the price rise in pulses and edible oils.
- Reduction in central excise and subsequent cuts in Value Added Tax by most States helped ease petrol and diesel prices.
- Wholesale inflation based on Wholesale Price Index (WPI) rose to 12.5 per cent during 2021-22 (April to December).
 - o This has been attributed to:
 - Low base in the previous year,
 - Pick-up in economic activity,
 - Sharp increase in international prices of crude oil and other imported inputs, and
 - High freight costs.
- Divergence between CPI-C and WPI Inflation:
 - The divergence peaked to 9.6 percentage points in May 2020.
 - However, this year there was a reversal in divergence with retail inflation falling below wholesale inflation by 8.0 percentage points in December 2021.
 - o This divergence can be explained by factors such as:
 - Variations due to base effect,
 - Difference in scope and coverage of the two indices.
 - Price collections,
 - Items covered,
 - Difference in commodity weights, and

SUSTAINABLE DEVELOPMENT AND CLIMATE CHANGE:

- India's overall score on the NITI Aayog SDG India Index and Dashboard improved to 66 in 2020-21 from 60 in 2019-20 and 57 in 2018-19.
- Number of Front Runners (scoring 65-99) increased to 22 States and UTs in 2020-21 from 10 in 2019-20.
- In North East India, 64 districts were Front Runners and 39 districts were Performers in the NITI Aayog North-Eastern Region District SDG Index 2021-22.

GOVERNMENT'S ACHIEVMENTS

- India has the tenth largest forest area in the world.
- In 2020, India ranked third globally in increasing its forest area during 2010 to 2020.
- In 2020, the forests covered 24% of India's total geographical, accounting for 2% of the world's total forest area.

AGRICULTURE AND FOOD MANAGEMENT:

- The Agriculture sector experienced buoyant growth in the past two years, accounting for a sizable 18.8% (2021-22) in Gross Value Added (GVA) of the country registering a growth of 3.6% in 2020-21 and 3.9% in 2021-22.
- Minimum Support Price (MSP) policy is being used to promote crop diversification.
- Net receipts from crop production have increased by 22.6% in the latest Situation Assessment Survey (SAS) compared to the SAS Report of 2014.
- Allied sectors including animal husbandry, dairying and fisheries are steadily emerging to be high growth sectors and major drivers of overall growth in the agriculture sector.

- The Index of Industrial Production (IIP) grew at 17.4 percent (YoY) during April-November 2021 as compared to (-)15.3 percent in April-November 2020.
- Capital expenditure for the Indian railways has increased to Rs. 155,181 crores in 2020-21 from an average annual of Rs. 45,980 crores during 2009-14 and it has been budgeted to further increase to Rs. 215,058 crores in 2021-22 – a five times

- increase in comparison to the 2014 level.
- Extent of road construction per day increased substantially in 2020-21 to 36.5 Kms per day from 28 Kms per day in 2019-20 – a rise of 30.4 percent.
- Net profit to sales ratio of large corporates reached an all-time high of 10.6 percent in July-September quarter of 2021-22 despite the pandemic (RBI Study).
- Introduction of Production Linked Incentive (PLI) scheme, major boost provided to infrastructureboth physical as well as digital, along with measures to reduce transaction costs and improve ease of doing business, would support the pace of recovery.

SERVICES:

- GVA of services crossed pre-pandemic level in July-September quarter of 2021-22; however, GVA of contact intensive sectors like trade, transport, etc. still remain below pre-pandemic level.
- Overall service Sector GVA is expected to grow by 8.2 percent in 2021-22.
- During April-December 2021, rail freight crossed its pre-pandemic level while air freight and port traffic almost reached their pre-pandemic levels, domestic air and rail passenger traffic are increasing gradually – shows impact of second wave was much more muted as compared to during first wave.
- During the first half of 2021-22, the service sector received over US\$ 16.7 billion FDI – accounting for almost 54 percent of total FDI inflows into India.
- IT-BPM services revenue reached US\$ 194 billion in 2020-21, adding 1.38 lakh employees during the same period.

SOCIAL INFRASTRUCTURE AND EMPLOYMENT:

- 157.94 crore doses of COVID-19 vaccines administered as on 16th January 2022; 91.39 crore first dose and 66.05 crore second dose.
- With the revival of the economy, employment indicators bounced back to pre-pandemic levels during the last quarter of 2020-21.
- Expenditure on social services (health, education and others) by Centre and States as a proportion of GDP increased from 6.2 % in 2014-15 to 8.6% in 2021-22 (BE).

EVILS OF MENTAL SLAVERY



He was arrested in 1970 for leading a group in Delhi in support of the recognition of Bangladesh, and imprisoned under the Maintenance of Internal Security Act (MISA) from November 14th, 1975, to December 18th, 1976.

BJP'S POLITICAL JOURNEY IN UTTAR PRADESH: AN INSIGHT

rime Minister Smt. Indira Gandhi tried to throttle democracy by imposing Emergency in 1975. The move threw India's democratic polity completely out of gear as several Opposition leaders were arrested and draconian measures undertaken to stifle free speech and press. The Emergency lasted for 21 months and ended with the announcement of elections in 1977. The Janata Party was formed by political leaders and activists of various organisations who had been united in opposing the State of Emergency in the country. The Congress (O), Swatantra Party, Socialist Party of India, Bharatiya Jana Sangh, Lok Dal and a small faction from the Indian National Congress known as the Congress for Democracy led by Jagjivan Ram formed the Janata alliance.

JANATA PARTY GOVERNMENT AT THE CENTRE

The Emergency, which was a dark chapter in the history of independent Indian, paved the way for the victory of Janata Party at the centre and Morarji Desai became the Prime Minister. Chaudhary Charan Singh was the Minister of Home Affairs and Jagjivan Ram became the Defence minister. Bharatiya Jana Sangh leaders Shri Atal Bihari Vajpayee became External Affairs Minister and Shri LK Advani became the Minister of Information and Broadcasting. However, in a short span of two-years, the Janata Party became a victim of mutual rivalry, internal contradictions and as a result Morarji Desai resigned on 19 July, 1979 and the first non-Congress government at the Centre collapsed. Subsequently, the leaders of erstwhile Jana Sangh were forced to leave the Janata Party on the pretext of 'Dual Membership'.

THE BIRTH OF BJP AND AFTER

On April 06, 1980the Jana Sangh leaders formed the Bharatiya Janata Party and Atal Bihari Vajpayee became the first President of the new party. Just two months after the formation of the party in June 1980, the

BJP made its electoral debut in Uttar Pradesh. It won 11 seats, while the Congress formed the government and VP Singh became the CM.

In the aftermath of the assassination of Smt. Indira Gandhi in 1984 the elections were held in the country and it was the first election for Bharatiya Janata Party after its formation at the national level and it won two seats with 7.74 per cent of the total vote share.

The next Assembly election in Uttar Pradesh was held in 1985 and the Bharatiya Janata Party improved its previous tally in the state and secured 16 seats with 9.83 percent votes. But from 1980 to 1988was a period of political uncertainty in Uttar Pradesh and six Chief Ministers came one after another during this period.

BOFORS SCAM AND JANATA DAL EXPERIMENT

In 1987, Bofors scam came to light in which the image of PM Rajiv Gandhi suffered irreversibly. The Shahbano case also exposed Rajiv Gandhi government's minority vote-bank politics. In January 1988, the BJP demanded the resignation of Rajiv Gandhi and declaration of midterm elections. In August 1988, National Front was formed and NT Rama Rao became its chairman and alongwith the birth of Janata Dal.

By 1989, PM Rajiv Gandhi was severely tainted by charges of corruption and in the general elections held in November; he barely managed to retain his own Lok Sabha seat and his government was thrown out of power. However, the Janata Dal with 141 seats emerged as the second largest block, and VP Singh, with the support of the BJP (86 seats) and communist parties (44 seats), was able to put together a coalition majority that took office in December 1989. This election firmly established the BJP as a major political force in the country with 11.36 percent vote share and 86 seats in Lok Sabha. Along with Bofors issue, BJP focused on the slogan 'Justice for all, Appeasement of none' in this election.

Along with the general election the Uttar Pradesh

Legislative Assembly elections were also held in November 1989. In this election further strengthening its hold, the BJP won57 seats with 11.61 percent votes and extended outside support to the Janata Dal government in the state. The Janata Dal won 208 seats and Mulayam Singh Yadav became the new Chief Minister. But for the Congress under ND Tiwari, this election proved disastrous and it suffered a historic defeat heralding the decline of Congress party which continues to this day without a semblance of revival in sight.

Throughout 1980s the BJP built up its ground in Uttar Pradesh and in other parts of the country. BJP started a Rath Yatra from Somnath to Ayodhya under the leadership of Shri LK Advani in September1989 and this turned out to be the most significant political mobilization for the party towards the end of this decade.

The Yatra also received unprecedented public support across the country.

FIRST BJP GOVERNMENT IN UP ON ITS OWN STRENGTH

With the dawn of 1990s the political scenario changed significantly in

Uttar Pradesh and the dedication and hard work of BJP Karyakartas brought victories for the party. The Legislative Assembly elections were held in the state in 1991. The BJP with massive support of the people won 221 seats with 33.30% percent votes and formed its first government on its own strength in Uttar Pradesh. Shri Kalyan Singh became the new Chief Minister. On December 6, 1992 the illegal Babri structure in Ayodhya was demolished and immediate after it the Kalyan Singh government was undemocratically dismissed and President's rule was imposed in Uttar Pradesh.

In the next Assembly elections held in 1996, the BJP secured 174 seats. After a spell of President's Rule, the BJP and BSP formed a government in April 1997 for a brief period. In the later part of the decade till 2002, the BJP-led NDA government ruled the state with Shri Kalyan Singh, followed by Shri Ram Prakash Gupta, and then Shri Rajnath Singh, at the helm. Following this, the two main regional parties-BSP and SP took turns to form governments in the state till 2017. However, during

their reign, marked by nepotism, political violence, deteriorating law and order, politics of appeasement, casteism, corruption, and terrorism, Uttar Pradesh economy suffered pushing the state to the dubious category of BIMARU states.

LANDSLIDE VICTORY OF BJP IN 2014

The Bharatiya Janata Party snatched a historic and unprecedented victory in the General Elections of 2014 and secured more seats than it did in the last two General Elections combined, taking its tally to 282 seats, the highest by a single party since the 1984 elections. The NDA also won in 336 seats in the Lok Sabha. The party's 2014 vote-share too was over 1.5 times that of its 2009 vote-share, with nearly every third vote cast in the country going to the party. The Key factor behind this landslide victory was the wave in favour of the BJP

and PM candidate Shri Narendra Modi. The BJP succeeded in transcending regions, religious divide and caste boundaries and it happened for the first time since 1984. The BJP tsunami swept the nation, and the Congress was obliterated, slipping to its

lowest ever tally of 44 seats in the Lok Sabha.

The biggest impact of the BJP tsunami was felt in Uttar Pradesh, where the Party won 71 out of 80 seats with 42.3% vote share and 73 seats with its coalition partners. It was also the best performance by a single party in the State since 1984.

BJP SCRIPTS HISTORYWITH LANDSLIDE VICTORY

Three years later, in 2017, Assembly Elections were held in Uttar Pradesh. The 15-year exile of the BJP in the state ended with the colossal victory of the party, which secured around 40 percent votes and 312 seats- the second-highest number of seats ever won by a party in Uttar Pradesh Assembly polls. outh constitute a large percentage of our country. Therefore. they important role in the development and growth of the country. The budget presented by the Modi government in parliament creates many avenues for increasing employability. Capital expenditure increased by 35.4 percent in the budget for 2022-23.lt has been increased from Rs 5.54 lakh crore in the current year to Rs 7.50 lakh crore in 2022-23. This is more than 2.2 times the amount spent in 2019-20, and it will amount to 2.9 percent of GDP in 2022-23. Through this sharp jump in allocation for capex, the government intends to create employment opportunities through the speedy growth of the country. Its strong focus on infrastructure development bringing huge opportunities for entrepreneurship as well as for job seekers. As Finance Minister Smt. Nirmala Sitharaman said while presenting the budget, PM Gati Shakti (Multi-modal Connectivity) is a transformative approach for economic growth and sustainable development. The approach is driven by seven engines, namely, roads, railways, airports, ports, mass transport, waterways, and logistics infrastructure. All seven engines will pull the economy unison. forward in These engines are supported by the complementary roles of energy transmission, IT communication, bulk water and sewerage, and

social infrastructure. Finally, the approach is powered by clean energy and Sabka Prayas—the efforts of the central government, state governments, the private sector working together—leading to huge job and entrepreneurial opportunities for all, especially the youth. The PM GatiShakti Master Plan for Expressways will be formulated in 2022-23 to facilitate the faster movement of people and goods. The National Highways network

will be expanded by 25,000 km in 2022-23 and Rs 20,000 crore will be mobilised through innovative ways of financing to complement public resources. The Productivity Linked Incentive scheme has been increased to 14 sectors in the budget to achieve the vision of Atma Nirbhar Bharat. It has the potential to create 60 lakh new jobs and has an additional production capacity of Rs 30 lakh crore during the next 5 years.

In view of creating employment

opportunities, especially vouths at local level, in the railways, the government has launched the 'One Station-One Product' concept. The scheme will be helpful in encouraging and popularising local businesses and supply chains. Similarly, the Credit Guarantee Trust for Micro and Small Enterprises (CGTMSE) scheme will attract youth. The scheme will be revamped with the required infusion of funds. This will facilitate additional credit of Rs 2 lakh crore for micro and small enterprises and expand employment opportunities. The Finance Minister said that the Raising and Accelerating MSME Performance (RAMP) programme with an outlay of Rs 6,000 crore over 5 years would be rolled out to make the MSME sector more resilient, competitive, and efficient. Udyam, e-Shram, NCS, and ASEEM portals would be interlinked and their scope would be widened.

The Startups scheme. which is devoted to budding entrepreneurs, will be promoted under this new budget to facilitate 'Drone Shakti' through various applications and for Drone-As-A-Service (DrAAS). In select ITIs in all states, the required courses for skills will be started. In vocational courses, to promote crucial critical thinking skills, to give space for creativity, 750 virtual labs in science and mathematics, and 75 skilling e-labs for simulated learning environments, will be

set-up in 2022-23.

The budget envisages a plan for a digital university that will be established to provide access to students across the country to a world-class quality universal education with a personalised learning experience at their doorsteps. This will be made available in different Indian languages and ICT formats. The university will be built on a networked hub-spoke model, with the hub building's cutting-edge ICT expertise. The best public universities and institutions in the country will collaborate as a network of hub-spokes.

The budget has also proposed setting up an animation, visual effects, gaming, and comic (AVGC) Promotion Task Force as the sector has the potential to offer huge employment opportunities for youth. Smt Nirmala Sitharaman said that telecommunications in general, and 5G technology in particular, can enable growth and offer job opportunities. She said that required spectrum auctions will be conducted in 2022 to facilitate the rollout of 5G mobile services within 2022–23 by private telecom providers. A scheme for designled manufacturing will be launched to build a strong ecosystem for 5G as part of the Production Linked Incentive Scheme.

The defence budget also envisages ample employability avenues for youths. The government, through the budget, reiterated its commitment to reducing imports and promoting AtmaNirbharta in equipment for the Armed Forces. The government is going to give more priority in defence manufacturing to Swadeshi manufacturers. 68 percent of the capital procurement of defence budget will be allocated to domestic industry in 2022-23, up from 58 percent in 2021-22. This Atma Nirbhar defence budget includes 25% of the defence R&D budget for industry, startups, and academia will be more beneficial to MSME. The proliferation of MSME in this sector has the potential to engage an increasing number of young people.



The Prime Minister, Shri Narendra Modi dedicated to the nation the 'Statue of Equality' in Hyderabad on February 5. The 216-feet tall Statue of Equality commemorates the 11th century Bhakti Saint Sri Ramanujacharya, who promoted the idea of equality in all aspects of living including faith, caste and creed. Governor of Telangana Smt Tamilisai Soundararajan, Union Minister Shri G. Kishan Reddy were among those present on the occasion.

Speaking on the occasion, the Prime Minister greeted everyone on the auspicious occasion of Basant Panchami and expressed happiness on dedication of the statue on such a pious occasion. He said "India is giving concrete shape to India's human energy and inspirations through this grand statue of Jagadguru Sri Ramanujacharya. This statue of Sri Ramanujacharya is a symbol of his wisdom, detachment and ideals."

The Prime Minister participated in the 'Purnahuti' of 'Vishwaksena Ishti Yagya'. The Yagya is for fulfilment of resolutions and goals. The Prime Minister offered the 'sankalpa' of the Yagya for the 'Amrit' Sankalp of the country and dedicated the yagya to 130 crore countrymen.

The Prime Minister recalled the Indian tradition of its scholars that views knowledge above rebuttal and acceptance-rejection. Assembly elections have already been announced by the Election Commission of India. As per the announcement, Goa will go to the polls on February 14, with all 40 seats to be voted in a single phase. The results of the election will be announced on March 10.

In Goa, the BJP began its political journey as a smaller alliance partner with the Maharastrawadi

Gomantak Party (MGP). In 1989, the BJP tried to make inroads into Goa politics and managed to get 0.39 percent of the vote share. But the successful alliance with the MGP gave results for the party in the 1994 assembly elections. Soon the BJP's vote share soared to 9.5 percent, and the party added four assembly seats to its tally. Within the next five years, the BJP emerged as the main opposition in the state and won 10 seats. From 1999 to 2004, Goa witnessed the rise and fall of governments. Finally Shri Manohar Parrikar formed his first government in the year 2012.

In the last assembly election (2017), the state of Goa witnessed a hung assembly with the BJP securing a high vote share of 32.5 percent. The Bharatiya Janata Party won 13 seats in the 40-member assembly and, with the support of the Goa Forward Party (GFP), Maharastrawadi Gomantak Party (MGP), and two independents, who believe that the BJP is the only party that can lead the state on the path of development, formed the government in the state. And late Manohar Parrikar was sworn in as the chief minister of the state once again. The path shown by the late chief

minister, Manohar Parrikar, was perfectly received by Dr. Pramod Sawant, who is now building a strong state on the same path.

The previous Congress governments in the state and in the centre never spared a thought for Goa. Goa's annual budget under the previous Manmohan Singh-led government at the Centre in 2013-14 was Rs 432 crore. It was the Sonia-Manmohan government and the TMC was supporting it, but

Prime Minister Shri Narendra Modi had allocated Rs 2,567 crore for the development of the state in 2021. The major infrastructure projects like the Atal Setu, the Zuari Bridge and the Mopa International Airport were possible in Goa only because of the "double engine" BJP government at the Centre and in the state. The previous Congress government in the state, led by then Chief Minister Shri Digambar Kamat, had nothing to show for infrastructure development and was only involved in corruption.

in corruption.

With the TMC, the NCP, and the AAP also in crosshairs, no party is

capable of giving a stable government. Someone wants to be an all-India political party, somebody wants to open their account, but they can't form a government. Only the BJP can form the government.

The double engine state government has achieved many successes in terms of implementing central schemes and state initiatives for development. The state government has launched "GoaOnline"—an e-governance digital portal where information on all government services is available at the tip of one's fingers. The portal holds and provides online facilities covering more than 42 government departments and boards. Goa is

ranked third in the 'NITI Aayog's Good Governance Index 2020–21.'

Apart from this, Goa has provided 100% tap water connections and achieved the "Har Ghar Jal" target on October 9th, 2020, which is four years before the targeted deadline. It is a matter of pride that the state has achieved 100% electrification by providing free electricity connections under 'Pradhan Mantri Sahaj Bijli Har Ghar Yojana' (SAUBHAGYA) to more than 1,28,208 households. As a result of effective planning and execution in line with the Swachh Bharat Mission, Goa has become "Open Defecation Free' in the first phase of the Swachh Bharat Mission by providing toilets to 1,56,743 households across Goa. The State government has successfully implemented the 'One Nation-One Ration Card' scheme across the State.

The Goa tourism industry has been the backbone of the state, catering to 40% of the state's population. The state hosts almost 12% of all the foreign tourists that visit India. With an aim to make Goa the most preferred destination by the year 2024,

"The Goa Tourism Policy 2020' has been framed by the government. The state government has hosted Asia's oldest and India's biggest international film festivals—the 52nd edition of the International Film Festival of India (IFFI). More than 148 foreign films drawn from 73 countries were screened, including 12 world premieres, 7 international premieres, 24 Asia premiers, and 74 India premieres.

It seems the electorate of the state is unreservedly supporting the BJP double engine government under the great vision of Prime Minister Shri Narendra Modi and the able leadership of Chief Minister Dr. Pramod Sawant for the third time in the state to continue with the ongoing pace of development and for the welfare of the poor.
