


Letter to the Editor


present to commemorate the foundation day.

The Telecom Story

India's Telecom sector was a 'showcase' for the success of Leconomic reforms. When the Government opened up the sector in 1994-95 to the private sector, there were many skeptics about the private sector being put in control of communications. Within years every critic was proved wrong. Public sector monopoly had led to a sluggish growth of the sector. India's teledensity at the time of opening out was 0.8 percent. Less than one out of every 100 people had access to a telephone. Contrary to popular perception mobile telephones proved to be a boon for the common and weaker sections. It hugely improved India's tele-density. The waiting list became a part of history. Costs were radically slashed down; linemen were no longer required. Most Indians felt better connected.

There were apparent mistakes made in the initial years -though made honestly. The licence fees regime could only ensure costlier telephony. The National Telecom Policy 1999 formulated by the NDA government corrected these mistakes. The switch over to revenue sharing reduced the cost to the operator and increased the volumes substantially. The increased volumes ensured much larger revenue to the government and cheaper services to the consumers. Technology began to converge between basic telephony, limited mobility and full mobility. This led to

universal access licence which were common to both the basic and the mobile services.

Telecom became the most visible face of the success of economic reforms. They attracted investments, increased employment and India became the fastest growing telecom economy in the world offering cheaper services. The UPA Government inherited this success story of telecom in 2004 and could only make it better.

Regrettably, the entire enthusiasm inherent in the success story has disappeared. Though services have substantially expanded, there are no takers for the spectrum auctions now. Fresh investors are reluctant to look at this sector and those who have invested in the sector despite having earned profits must be regretting the environment in which they function. How did this success story turn sour?

The Prime Minister initially gave the responsibility of telecom department to a Minister who apparently had a conflict of interest. Criminal cases against the first Telecom Minister of the UPA are under investigation. After he was dropped, his successor from the same party, the DMK, decided to run havoc with the Department. In 2007-08 spectrum was allocated at rates determined by the market mechanism of auction in 2001. The sector had hugely expanded in seven years and the value of the spectrum had substantially Despite being increased. cautioned that the price determined at the time of allocation be freshly undertaken either through auction or through indexing, he decided to allot the spectrum at a rate much less than the market prices. The mode of allocation was conspiratorial. The goal post was altered half way through. The criteria of first-come-firstserved was changed to those who pay the entry fees ahead of others. This information appears to have been leaked out to the most favoured applicants. The result was disastrous. The report of the CAG shattered the confidence in the credibility of



governmental functioning. The CBI had to file charge sheets where the Minister, civil servants and investors were all arrested. The Supreme Court took the extraordinary step of cancelling the licenses. The biggest success story of economic reforms had now become a monumental scam.

Now the third minister was appointed to look after the Telecom Department. wanted to get the sadistic delight out of the fact that the scams were not new to the telecom sector under the UPA government. He, therefore, selected a Judge of his choice to 'unearth' an NDA scam. The Judge's report was sent to the CBI. The CBI has now filed a charge sheet in the Court. The essence of the CBI case relates to the spectrum user charges. When the service expands, the operators need extra spectrum. Under the NTP 1999 additional spectrum charges is to be paid for through revenue sharing. The policy framed in 2001-02 was that on 4.4 MHZ the initial start up spectrum a 2% user charge would be paid; upto 6.2 MHZ a 3% user charge will be paid and for the entire slab from 6.2 MHZ to 10 MHZ the charge would be 4%. The entire allegation against the NDA is as to why the slab between 6.2 MHZ and 10 MHZ was not broken in two and between 8 MHZ to 10 MHZ an extra 1% charge was not levied.

The spectrum user charges are a tariff fixation. Tariff fixation is an Executive function. The Executive at a given point of time considers various factors while increasing or reducing tariff or while determining the size of the slabs on which a

particular tariff is charged. There is no scientific rationale on which this can be done. Tariffs are fixed on a commercial assessment of the market conditions. The underlying consideration has to be the promotion of the sector. An administrator may well feel that lower tariff can reduce costs and increase the volumes and hence benefit both the sector and the revenues. In this case slabs could have been fixed keeping in mind the parity between the basic and the limited mobility. Subsequent reports of the TRAI appear to have accepted the principle on which these tariffs were fixed. If tariff fixation becomes a ground for invoking the Prevention of Corruption Act clauses such as causing wrongful loss to revenue, every Finance Minister who reduces the customs or excise duty in the Budget may be subject to such an accusation. The CBI charge-sheet names my

then colleague, Shri Pramod Mahajan, as a conspirator in tariff fixation. Since he is no more he obviously cannot be prosecuted. As a Member of the then government I feel obliged after examining the charge against him to suggest that the charge is absolutely ill-founded and baseless.

The telecom story is a case where the UPA government and the Prime Minister have a lot to introspect. Having inherited a 'showcase' success story, the first Minister appointed by the UPA conflicted his personal interest with that of the sector. His successor got trapped in his own shenanigans. The third minister set out to teach the NDA a lesson. Former Civil servants and investors have become his victims. In the process he has damaged the sector further adding to its' instability. ■

Stage all set for Karnataka assembly elections

The trumpet for the Karnataka Assembly election was sounded with the announcement of schedule of election program by the Election Commission of India on April 10, 2013. With the issue of a statutory notification, the Commission has set the process rolling for the Assembly polls in the State. With it the Model Code of Conduct has also come into effect immediately from the date of notification. As per the schedule, elections will be held in Karnataka in a singlephase on 05 May.

The total number of Assembly constituencies in the State of Karnataka is 224 and out of it 36 seats are reserved for the Scheduled Castes and 15 for the Scheduled Tribes as determined the Delimitation Parliamentary and Assembly Constituencies Order 2008. The poll in Karnataka will be conducted at all polling stations using EVMs and counting of votes will take place on May 08, 2013. Noteworthy that the term of the Karnataka Legislative Assembly will expire on 03 June 2013.

As per the Commission's notification the electoral rolls of all the existing Assembly Constituencies in the State have been revised, with reference to January 01, 2013 as the qualifying date, and have been finally published in two phases

(for 178 ACs on 16.1.2013 and for the remaining 46 ACs on 28.1.2013). As per the final published electoral rolls, total electors in the State are 4,18,75,267 cr.

The elections for the 14th Karnataka Assembly is likely to be a three-way contest between the ruling BJP, the Congress, and the JD(S).

So far as the configuration of the present Assembly is concerned it is different from the one voted into power in 2008. Karnataka, which witnessed political instability after the 2004 Assembly elections threw up a fractured verdict and ultimately led to collapse of three coalition governments, turned a new leaf with the people voting into office the BJP government. BJP's 'lotus' bloomed for the first time in south India in 2008. The support from independent legislators to the BJP led government at the beginning of its strengthened its position in the State Assembly. Now after the exit of 14 legislators the Party

enjoys a simple majority in the present Assembly. The current effective strength of the Assembly is 211; the BJP has 104 MLAs, the Congress and JD(S) combined have 97, and there are 7 independents.

Meanwhile, the Bharatiya Janata Party has released its first list of candidates for the Assembly elections. Opposition Congress and Janata Dal (S) have also released their first list of candidates on 05 April. Of the 224 Assembly constituencies for which elections are being held, the BJP's first list has 140 names, while the Congress and the JD(S) have announced 177 and 122 candidates respectively.

The BJP's list released in Delhi by the party's Central Election Committee has the names of all the senior leaders and most of the sitting MLAs. As per sources, now the party's core committee is scheduled to meet on April 8 to finalize the names of candidates for the remaining constituencies. Owing to the large number of aspirants,

finalizing the first list of candidates in various constituencies has become a tough task for BIP. As per reports the number of aspirants touched 20 in some of the constituencies. Following this, the Party held two rounds of consultations with its district units to take their assistance in choosing the candidates. The main intention was to take them into confidence in the selection process as part of the efforts to ensure a unanimous selection to check the possibility of any dissidence.

Interacting with media persons after the release of the first list, Karnataka Deputy Chief Minister Shri Eshwarappa said, "that almost all party legislators had been included in the list. The second list for the remaining seats was being prepared and the process would be completed soon. He further said BJP would not have any pre-poll alliance with other parties and urged the workers to organise the party at the grass roots and bring it back to power".

The campaign heat is yet to pick up in the State. However, to get a comprehensive victory for the second time the ruling Bharatiya Janata Party has

launched its 'Vijay Sankalp Yatra'. This has also marked the commencement of full-fledged election campaigning in the north Karnataka region. Apart from the Party's new State president Shri Pralhad Joshi, national general secretary Shri Ananth Kumar (MP); Chief Minister Shri Jagadish Shettar, Deputy Chief Ministers Shri K.S. Eshwarappa and Shri R. Ashok apart from all BJP Ministers and legislators would participate in the Yatra.

Briefing media persons on the first day of the Yatra Karnataka Agriculture Minister Shri Umesh V. Katti said that the Yatra was conceived with the objective of informing people about the achievements of the BJP government during the last vears, motivating Karyakartas to work for the success of the Party, and appealing to people to vote for BJP in Assembly elections. He said the Party took up several development works and so this Yatra is getting tremendous public support. He informed that BJP will not tolerate corruption and continue to fight against corruption by giving more powers to the Lokayukta to take

up cases against Ministers and legislators and will not bow down before the media pressure.

In the meantime, the BJP has exuded confidence about forming the next government in Karnataka. At the launch of the Vijay Sankalp Yatra, Karnataka Chief Minister Shri Jagadish Shettar led the attack, accusing Congress led UPA government at the Centre of "stepmotherly treatment" by denying the State funds for development work. "Not a single paisa was released under the Pradhan Mantri Gram Sadak Yojana (PMGSY) to Karnataka in recent times. I pleaded for the release of funds, but the Centre did not budge an inch. We even offered to share the cost of works by contributing 20 per cent of funds required, but the Centre did not come to our assistance," he said.Meanwhile, the State had released funds for work on 50 km of roads in rural areas in each Assembly constituency across the State, he said.

Shri Shettar also accused the Union government of not being cooperative in railway projects sanctioned under a cost sharing basis. "While the State government has provided its share on all railway projects, the Congress led Centre has not released funds, causing inordinate delays." The Chief Minister listed the zero per cent interest on crop loans and the agriculture budget, creation of new Taluks and implementations of the recommendations of the Najudappa committee report as the pioneering decisions taken by the BJP government. Therefore, he said, BJP will get peoples' support and form the next government in Karnataka.

₹ 200 crore would be spent on conducting elections in Karnataka

Rs. 200 crore would be spent on conducting elections to the State Legislative Assembly of Karnataka on May 5, the State's Chief Electoral Officer Anil Kumar Jha said in Bangalore. The State government will bear the entire cost of the poll, he said. About Rs. 2.5 lakh would be spent in each constituency to create awareness on enrolment of names in the voters' list and taking up Systematic Voters Education and **Electoral Participation** (SVEEP) plan.

In this surcharged atmosphere the poll pundits' predictions further charged the election atmosphere of the State. As per them the Bombay-Karnataka region consisting of 57 Assembly constituencies played a significant role in bringing the BJP to power in the last elections by electing 38 MLAs. BJP launches 'Suraj Sankalp Yatra' in Rajasthan

The Rajasthan unit of BJP on April 3 launched its 'Suraj Sankalp Yatra'in Jaipur, to give the message among people about Congress Government's misruled in the State. Several BJP MPs, MLAs and its state Vice-President Shri Arun Chaturvedi were present on the occasion. The Yatra, which is going to end in July, will cover over 200 places in the seven divisions of the state The Suraj Sankalp Yatra will cover a distance of 1,380 kms in Udaipur division in first phase till April 16. In total, the Yatra will cover over 200 places in 33 districts of the state and 35 mass meetings will take place during the period. Earlier the State BJP Pariwartan Yatra in 2003 had played a key role in bringing the BJP to power.

he economy of the country during 8-9 years has been relegated to its status in 1990-1991. The Prime Minister himself has admitted that our economy is not in a good position and we are going back to its position in 1990-91. We should not blame circumstances. The global meltdown did have adverse effect on our economy. So there were some economic hardships.

There are some other indicator and monitor of the growth which have not been mentioned here. Here the growth is without jobs, growth without health, growth without education. It is just an eyewash where figures have been fudged. Nowhere in the budget we find any reference to the culture or values. If the Government really

wants the progress of the country, it should for go hackneved model. Here no Washington consensus or a Gformula or a G-8 formula will work.

Rather the Government should evolve a consensus with the people of the country. As the Finance Minister. of the country, he should have envisaged and dared to achieve one and a quarter to one and a half times as much economic space and share in world economy as we had during the sixteenth century. However, you are going nowhere. I failed to understand as in what direction you want to lead the Indian economy. There is a need for taking Indian economy and resource mobilization to new heights. This is a country of one billion twenty crore people which abounds in prosperity, talent and energy but the Government is only making the economy to hover around a figure of 1.25 per cent and 2 per

economic objectives of the nation and it should be to cross that 24 per cent share of world GDP India once had and also that there will be nobody hungry in this country.

Foreign investment should not be the only imperative of the Government. The inherent strength of the country should be enhanced first and then one must pave the way for the foreign money as per the requirement of the country. However, there is an inherent contradiction in

economic policies of the Government. There is no clarity in the priorities and objectives of the Government. Studies tell us that a lot of the unrest in the country is because of the fact that development schemes of the Government are

creating disturbance in the lives of the people. The Government has itself accepted the fact that inflation continues to be on higher side. Lack of proper storage facility for foodgrains and lack of clear cut policy in regard thereto are the major contributors to the food inflation. On one hand, farmers are dying and on the other foodgrains are rotting and starvation is rampant. This is not right. Fiscal deficit has been shown as reduced only by jugglery of figures. Fiscal deficit has been tried to be contained by cutting down on the expenditure of various ministries. There was no need for such jugglery. The Government also says that they have shown a lot of favour to the Scheduled Castes and other backward people but I would like to say that only few fortunate ones have got this benefit.

In the field of health, the Government has said that efforts are being made to bring Ayurveda, Homeopathy and Unani to the mainstream of this sphere. I would like to know whether these systems of medicine had not been in our mainstream from the ages? Instead of saying that these systems of medicine will be recharged and reenergized, the Government is talking about bringing them to the mainstream. This is not right.

Rajnath demands complete loan waiver to farmers living in drought affected areas

By National President Shri Rajnath Singh reached Aurangabad on April 1 on his two day visit to drought affected areas of central Maharashtra. Starting his journey from Aurangabad district Shri Singh met farmers and other locals who apprised him of the worsening drought situation in the region.



Addressing farmers at Chara Chavni and Pimpri Shri Singh said, "Farmers living in drought affected areas facing an acute agrarian crisis. Drought has adversely affected more than 11000 villages of Maharashtra and nearly 50 percent crops in more than 3500 villages have been damaged."

Demanding complete loan

waiver to farmers living in drought affected areas the BJP President said the farmers should be given input subsidies, free seeds, subsidised fertiliser and hundred percent subsidy on drip irrigation system for at least two years. "Farmers should be given fresh agricultural loans at zero percent interest rates and steps should be taken to

ensure enough supply of fodder to the livestock", he added.

Calling the drought relief package announced by the Centre inadequate Shri Singh said, "The c e n t r a l government's relief package worth Rs 1200 crore is

insufficient because the state government itself demanded nearly Rs 1800 crore for drought relief. The government should increase the amount allocated for drought relief and a central monitoring team should be constituted to keep a vigil on drought relief package implementation."

Blaming the current ruling

dispensation in the State for rampant corruption in irrigation projects Shri Singh said, "A scam worth more than Rs 70000 crore was committed in implementing many ambitious irrigation projects and even then only 0.1 percent of irrigated land has been added to the total cropped area of the State in the last ten years." Expressing concern over the receding water level in the drought affected areas he said," Although the state has enacted Maharashtra Water Resources Regulatory Authority Act (MWRRA)but it has not been able to prevent widespread diversion of precious water away from common man, farmers and rural poor. There is an urgent need to amend the MWRRAA to prevent the misuse and diversion of water."

"Drought has forced rural poor and farmers out of employment and people are migrating from villages to the cities in large numbers. The government should address this problem by widening the scope of MNREGA and link it with agriculture", he added.

Shri Singh also assured the farmers that the issue of drought in Maharashtra will be raised in both the Houses of Parliament. ■

Union Budget uninspiring and Deceptive: Venkaiah Naidu

Points made by Shri M. Venkaiah Naidu, MP while initiating the discussion on the union budget 2013-14 in Rajya Sabha on march 18, 2013.



- The budget failed to address the two main issues - One is corruption which is eating into the resources of the country and the other is inflation which is breaking the backbone of the poor and middle class.
- Slow growth rate, growing unemployment, agriculture crisis and presence of black money within the country and stashed abroad. FM couldn't address any of these challenges.
- The last budget had returned the country to pre-reforms growth rate of 5%. This budget also has the potential of carrying forward the same.
- It is not clear how the fiscal deficit of 4.8% will be bridged. There are only two ways - to print new notes or to borrow. Thefirst will increase inflation and the other will lead to insolvency.
- The Central Plan outlay BE for next year (2013-14) is 5,55,322 crore. It was 5,21,025 for the current year. RE for the current year is 4,29,187 crore. If you compare RE for the current year with BE of next year, it is up nearly 30%! If you compare Budget Estimates for the current and the next financial years, the increase is a mere 34,297 crore i.e., 6.58% which is lower than the rate of inflation and hence a fall in real terms. It is the same story with education, health and so on. In most cases, the increase in terms of BEs barely covers inflation or is even less.
- The gloomy situation is the making of the UPA only. Earlier, our PM and FM were assuring us that "India will not be affected by the slow down and our fundamentals are strong." And FM himself said in a HT Conclave that 'India well insulated from US financial crisis, no cause for alarm'. What went wrong then?

- ▶ Even the IMF says India's problems are domestic and largely of its own making. It reasoned that the slowdown is mainly led by falling infrastructure and corporate investment.
- ▶ Earlier, the UPA blamed the Left for creating road blocks. Now that the Left has left the UPA, what are the right things this government has done to set right the economy.
- After completely denying many a times about any slowdown, the government is now using global slow down as an alibi to cover up the consequences of its own mismanagement of
- ▶ For the first time, the external debt is more than forex reserves.
- ▶ Mismanagement of economy and policy paralysis have led to the present situation.
- Even a soft spoken and noted industrialist, Sri Kumar Mangalam Birla, openly complained of the country's inconsistency and lack of transparency in business policies.
- Even in the face of adverse external environment, 48 countries grew faster than India in the year 2012. (27 grew faster than 7%, 10 grew faster than 9%). All that required is prudent economic management, good governance and revival of domestic policies.
- May I remind you that the growth rate target for the present year was 7.6% but achieved was only 5%. Even you couldn't reach your own mid-year review target of 5.7 - 5.9%! Going by your governance and performance records, it is very hard to achieve the projected growth rate of 6.1% to 6.7% next fiscal.
- Morgan Stanley and HSBC downgraded India's growth rate to 6% for 2013-14. Earlier



their estimate was 6.2%.

You had inherited a robust economy

- ▶ UPA assumed office with the economy growing at 8.1%, the fastest in 14 years. In 2012-13 the rate fell to 5%, the slowest and the lowest in the decade.
- ▶ The present FM, while presenting UPA's first budget in July 2004, himself accepted that the "economic fundamentals appear strong and the balance of payments is robust." Who brought nation's economy to such a pass?
- ▶ Even the initial higher growth under the UPA was because of the good work done, foundations laid, schemes initiated by Shri Vajpayee led NDA.
- ▶ UPA government has miserably failed to build on BJP's growth initiatives and destroyed the country's reputation and credibility with policy paralysis and corruption scandals.

Inflation - The UPA has given up 'Aam Aadmi'

- ▶ Inflation was targeted to be around 6.5%, but it remained above 7% for the most part of the year. Food inflation February figure is 10.91%.
- ▶ The prices of almost everything are skyrocketing be it electricity, water, gas, diesel, petrol, pulses, wheat, rice etc. This budget offers nothing for home makers.
- ▶ Price rise in case of LPG during February price rise was 26.21% as against 4.28% in January. In case of petrol price rise was 6.25% as compared to 3.77% in January.
- ▶ Food and primary articles have shown higher annual price rise of 11.38% and 9.70% respectively. Common man's food items have all become dearer. Onions went up by 154.33%, rice by 18.84%, wheat by 21.63%, cereals by 19.19%, fruits by 8.93% and milk by 4.57%.
- ▶ Vegetables compared to last year has risen by 26%; sugar by 13%, edible oils by 15%, cereals by 17.4%. The proposals made by the Railway Minister will further escalate inflation because he has declared that every six months there will be revision of tariff linking transport charges with oil prices. Food grains, cooking gas, cement, coal, iron & steel all products will go up.
- ▶ Prices of petroleum products were increased before and after the budget; in all 30 times, Also, fertilizer prices have gone up 14 times. Then what is the sanctity of budget?

Fiscal Deficit

- Deficit Deficitdeficits everywhere. Fiscal deficit, revenue deficit, current account deficit and above all trust deficit?
- ▶ The Fiscal and Current Account Deficits are almost as bad as 1991. The rate of growth is lowest in the decade. Current Account Deficit has risen to unacceptable level of 5.4% of the GDP.
- ▶ Fiscal Deficit was 2.5% in 2007-08 and now at 5.2% and you hope it to be brought down to 4.8% next year. Where is the roadmap?
- ▶ The rupee has fallen by more than 20% in the last one year.
- ▶ The FM was able to achieve the 5.2% fiscal deficit number largely because of the massive cut on spending and deferment of payments on fertilizer and other subsidies and thus saved Rs.91,838 crore from the budgeted plan expenditure of Rs.5,21,025 crore for the current fiscal. FM reduced budget allocations and expenditure by almost 18%, the steepest cut in expenditure

Words for the poor and Deeds for the rich

- Withdrawal of subsidies The poor and farmers are doomed
- ▶ In the current financial year, the total subsidy is expected to rise to Rs.2.47 lakh crore against the budgetary target of Rs.1.79 lakh crore. Much of the increases in outlays will be absorbed by the likely increase in prices, particularly subsidies.
- ▶ What happened to your *aam aadmi* slogan? Your policy is words for the poor the deeds for the rich.
- ▶ But in contrast, the additional giveaways from 2008-09 corporate sectors have caused a tax expenditure of Rs. 7.5 lakh crore between 2009-10 to 2013-14. The giveaways have risen from Rs.2.85 lakh crores in 2007-08 to average Rs.5 lakh crore every year, totaling Rs.25 lakh crore for the last 5 years. Even the Economic Survey mentions about this.
- ▶ In 2012-13 alone, the aggregate revenue forgone from Central taxes on account of tax concessions to the rich and the corporate sector are projected to be Rs.5,73,627 crore. If one adds the Rs.5,33,583 crore of forgone tax revenue in 2011-12, the total is a whopping Rs.11,07,210 crore. According to a study, revenue foregone



- since 2005-06 under Corporate Income tax, Excise & Customs is Rs.31,11,169 crores.
- NPAs under the CORPORATE CATEGORY as on 31.12.12constitute 53.68% amounting to nearly 1,00,000 crore. Total Income Tax arrears as on 31.12.12 is Rs.4,18,696 crores and the government is not able to recover this huge sum for reasons best known to them.

Allocations

Lowest Defence Budget

- ▶ Lowest Defence Budget increase in over 30 years. The allocation of the Defence has been reduced. This year China has increased its defence budget by 20%.
- ▶ India remains the world's biggest importer of weapons during 2008-2012. India's imports were 109% higher than that of China. We need to develop our weapons indigenously. How do you do that with reduced allocations?

Meagre allocations

Women's safety

- ▶ Allocation of Rs.1,000 core fund for women's safety and welfare is far from adequate in covering the rehabilitation and medical costs of survivors of gender violence. Where is the money for speedy justice, fast track courts, filling up of vacancies in judiciary?
- ▶ Justice Verma committee suggested provision of adequate safety measures and amenities in respect of women. With a mere 1,000 crores under the so-called *Nirbhaya Fund*, how this is possible?

Skill development

▶ The UPA government has allocated a mere Rs.1,000 crore for skill development. Contrast this with the Rs.800 crore that just one State, Gujarat, has allocated for skill development. Madhya Pradesh allocated 476 crores. If one State gives 800 crores, then what is 1000 crores for the entire country. You boast it as a major initiative for growth.

Disabled persons

▶ 12th Plan promised higher allocations for the disabled persons. The outlay for the Inclusive Education for the Disabled at the secondary stage has been reduced from Rs.63 crore in 2012-13 to Rs.45 crore in this budget. See your concern for the poor and disabled.

One Women's Bank

How that one bank in one corner of the country is going to help or empower the women-

- entrepreneurs? Should we understand that the other banks are absolved of their responsibilities towards women?
- Instead of creating one bank for the entire country, you could have taken steps to incorporating women within the existing public and private banking systems. A nationwide bank is less effective than enhancing the existing banking services to ensure ease of access to women.

Agriculture

- Agriculture is basic culture of the country. In 1950-51, agriculture used to contribute 53% of GDP now it is at 14%. From 19% in 2004-05, it dropped to 18.3% in 2005-06 and to 17.4% in 2006-07. It further dropped to 16.8% in 2007-08, 15.8% in 2008-09 before reaching 14% in 2011-12.
- ▶ From 19 percent in 2004-05, the percentage share of agriculture & allied sectors in GDP dropped to 18.3 percent in 2005-06 and then to 17.4 percent in 2006-07. Reuters
- ▶ Why mum on Swaminathan Commission's recommendations? The key recommendation that MSP should be cost of production + 50% has not been implemented so far.

Mismatch between MSP & cost of production

- ▶ The latest calculation of Commission for Agricultural Costs & Prices (CACP) is testimony to this reducing margin for the farmers. Input costs like cost of seeds, pesticides, fertilizer, diesel, power, water have all gone up. According to Haryana government, the cost of producing one quintal of paddy in the State is Rs.1,566. The government buys paddy at 1,280 per quintal. So, the government does not even pay the cost of production, let alone profits, to the farmers.
- ▶ It is true that MSPs have been hiked. What you forgot is the fact that cost of production has also gone up by 300% thereby even surpassing hiked MSPs.
- ▶ There has been abnormal and manifold rise in the prices of agriculture inputs like fertilizers, pesticides, diesel and labour wages.
- Between January 2008 and January 2012, prices of cruicial farm inputs went up sharply, impacting cost of cultivation across States. Yet, the government announced MSPs are lower



than the cost of Production of the most kharif crops.

- ▶ What happened to Hooda Committee's recommendation of Rs.10,000/- compensation to farmer for loss of crops?
- A massive loan waiver scam has been unearthed by C&AG. More than 34 lakh farmers who were eligible for loan waiver were not benefited on account of the faulty implementation of the scheme. More than 24 lakh ineligible farmers became beneficiaries.
- ▶ Farm suicides have continued unabated during your regime. 19000 farmers committed suicides in 2011 and 14000 in 2012. This budget fails to address any of these farmers' problems. Now we are getting reports from AP that the distress farmers are selling their organs to come out of agriculture debt trap.
- ▶ Look at the BJP-ruled states. Karnataka came with a separate 'agri budget' which was extremely innovative. Madhya Pradesh showed a double digit agri-growth rate at 18.2%, the highest in the country. Gujarat is growing at 10.8%.
- ▶ What are the steps taken to ensure lower interest rates on agriculture credit? Swaminathan Committee recommended credit to be given at 4%. Some of the BJP ruled states are giving at the rate of 0% interest, and some at 1% or 2%. Then the States with their limited resources can provide loans at lower interest rates, why not the Centre? This speaks of your attitude towards agriculture and welfare of farmers.
- ▶ Contrary to PM claims, only 1/4th of the farmers are getting agriculture credit from the banks forcing the remaining to borrow from private lenders, according to the Rangarajan Committee.

Industry & Investment Climate

▶ Government should know why the investments have fallen. Land acquisition, rehabilitation and clearances are a few of the other main reasons. The coal linkage problem is also affecting Rs. 5 lakh crore investment proposals.

- ▶ Stable tax policy is essential to encourage investments in the businesses. However, investors have lost confidence due to repetitive retrospective amendments.
- As per the World Bank and International Finance Corportion's Doing Business 2013 data, India is ranked a lowly 132 out of the 185countries analyzed. In the category of "Paying Taxes", India's ranking is further low, at 152 which has worsened from 149 in the year 2012. This clearly indicates that India is loosing out on its competitiveness vis-à-vis other countries.

Infrastructure

- ▶ Infrastructure has received mere lip service. The problem in infrastructure is of clearances, administrative bottlenecks and interest rates.
- ▶ 37 projects sanctioned under BoT in the last three years are yet to take off. Nobody is coming forward due to lack of resources, banks and financial institutions are not providing adequate loans. Last year, there were no takers for NHAI's 11 projects for expansion of 4-lanes to 6-lanes.
- ▶ During the NDA regime, construction of highways achieved a level of 11 kms. per day. Today it stands at an abysmal low of just 3 kms. per day despite their tall promise of building 22 kms. every day.
- Power generation which was targeted at 78,000 MW in 11th plan actually achieved only 54,000 MW. The performance of other sectors of infrastructure like rail, ports, oil and gas is also lack luster.
- ▶ With all round failure to address the power sector's pervasive and crippling problems, the UPA government is succeeding in pushing the country to kerosene lantern days again. In Andhra Pradesh, from 6.00 am to 6.00 pm there will be no power! Andhra Pradesh has now become *Andhera Pradesh*.

Black money

- When UPA-2 came to power in 2009 PM promised to bring back black money in 100 days. Many such 100 days have gone by. Nothing happened.
- You are silent even on your government's 'White Paper on Black money'. Your predecessor promised a more effective policy response. Where is that more effective policy



response?

Employment

- ▶ Economic Survey says India will face a shortage of about 17 million non-agricultural jobs by 2020 if labour reforms and high-growth policies are not taken up immediately.
- ▶ The BJP led NDA could create 12 million jobs in its tenure, the UPA could create only 2 million. What the UPA so far offered the country is "jobless growth".
- ▶ 17 lakh applications for 1500 posts in SBI!. 2 lakh applications for 100 posts in DRDO!. Today the headlines in Economic Times is disturbing 13 IIMs unlucky for placements. Even in IIMs that is the situation.
- Economic Survey warns that by 2020 India could be faced with upto 16.7 million 'missing jobs'.

Flagship programmes

- ▶ Flagship programmes are flagging.
- ▶ MNREGA, originally provided for Rs.40,000 cores, In the past two years, this amount has been reduced to Rs.33,000 crores.
- ▶ Pradhan Mantri Gram Sadak Yojana (PMGSY) got 24,000 core in the last budget but could spend only Rs.10,000 crore.
- ▶ The 26 schemes covered under the Under Direct Benefit Transfer (DBT) scheme, have a budgetary allocation of Rs.5595 crores. Till today the actual expenditure is only Rs.5.38 crore. This scheme according to UPA is a game-changer of Indian politics, finally it will end as regime changer.
- ▶ Over 28,78,41,507 Aadhaar numbers have been generated as on February 28, 2013. That means less than 25% of the population have been issued Aadhaar cards. *Aadhar* is not going to enhance your *Janadhar*. It will make you *Niradhar*.

- ▶ The estimated requirement of food subsidy in the government's National Food Security Bill was Rs.1,17,000 crore for distribution of 7 kg. of foodgrains per person per month. The Parliamentary Standing Committee projected a subsidy demand of Rs.1,12,000 crore for the distribution of 5 kg food grains per person per month. They suggested a coverage of 67 per cent of the population.
- ▶ Rajiv Gandhi Drinking Water Mission : Allocation in 2012 was Rs.10,500 crores. 11,000 crores in 2013. Token increase.
- ▶ Rajeev Gandhi Grameen Vidyudeekaran Yojana : Allocation for 2012 was 4,900. For 2013 it is 4,500 crore. Reduced.
- ➤ Grameen Telephony: Allocation for 2012 was 3,000 crore and it is the same in FY 13. No change.
- ▶ Rural Irrigation Project : Allocation for 2012 was 1,081 crore. 2013 it is 1,207 crore. A meager hike only.
- ▶ Either the allocations were reduced or remained stagnant. Even if hiked, they are nominal.
- ▶ UPA-II has done worse than UPA-I in social sector spending

Mining companies should not lay off workers: Manohar Parrikar

Mining companies should be able to "support" workers, instead of laying them off following the mining ban, Goa Chief Minister Shri Manohar Parrikar said the State legislative assembly in Panaji on 03 April 2013

Shri Parrikar was responding to a question

from Congress legislator Atanasio Monserrate over the fate of about 40,000 mining sector workers who have been rendered jobless following the ban enforced by the



Supreme Court. "The mining companies should be supporting them. They (companies) have earned from mining for over 20 years. I don't see why they cannot sustain their workers for at least two years. And the ban has been on only for six months," he said.

Noteworthy, mining in Goa has been banned by the Supreme Court since October last year, following a petition by local green lobby activists and noted lawyer Prashant Bhushan. Last year, a judicial commission headed by Justice M.B. Shah had exposed a Rs.35, 000 crore illegal mining scam during the Congress government in which politicians, bureaucrats and mining companies were linked.

Chief Minister Shri Parrikar, who has already announced compensation for unemployed mining workers, truck drivers and river barrage owners working in the mining sector, also warned the mining companies not to displace workers. He said when the mining work will recommence the workers would have to be taken back by the companies.

Raman Singh to embark on 2,700-Km Vikas Yatra

Chhattisgarh Chief Minister Dr. Raman Singh will roll out his 2,700-km long 'Vikas Yatra' from May 6 as the State goes to polls later this year. The blueprint for the six-phased yatra was drafted and approved at a key meeting at the State BJP headquarters in Raipur which was attended by senior party leaders, including the BJP State President.

Interacting with media persons BJP State General Secretary Shri Shivratan Sharma said, "Chhattisgarh Chief Minister Dr. Raman Singh



will embark on a 2700-km long journey on May 6 from Dantewada with prayers at Maa Danteshwari temple; the journey which will cover 81 out of the total 90 Assembly seats will conclude on June 15 in tribal heartland Surguja".

According to that communication Industry



Minister Shri Rajesh Munat has been appointed as coordinator of the yatra, while Shri Subhash Rao will be the cocoordinator.

Shri Singh, who is heading the government since December 7, 2003, will mostly cover the 'Vikas Yatra' by road.

During the yatra Dr. Raman Singh would make announcements of a series of development works and welfare wherever he visits during the yatra and would also brief people about the development works being carried out by his Government for welfare of the people and it will set a tone for BJP's hat-trick victory in the State that has 2.55 crore population with 32 per cent tribals.

CM approves 2,700 Cr to construct 49 roads in Naxal-hit districts

A sum of Rs. 2,719.63 crore had been approved by Chief Minister Dr. Raman Singh as a Special Action Plan for the construction of the roads in Naxal affected districts in Chhattisgarh. The State Public Works Department has undertaken the task of constructing the 49 roads measuring 1,970 kms, said an official statement of the government in Raipur on 03 April.

As per the Departmental Administrative Report of the last financial year (2012-13), the PWD had already completed construction of nine roads out of 49 while incurring an expenditure of `199.83 crore.

Chief Minister Dr. Raman Singh with a view to providing a momentum to the development work in the Leftist insurgency affected backward areas had accorded top priority to the construction of roads in such districts for efficient implementation of the welfare schemes in larger public interest.

As a sequel to the road projects in the Naxal affected areas, the State Government has also sent a proposal to the Central Government to contract roads under a special project (LWE) in the undivided seven districts. The upgradation work of the roads would also involve making them two lane and also strengthening them. The small and large bridges on the way of the roads would be constructed from a scratch, he added.

BJP demands CM's resignation over CAG expose

Referring to the CAG report tabled in the Delhi Assembly on April 04, Delhi BJP said the report has exposed rampant corruption in the Government. Stating that it is high time that Delhi Chief Minister Smt. Sheila Dikshit should resign, Delhi BJP President Shri Vijay Goel said the Government in connivance with power companies had cheated the common man.

Addressing the Media persons Shri Goel said, "The report has been unable to find a single facet of life which remained unaffected and uncovered by the incompetent and corrupt malpractices of the Government. Be it life saving health care, transportation, water, power, sewerage, policing, housing, girl child etc and the list goes on".

He further said that the Government has violated all the norms, schemes are not completed, and the flats that were supposed to give shelter to the poor are not completed yet. "Out of 10,000 only 85 are just allotted. Poor people are compelled to pay more for LPG and power. It is shocking that 50 per cent of people in Delhi are not getting water. Most of the money is being spent on wrong places," Delhi BJP State President said.

Citing the mention of pathetic state of health infrastructure in the Capital, Shri Goel said hospitals are not offering any facility to the poor people, even ambulances or medicines are not available.

"Funds are misused and there is grave irregularity in every phase and department. BJP will also knock the doors of court against the power companies involved in the conspiracy and after consulting legal experts," he said. ■
