BJP will bring forth true potential of Indian economy: Rajnath Singh

BIP National President Shri Rajnath Singh on his 5-day visit to United States of America addressed Indian diaspora. On 22nd July he delivered speech at OFBJP function in New Jersey (USA). The same day in three separate meetings in Washington D.C, several leading US business leaders & policy formulators interacted with Shri Rajnath Singh on Indo-US Strategic Business & Investment concerns.

Shri Rajnath Singh while addressing a massive public gathering of Overseas Friends of BJP (OFBJP) at Edison City, New Jersey has refuted the claim that 'Indian Success Story' is over. He said that though the present economic indicators in India were not appreciated well by the International community but there was a strong inherent strength in Indian Economy which could be tapped by proper implementation of policies and good governance.

"If BJP is voted to power in the next Lok Sabha polls, we will bring forth the true potential of Indian economy, the glimpse of which, people of India have seen during Shri Atalji led NDA Government", he said. Elaborating his point he highlighted various initiatives of the NDA government and of the present BJP ruled State governments in India.

Exhorting the large gathering at the OFBJP, US meeting Shri Rajnath Singh said that the time of India had arrived and large Indian diaspora overseas should come forth in their respective countries and capacities to fulfill this dream.

On the issue of Visa denial to Shri

Narendra Modi, he said, "It is paradoxical that on the one hand the report of US Congress him for governance and on the other hand they deny him even a visitor Visa. US government should re-think and reconsider its decision." On the issue of US-India relations, the BJP President said that it was the BIP which laid down the foundation of strategic partnership between both the countries and hoped that this relationship would be further strengthened.

He urged the US Government for reconsideration of this stringent bill. He assured US business leaders of continuance of Indian Reforms process off course with level playing field.

The leading business leaders representing "energy, tele-communication, pharmaceutical manufacturing, infrastructure defence production and service sectors interacted with Rajnath Singh for more than an hour in a luncheon meet organised by US India Political Action Committee.

In the evening several prominent personalities who play crucial role in Indo-US relations interacted with Sri Rajnath Singh at dinner hosted by the Indian Embassy at Washington DC. ■

eader of Opposition in the Rajya Sabha Shri Arun Jaitley on July 21 said, "Corruption is the main agenda in upcoming Lok Sabha election. And, Chandigarh residents would play a vital role in rooting out corruption from the country." Talking about the corruption unleashed in the country, the Leader of Opposition said, "With 2G, Coal Scam, Rail-gate scam etc running into several lakhs of crores, the Congress has indulged in crony capitalism and Congressmen has become name lenders and renters as in the Coal Scam where the Coal blocks were allotted with name chits being passed onto the screening committee. So large has been the degradation that even the status report submitted to the Supreme Court was fudged to save those from the PMO and the Coal Ministry."

Expressing disappointment over the worsening economic situation of the country, he said, "During Vajpavee's Government, India was the target destination for FDI. However, today even Indian businessmen are not willing to invest in the country. In such circumstances, irrespective of the policy changes being made FDI is not going to come. With the current account deficit having become unmanageable, instead of working to improve the economy, the Congress wants to open the coffers to buy votes bank and corrupt the country before they go," he said.



Since its formation the Indian Mujahideen has been responsible for a large number of attacks in India. The Congress party's spokesman has sought to re-write history

Congress party spokesperson went to Lathe extraordinary extent of rationalising the formation and existence of the "Indian Mujahideen" The Indian Mujahideen is admittedly a terrorist organisation. It is designated as a terrorist organisation under the Activities Unlawful (Prevention) Act in India. Its' ban has been continued by the UPA Government. It has been included in the list of Foreign Terrorist Organisations by the US State Department. It is proscribed in the United Kingdom. Serious political observers are at a loss to understand why the Official spokesperson of the Congress could have rationalised the formation of Indian Mujahideen in India ie as an organisation formed as a reaction against the riots in Gujarat in 2002.

The UPA is in the tenth year of its existence. As the general elections approach the UPA is confronted with a huge antiincumbency. There is a visible leadership failure. Its' leadership is seen to be ineffective. Its' governance is highly inadequate. The Government has run out of ideas on how to bring the economy back on rail. The UPA

has added corruption as a new Directive principle of State policy. The ten year misrule of the UPA reflects on how 'The Indian story' was effectively destroyed. After UPA's miserable track record of governance the need for an effective and clean

is perceived to be ineffective; the incoming are perceived to be non-leaders.

Faced with both the crisis of governance and a lack of leadership, the UPA's desperate strategy appears to be to deflect the agenda. Under no

circumstances must the destruction of 'The India's story' by the UPA be allowed to occupy the centre stage of the electoral agenda. The UPA has therefore only one option left. Communalise the polity in the country and change the electoral agenda. All those who want to throw the UPA out of office must understand that their focus must remain on the issues of governance which the UPA will try to duck.

The last few weeks have witnessed a crude attempt by the UPA leaders at this strategy. There are three visible indicators of this. Firstly, the UPA has concentrated its' attack on Narendra Modi. In Gujarat the initial strategy of the Congress was to excessively attack Modi. Modi always excelled in this political battle with Congress. He got the better of them. Finding this strategy counter-productive the Congress would then go back to the alternate strategy of pretending



that Modi did not exist as far as their campaign was concerned. At the Centre the Congress strategy in the first phase comprised excessively attacking Modi. In the process, they are conceding the centrestage to them. Soon they will realise the counter productivity of their strategy and move back to the alternative practice of pretending to ignore Modi.

We have almost lost count of the scams because they appear with alarming regularity. No one knows when the next scam will explode. But for a strong campaign by the opposition, the

media, and interventions by the court, not a single scam would have been fairly investigated by the Congress.

The Indian economy is at a terminal stage. Except inflation and the fiscal deficit, everything is going down. April's industrial growth figure was revised downwards, from 2.3 to 1.9 per cent. Overall growth may be less than 5 per cent.

Even Indians are not investing in India. FDI in retail was pushed through despite strong opposition. After more than 10 months, there is no investment in this sector, either. Infrastructure growth is politics neutral since every party supports it. The NDA had a shining record in this area. Yet the UPA has messed up. Telecom, an important area of infrastructure growth, suffered a serious blow because of massive corruption in the award of licences.

The power sector is in a mess because of "coalgate". The national highway programme, another outstanding success story of the NDA regime, is suffering because of massive corruption, delays and lack of transparency. Real estate, another engine of infrastructure growth, is mired in corruption, favouritism and lack of clarity on policy issues.

The only link between good economics and good politics is good governance, which has become the biggest casualty under the Congress-led regime.

The obvious answer is good governance. Today, there is a serious lack of trust and a crisis of credibility in the combined leadership of Sonia Gandhi and Manmohan Singh.

If Indians are reluctant to invest their rupees in India, why will foreigners invest their dollars and pounds? This crucial question is not being answered by the Congress, because they know they have no answer.

The next election will be fought only on these issues, namely corruption, inflation, rising unemployment, the critical state of the Indian economy, national security and the people's profound sense of disappointment. The Congress knows it has no tangible explanation for its failures, therefore the secular-communal card is being played again. The party has a dubious record on this account. Apart from riots in

different parts of the country, the brazen way in which it has sought to shield and bail out the leaders of the Sikh massacre of the '80s is well known. The Congress lacks the moral authority to talk about secularism.

India is secular because its civilisational and cultural heritage is secular. The India of 2013 is a different India, confident, sure of its strength and a profound human resource, mostly young, aspirational and with a stake in the growth of the country.

The India of today is looking for an alternative at the BJP and Narendra Modi. Today, he enjoys immense popularity, reflected in various popular opinion polls where his ratings are almost triple Rahul Gandhi's. Congress leaders entertain a pathological hatred of him, though the people

of Gujarat have elected him repeatedly. Riots are unfortunate anywhere, and the guilty must be punished.

But today there is peace, progress, prosperity and all-round development in Gujarat, where no riots have taken place for the last 10 years. The Congress needs to ask itself what explains his outstanding popularity despite their consistent campaign of calumny. It is his impeccable integrity, exemplary record of good governance and strength of leadership.

The people of India are yearning for a change. The Congress is raising the same old bogey of the secular-communal divide. It has failed in the past and is bound to fail again.

Free food will come at a very steep cost By Balbir Punj

Four decades after the Congress proclaimed 'garibi hatao' and promised to banish hunger and poverty from the country, it is now looking to hand out free food to win yet another election.

In 1971, the Congress, or rather the faction of the party led by Indira Gandhi, launched the 'garibi hatao' slogan to win the election and beat its rivals in the game of hoodwinking the people. Twenty years after that — during most of which period the Congress was in power except for a tiny interval — data showed that 51 per cent of the people were still below the poverty line, with an income of \$1.25 per capita per day.

Another 20 years down the line, a controversial poverty line and contested data showed that around 30 per cent of the people were still below the poverty line. The latest data is so controversial that the Congress-led UPA Government itself has had to set up several committees to define where to draw the poverty line. At first, it was the Planning Commission that drew the poverty line. When it was widely challenged, the Tendulkar Committee was constituted.

The Tendulkar Committee did not give a clean chit to the Government. So, yet another committee was set up — the Rangarajan Committee. This committee is yet to give its report. But even if you accept the claim that some 29.8 per cent of the people live below poverty line as of 2009-10 (Economic Survey 2012-2013), the fact is that the bulk of the poor are still with us. In other words, even four decades after the Congress said

garibi hatao, the slogan has remained only a pipe-dream.

With this record, one can only conclude that the latest promise of conferring food security by doling out low-priced food grains to 75 per cent of the rural people and 50 per cent of the urban population is yet

another attempt to hoodwink people, as the general election is less than a year away.

Over the decades, the Congress has repeated its electoral tactics with predictable regularity. In 1971, it sought to mislead the people by blaming the Opposition for the state of affairs when it was only the Nehru-Gandhi family that had been at the helm since 1947.

Now, once again, it is the Opposition that is being pilloried. The

Congress's claim that it had to resort to the 'Ordinance path' to enforce the food grains entitlement scheme is so outrageously false that no right-thinking person can be fooled. The ruling party says that food security was its electoral promise in 2009. Then, why did it wait till 2012 to force it down our throats?

The fact is that the 'super Cabinet', called the National Advisory Council, consisting of all sorts of jholawallahs and headed by Congress president Sonia Gandhi, who has no accountability even to her party, was in sharp conflict with the Government over the nittygritties of the scheme.

As usual, the devil was all in the details. The scheme travelled back and forth between

the NAC (or more correctly Ms Gandhi) and the Government for years. The draft bill itself was finalised only in 2011 and it took Government almost two years to decide on the recommendations of the standing committee. So, who is to blame?

The latest excuse the ruling party trots out is that the Opposition washed out session after session in Parliament. This is yet another white lie. Take the last session for example. The contention between Government



and the Opposition was the continuation of Mr Ashwani Kumar as the Union Law Minister after he was found to be interfering with the CBI investigation in the coal block allocation scam.

If the Government wanted the Budget session to go ahead, all that was needed was to get the then Law Minister to resign. For weeks the Prime Minister went on saying that Mr Kumar would not go, but finally he had to give in, after the Supreme Court rapped the Government by pointing out that the Law Minister's interference had taken the soul out of the CBI's investigation report. Surely, the culprit is the Government whose wrongdoing has been found out first by the media and then confirmed by the apex court.

As for the food security scheme, it has been seen by several international economists like Jagdish Bhagwati and OP Bhalla, and they all agree that it is both unworkable and a sheer waste of money. Also, while the Congress blames the BJP particularly, it is the BJP's Government in Chhattisgarh that has been praised for its efficient implementation of the Public Distribution System, enabling all those below poverty line to get low-priced food grains. The success of the PDS in reducing the impact of poverty under the Raman Singh regime has been widely recognised. Jean Dreze and Amartya Sen, who are no supporters of the BJP, have hailed the scheme in their latest book, An Uncertain Glory:

India and its contradictions, in which they write about the way a corruption-ridden, inefficient PDS has been

transformed in Chhattisgarh: "Many recent reports indicate that food distribution in Chhattisgarh is now quite regular, with most cardholders getting the quota every month at the correct price." They quote several investigations in support of this contention. They also add that in some districts of the State, even pulses are distributed at the symbolic price of five-rupee a kilo.


All this carries a big lesson: What is needed is not another scheme but an efficient implementation of the existing PDS to bring succour to the needy. Why is it that BJP-led State Governments are able to do this while Congress-led State regimes, in Rajasthan and Assam for instance, fail?

The report quoted speaks of the absence of corruption that has made the difference, apart from an efficient organisation. Chhattisgarh was under Congress rule earlier. Why did it not succeed then, while the BJP has demonstrated years of success, leading even to the reelection of this Government?

The difference is in corruption and governance. If in the so- called backward States like Chhattisgarh and Madhya Pradesh, as well as in the developed States like Gujarat, the BJP-led Governments can distribute low price grains to the needy, why cannot this be done on a national scale? The Congress has no answer because its Governments, including at the Centre, are riddled with corruption and inefficiency.

The food security scheme is the Congress's election gimmick to cover up its widely acknowledged policy paralysis that has led to a deceleration of the economy from a healthy nine per cent growth to five per cent, a fall in the value of the rupee accompanied by fast depletion of foreign exchange reserves, a continuing current account deficit. and fiscal mismanagement that has shot up deficit to over five per cent of the GDP. ■

Bringing Food Security Bill as an ordinance is undemocratic

- UPA has adopted completely an undemocratic route by bringing Food Security Bill as an ordinance. It is relegation of parliament on a very crucial bill for poor which has wider implications for agriculture.
- For Congress the Food Bill is just another major political step and they are purposefully giving a blind eye to huge grey areas of the bill.
- This effort to spread the benefits of economic development to the poor seems laudable at first glance. However, this distribution of resources is exactly what the bill fails to provide for. While it legislates for specific amounts of food grains to be distributed to needy families, it lacks detail on how it plans to ensure this allocation.
- The 117 million small and marginal farm families with population of 585 millions, constitute almost 78 per cent of the rural population. They now produce food for themselves, and also for others. Under the Food Security Bill, most of their families will qualify for subsidised food grains. And they will get grain supply at less than 1/8 of the price at which they produce and sell grains to the government. If the government would supply them grain at 1/8 price, why should they till and toil on their land and produce 51 per

- cent of national food using 46 per cent of the cultivated area, particularly when their cost of cultivation per acre as compared to medium and large players is higher.
- Rice and wheat cultivation is the most difficult and least gainful farm operation which is already haunted by shortage of labour and skyrocketing wage and input costs. Giving highly subsidised foodgrains to small and marginal farmers is the best way to dissuade them from farming for their family's food supplies. The Food Bill is bound to encourage the small and marginal farmers to go for alternatives easv commercial crops horticulture. Most States are deficient in food production. If in those States small and marginal farmers shift away from foodgrains, the country will face huge dent in food security.
- If a small farmer could get foodgrain for as little as Rs.1 per kg, as proposed in the Food Security Bill, why should he bother to grow his own?
- India's supply chains are afflicted by inadequate infrastructure and its distribution channels riddled with corruption. Food grains are produced in surplus in the country, but rot due to the lack of sufficient cold storage year after year. And yet, instead of dealing with this recurrent

- underlying problem, the bill seems to focus on the superficial aspects of food security. Without paying attention to effective distribution, the bill will simply exacerbate the problem of food wastage while millions continue to starve.
- India's underperforming PDS system The government intends to use the Public Distribution System for delivering subsidies to the poor. The PDS is already used to deliver food subsidies to the poor but around 51% of the food delivered that way is currently lost to leakages. It is sold on the open market for a higher price.
- Current leakage from the PDS, variously estimated by researchers at 40 to 55 percent.
- The government has not as yet explained how it plans to finance this policy which is estimated to require 95000 crore rupees per year. And it is estimated to increase further to Rs. 3 lakh crores.
- The country needs legislation that allows farmers to profit economically and grow autonomous, instead of forcing them to further depend further on the state. The government would do better to provide market incentives, not charitable hand-outs.
- Effect on farmers and producers-The very low prices



- of the subsidized food will distort the market and farmers who can't sell to the government-assured program will lose out on the open market because prices will be forced down.
- Reform in Agriculture should be guaranteed before food bil, says NAC Member N.C. Saxena (former secretary of the Planning Commission). He says, "Passing the bill is a necessary but not a sufficient condition for reducing hunger. India requires a significant increase of targeted investments in irrigation, electrification, nutritional programmes, clinics, disease control, rural roads and sanitation,"
- Implementing this bill could widen the already swollen budget deficit next year, increasing the risk to its coveted investment-grade status. The government has already budgeted 950 billion rupees for the scheme in the current fiscal year ending March 2014. If the bill is passed, it will need to come up with as much as 1.3 trillion rupees in 2014/15, adding to a total subsidy burden that already eats up about 2.4 percent of gross domestic product. Moreover, UPA govt has not come out with a detailed plan related to finances required to meet the bill objectives. It becomes further serious when we are already in the midst of Fiscal deficit and CAD.

Merits of Chhattisgarh Food Act

 The CFSA covers the public distribution system, school meals, anganwadis (including take-home rations for

- pregnant/lactating women and children under three) and free meals for the destitute and homeless. It excludes 10 per cent of households from the PDS.
- Sensible use of technology (for example, full computerisation of PDS) Greater transparency (public scrutiny of all records) and three, strengthening accountability (public institutions such as Gram Panchayats have priority in running ration outlets).
- Putting ration shops in the hands of those trusted by the community they serve, incentives for those running the fair price shops.
- Computerised tracking of foodgrain
- Apart from grains, beneficiaries are entitled to 2 kg of pulses at Rs 5- Rs 10 per kg.
- It has 90% coverage
- PDS has been greatly improved well before introduction of FA

Sharpening his attack on the Congress Shri Modi said that the nation struggled against the British but now, soldiers who are guarding us are beheaded by Pakistan and their Prime Minister is fed chicken biryani in India. He attacked the Centre's failure on the Sarabjit issue and their inaction over the Italian marines issue as well.

On the issue of black money the Chief Minister avowed that if black money returns it can benefit a lot of people but the Centre's inaction on the issue gave the impression that they are protecting those who have black money. Similarly, he asked why the probe in the coal scam is being delayed.

Shri Modi shared that when India got freedom, Re. 1 equaled \$1 and that now the value of the rupee has fallen despite an economist PM. He shared that the value of the currencies of several smaller nations like Pakistan, Sri Lanka, Maldives is not falling but it is happening to us. Shri Modi observed that such is the influence of Congress that even the best *Arthashastri* becomes *Anarthshastri* and that whoever joins the Congress takes nation on the path of destruction.

Shri Modi said that while Lokmanya Tilak said 'Swaraj is my birthright,' we should now say 'Surajya is my birthright.'

Before Shri Narendra Modi spoke, Deputy Leader of Opposition in the Lok Sabha Shri Gopinath Munde spoke. Other speakers included Maharashtra BJP President Shri Devendra Fadnavis, Pune BJP President Shri Anil Shirole, youth leader Smt. Poonam Mahajan, Shri Prakash Javdekar and MLA Pankaja ji Munde. A large number of people gathered to hear Shri Modi speak. ■



Bodh Gaya blasts expose India's weak flank again

ord Buddha is believed to have received his enlightenment at Bodh Gaya. The place is sacred not only to Hindus but also to Buddhists around the world. Yet this most holy place came under terrorist attack on July 7.

Earlier, the Intelligence Bureau had sent a warning to the Bihar Government about a possible terror attack at Bodh Gaya. The alert was sounded following confessions by Indian Mujahideen operatives caught by Delhi Police between August and October last year for their involvement in the 2012 Pune blasts. In an official release dated October 26, 2012, Delhi Police said: "...sustained interrogation of the accused arrested by us revealed that a person, Sayed Magbool, was in association with (the four previously arrested terrorists) and together they planned to commit fidayeen attacks on the Buddhist shrines in Bodh Gaya in Bihar as retaliation to the alleged atrocities committed upon Muslims in Myanmar".

Apart from Buddhist targets, the operatives had also revealed their plans to attack Dilsukhnagar in Hyderabad and the Pune court house and prison. Maharashtra Police's Anti-Terrorism Squad had also said at the time that its own interrogation of the IM operatives had exposed the group's plans to attack

Dilsukhnagar and Bodh Gaya. However, nobody took the warning seriously. Consequently, Dilsukhnagar was bombed in February and Bodh Gaya, earlier this month.

the warnings were received, nobody took stock of the situation. Were we adequately prepared with the right kind of arms and equipment? Did we have evidence enough to make a strong legal case? Instead of answering these questions, our Government has only issued condemnatory statements after the attacks. Since then, it has been business as usual for the Government and the terrorists alike.

In this context, it will be worthwhile to remember what the Supreme Court had observed in Kartar Singh versus State of Punjab [1994] 3 SCC 569. The apex court had said that the country was in the firm grip of terrorist violence and was caught between deadly pangs of disruptive activities. Apart from the many skirmishes in various

parts of the country, there were countless incidents of bloodbath, firing and looting wherein even women and children were not spared. Parts of the country had been reduced to graveyards. Deplorably, youths had been lured by hardcore criminals and underground extremists who used the ideology of terrorism to brainwash and engage them in crimes against humanity. They deserved no mercy.

Yet, in this country few if any effective steps are taken to bring to book those who spread mayhem and anarchy. Now, compare this to the situation in the US where there has only been one major terrorist attack since Al Qaeda flew two planes into the World Trade Centre and changed the New York skyline forever more than a decade ago.

After the September 11, 2001 terrorist attack, Washington, DC passed the Uniting and Strengthening America by Providing Appropriate Tools Required to Intercept and Obstruct Terrorism Act of 2001, popularly known by its acronym USA Patriot Act or simply as the Patriot Act. This piece of legislation has played a key part in a number of successful counter-terror operations that have helped protect innocent Americans. The Act gives federal officials greater authority to track and intercept communications, both for law enforcement and foreign intelligence gathering purposes.

In India, on the other hand, the Union Government has actually diluted anti-terrorism laws. In fact, one of the first things that the Congress-led UPA regime did when it came to power in 2004 was to repeal the



Prevention of Terrorism Act, 2002 that had been legislated by the BJP-led NDA Government before it. Previously, in 1995, the Terrorist and Disruptive Activities (Prevention) Act had also been allowed to lapse.

Under the existing laws, the onus lies on the investigating agencies to prove the guilt of a suspected terrorist. In other

words, we have tied our own hands and feet when it comes to combating terrorism. To make matters worse, we also do not have a Witness Protection Act. And we also expect the illequipped and ill-trained police to handle terrorism. Former Union Minister for Home Affairs P Chidambaram had sympathised with the ordinary

police constable saying he is the "most abused" part of the force and the "most reviled public servant". He had also spoken at length about India's poorly trained police force, especially at the lower ranks. "Everyone believes that he (Constable) can be bullied, or cajoled or bribed... Self-esteem of average policeman is very low...And this average Police Constable is a frontline force for the internal security", Mr Chidambaram had said.

The Government knows well about the problem and how it can be resolved. But why does it not rectify the deficiencies pointed by its own Minister, instead of passing the buck to the State Government? The trouble is that the Union Government is worried that if it takes strong action, it will lose the game of vote-bank politics.

Also, there are plenty of busybodies who will advise the Government that taking a tough and innovative stand in matters of law and order will lead to violation of human rights. Yet, how exactly going soft on terrorists can violate anybody's human rights remains a mystery. Against this backdrop, it is also important to acknowledge the cold and harsh fact that most terrorist attacks in this country could not have been effectively carried out without ample local support.

No time is right for anything, but doing the right thing is what makes the time to be right. The Union Government should remember what Gandhiji once said: "Strength does not come from physical capacity. It comes from an indomitable will."

- January 2008: Terrorist attack on CRPF camp in Rampur kills eight.

Bihar shows the way: How to loot our children

ew States can boast of success in keeping the snouts of venal politicians, bureaucrats and others out of the trough. If that reveals greed, it also reflects poorly on our nation which doesn't care enough for its children

Nothing can be more hideous than little children, some as young as four years old, dropping dead after eating a meal which is their sole motivation for attending school. The 23 children from poor families who died after their midday meal, meant to bolster their nutrition intake, Government-run school in Bihar's Saran district, were innocent victims of greed, corruption and apathy. Their tragic deaths are likely to discourage parents from enrolling their children in school; those children who saw their friends dving a horrible death are unlikely to look forward to going to school in the hope of a hot meal.

Official inquiries take their own time and bureaucrats have mastered the art of sidestepping responsibility while helping their political masters to escape accountability. demand an explanation as to why the Bihar Government sat on Rs 500 crore, meant to modernise school kitchens and buy new utensils for the mid-day meal scheme, without spending the money. This Central allocation was returned unused after skimming interest off the money by parking it in a bank. Pretending ignorance is not good enough; a Chief Minister is accountable for such stunning lapses and responsible for its consequences.

It would, however, be incorrect to suggest, even if ever so remotely, that Bihar alone is afflicted with the malaise of illimplemented welfare programmes. Barring those States which have embraced the Akshayapatra scheme to implement the mid-day meal programme, few if any can boast of success in keeping the snouts of venal politicians, bureaucrats, contractors, teachers, jholawallahs of fly-by-night

NGOs and the pimps who facilitate deals among this despicable lot out of the trough. If that reflects greed and corruption (one feeds on the other) across the country, it also reflects the true face of our society.

As a nation we are not overtly mindful about protecting and nourishing our children who shall inherit this country from us. And, since children do not vote, they do not exist for political parties, although children under six years comprise nearly a fifth

of the population.

This point is amplified by statistical data collated during the Third National Family Health Survey conducted over 2005-06. For instance two-fifths of 011r children malnourished, which roughly translates into more than 16 crore malnourished children, many of whom may not make it through infancy. As many as more than a third of our children suffer from stunted growth and three quarters of them are anaemic. A whopping 50 per cent are not fully immunised.

In Uttar Pradesh, which the

Samajwadi Party propagandists do not tire of describing as 'Uttam Pradesh', Government funded panjiri, a ready-to-eat high calorie mix meant for midday meals at schools, is fed to cattle under the malign gaze of corrupt officials. Such was the clout of the 'panjiri mafia' in Uttar Pradesh that the mid-day meal programme is in a shambles in half the districts of the State. It to reason malnutrition among children in these districts should be as high as 50 to 70 per cent.

The Supreme Court, in a judgement, had sought to enforce the mid-day meal scheme across the country. But that's easier said than done. An internal memo of the Union Government, while admitting 30 years too late that the Integrated Child Development Scheme has failed, says, "The prevalence of child malnutrition in India is among the highest in the world." A recent Comptroller and Auditorreport further General underscores the abysmal failure of the mid-day meal scheme.

Meanwhile, to grab news space while the Bihar tragedy was unfolding, the Congress-led UPA regime let it be known that from now it would be serious about implementing the mid-day meal scheme. We could even see Congress president Sonia Gandhi and her courtiers in the National Advisory Council pushing for a Right to Mid-day Meal Bill.

A criminally callous political leadership can only make a mockery of hunger and poverty. An indifferent people deserve no better.

This ghost will not go away that easily

any people believe that the death of Ottavio Quattrocchi will effectively put the lid on the Bofors scandal, and consign the issue to the dustbin of history. They are mistaken. Closure will come when truth is out

The news of the demise of Ottavio Quattrocchi, the Italian businessman and close friend of

Although Congress-led Governments at the Centre have tried to bury the scam, there were independent investigators and institutions in the country, including the media, which felt duty-bound to put the facts in the public domain. Even as the CBI responded to its master's voice, this Tribunal did the most detailed examination of the involvement of Ottavio Quattrocchi as a middleman in the Bofors payoffs scandal.

Sonia and Rajiv Gandhi, has prompted some people to say that with his passing, the Bofors kickbacks scandal is laid to rest. To put it mildly, this is wishful thinking.

So many in the dramatis personae of the Bofors Saga are no more. Rajiv Gandhi, Martin Ardbo (president of Bofors when the deal was signed and whose diary entries gave vital clues to the Swedish police), former Defence Secretary SK Bhatnagar, Win Chadha, the company's agent in India, and now Ottavio Quattrocchi. With the passing of each of these individuals, commentators speculated that

the scandal will die a natural death. But, no such thing has happened. And the reason for this is simple: The people of India know that certain persons in power knocked off commissions and bribes while finalising the contract with the Swedish arms manufacturer for supply of field guns. They also know that nobody was punished for these

offences.

A 1 t h o u g h C o n g r e s s - 1 e d Governments at the Centre have tried to bury the scam, there were independent investigators and institutions in the country, including the media, which felt duty-bound to put the facts in the public domain. One such institution was a Delhi Bench of the

Income Tax Appellate Tribunal. Even as the CBI responded to its master's voice, this Tribunal did the most detailed examination of the involvement of Ottavio Quattrocchi as a middleman in the Bofors payoffs scandal. Some key points made by the Tribunal are worthy of mention here:

Ottavio Quattrocchi remained in India from February 28, 1965 to July 29, 1993, except for a brief interval from March 4, 1966 to June 12, 1968. He was a certified chartered accountant by profession, working with Snamprogetti, an Italian multinational company, but "neither Snamprogetti nor

Ottavio Quattrocchi had any experience of guns, gun-systems or any related defence equipments".

The Tribunal noted that despite the Indian Government's policy against suppliers hiring agents, Bofors entered into a fresh consultancy agreement with a company called AE Services Limited, UK, on November 15, 1985, at the behest of Ottavio Quattrocchi. An extraordinary aspect of this deal was that Bofors committed itself to pay this company three per cent of the total value of the contract only if the Indian Government awarded it the contract by March 31, 1986 (that is within 137 days of the signing of the contract on November 15, 1985). This was indeed an extraordinary stipulation and a tough deadline to meet specially when it concerned a major international weapons deal. But was even more extraordinary was that Ottavio Quattrocchi met that deadline! The Rajiv Gandhi Government signed the deal with Bofors on March 24, 1986 – just a week before the deadline set by Bofors was to expire.

After signing the contract with Bofors, the Indian Government released the first tranche of payments to Bofors which was equivalent to 20 per cent of the contract value on May 2, 1986. Once it received the first tranche, Bofors remitted US\$7.343 million on September 03, 1986, to A/c No 18051-53 of AE Services Limited at



Nordfinanz Bank, Zurich. This worked out to exactly three per cent of the advance payment made by India. Thereafter, the Tribunal recorded the money trail, as tracked by the investigators, in detail. From Nordfinanz Bank the money was transferred to Account No 254.561.60W of Colbar Investments Limited (a company registered in Panama) in the Union Bank of Switzerland, Geneva in September, 1986. From this account, again the funds were moved to Account No 488.320.60 X of a company called Wetelsen Overseas, SA in the same bank in July 1988. Thereafter, the funds were once again moved to Account No. 123983 of International Investments Development Company in Guernsey (Channel Islands) in May 1990. The ITAT said on the basis of records before it that "these Accounts of Colbar Investments as well as Wetelsen Overseas were being controlled by Ottavio Quattrocchi and his wife Maria Quattrocchi".

In the final analysis, the tribunal noted that Win Chadha and Ottavio Quattrocchi had been transferring the funds received from Bofors frequently from one account to another and from one jurisdiction to another to avoid detection and to obliterate the money trail.

In the final analysis, Bofors paid out the equivalent of 243 million Swedish kroners as commission to Ottavio Quattrocchi and Win Chadha. But the most extraordinary development was that AE Services unilaterally announced that it would forego the rest of the commission due to it from Bofors, after the kickbacks

scandal broke out in April 1987.

Strangely, despite this clinching evidence of Ottavio Quattrocchi getting commissions from Bofors, Prime Minister Manmohan Singh ensured the defreezing of Ottavio Quattrocchi's bank account by the UK Government and ordered the CBI to withdraw the case against him. People also recall how Ms Gandhi protested angrily at a Press conference at the Congress headquarters some years ago and asked, "Where is the proof? Show me the proof", when a correspondent asked her how Ottavio Quattrocchi got paid when we bought guns from Bofors. Ms Quattrocchi has been saving much the same thing. But these loud protestations will not

No financial or bribery scandal will fade out of public memory unless there is adequate reparation for the losses suffered by the exchequer. Unless this happens, a scandal is deathless. It will linger in the public mind and will be passed on, possibly with some embellishments, from one generation to another. While this is generally the case, it is more so in cases concerning a nation's security. The taking of bribes or commissions when we buy guns for our soldiers is deemed an act of treachery (desh droh) and is never forgotten. Meanwhile, despite clinching evidence of the money trail, Ms Quattrocchi is fooling nobody by claiming that her husband was "hounded for over 20 years" over the kickbacks

The key figures in this scandal are all dead and they have gone unpunished. In this scenario, there is only one

situation in which the Indian public conscience can be appeased. That is when the Quattrocchis accept the truth that they got payments from Bofors when we bought guns for our Army and return the money to the people of India. This could create an incentive for the people to forget the scandal. Until they do that, the ghost of Bofors will to haunt continue Quattrocchis and those for whom they batted all these years.■

four-member unidentified gang hacked State BJP General Secretary Shri V Ramesh to death while he was returning home after visiting the party office in Salem on July 19. Salem

range Police DIG said Shri V Ramesh had gone to his office to discuss party affairs around 9 pm and was attacked by four persons while returning to his residence. He said the 52-year-old was attacked with sharp-edged weapons and he died on the spot.

Anguished over the killing, BJP activists staged protest in Chennai and the entire state demanding immediate arrest of those responsible for the murder. The identity of the assailants and the motive for the attack were under investigation, police added. Shri Ramesh is the

second senior party functionary in Tamil Nadu to be murdered in the last nine months.

BJP State medical wing secretary Dr V Aravind was also killed in front of his clinic in Vellore by a gang in October, 2012.

BJP state President Shri Pon Radhakrishnan interacting with media persons said, "We want the guilty to be brought to book. We want a detailed probe into the incident by a retired judge of the Madras High Court". "We want a detailed probe so that such incidents don't happen in the future," he said.

Shri Radhakrishnan accused the state government of not providing security to BJP



leaders and claimed in the last one year, three state-level leaders – Shri Arun Reddy, Shri P Murugan and Shri Velliyan — were murdered and the culprits were still at large. He alleged that even police had not taken action on their pleas to provide protection to party men.

BJP national leaders also condemned the incident, with BJP National Election Campaign Committee Chairman and Gujarat Chief Minister Shri Narendra Modi and Leader of Opposition in the Lok Sabha, Smt. Sushma Swaraj, calling for action against the guilty. Both expressed shock over Shri Ramesh's killing, with Smt. Swaraj pointing out that this was

> the third such incident in the state involving a senior party functionary. "Killing of our Tamil Nadu unit's General Secretary Shri Ramesh is shocking. Spoke to TN BJP president last night and expressed sadness on the killing. My deepest condolences to the family of Shri Ramesh. May his soul rest in peace. The culprits must be punished at the earliest," Said Shri Modi. Smt. Swaraj said government must apprehend those "brutal" behind the murder.

BJP leaders in the state were being attacked in a "planned manner" and said not all the accused in the case pertaining to planting a pipe bomb in Shri L.K. Advani's yatra route in 2011 have been apprehended so far. She demanded that the state government set up a Special Investigation Team to probe each of the attacks on party leaders in the state and called for upholding peace and law and order.



What creates struggle and warfare?

n the matter of the projection of akasha and prana into manifested form and the return to fine state, there is a good deal of similarity between Indian thought and modern science. The moderns have their evolution, and so have the yogis. But I think that the yogis' explanation of evolution is the better one: "The change of one species into another is attained by the infilling of nature." The basic idea is that we are changing from one species to another, and that man is the highest species. Patanjali explains this "infilling of nature" by the simile of peasants irrigating fields. Our education and progression simply mean taking away the obstacles, and by its own nature the divinity will manifest itself. This does away with all the struggle for existence. The miserable experiences of life are simply in the way, and can be eliminated entirely. They are not necessary for evolution. Even if they did not exist, we should progress. It is in the very nature of things to manifest themselves. The momentum is not from outside, but comes from inside. Each soul is the sum total of the universal experiences already coiled up there.

So the external things can only give us the environments. These competitions and struggles and evils that we see are not the effect of the involution or the cause, but they are in the way. If they did not exist, still man would go on and evolve as God, because it is the very nature

of that God to come out and manifest Himself. To my mind this seems very hopeful, instead of that horrible idea of competition. The more I study history, the more I find that idea to be wrong. Some say that if man did not fight with man, he would not progress. I also used to think so; but I find now that every war has thrown back human progress by 50 years instead of hurrying forwards. The day will come when men will study history from a different light and find that

neither the cause nor the effect, simply a thing on the way, not necessary to evolution at all.

competition

The theory of Patanjali is the only theory I think a rational man can accept. How much evil the modern system causes! Every wicked man has a licence to be wicked under it. I have seen in this country (America) physicists who say that all criminals ought to be exterminated and that that is the only way in which criminality can be eliminated from society. These environments can hinder, but they are not necessary to progress. The most horrible thing about competition

is that one may conquer the environments, but that where one may conquer, thousands are crowded out. So it is evil at best. That cannot be good which helps only one and hinders the majority.

Patanjali says that these struggles remain only through our

ignorance, and are not necessary, and are not part of the evolution of man. It is just our impatience which creates them. We have not the patience to go and work our way out. For instance, there is a fire in a theatre, and only a few escapes. The rest in trying to rush out crush one another down. That crush was not necessary

for the salvation of the building nor of the two or three who escaped. If all had gone out slowly, not one would have been hurt. That is the case in life. The doors are open for us, and we can all get out without the competition and struggle; yet we struggle. The struggle we create through our own ignorance, through impatience; we are in too great a hurry. The highest manifestation of strength is to keep ourselves calm and on our own feet.
