



# On FDI it's a technical win and a moral defeat for Congress

The vote on FDI in retail trade was a repeat of the 2008 drama on motion on Indo-US Civil Nuclear Deal which culminated in U-turn by some political parties on their declared earlier stand on the issue and the Cash-for-Vote scandal. It was the SP and BSP which turned out to be the saviours of the UPA government on both critical moments as against their declared stand on the issue. As in 2008, this time too it was the CBI, as a leading Hindi daily put it, which turned out to be the minister for parliamentary affairs managing the numbers in the house and influencing the trend of voting.

As in 2008, what was at stake was not the interests of the nation but Congress arrogance of power powered by the wishes and interests of USA in pushing through the Deal. A great noise was then made about the flood of benefits that were to deluge the Indian nation. But after four years the country is still suffering the drought of any tangible benefits to India out of this deal.

Similarly, the decision to allow 51% FDI in retail trade too was motivated not by public interest but by the wishes of US rulers. There is no dispute about it because, like Indo-US Civil Nuclear Deal, this vital decision never formed part of the Congress 2009 Election Manifesto. The US administration had been prodding the Manmohan government on the issue for quite long. But impetus to this government which, in the words of its own Minister P. Chidambaram, was suffering from "performance deficit", was provided by a meeting which Dr. Manmohan Singh had with US President Obama in November 2011 President Obama, according to press reports, "impressed upon (PM Dr. Manmohan) Singh the need for introducing FDI in retail". It was only after that that our PM hastened with the idea but had to defer it because of staunch opposition from its allies, including TMC. Later, during her visit to India last summer US Secretary of State Mrs. Hillary Clinton pressed upon the same point. In the meantime, the renowned American magazine Time dubbed our Prime Minister as "underachiever". That became the boiling point. Congress-led UPA unilaterally took a decision on FDI to prove to the US President and the world that this government was functioning. It is a clear case of the UPA having outsourced policy-making to countries like USA ignoring the national interests.

Just like 2008 Nuclear Deal issue, the Congress was not sure of its numbers It allowed about 2 weeks of Parliament's business to go waste refusing the just demand of BJP and other opposition parties for a discussion on FDI issue in the house under rule 184 which entails voting after discussion. In view of the danger of the current winter session of parliament getting washed away, as it was last year, the Manmohan government relented for a discussion under rule 184. The discussion succeeded in exposing the hypocrisy of certain political outfits. Speaking on the motion political parties having a combined strength of 261 in a house of 544 vehemently opposed it. They wanted the government to withdraw the decision. Even UPA's alliance partners, like DMK and NCP expressed their opposition to the move. After the vote NCP announced that it is against it in Maharashtra. Yet when it came to voting only 218 supported the motion to oppose government move on FDI in retail trade and 253 went with the government. To add to the irony, Prime Minister Dr. Manmohan Singh, after the vote, claimed that Government has the approval of Lok Sabha for the move little realizing that the vote in parliament had exposed the lack of a clear majority in the



house which is 272.

Another irony was added by Commerce Minister Anand Sharma when he claimed that 11 (including Maharashtra) out of 21 States had supported the UPA move on FDI ignoring NCP's stand.

Yet more ironical is the fact that conduct of certain political outfits did not match with their words. While voting or staging walkout, the political parties forgot the stand they had taken while speaking in the house.

Still more contradictory was the conduct of the Bahujan Samajwadi Party. In Lok Sabha it spoke against the FDI in retail and even staged a walk out claiming that it was not satisfied with the reply of the government. But in Rajya Sabha it staged a U-turn and supported the government.

The vote in Lok Sabha and Rajya Sabha was a victory but only in technical terms. In fact, it was more of a great moral defeat for the UPA because in Lok Sabha the 43 members who staged a walk-out were ostensibly against the government decision and even those like NCP and DMK who went with it had voiced their opposition.

From the words and conduct of the Congress-led UPA government it is now clear that be it the Indo-US Civil Nuclear Deal or the FDI in retail, it is only promoting the interests of USA and big trade chains like the Walmart in utter disregard to the fate of the small retailer and the service sector composed mostly of self-employed which generates 58 percent of GDP. It "will involve a loss of jobs both in the manufacturing and services sectors".

The worry of the Indian people to allow 51% FDI in retail trade is not out of place when they fear the repeat of the same mistake the then rulers of India committed while allowing the then East India Company to enter the country as a trader. Our then rulers thought – as do the present ones – that they are coming to India to help our country generate more trade, more services, more employment and more production. But sooner the trader turned into an invader and exploiter, ruling the country on the strength of the wealth it had squeezed out from within our country. The annual turnover of just one company, Walmart, was \$443.9 billion in 2011 just one-fourth of India's GDP of \$1847.98 billion. They are not coming for charity but to extract profit at the country's cost.

Just as the East India Company exploited our trade, industry, agriculture and even influenced our rulers, the great companies like the Walmart are sure not to lag behind. Our culture, our agriculture, our trade, and ultimately our future shall be open to exploitation by these companies to intrude and influence our politics with their purses made hefty from our own soil. That is the danger the people of India can never lose sight of. A well-known columnist has already warned that sooner than later India may be witness to another phenomenon: In addition to farmer suicides India may be a witness to the same tragedy with the retail traders who will go out of business, penniless and under debt.

Therefore, even if the FDI has the technical approval of the Parliament it does not have the tacit approval of the people of India. The opposition parties, particularly the BJP, has to take this issue to the people in every way to apprise them of the dangers that lie ahead for the country at the hands of the present Congress-led UPA government. This anti-people government and Congress have to be shown the door in the coming elections and finally in 2014. The time is not far away when people will have to give their verdict.

Commission questions timing of Aadhar-based direct cash transfer scheme

Election

Unhappy with the announcement of the direct cash transfer scheme by the government at a time the model poll code is in force, the Election Commission has sought a report from the Cabinet Secretary.

In the letter, the poll panel has conveyed its displeasure over the timing of the announcement and said it could have been avoided in view of the Gujarat elections later this month. Election Commission have asked the Cabinet Secretary to give us a factual report on the issue by December 10 evening. EC has said if they do not find any reply they will proceed further.

A BJP delegation led by BJP Parliamentary Party Chairman Shri L K Advani had personally met the Chief Election Commissioner on November 30 to complain against the announcement.

Four of the 51 districts in which the cash transfer scheme is to be implemented from January 1 fall in pollbound Gujarat. Sources said the Election Commission's fresh letter to the Cabinet Secretary was the second reminder in the matter. ■



## BJP 'Sankalp Patra' released A vision and action plan for Gujurat : Modi From Our Correspondent

n 4th December 2012 the Gujarat BJP released the 'Sankalp Patra', its manifesto for the 2012 Gujarat Vidhan Sabha Elections. The Sankalp Patra is a comprehensive document listing out a clear and coherent vision for the development of all sections of society over the next 5 years.

Leader of the Opposition in the Rajya Sabha Shri Arun Jaitley, Gujarat Chief Minister Shri Narendra Modi, Gujarat BJP President Shri RC Faldu and BJP National Vice President Shri Purushottam Rupala were present on the occasion.

Speaking on the occasion Shri Modi said that the Sankalp Patra is not mere promises but a strong commitment towards development. It is a blue print for the next 5 years where both a vision as well as action plan has been listed, the Chief Minister said. Shri Modi said that the Manifesto has taken special care of the neot middle class that has emerged in the last 10 years and is enjoying the fruits of development. He added that the 'Sankalp Patra' does not only talk about youth development but also youth led

development. The Chief Minister stated that the 'Sankalp Patra' gives importance to Skill, Scale and Speed.

Highlights of the Sankalp Patra

- Having achieved 100 % enrollment in primary schools and decreased dropout ratio to 2%, we will now bring the dropout rate to zero and stabilize it at that level. Further, through initiatives like 'Gunotsav,' we will bring qualitative improvements in education.
- Mukhyamantri Scholarship Yojana for assisting poor students to pursue higher studies. Continuing our tradition of establishing specialized universities, we will set up more such institutions including those for marine, auto, infrastructure, engineering, management, biotechnology etc. Medical colleges to be set up in each major district including tribal regions.
- The scope of 'Vidyalaxmi' bond will be enhanced to cover all Girl students studying in

government schools across the state (presently being given in only those villages where female literacy is less than 35%).

- The scope of *Mukhyamantri Amrutam (MA) Yojana* will be gradually expanded to include neo (lower) Middle class families. At present poor families are covered up to Rs. 2,00,000 per annum for treatment of catastrophic illnesses such as cancer, heart failure, neurological diseases, kidney disorder etc.
- Healthcare services will be decentralized and district civil hospitals would be equipped with



Cardiac Intensive care unit, kidney dialysis centre and neonatal intensive care unit

- While in 40 years, only 6.70 lakh agricultural power connections were provided, the present BJP government has provided 4 lakh such connections in only 11 years. Further, we will see to it that all pending demands are met on an immediate basis.
- We have already covered more than seven lakh hectares of land under drip/sprinkler irrigation. We will cover more and more land under these systems furthering our motto of 'per drop more crop'.
- Small and marginal farmers pay 7% interest on agricultural loans taken from cooperative organizations. The government will share their burden by paying 3% interest so that the farmers have to pay only 4% interest.
- All dams of Saurashtra will be filled with Narmada Water in next three years under



'Saurashtra Narmada'.

- "My own home in my area"- is a dream of every individual and for fulfilling this dream we will implement *Mukhymantishri Grih Samrudhhi Yojana*.
- An ambitious project of Rs. 33,000 crores to be implemented by setting up a separate department to be headed by the Chief Minister. Total 50 lakh pucca houses will be built up in next five years including 28 lakh houses in rural area and 22 lakh houses in urban area
- The present government has already done a lot in this direction. We have numerous examples like 108 Emergency services, BRTS, new ST buses, City civic centres and one day governance, ICU on wheels, New engineering colleges etc. Gujarat government provides engineering education with the lowest fees in the country. Making public services and facilities better and efficient and even better than the private sector is an important part of our governance. This would ensure good quality services at affordable rates to the middle class.
- 13,000 crores to around 85 lakh poor through *Garib Kalyan Melas* so far. We will make *Garib Kalyan Melas* more scientific by integrating all poverty alleviation schemes in next five years.
- More than 30 lakh employment generation with the development of industrial and service sector.
- In addition, more than 30 lakh to provided with self-employment and skill-development training under 'Mission Mangalam' scheme. Skill Development University will be set up. Minimum wages of laborers will be increased.
- Special focus on the project for developing Gandhinagar as a solar city and a carbon neutral city.
- A policy will be formed to encourage positive attitude amongst families towards the birth of girl child.
- Vidya Laxmi Bond' scholarship programme will be expanded to cover all girls studying in government schools. Besides strengthening of Government facilities for pregnant mothers and infants, the *Chiranjeevi* scheme will be made more effective.
- *Khel Mahakumbh* has been held across the state since 2010 for one month. It will be made more outcome oriented.
- Annapurna Yojana Planning of providing food

to the poor through Sakhi Mandals with government assistance.

- The PDS system of Gujarat which has been well acknowledged even by the Supreme Court of India will be further strengthened and coupons for ration will be distributed through eGram] Vishwagram centres.
- Leadership in non conventional energy including solar and wind power. Gujarat will be of game changer in solar power sector. Rooftop solar generation on houses will also be encouraged.
- Drinking water is being provided to 75% population in the state comparing to 30% average of the country. The coverage will be extended in next five years.
- Special package of housing for urban poor around 25 lakh houses to be constructed.
- Ahmedabad-Gandhinagar metro rail services (MEGA) at a cost of Rs. 15,000 crores, BRTS in other cities
- Riverfront development in other cities, more Twin cities. World-class development of roads, railway.
- Development of logistic parks at Ahmedabad, Palanpur, Vadodara, Dahej, Hajira.
- Special focus on tourist destinations like Saputara, Pavagadh, Girnar.
- Sea and river cruises services including hover craft between Dwarka and Bet-Dwarka to be developed.
- Dandi March route to be developed as heritage corridor.
- Special Lok Adalats for women.
- Currently, 323 Million Metric Ton per Annum (MMT PA) cargo is being transported from ports of Gujarat. We will increase this capacity to 500 MMT PA by 2015-16 and 800 MMT PA by 2020.
- Gujarat will be developed as a Ship building hub of South Asia.
- Gujarat offers statewide network of broadband connectivity. Now the government will set up statewide WiFi network. WiFi facilities will be made available on public places and commercial centers.
- Marine biotechnology especially Sea Weed Cultivation will receive focused attention.
- Right to Services Act to be introduced. An annual recruitment drive will be held to fill up Government vacancies along with well-planned projections of future requirements.

## Think about Gujarat, development comes to the mind, think of the UPA scams, corruption, pricerise come to the mind : Modi

After a phenomenal response in South Gujarat and Ahmedabad district, Gujarat Chief Minister



Shri Narendra Modi addressed huge public meetings in various parts of Saurashtra. First Shri Modi addressed a meeting in Gondal (Rajkot district) followed by Dhola (Bhavnagar district)



and then addressed a massive rally in Bhavnagar city.

Shri Modi spoke about the development initiatives in Gujarat and came down heavily on the UPA over its colossal failures on every front. Shri Modi recalled that when he took over as the Chief Minister the total budget of the state did not exceed Rs. 6,000 crore whereas just recently he dedicated the SAUNI Yojana worth Rs. 10,000 crore to the people, which will bring the waters of the Narmada to Saurashtra.

Similarly, a town like Gondal today has development works to the tune of Rs. 4700 crore thus illustrating the scale of development in Gujarat over the last ten years. He talked about the Supreme Court praise for Gujarat's land acquisition policy.

He attacked the Congress on the issue of the cotton export ban and said that Prime Minister Dr. Manmohan Singh must answer the farmers on why this step was taken that caused a loss of Rs. 7,000 crore to Gujarat's farmers. Shri Modi said that the Gujarat Government has come up with textile parks for cotton growing districts that will help farmers and will enable cloth and garments to be manufactured there itself.

He pointed out that the 'New Textile Policy' of the Gujarat Government is to protect the interests

of Gujarat's farmers from the Delhi Government. He shared that the textile industry comes second only to agriculture in generating jobs and that the policy will create as many as 25 lakh jobs for the people. The Chief Minister spoke about how the Dahej-Ghogha ferry service will further increase the development in Bhavnagar.

Shri Modi stated that there are two examples of Governance in India- one of the UPA and the other of Gujarat's BJP Government. He added that when we think of Gujarat it is development that comes to the mind and when we think of the UPA, all that comes to the mind is scams, price rise, corruption etc.

Shri Modi opined that even criticism of the Gujarat Government is on the issue of development while there is no such hope of development from the UPA. He affirmed that if one goes to any part of Gujarat, there is some or the other development work going within a radius of 25 km. The Chief Minister termed the Congress as an expert at telling lies and added that even 4 PHDs are not enough for them! He said that the Congress promised to reduce prices in 100 days but that did not happen and instead they even snatched gas cylinders leaving the people at the mercy of the black market. He exposed the Congress lie that the Gujarat Government has been doling out Gauchar land and shared that it was the Congress, who in its rule doled out large tracts of Gauchar land.

Shri Modi spoke at length about how the Congress has cheated its workers and cheated their own ally the NCP when they first offered them 9 seats but later on put candidates on these seats. The Chief Minister made a direct attack on the Congress, saying that they do not have the courage to fight the BJP directly, which is why they are making behind the curtains alliances with others.

He urged the people not to think about their community, village, Taluka or district but instead think about the entire state when they go to cast their vote. He also said that he has given his life in the service of the people of Gujarat and based on the development of the last 11 years the people should decide.

## FDI going to create monopolistic market for the consumers : Sushma Swaraj

Synopsis of the speech delivered by Leader of Opposition in Lok Sabha Smt. Sushma Swaraj on December 4, 2012 moving the motion recommending to the Government to immediately withdraw its decisions to allow 51% Foreign Direct Investment in multi-brand retail trade. Tirst of all, I would like to thank you as you have admitted this FDI discussion under Rule 184. We were insisting that if we take up the discussion on FDI, then it would only be under Rule 184, as there was a background behind it. Last year, the Government had taken a decision exactly on the same lines during the Winter Session of 2011. They allowed 51 per cent direct foreign investment in retail business. At that time, the decision was opposed by all sides. The Opposition as well as the constituent parties of the Government had also opposed it. The Leader of the House at that time had stated in the House that he would talk to the Prime Minister and convey the sentiments of the House to him. An All-party meeting was held again on 7th December, 2011 and the Leader of the House stated that he had discussed with the Prime Minister and the Government had decided to keep

this decision in abeyance until talk are held with all the stakeholders and a consensus is reached. From the word 'stakeholder' he meant the political parties and the Chief Ministers of various States. Reiterating his views, he also made a statement in the House on 7th December 2011.

But I regret to say that leave alone consensus even efforts were not made for the same. We are the main Opposition party, leave alone the meeting even no correspondence was made with us in this regard. We were not even telephonically contacted in this regard. One fine day we came to know about the decision of the Cabinet allowing 51% FDI in retail sector through Never before, the television. assurance given to Parliament was so flagrantly violated like this.

The Minister of Parliamentary Affairs and the Minister of Commerce said in their response that they had changed the policy and made an enabling provision for the States. Therefore, there was not need to consult the States in this regard. It is pertinent to mention here that the Minister of Commerce also gave the same statement in Rajya Sabha on 7th December 2011 as was given by the then Leader of the House in Lok Sabha. As far as the FDI is concerned. I want to reveal the truth of the claims of the Government, which it has been given in support of the FDI. Their first claim is that the FDI is in the interest of consumers. It is a basic principle that if the market is competitive it is in the interest of consumers and if the market is monopolistic, it is against the interest of consumers. The FDI is going to create monopolistic market for the consumers, which cannot be in their interest.

The international experience teaches us that they indulge in predatory pricing and nobody can deny this fact. First, they



reduce the prices to such an extent that remaining businessmen are compelled to leave the market and when all these businessmen leave the market they increase the prices suddenly and then, the consumer has no choice but to purchase from them only because there is no other choice for them. Therefore, their claim that the FDI in multi-brand retail sector is in the interest of consumers is totally wrong and beyond the truth. The second claim of the Government is that this is in the interest of farmers also as they would purchase their produce directly from them at higher prices and farmers will get remunerative prices for their produce. Big retailers buy cheap from the farmers, they pay less salary to their employees due to which they are able to sell cheaper.

They do not compromise on their profits and jack up the prices by keeping their profit margins intact. Evidence from across the EU suggests this and the nature of the complaint received from there was that the joint retailers were squeezing the prices paid to the farmers for products like milk, meat, poultry and wine and, in some instances, forcing them to sell it below cost prices. This is not the only instance but the experience throughout the world tells us that they buy cheap from the farmers.

Further, I would like to say that the question of making payments to the farmers whether less or more only arise when they will purchase from the farmers in the first instance. The truth is this that they are not going to purchase from the small and today there is a sector in India where there is no middleman and that sector is sugar sector. No middle man exists in the chain between farmer and the mill owners. But, it has happened so many times that the mill owners refuse to buy the sugarcane from the farmers by saying that they cannot crush more quantity. What I am trying to emphasize and answering this logic given by them wherein they are maintaining that bringing in FDI will make the middle man extinct and the farmers will benefit is that the sugarcane farmers are forced to run here and there in a sector where there is no middle man

medium farmers at all. The experience of Pepsi is a testimony to this fact. The companies like Mc Donald and Pepsi reject the whole consignment of the farmers produce on one pretext or the other. The Government is of the opinion that the farmers will benefit most due to the extinction of the middle men.

I would like to tell you that even today there is a sector in India where there is no middleman and that sector is sugar sector. No middle man exists in the chain between farmer and the mill owners. But, it has happened so many times that the mill owners refuse to buy the sugarcane from the farmers by saying that they cannot crush more quantity. What I am trying to emphasize and answering this logic given by them wherein they are maintaining that bringing in FDI will make the



middle man extinct and the farmers will benefit is that the sugarcane farmers are forced to run here and there in a sector where there is no middle man and there is a direct agreement between the mill owners and the farmers. So, this argument that extinction of the middle man from the chain will benefit the farmers is not true. In our market, the most prominent among the middle man is the 'Adhati' in our food grain market. There is a relation of faith between them and the farmers. On the basis of which they lend money to the farmers on the occasion of the wedding of later's daughters marriage and other occasions. having The people an understanding of rural economy will agree with my point.

I would like to ask whether the companies like Walmart and Tesco will be able to lend to the farmers. Will anybody of their ilk directly purchase from the farmers? New agencies will be created and new middle men will arise. Therefore, it is utterly wrong to say that bringing in FDI to this sector will erase the middle men. The third claim of the Government is that FDI will create new employment opportunities. The Minister of Commerce has even given a figure to support this argument. He has said that 10 million new jobs will be created wherein 40 lakh people will be directly employed through this sector. However, the figures available with me fail to match with the given figures even after making liberal assumptions. I am unable to understand as to from where do they get their figures? Maximum level of unemployment will result in



manufacturing sector. Factories will be closed down. The Government has stated that 30 per cent of sourcing will have to be done from the local industry. You have cut down by 70 per cent the current production if you persist with this decision. Can any factory become viable at a rate 30 per cent? Factory after factory will be closed down. 90 per cent out of the remaining 70 per cent will be imported from China. Therefore, factories will prosper in China, employment opportunities will be generated in China and income level will also rise in China even as 12 crore of our households will witness gloom and uncertain future. Our manufacturing sector will suffer. Therefore, there cannot be a greater myth than this clause of 30 per cent sourcing. It will not be possible to make this 30 per cent sourcing from the local industry a reality. Now, I would also like to share with you the negative consequences of this policy on the retail sector. The experience all across the world tells us that small shops and small retailers have met with doom wherever FDI in multibrand has been opened.




## Aiyar's 'animal' comment : BJP MPs serve breach of privilege notice

BJP MPs Shri Jagat Prakash Nadda, Shri Dharmendra Pradhan and Shri Bhupendra Yadav have sent the privilege notice against Shri Aiyar under Rule 188 of the Rules of Procedure and Conduct of Rajya Sabha to the RS Secretary General. Shri Aiyar, a Rajya Sabha MP from Congress Party had during a television debate on logiam in Parliament on FDI in retail, reportedly made the controversial remarks. "The use of such derogatory and defamatory words is unacceptable and constitutes contempt of this House. Therefore, we feel obliged to raise this question of privilege against him," the notice stated. The BJP MPs claimed Aiyar had in the televised debate in Bhupendra Yadav's presence referred to MPs shouting slogans in the Well of the House as "animals". Stating that Aiyar has used and reiterated the word 'Jaanwar' (animal) for MPs, the notice sent by the MPs read "the said offending word has been subsequently used by him several times in the course of the interview and he has justified using the said word on live television." Members in Rajya Sabha belonging to various parties have raised strong objections to Aiyar's reported comments and demanded an apology. An apparently embarrassed Minister of State for Parliamentary Affairs Rajiv Shukla tendered an immediate apology on behalf of Aiyar and informed the House that he will talk to him in this regard and ask him to apologise.

The Indian market will be flooded with Chinese goods and then our manufacturing sector will be doomed. That is why we are opposing this also. Bring FDI in strategic sectors like infrastructure. How do you believe what you are saying is going to help the country? The farmers in Britain are forced to sell their produce at the dictating price of the companies. You did not even bother about what the Standing Committee has opined. The Switzerland experience of Walmart is also not good. ## Why not vote on FDI in retail?

There is a legitimate apprehension in the country about whether the current Parliament session will go on or be disrupted. This is on account of a virtual breakdown of the relationship between the government and the opposition in terms of political dialogue. Obviously, such a situation is not desirable in a democracy. Consensus on various issues is possible and at times it is the pressing need of the hour. But in an environment where the government of the day survives on manipulation and creates an environment of confrontation, political consensus will always be elusive.

On December 7, 2011, the government assured both Houses of Parliament that the decision to introduce FDI in multibrand retail would remain in abevance till the it consulted all stakeholders and arrived at a consensus. The stakeholders were described as the state governments and political parties, among others. There has been no serious effort by the government, since then, to engage political parties or state governments. When we raised this issue with the government, the answer was that the it had assured Parliament that it would consult and arrive at a consensus with political parties and state governments - it had not assured Parliament that it would consult "all" political "all" parties and state

governments.

The government, obviously, was being too clever by half. As the opposition, we still relented. We assured the government that the Parliament session would function normally, provided the first item on the agenda was a discussion on FDI in multibrand retail under a voting provision. Once this debate took place, the rest of the business, legislative including business, would go on. The **UPA** government contrived an argument that a voting resolution on a policy matter had never taken place. We cited precedents that, in fact, Parliament had debated policy matters under a voting provision.

Why should voting be considered alien to а parliamentary democracy? In fact, democracy is a game of numbers. Voting is the essence of democracy. There has to be a parliamentary control over decisions. executive А parliamentary disapproval of executive decisions through censure motions is the normal rule. Issues cannot be merely talked out. They have to be voted on in order to determine the sovereign will. There is now a lurking suspicion that the government will not agree to a voting provision till such time that the "regular suspects" among the loyal opposition

parties have been managed, either to vote with the government or to abstain from voting. It appears that the government does not seriously want the session to go on. It is creating a situation conducive to a stalemate.

My expectation from this session is that we should seriously discuss the state of the economy. The GDP growth rate has substantially declined. There is fear that the growth story of the Indian economy is being diluted. There is a danger that the "I" may be knocked out of the BRICS. The government has attempted to create an impression that it wants to introduce the new generation of reforms. It has brought a bad name to the word "reform". Reforms are the art of the possible. If reforms are marketed purely as anti-people, their visible face being price rise, increase in diesel cost, increase in cooking gas cost, restrictions on cooking gas quotas, popularsanction will not be there behind reforms.

The farm sector is in a precarious condition. Infrastructure expansion has slowed down. The power sector suffers from coal shortage and is moving into a debt trap. The manufacturing sector suffers from high interest rates, lack of trade facilitation, high power costs and large currency depreciation.

The issue of corruption has to be debated in the current



House. There is consensus on a large number of issues in the report of the select committee on the Lokpal Bill. There is, however, no unanimity on all issues. Some further reforms, over and above those suggested by the select committee, are required to strengthen the freedom of the CBI from the clutches of the government. The surreptitious manner in which the new CBI director was appointed by the government, rather than by the collegium, on the eve of the submission of the select committee report, has set a bad precedent. It has sent out an impression that the government is uncomfortable about letting go of its control over the CBI, which has been used to secure its own longevity. The scam in the allocation of coal blocks requires to be debated at length in Parliament.

The session started with a pathetic attempt by the government to choreograph controversy by bringing a bad name to the institution of the CAG. The rehashed story, attributed to a former official of the CAG, hit the headlines. The UPA chairperson herself also participated this in choreography by suggesting that the loss figures in the 2G spectrum allocation were attributable to the BJP. The government cut a sorry figure when the official concerned turned hostile in the course of a television interview and altered the identity of the person who had allegedly interfered with the CAG recommendation. It was no

longer the PAC chairperson, Murli Manohar Joshi, but some unidentifiable member of the PAC who had allegedly interfered in the CAG report.

Important legislative business is pending. We in the opposition would like to cooperate by arriving at a consensus on a significant part of this business. However, before we can reach that stage, the government will have to resolve the stalemate pending on the issue of FDI in retail. The earlier the government is able to resolve it with a voting provision, the easier it will be for parliamentary functioning.

## Congress led UPA Govt. indecisive, incompetent : Advani

For the Congress, ridiculing Constitutional bodies or bending them to suit its own purpose has become a habit. Now, even senior Union Ministers brazenly question the credentials of these organizations

It all began with the loaded pronouncement by the Minister of State in the Prime Minister's Office that changing the composition of the Office of Comptroller and Auditor-General of India was "under active consideration" of the Government. Days later the 2G Spectrum auction turned out to be flop show vis-à-vis the Government's revenue expectations and Union Ministers virtually celebrated their disastrous performance. Then came the "revelation" from a retired CAG official that the loss suffered by the exchequer in the controversial 2G Spectrum sale was actually paltry, but his opinion was brushed aside and a grossly exaggerated figure was put out in the CAG report.

Union Ministers are now working overtime to mock at the CAG for saying that Raja's method of selling scarce Spectrum had caused a notional loss of '1.76 lakh crore. They are also throwing challenges at him and also making oblique references to judicial interference in governance. judiciary is right. The Government is perfect, the fault lies with institutions which are mandated by the Constitution to protect the rights of citizens.

Following the poor response of the industry to the 2G Spectrum auction, Union Minister for Telecommunications Kapil Sibal and the Union Minister for Information and Broadcasting Manish Tiwari have been taunting and challenging the CAG and asking, "Where is the Rs. `1.76 lakh crore?" Where does the fault lie? The truth is that the telecom industry was cold to the auction in 2012 because of the Government's faltering policies and its poor performance on the economic front over the last three years. Hit by scam after scam, the Government's image took such a severe beating that there is a major trust deficit as far as this Government is concerned. This is the reason why the telecom industry shied away from the bids. Second, Union Ministers say the judiciary and the CAG should stay clear of policy making. This has always been the case, but what should constitutional authorities do when they see the shameful and partisan manner in which a Minister like A Raja behaved while selling spectrum? Should they allow the looters a free hand or step in to save the constitutional right of 1.2 billion people to good governance?

One saw an equally shameful assault on the higher judiciary by the Congress in the 1970s and particularly during the dreaded Emergency, when Ministers and senior party leaders openly threatened Supreme Court judges. Since the days of Indira Gandhi, the Congress has always been uncomfortable with independent constitutional authorities. Such has been its allergy to strong institutions that it openly canvassed for a 'committed judiciary' (committed not to the Constitution but to the Congress) and tried to pack the courts with "committed" judges.

Such was the party's gross interference that the entire system of judicial appointments were called into question, leading to the Supreme Court decision that appointments to the higher judiciary would henceforth be made by a collegium of judges. Long years have gone by but the executive has not been able to regain its voice vis-à-vis judicial appointments in the country.

The Congress, which sought to corrupt the system of appointments, is wholly responsible for this situation. The party's complete lack of commitment to core constitutional values has been apparent elsewhere as well. One has seen the party appoint persons like Navin Chawla, who the Shah Commission said "is unfit to hold any public office which demands an attitude of fair play and consideration for others...", as an Election Commissioner. He even later became the Chief Election Commissioner.

Let us also not forget the graceless conduct of Prime Minister Manmohan Singh and then Union Minister for Home Affairs P Chidambaram, as members of the committee to choose the Central Vigilance Commissioner. ## New Zealand to aid Himachal Pradesh in horticulture & agrisectors: Dhumal

New Zealand would co-operate with Himachal Pradesh in strengthening its horticulture and agriculture sectors by providing expertise and

technology transfers. Himachal Pradesh Chief Minister Prof. Prem Kumar Dhumal held a highlevel meeting with visiting officials and a business delegation headed by Minister of Primary Industries



of New Zealand, David Carter, at his official residence, in Shimla.

Chief Minister Prof. Dhumal welcomed the proposal of the New Zealand Government collaborating with the State in technology transfer in horticulture and agriculture sectors. He said that horticulture was the major cash crop in the State and was contributing significantly towards the State's gross domestic product while agriculture had been the traditional vocation in the State as over 90 percent of the population was directly or indirectly dependant for their livelihood over agriculture. The Chief Minister said mutual collaboration between the two countries would be beneficial to the State in the field of horticulture and agriculture sectors.

He said that the State had only 4 to 9 MT per hectare of apple yield as compared to over 25 MT per hectare yield in New Zealand. He said that the State would import quality and early-variety rootstock of apple from New Zealand for multiplication State Reports

in different laboratories in the State for further distribution amongst the horticulturists.

He said that creating cold chain to preserve the fruit and vegetables grown in the State could also be beneficial with mutual cooperation between Himachal Pradesh and New Zealand. He said that since apple crop was a highly perishable commodity that had limited shelf life, facilities of cold chain would help boost its shelf life and of other vegetables that could be stocked for longer to fetch remunerative prices by marketing the same at appropriate time.

Shri Dhumal said that fruit processing industry was another field where New Zealand could lend its support to the State so that instead of marketing the produce to distant markets, the same were processed to produce value based products for marketing.

### BJP seeks CBI probe into K.T. Jayakrishnan's murder

The Kerala BJP has reiterated its demand for a reinvestigation by the Central Bureau of Investigation (CBI) into the murder of Shri K.T. Jayakrishnan.

## Enquire into contract of cluster bus service in Delhi: Vijender Gupta

**B**JP Delhi Pradesh President Shri Vijender Gupta has said that the irresponsible attitude and

corruption by Delhi Government are the reasons of the failure of widely publicized DTC cluster bus service. He has asked Minister Arvinder Singh Lovely whether he had relations with one of the Chadha brothers, Hardeep Singh killed recently.



Under the cluster bus service 150 low floor buses were to be operated in various roots of South Delhi. Only 16 buses are plying on these cluster routes till date. It is said that Hardeep Singh Chadha was the owner of this cluster bus service. He had secured the contract of cluster service with the help of his relations with Delhi Government. Hardeep Singh was also operating other business. It is said that he had relations with former Transport Minister Arvinder Singh Lovely, but he was not serious about starting the cluster bus service. The Government did not take any penal action against it. Due to this the passengers of aforesaid routes are suffering, Shri Gupta said.

The Delhi Government for the purpose of improving the public transport system in the capital had divided entire Delhi into 34 routes. These parts were named clusters. New low Floor-AC and non-AC buses were to be operated by the private cluster operators having different colours in all the clusters. Government spent crores of rupees in the publicity of this scheme. Even after two years neither new buses have been purchased nor new buses have started playing in all the clusters.

It may be mentioned that the blueline buses called as killer buses of Delhi were stopped from operating due to the intervention of court. But now Delhi Government is going to operate those blue line buses on 97 routes of outer Delhi. Under this service 1532 blue line buses shall transport the passengers. There is apprehension of increase in accidents once again due to it. ■

A Jivanmukta or liberated sage is the real Guru or spiritual preceptor. He is the Sadguru. He is identical with Brahman or the Supreme Self. He is a Knower of Brahman.

A Sadguru is endowed with countless Siddhis (psychic powers). He possesses all divine Aisvarya (powers), all the wealth of the Lord. Possession of Siddhis, however, is not the test to declare the greatness of a sage or to prove that he has attained Self-realisation. Sadgurus generally do not exhibit any miracle or Siddhi. Sometimes, however, they may do so in order to convince the aspirants of the

existence of superphysical things, give them encouragement, and instill faith in their hearts.

The Sadguru is Brahman Himself. He is an ocean of bliss, knowledge, and mercy. He is the captain of your soul. He is the fountain of joy. He removes all your troubles, sorrows, and obstacles. He shows you the right divine path.

He tears your veil of ignorance. He makes you immortal and divine. He transmutes your lower, diabolical nature. He gives you the rope of knowledge, and takes you up when you are drowning in this ocean of Samsara (cycle of birth and death). Do not consider him to be only a man. If you take him as a man, you are a beast. Worship your Guru and bow to him with reverence.

Guru is God. A word from him is a word from God. He need notteach anything. Even his presence or company is elevating, inspiring, and stirring, His very company is self-illumination. Living in his company is spiritual education. Read the Granth-saheb (the holy scripture of the Sikh religion). You will come to know the greatness of the Guru. Man can learn only from man, and hence God teaches through a human body....

How to Choose Your Guru

If you find peace in the

presence of a Mahatma (great soul), if you are inspired by his speeches, if he is able to clear your doubts, if he is free, from greed, anger, and lust, if he is selfless, loving, and Iless, you can take him as your Guru.



He who is able to clear your doubts, he who is sympathetic in your Sadhana, he who does not disturb your beliefs but helps you on from where you are, he in whose very

presence you feel spiritually elevated-he is your Guru. Once you choose Your Guru, implicitly follow him. God will guide you through the Guru.

Do not use your reason too much in the selection of your Guru. You will fail if you do so. If you fail to get a first-class Guru, try to follow the instructions of the Sadhu (a spiritual person) who is treading the path for some years, who has purity and other virtuous qualities, and who has some knowledge of the scriptures. Just as a student of the Intermediate class will be able to teach a student of Third Form when a professor with M.A. qualification is not available, just as a subassistant surgeon will be able to attend on a patient when the civil surgeon is not available, this second- class type of Guru will be able to help you.

If you are not able to find out even this second-class type of Guru, you can follow the teachings contained in the books written by realised saints like Sri Sankara, Dattatreya, and others. You can keep a photo of such a realised Guru, if available, and worship the same with faith and devotion. Gradually you will get inspiration, and the Guru may appear in dream and initiate and inspire you at the proper time. ..
