By denying JPC

UPA depriving MPs the right to information Persevering to protect the guilty

The demand voiced by the main opposition Party, Bharatiya Janata Party, and supported by the other opposition groups in both houses of Parliament, is nothing new. Neither is it new that proceedings in both houses of Parliament have been stalled for pressing this demand. In the 2001 JPC on market scam and in 2003 Cola case the Congress along with other parties had behaved the same way as is the opposition parties today for 2G spectrum scam. It is a different matter if Congress is taking a very moralist stand on the issue today saying that it is willing to every issue in the house. But this, again, was the stand of the NDA government earlier which the Congress and other parties had refused to listen.

During the last about two years, the media had been agog with reports of wrongdoings going on in the ministry of communications under the then Minister Mr. A. Raja. But the Congressled UPA government had either been ignoring or denying these reports vehemently. Till the very last the Congress President Mrs. Sonia Gandhi and the Prime Minister Dr. Manmohan Singh had been giving Mr. Raja a clean chit.

There were contradictions too. On the one hand, government and Congress claimed that every-

thing in the grant of 2G spectrum licences was done as per the rules and policy and, on the other, it was being denied that the PMO was in the know of what was going on in the matter of 2G spectrum. On the eve of the presentation of the report of the Comptroller & Auditor General (CAG) of India in Parliament and under pressure of the Opposition, Mr. A. Raja was suddenly made to resign.

The CAG report has nailed the UPA claims. It has computed the loss to the public exchequer, through underhand means, at `1.76 crore. The amount is so enormous that it is more than what the country spends annually on its defence. Yet both the Congress and UPA government continue to maintain that nothing wrong has

been done by Mr. Raja as if putting the nation to such a colossal loss, in their eyes, is nothing wrong and criminal.

Pampering guilty

That, in spite of having made Mr. Raja resign, both the Congress and Prime Minister continue to have a very soft corner for Raja in their heart became evident when just a few days after Mr. Raja's resignation, on November 16 Prime Minister addressing a conference called by CAG he could not hide what lay in his heart when he preached this constitutional institution to make a distinction between "genuine error" and "wrongdoing". In other words, Dr. Manmohan Singh was trying to put the conduct of Mr. Raja which had caused the State ex-

chequer a loss of `1.76 crores in the category of "genuine error" and not a crime against the nation.

Further, on November 23 when Dr. Manmohan Singh visited the Central Hall of Parliament to pay homage to late Murasoli Maran, a DMK leader, and Mr. A. Raja greeted him, the Prime Minister patted Mr. Raja very affectionately.

Even the CAG report has clearly established that the Prime Minister was kept in the loop by the DoT in everything done -right or wrong. The Report highlights that Mr. Raja had even ignored the directions of the PMO and advice of the Finance Ministry. He had even gone to the extent of questioning the right of this institution of the Constitution to go into the 2G spectrum allotments claiming it as "a matter of policy".

Needle of suspicion

Question arises: If Mr. Raja had committed no "wrongdoing" in the issue of 2G spectrum licences; if the PMO is not involved in any way, directly or indirectly; and if there is not the least onus of responsibility on the Congress Party as an organization on the political front for anything wrong, why was Raja made a scapegoat?

Why did the CBI register a criminal case at all about 11 months back if no crime had been committed? Against whom was the case registered and what was the crime committed? If there is nothing wrong, what made the Supreme Court to comment: Why is Raja still a minister? (Till that time, Mr. Raja had not resigned.) On November 25 the Supreme Court was constrained to ask why Mr. Raja and the then DoT December 16-31, 2010 Q 7

Embarrassments for UPA

UPA has had to face a series of embarrassments in the Supreme Court when Janata Party President, Mr. Subramaniam Swamy, dragged the PMO in the matter of denial of permission to prosecute Mr. A. Raja for his criminal conduct. Besides other comments by the Supreme Court judges which have embarrassed the UPA, it was for the first time in history that a sitting prime minister was made to file his reply in the highest court of the country.

Since November 9 when the two houses of Parliament assembled for the winter session, not a single day's business could be transacted because the opposition is adamant on its demand for constitution of a Joint Parliamentary Party (JPC) to go into the whole 2G spectrum deal. The government is equally adamant not to succumb to this demand. The gesture of the Congress that its MPs will not draw their daily allowance till the Parliament functions normally is not going to give a moral strength to ruling UPA because it is standing on prestige which does not have the sanction of morality and laws of ethics. Its standing in the eyes of the people has touched the lowest ebb.

Why no JPC?

As is the rule and practice, the members of the JPC have to be nominated by the Speaker in proportion to the strength of parties in the House with chairman belonging to the ruling party. That clearly means that the UPA will have a majority in the JPC too besides it being presided over by its own trusted individual. But the anxiety of Congress lies in lack of its own confidence in its own



allies who too will also be represented in the JPC. It fears that they may any time tilt the balance to its discomfiture and embarrassment.

Never in the history of our parliamentary party has the ruling party been so insensitive to the feelings and demands of the Opposition. Prime minister late Rajiv Gandhi enjoying an unprecedented road-roller majority in Lok Sabha, conceded the demand for a JPC to go into the Bofors scandal where allegation was just of a ₹ 60 crore commission/bribery in spite of the fact that the opposition then was in a hopeless minority.

In 1963, when just about 110 MPs from both houses of Parliament made a written demand to India's first Prime Minister, Pandit Jawaharlal Nehru, for instituting a commission of inquiry against his blue-eyed Punjab chief minister and a Congress strongman, Sardar Partap Singh Kairon, the democrat in Pandit Nehru lost no time in conceding the demand and constituting a Das commission for the purpose.

The present Congress does swear by the name of Pandit Nehru and Rajiv Gandhi. But when it comes to living up to their traditions, it fails to display the same grace and spirit in 2G spectrum scam when the charges are much more serious than ever before.

Standing on feet of clay

When the government and the Congress forcefully claim that nothing wrong or against the rules and policies has been committed by Mr. A. Raja and the hands of Congress and UPA are clean, why do they dread the prospect of a JPC? Their reluctance only gives rise to the suspicion December 16-31, 2010 Q 8

that there are many skeletons in its cupboard.

If the Opposition is responsible for not allowing the two houses of Parliament to function smoothly, equally - and even more than that - is the UPA responsible for not creating an environment conducive for the purpose. As per media reports, certain allies of UPA, like the Trinamool Congress, have come out in support of a JPC.

In their opposition to the JPC demand the Congress and UPA are standing on the feet of clay and have neither the strength of morality nor of the people behind them in their effort to put the independent India's largest scam under the carpet. The more they oppose the JPC the more it fortifies the suspicions in the mind of the people and, on the contrary, provide more political and moral power to the opposition to press for their demand. UPA needs to forget that with its present intransigent attitude it will succeed in pushing this scandal under the carpet.

The Congress of Mrs. Sonia

Gandhi which takes pride in having enacted the Right to Information Act is itself guilty of denying the elected representatives of the people of their right to information. By doing so, it is not promoting the interests of the people but only venturing to protect the guilty who have robbed the nation of a colossal sum of `1.76 llakh crores.

The UPA seems to be living in a fool's paradise that it will be able to stifle the voice of the people and the opposition through its autocratic designs. It must understand that democracy is certainly a rule by majority yet, at the same time, not a dictatorship of the majority. Neither is it a whim of the majority nor its arrogance and intoxication of power. It is a rule by consensus in a spirit of give and take. Transparency is the soul of democracy. Denial of the right to information and to know the truth on the strength of roadroller of majority is the curse of a dictatorship, not a virtue of a democracy. But that is what seems to be happening in India at the moment.




Autonomy of investigative agencies seriously compromised : Advani

he Winter Session of Parliament continues to be stalemated. The responsibility for this stalemate is entirely of the UPA Government. The UPA has diminished all institutions which were responsible for investigations to ensure probity in public life in India.

The autonomy and independence of the Central Bureau of Investigation has been seriously compromised. Its investigation no longer inspire the confidence. It has become a convenient instrument in the hands of the Government either to whitewash certain investigations or to harass political opponents.

The Central Vigilance Commission is the internal vigilance authority of the Government. The appointment of its chief has completely demolished the credibility of the CVC as an institution. A person charge-sheeted in a corruption case, who attempted to deny the CVC and CAG its authority to question the impropriety in the 2G spectrum allotment, appointed as its Head. appointment was questioned first during the meeting of the appointing collegium by the Leader of Opposition (Lok Sabha), thereafter in the media and subsequently before the Supreme Court.

The Government cannot seriously expect the Opposition

to accept that the CBI and the CVC are the appropriate institutions which are capable of an honest investigation into the monumental 2G spectrum allotment scam.

The Prime Minister gave repeated clean chits to Shri A. Raja, the erstwhile Telecommunication Minister. He turned a deaf ear to the national hue and cry. The Parliament first debated this issue in the Rajya Sabha on 23.7.2009. Obviously,

the Opposition is no longer interested in merely talking out the issue. It wants action and therefore we had to resort to an extraordinary step of a parliamentary stalemate when scam after scam were being pushed under the carpet by the Government. But for the parliamentary stalemate, Shri A. Raja would not have resigned; but for the fear of a hostile public opinion some action would not have been initiated into the various scams surrounding the organization of Commonwealth Games.

The width and magnitude of the matter involved in the 2G spectrum allotment case are far beyond the scope of the Public Accounts Committee. The CAG is an internal auditor of the Government. It raises various accounting and auditing issues. The PAC confines itself to the parawise observations of the CAG. It cannot go beyond the issues which were before the CAG.

The 2G spectrum allotment scam involves wide ranging issues. Why was it necessary that the Telecommunication portfolio was to be allotted only to the DMK? Were corporate interests at play that even within the DMK it was to be allotted to only to a particular individual to the exclusion of others? Were the Telecommunication Minister and his close associates in regular touch with corporate



lobbyists while formulating the policy for allotment of 2G spectrum?

What is the truth with regard to the role of these lobbyists in relation to various institutions so vital to the working of the Indian democracy? Was the allotment policy framed to favour a few at the cost of the National Exchequer? Why was spectrum allotted in 2007-08 at 2001 prices? What is the magnitude of loss caused to the public exchequer? Is there evidence available to suggest that there is an nexus between the allotting authority and the beneficiaries?

A large number of these issues are not within the purview of the PAC. Some may overlap with the PAC but there is nothing new or extraordinary about the limited overlap between two different parliamentary committees.

When the investigative agencies have been compromised, the magnitude of the scam is unprecedented, a coverup has taken place at the behest of the highest in the Government, institutions so vital for the effective functioning of the democracy are under cloud, Parliament cannot abdicate its responsibility and say it will not investigate into the matter.

Why is the Government running scared of a Joint Parliamentary Committee? The Committee will be headed by a Government nominee. Are we entitled to presume that transparency which is vital for the effective functioning of a JPC scaring the Government because embarrassing truths stares it in the face. The responsibility for the parliamentary stalemate rests entirely on the shoulders of the Government. Once the JPC is announced the NDA favours the resumption of parliamentary business forthwith. The more it delays the setting up of a JPC, the more is the Nation entitled to presume that the government is trying to evade the search and detection of truth which may be embarrassing to it. ■

Proceedings in Somaiya's defamation case against Digvijay Singh commence

n November 29, 2010 the Mumbai Court started the process in the defamation case filed by BJP National Secretary, Dr. Kirit Somaiya against Congress leader Digvijay Singh. Additional Chief Metropolitan Magistrate, Shri V.D. Jadhavar, after hearing Dr. Kirit Somaiya, kept further hearing on 3rd January 2011.



Advocate Dinanath Tiwari, on behalf of Dr. Somaiya, had sent a legal notice last week asking Digvijay Singh to submit public apology.

In his complaint Dr Kirit Somaiya states that Shri Digvijay Singh had on November 15, 2010, made several blatantly false and frivolous defamatory allegations against him and had called him a 'broker of the Share Bazaar' and a 'scamster and master in the Stock Exchange scam'.

The complaint further states that these statements were widely reported in the print and electronic media, thereby lowering Dr. Somaiya's esteem in the eyes of the public. Dr Somaiya states that these false and baseless charges made by Digvijay Singh amounts to a very serious defamation and have caused him considerable, distress and embarrassment. The allegations were made with the intent to harm his reputation. The judge has admitted the case and posted the next hearing on January 3, 2011.

Dr. Somaiya criticized Digvijay Singh's allegations by stating that this is a case of 'ulta chor kotwal ko datey'. He added that the BJP was always in the forefront in exposing the scams and fighting for the rights of the common man while it was the Congress which has always been surrounded by corruption.

The BJP supporters took out a condemnation procession in the city and burnt an effigy of Chief Minister Buddhadeb Bhattacharjee even as 22 BJP supporters were produced at a court in Kolkata and remanded to five days in police custody.

West Bengal BJP President Shri Rahul Sinha said that the manner in which the BJP leaders and supporters were beaten up by the police on the dais was unprecedented and demanded CM Bhattacharjee's resignation over the incident. "If the State Government thinks that it can throttle the Opposition's voice in this manner, they are wrong. Such tyrannical ways cannot stop us," he added.

BJP condemns police brutality on peaceful demonstrators in Kolkata

In a statement in Kolkata on November 30, 2010 the Pioneer editor and BJP Member of Parliament Shri Chandan Mitra said the Bharatiya Janata Party unequivocally condemns the brutal assault on peaceful demonstrators in Kolkata by the police, clearly acting under orders of a jittery CPI (M) regime in the State. Police indulged in wanton and unprovoked violence against party workers who were assembling in Central Kolkata in response to the call for encircling Writers' Building, the seat of the Government. Nervous that the

unprecedented gathering of BJP supporters would completely overshadow a CPM rally close by, in which Chief Minister Buddhadeb Bhattacharjee was the main speaker, the police unleashed a reign of terror to foil the BJP's hugely successful gathering.


In their desperation to make the CPM rally a success, the police went berserk and lathi-charged peaceful BJP supporters, injuring over 1,000. Television pictures clearly show how the Kolkata Police and RAF personnel went after BJP workers, chasing them from lane to lane, dragging them out and mercilessly beating them to pulp.

State President Shri Rahul Sinha, former President Shri Tathagata Roy and many other prominent party leaders were grievously injured in the lathi-charge and had to be hospitalized.

Earlier, the police reached the BJP party office, some distance away from the venue of the protest and lathi-charged several thousand assembled workers to prevent them from marching towards Writers' Building. When such brutal violence failed to dampen the enthusiasm of determined party workers, the police fired over 100 rounds of tear gas shells. The police ransacked and destroyed the rostrum from which leaders were to address the workers. Hundreds of party members and supporters have also been arrested.

The BJP protests strongly against the high-handed action of the police which revealed once again its open partisanship in support of the State's notoriously intolerant Left Front Government. Having seen the writing on the wall, the CPM has become thoroughly rattled because they know their 34-year-long misrule is about to end in the elections next year. After that they will have no place to hide, such will be the wrath of West Bengal's tortured and tormented people.

The BJP pledges to continue its peaceful agitation to arouse public opinion against the brutal *Goonda Raj* of the CPM and the disruptionist politics of the Trinamool Congress. Today's state-sponsored violence against BJP workers is yet another example of "Vinaash kaley viprit buddhi".

Was there a design to foist Thomas as CVC? Somebody pulling the strings from behind?

The Congress-led UPA is in a bind over the appointment of Mr. P. J. Thomas as a Central Vigilance Commissioner (CVC). Its strenuous efforts to seek a safe passage through making him 'voluntarily' resign to save itself of further embarrassment seemed to have boomeranged. So far Mr. Thomas has refused to submit and oblige the government.

That the Congress supremo Mrs. Sonia Gandhi and Prime Minister Dr. Manmohan Singh continued to ignore, deliberately, what Mr. A. Raja was doing in ministry telecommunications understandable. For them the continuance and stability of their government was more precious than the '1.76 lakh crore loot of the public exchequer. They could not afford to annoy DMK to which Mr. Raja belonged because UPA is subsisting with the life-saving support extended by this party.

But intriguing is the way the Congress and Prime Minister put their foot down on the selection of Mr. Thomas to the constitutional office of CVC even in the face of fierce opposition to his selection by the Leader of Opposition in Lok Sabha, Mrs. Sushma Swaraj, the third important member of the 3-member collegium with Prime Minister and Home Minister (HM) as the other members. Mrs. Swaraj had based her opposition

to his selection not on any political considerations but because of his past service record. Mr. Thomas was the Secretary Department Telecommunications (DoT) under Mr. Raja when the infamous 2G spectrum allotment scam took place. A chargesheet under section 120B of the Indian Penal Code accusing him of criminal conspiracy in the Kerala palmolein import scam in 1991. There seems another connection. Congress-led UDF government was ruling in Kerala when this scam happened.

The government, in all fairness, certainly needed an individual with an impeccable record of integrity, honesty and fairness who outshone all others as an outstanding civil servant who is to be saddled with the onerous responsibility to ensure probity and honesty in government and public life as the country's anti-corruption watchdog. Should a person occupy such an important position on whom people could raise a finger on his conduct?

Overrules own rules

It seems the Congress had picked up Mr. Thomas for the job much before the process of selection was actually set in motion. Therefore, the whole exercise seems to have been designed to achieve the objective to put him on the job. The first step in this direction was the subversion of the 2000 guidelines

issued by the Department of Personnel and Training (DoPT) interestingly, in consultation with the then Central Vigilance Commission which Mr. Thomas was to head following his selection - through its Office Memorandum (OM), (TOI Dec. 07, 2010) that the vigilance clearance to an officer of the All-India Service "shall not be withheld unless chargesheet has been filed in a court by investigating agency in a criminal case and the case is pending". Therefore, as per the DoPT guidelines Mr. Thomas's was a fit case to withhold the vigilance clearance. Since the DoPT is under the charge of the Prime Minister, no such clearance could have been issued without his consent. particularly when it is in violation of the Department's own guidelines. Had the PMO withheld the "vigilance clearance" his name could not have figured in the panel of names under consideration for the post of CVC.

Since a 3-member committee makes the selection of an individual for CVC, it clearly means that there must be a consensus in the matter. It cannot be done through a system of voting in which the government has a clear 3-1 majority with PM, HM and Leader of Opposition in Lok Sabha as members. That the UPA government chose to ignore the

First of all please accept our congratulations for successful conclusion of 'Janata vandan - karyakarta abhinandan' - a unique programme organized in Madhya Pradesh. What do you think were the main features of this programme?

organization gained grounds by being in the government?

Organization is the mother of power and it should always strive to protect the power like a mother protects her child. The coordination which is seen in Madhya Pradesh should not only be emulated by BJP but also by other political parties.

What kind of works the organization expects from the government?

Pandit Deendayal Upadhyayji had said that until we are able to bring a smile on the face of the last man in the society our political mission will not be complete. I am feeling glad to say that all the plans and projects of BJP State government and chief minister Shri Shivraj Singh Chauhan are guided by the principles of antyodaya. Work for everyone and everyone for work is the guiding principle. Madhya Pradesh government has taken many historical decisions for women including women reservation. While on the one hand Madhya Pradesh government has become synonymous with the social security programmes, on the other hand Public Service Guarantee Act 2010 is widely acclaimed as a step to be emulated by others too.

You have almost completed six months as State president. What are the main steps you have taken? What influence do you see on government and party by actions like 'Shuchita Samkalp'?

We have covered 141 *mandals* within six months. There are 618 *mandals* in Madhya Pradesh. By the end of one year we will be able to reach around 300 *mandals*. Tribal and scheduled areas are my priorities. *Karyakartas* are feeling that not a party president but a common *karyakarta* is

reaching them. It is also an achievement that a karyakarta is able to meet another karyakarta. We have started membership campaigns in the areas in which BJP lost in the elections. We have organized *Annadata Sammelan* for farmers. "Save National Highway" campaign was launched in several places in the State on the same day. Central minister Kamalnath felt compelled to start highway works. BJP emerged as the voice of the victims of Bhopal gas tragedy which remained buried under the debris of history for a long time. BJP MLAs from the State sat on a dharna in Janatar Mantar in New Delhi protesting against the discriminatory approach of the UPA government against Madhya Pradesh. Chief minister Shri Shivraj Singh started "Vanavasi Samman Yatra". The State has tried to march ahead on the path of the politics of shuchita by keeping away from unnecessary and vulgar political showmanships. The different layers of the organization have been knit together in such a manner so that dialogue and tour takes place as normal ingredients of organizational activities.

You have become a State president after serving as national secretary in the organization. How do you feel working at state level after contributing on the national level politics?

We are *karykartas*. We have never become a karyakarta under anyone's pressure or influence. Inspired by nationalism we wanted to work for the organization. We became karykarta on our own. Therefore a habit to work in the organization as per organizational plan has always been there. I never gave a thought as to where I stood. I never thought over the work which was assigned to me. My concerns were always limited to the extent that I should keep working for the organization doing justice to the work assigned to me. Whether I was a national secretary or today I am a State president does not matter much - I was a karyakarta before, I am a karyakarta now and will remain a karyakarta as long I am alive. Therefore it doesn't matter where I am, wherever I am, I should be always in the organization – this is the only expectation.■

Delhi is now the official "Rape capital of India": Smriti Irani

In her letter to Delhi Chief Min ister Smt. Sheila Dikshit BJP Mahila Morcha National President Smt. Smiriti Irani on 24 November 2010 said the Indian capital awoke to an outrageous and preposterous crime. On March 17, 2004 a 59 year old Australian tourist was allegedly sexually assaulted and murdered by a taxi driver near IGI Airport, barely a couple of hours after She landed from Brisbane.

However the right to life enshrined in the constitution means something more than a mere survival or animal existence. It includes right to live with human dignity. he most heartening news I have read in a long, long time is the front page report in the Times of India on December 03, 2010 bearing caption "S.I.T. CLEARS MODI OF WILFULLY ALLOWING POST-GODHRA RIOTS - Finds No Substantial Evidence"

ver since the UPA-II as sumed office there has ■ been a legitimate apprehension in India and amongst the developing countries with regard to the dilution of India's conventional position in the climate change negotiations. The Minister for Environment, Shri Jairam Ramesh, has made a statement on the eve of the UN Climate Summit in Cancun. He has been quoted as suggesting -"We are certainly prepared to engage in a system of monitoring, review and erifications/international consultation and analysis (MRV/ ICA) of domestic climate actions which respects national sovereignty.... and we have suggested a set of operational guidelines on how this system will function."

On 7.12.2009 before leaving for Copenhagen the Environment Minister had clearly stated in the Parliament thus -

"The fourth non-negotiable is : Why we accept international scrutiny of supported actions? We will not accept the same level of international scrutiny and the same type of international scrutiny for the unsupported actions. So, wherever the world supports us in terms of finance and technology, they can come and verify what we are doing. But, where you are not supporting us - the bulk of our actions will be unsupported actions - we will not subject these actions to international scrutiny. However, we are in an open system. We are in a democratic system. We are account-

able to Parliament."

Notwithstanding this assurance to Parliament the Environment Minister at Copenhagen committed himself to a position in the accord which stated thus

"Non-Annexure-I parties will communicate information on the implementation of their actions through national communications, with provisions for international consultation and analysis under clearly defined guidelines that will ensure national sovereignty is respected."

Thus from a position of no international scrutiny for unsupported domestic actions which was categorically assured to the Indian parliament, the Minister committed India to international consultations and analysis.

Analysis would obviously involve a review of the targets achieved or not achieved.

He has now on the eve of the Cancun summit committed India to a position of being prepared to engage in a system of monitoring, review, verifications/international consultations and analysis of domestic climate actions. Slowly but surely the Minister has committed India to international verification of unsupported domestic actions. This was never India's position. This was never the position of the developing countries. Why has this change taken place? It is contrary to the parliamentary assurances. It is contrary to the mandate of the G-77 alliance which India has forged over the years with like minded countries. It is contrary to the elementary principles of equity where the developed countries pollute and India through unsupported domestic actions pays for environmental correction and those very steps are now subjected to international verification which gives them a binding character.

The Bharatiya Janata Party is seriously concerned with this deviation of India's national position on the eve of the Cancun summit. We urge the Prime Minister to personally intervene and prevent the Environment minister from deviating from our national position in favour of the developed countries.

- ▶ This was the first peaceful and incident free election in the history of Bihar. This was the cause why women could exercise their franchise in large number.
- All sections of society approved leadership of Sh. Nitish Kumar and Sh. Sushil Kumar Modi. All casts and even minorities voted positively for development. It was clean sweep of NDA in 19 out 38 districts. They are Arwal, Aurangabad, Buxar, East Champaran, West Champaran, Gopalganj, Jahanabad, Katihar, Lakhisarai, Munger, Nalanda, Nawada, Rohtas, Shivar, Shekh Pura, Sitamani, Siwan, Supol, Vaishali. Here Congress, RJD and LJP could not win even a single seat.

BJP Highlights:

- ▶ BJP gained 37 seats and JDU gained 27.
- ▶ BJP won 91 out of 102 seats contested giving a strike rate of 90%
- ▶ BJP has 16% lead in the seats won by the party. This is a huge margin.

Complete rout of RJD,LJP, Congress and Left parties:

RJD, LJP combine decreased their strength from 85 in 2005 to 25 seats in 2010. Their vote share went down for RJD down from 23.5 pc to 18.6 pc and LJP from 11.1 pc to 6.7 pc.

Lalu's wife Rabri Devi contesting on two seats lost both by a convincing

margin of votes. At Raghopur she was trounced by JD (U) and in Sonepur it was the BJP which had the best of her.

- Both the brother in laws of Lalu, one fighting as an
- independent and other as a congress nominee not even lost but, where relegated to insignificance of not worth even mention.
- ▶ Similarly, Paswan's two brother and equal number of son-in-laws lost these elections ending his any chance of even retaining a seat within the family out of the total 3 he won.
- ▶ Congress strength declined from 9 seats in 2005 to merely 4 seats in 2010.
- ▶ Congress could not manage to win any of the seats where Sonia and Rahul Gandhi campaigned.
- ▶ For the first time left parties CPI, CPI (M) and CPI (ML) fought these elections jointly and saw their worst of the performances in Bihar assembly elections history. Just a seat was won by CPI. No matter they come together it will all be their approach towards developmental issues which would matter finally.
- "Teghra" seat once known as Leningrad of Bihar and held by left parties for 48 years was breached and decimated by BJP candidate finally in these elections.

several important states like U.P., Bihar, Punjab, Haryana, and Delhi, the Congress had failed to get a single Lok Sabha seat.

Similarly last week, no one was surprised that the JD(U)- BJP alliance led by Nitish Kumar won hands down in the Bihar Assembly elections outcome last week.

But what amazed all was that even while the most optimistic assessments about the victory margin were that the NDA alliance would get a two third majority (Shekhar Gupta, a senior New Delhi editor, who was part of a high level news team which went around the State shortly before the last round of polling told me so), the final results were that the Nitish – Sushil combination secured 216 out of 243 seats, which meant 8/9th of the Assembly's total strength!

I hold that the good governance and development work that the NDA alliance gave to Bihar in the five years under Nitish Kumar secured for it a renewed mandate. But the real reason for the extraordinary victory won by us - with JD(U) winning 115 out of 141 seats it contested, and BJP winning 91 out of 102 seats it contested - was the preceding fifteen years of jungle raj.

During the poll campaign Congress speakers kept blaming Laloo and RJD for these 15 years, but the fact is that for a substantial part of this period, Congress was part of the RJD Government. It was the contrast actually experienced by the people between the RJD -Congress tenure and JD(U) -BJP tenure which conferred on the NDA such a wonderful landslide.



MP Public Service Guarantee Act is path-breaking

adhya Pradesh Public Service Guarantee Act / Lok Seva Adhiniyam 2010 framed and implemented by BJP Government in the state, is a step towards the realization of good governance, or Suraj, or Ramrajya. The act is first of its kind in India. Certainly, it will be helpful in curbing corruption, reducing red-tapism, simplifying procedures, and increasing accountability. Many countries, have taken initiatives to empower their citizens through 'Citizen's Charter' by raising their critical awareness of the quality of services, and at the same time to encourage those responsible for the delivery of such services to improve their standards of performance, to operate in a more transparent way and to be more responsive to the needs. But first time Idea of citizen's charter was converted into act in India by Madhya Pradesh Government. It was passed by Vidhan Sabha on July 30, 2010 and formally launched on October 9, 2010. The Act guarantees delivery of services to common people within a stipulated timeframe. Yet nine departments as energy, labour, PHD, revenue, urban administration, General administration, social justice SC/ST welfare, food and supply come under this act. These departments include the services like Birth Certificate, Caste Certificate, Domicile Certificate, Tap water supply connection, electricity connection, old age pension, BPL card, ration card, Khasra copies, Death Certificate etc. government is also planning to

include more and more departments and their services.

Procedure delay in providing services is one of the root cause of corruption is made by officials to attract illegal payment from service seeker. If the officer responsible for the service fails to provide the service in time, he will have to pay a fine. In case, citizens fail to get services on time, 'they could make an appeal to first and second appellate officers, who would give instructions to the officers concerned. If there is a delay, the officers would have to pay a fine of Rs 250 per day, with a maximum of Rs 5,000.' If first appellate officer fails to ensure delivery of services without valid reason, he, too, would have to pay a fine amounting minimum Rs 500 and maximum at Rs 5.000. There would be a fixed time as to how many days an officer is entitled keep a file. The service time will start from the time of receiving and acknowledging the application. The official concerned would have to either provide the service or reject the application mentioning the reason for rejection.

The applicant can file first appeal within 30 days of the time period. However, appellate authority will be free to accept the application later on if he is convinced that the appellant has valid reason for not filing the application in time.

The applicant can file second appeal within 90 days. If the second appellate authority is of the opinion that the designated officer without any reason failed to give service to

the applicant that he would be free to impose a fine of Rs 250 per day until the time the service is not provided by the officer. The money will go to the applicant as compensation.

The act will further strengthen and will add fllip to citizen friendlygovernance. It aims at bringing the fruits of governance to last man in the last row(Antyodaya) as being conceptualized by Pundit Deendayal Upadhayaya. Governance should be simple and non-intimidating but quite opposite is happening in India for which common people (Aam Adami) find it next to impossible in accessing government machinery administration. The act is departure from traditional mode of governance and is a revolutionary step towards people friendly administration. Due to non-accountability in delivery of public services to the people within stipulated time frame till now, the public or tax payers have been at mercy of colonial minded clerical babudom. It would empower the public to demand their right to have time bound services.

The act is historic and may pave the way for other states to follow suit. But real and tangible result will depend on the will of the respective government and political parties in those states. NDA government in Bihar is set to frame this type of public service guarantee act. The act also reflects the Madhya Pradesh Government led by Shri Shivraj Singh Chauhan concerns about the problem of masses.

CPI(M) killer gang hacks RSS Swayamsewak

BJP hartal in Palakkad & Malampuzha near total

Kerala BJP leaders including its former President Shri PK Krishnadas and Palakkad district president Shri Krishna Kumar were attacked by the police on December 02, 2010 during



a procession carrying the body of RSS Swayamsewak Ratheesh (24) who was hacked to death in a moving bus by a suspected CPI(M) killer gang at noon on December 01.

Clashes occurred between the police and BJP workers at various places. BJP functionaries including Shri Krishnadas, Shri Krishna Kumar and several district and local level leaders came

under attack from the police at Koottupatha, Palakkad, following which workers blocked National Highway 47. Shri Krishnadas said that the entire responsibility for December 01's untoward incidents in Palakkad district was with the police. Earlier in the day, he had alleged that Shri Ratheesh's murder and the brutal attack on the other *Swayamsewaks* were with the full knowledge of the district CPI (M) leadership.

Meanwhile, the hartal called by the Sangh and BJP workers in Palakkad and Malampuzha Assembly constituency areas and Chittur Taluk in the district on December 02 was total. Shops and other commercial establishments remained closed while public vehicles kept off the roads. 47 MoUs signed to generate 58,000 MW power

Madhya Pradesh Chief Minister Shri Shivraj Singh Chauhan has said that with a view to emerge as a power hub and to provide round-the-clock



power supply to the people of the State, MP has inked 47 MOUs to produce 58,000 MW of power in next few years.

Interacting with media persons Shri Chauhan said, "Though power generation in the State has doubled in the last seven years, the demand too has increased from 4,652 MW in 2002-03 to 7,786 MW in 2010-11 and to bridge this gap and emerge as a power hub in the country, the state has signed 47 MOUs to produce 58,000 MW of power in the next few years".

He said by the year 2013, Madhya Pradesh would supply 24-hours power to the people in the State. Referring to the state's industrialisation, he said due to special efforts being made by the State government, production has started in various units which were setup with an investment of nearly Rs 6,500 crore.

In this financial year, up to March 2011, units with an investment of nearly Rs 40,000 crore will start production in the State," Shri Chauhan said, adding earlier the State was known as a BIMARU state, but now it has become a developing state.


