## Check the growing menace of corruption

he people are today witnessing a government which is neck deep in corruption. Not only that the government has been found indulging in various acts of omissions and commissions it has also refused to take responsibility to act and set the system right. The Congress led UPA government at the centre has become synonymous with corruption closing its eyes to the rot that has crept in the system affecting the functioning of the government. The functioning of the government is afflicted by the patronage extended to criminally corrupt elements in the Congress party. A *majboor* Prime Minister wanted to hide this fact when he tried to shift the blame to his coalition partners citing his *majboori* while hiding the prevalent corrupt culture of the Congress.

The Congress led UPA was completely exposed in its first tenure when it chose to save its government through dubious means resorting to payoffs to the MPs and thus imperiling the parliamentary polity. The CWG loot, Adarsh society scam and 2G Spectrum scam are some of the huge scams hitherto witnessed by the people yet no effective and credible measures have been taken to nail the culprits. The Shunglu Committee report has now been published but the government has refused to budge even in the face of severe indictments of the likes of Shiela Dixit and Suresh Kalmadi. The government is seen hobnobbing with the culprits, scamsters and those who have looted the public money. Even Supreme Court had to intervene and pass severe strictures to pressurize the government to act. The episode related to appointment of PJ Thomas as CVC and his removal is a case in point. A minister of Delhi government stands indicted by the Lokayukta but he shamefully continues in the office under the open patronage of the chief minister. The chief minister of Delhi now herself stands indicted by the Shunglu Committee which was constituted by the Congress led UPA government itself but she prefers to cling to her position rather than abide by the moral standard in public life. Smt. Sonia Gandhi and Dr. Manmohan Singh continue to maintain studied silence on all these issues indirectly blessing all the wrongdoers while failing to control the rising prices and pushing the country to an era of misgovernance, corruption and loot of public funds.

The absence of any credible action on the part of Congress led UPA government is generating a lack of credibility of the entire political system. The people now cannot be fooled with the half hearted approach of the government mainly aimed to hoodwink the nation. The people have now started to see it as a ploy to mislead them. It is therefore the fast undertaken by Shri Anna Hazare has started to gain momentum and taking the shape of a movement. Shri Anna Hazare deserves accolades for having taken initiative on crucial issue of Jan Lokpal Bill and corruption. He should be congratulated and supported in his pious act. On the other hand every political party should now take note of the people's support to such initiatives and try to uphold the moral standards which the people expect of them so badly. The Indian ethos and tradition always celebrate high moral and ethical values in public life. The tradition of India worships the rishis and mahatmas, the kings have always been accorded secondary position in the society. We know the difference between tyagis and bhogis, so the Indian politics will always be guided by the high principles of moral values and ethics in public life. It is high time that effective and credible measures are initiated to check the growing menace of corruption.

# A developed Asom, free from infiltration is BJP's Asom Vision : Gadkari

'Asom of Our Dreams: Asom Vision 2025' document released by BJP National President, Shri Nitin Gadkari on 30 March 2011



som deserves better governance and BJP promises to give it while converting Asom into a developed state free from infiltration, said BIP National President Shri Nitin Gadkari on March 30. He was releasing a vision document for the State -' Asom of Our Dreams: Asom Vision 2025' - in Guwahati. "BJP has a track record of Good Governance and all the BJP or NDA ruled states in the country today are ahead on the count of several development parameters. "Many of our States like Gujarat, Chhattisgarh, and MP have bagged several awards for better quality of governance. ", asserted the BJP President while addressing function organised for the release of the vision document. Shri Gadkari, known for the success of Mumbai-Pune Expressway, also stressed the need for world-quality road network and establishing a lowcost Helicopter Connectivity


across the regions of the State mainly for promoting tourism. Shri Gadkari also criticized the Congress governments saying that funds allocated for North -East go into the coffers of politicians here and the people of Asam continue to starve of development. "While Asom continues to lag on all development indices, on the count of corruption, Gogoi govt's graph is always moving up". Shri Gadkari also stressed that the Vision Document provides for special economic incentives like tax holidays for those industrialists who desire to set up manufacturing units in the State.

Apart from autonomous universities dedicated to like disciplines Animal Husbandry, Petroleum Sciences and establishing a 'Rice Research Institute', the Vision Document also promises implementation of some schemes and programmes carried out successfully by the BJP governments. Prominent among these are the Soil Health Card scheme Gujarat, of procurement model of Karnataka, PDS system of Chhattisgarh, and environment friendly policies of Himachal

Pradesh. Among other things, this Vision document also speaks about greater impetus to food processing industries, developing cities as urban growth centres, incubation centres for promising entrepreneurs through industryuniversity tie up, constructing adequate number of rail-road bridges across Brahmaputra, introducing latest technologies like GPS, GIS, bio-metrics etc. for e-governance systems mainly to enhance delivery mechanisms and combat corruption. The vision document also talks of introducing metro and mono rail in metro cities like Guwahati, a Konkan railway type system for goods transport. Besides developing Sualkuchi as an ideal cooperative township of looms. The document also stresses the need for a Research and Development Institute for Muga and other local handloom. This 75-page document has 35 chapters. It also speaks of special schemes for tea tribes as well as other tribal communities in the State and setting up an independent Barak Board for development of Barak valley.

Present on this occasion were prominent Asom BJP

# Winds of change blowing in poll bound States

lection campaign in poll bound States started in full **⊿**swing as soon as Election Commission has announced the date of polling in five States-Assam, West Bengal, Tamil Nadu, Kerala Union Territory Puducherry. In West Bengal election is taking place in six phases. Elections in Tamil Nadu, Kerala and Union Territory of Puducherry will be held in only one phase. Election Commission has decided to hold the election in Assam in two phases in which one

phase of election has been completed on April 4, 2011. An estimated 75 per cent voters exercised their franchise in the first phase of the Assam assembly election, covering 62 of the 126 constituencies.

One special feature of these elections is voting right accorded to NRIs. For the first time, in accordance with the recent amendment to the RP Act, overseas Indian citizens have been enabled to be enrolled as voters and would be able to vote in person.

Main campaigners of different political parties are busy in poll bound States to canvass for their party candidates raising issue of corruption, price rise and local grievances of the people.

#### **Assam**

Assam has already entered into second Phase(April 11) of elections, First phase has been completed peacefully on April 4,2011. An electorate of 85,09,011, comprising 43,91,895 males and 41,17,116 females, will decide the fate of 485



candidates (447 males and 38 female).

The electorate will exercise their franchise in 11,264 polling stations. The contest in the State is triangular among BJP, AGP and Congress party. The ruling Congress though burdened with anti-incumbency, corruption, price rise is expecting to form the government for the third consecutive term with Prime Minister Manmohan Singh, UPA Chairperson Sonia Gandhi and Union Finance Minister Pranab

Mukherjee among others batting for its Chief Minister Gogoi by claiming his achievements during the last 10 years. For grabbing the votes of illegal Bangladeshi in the State the Congress party has been allegedly indulging in making their voter

identity cards and *rasan* cards through out its tenure.

The BJP has put in an aggressive campaign with its national leaders including BJP National President Shri Nitin Gadkari, Chairmen of BJP Parliament Party Shri L K Advani,

Leaders of Opposition in both Lok Sabha and Rajya Sabha Smt. Sushma Swaraj and Shri Arun Jaitley, former party National Presidents Shri M Venkaiah Naidu, Shri Rajnath Singh Gujarat Chief Minister Shri Narendra Modi and Jharkhand Chief Minister Shri Arjun Munda campaigning in the State.

BJP has been raising the issue of corruption particularly on the multi-crore funds diversion scam in North Cachar Hills, and alleged failure of the Congress to solve the issues of foreigners'





influx, flood, erosion and neglect of the weaker sections, particularly the tea tribe community.

#### West Bengal

In West Bengal elections will be held in six phases(First-April 18, second phase-April 23, third phase- 27 April, fourth phase -3rd May, fifth phase-7th May, sixth phase-10 May). Political situation in West Bengal indicates clearly that left front is on decline. Left front is facing tough challenges in the State. Earlier the front got defeated in Lok Sabha and municipal corporation elections. Congress and Trinamool Congress Party have forged alliance after a great difficulty to fight the assembly election. As per the agreement, Congress is fighting in 65 seats and TMC will fight 229. On the other side BJP has entered into seat adjustments with some smaller parties while contesting election on all 294 seats. The party is raising issue of naxalism, State backed tyranny of left parties, corruption, unemployment, bungling in voter lists etc.

#### Kerala

The election to thirteenth assembly in the State is slated to be held on 13 April 2011 to elect members from 140 constituencies in Kerala.



Election results will be released on 13 May 2011. There are two major alliances in Kerala. The U n i t e d Democratic Front - UDF is the coalition of parties led by the Indian National Congress. The Left Democratic

Front - LDF is the coalition of mainly the Communist parties, led by Communist Party of India (Marxist). The BJP is also contesting in the State and fielded candidates in 139 constituencies leaving one seat to their NDA alliance partner Janata Dal (United).

In the State the situation is slightly different as anti-incumbency mood leads to a change in the Government every five years with the UDF and the LDF alternately seizing power. Going by the State's electoral history, it is the UDF's turn to form the Government this time.

But Congress led coalition finds hard to win the election. The coalition has now been engulfed

ddressing a massive gathering of party Karyakartas and common people from across the state at Morabadi ground, in Ranchi (Jharkhand) on March 26 BJP National President Shri Nitin Gadkari vehemently criticised the Congress party for patronizing corruption and adopting wrong policies resulting in price rise of essential commodities. He said the Congress party was promoting corruption on a large-scale and was incapable of putting an end to the inflation affecting the masses.

Shri Gadkari said, "Congress is a cancer. All the cases of corruption like 2G scam, Commonwealth Games scam, Adarsh Housing, Devas-ISRO and others have the hidden support of Congress, while Manmohan Singh preferred to turn a blind eye to all this."

Criticizing Dr. Manmohan Singh, the BJP National President said, "The PM is again trying to downplay the issues by feigning ignorance."

Referring to Smt. Sonia Gandhi and her son Sh. Rahul, Shri Gadkari lashed out at the Congress, saying, "Shri Chidambaram and Shri Pranab Mukherjee cannot become Prime Minister by serving the party, as it is now a family property of the mother-son duo."

He said it is the BJP which gives due honour and reward to party *Karyakartas*, much to delight of thousands of workers, who clappd intermittantly and listened to Shri Gadkari with rapt attention. Citing example, Shri Nitin Gadkari also said that the BJP was the only political party that elected an ordinary worker its national president.

Shri Gadkari said BJP had trounced Congress in the recently-held Bihar elections by securing 91 out of 102 seats contested. Shri Gadkari added, "Now it is the turn of Uttar Pradesh and other states where Congress will be wiped out. Good governance and development is our mission and

the BJP aims not only to garner power but to use the same for social and economic change in the country".

He asked Jharkhand Chief Minister Shri Arjun Munda to prepare a development blueprint for the state, keeping in mind the next 10 years.

Addressing the gathering Chief Minister Shri Arjun Munda, accused the Congress led Central government of ignoring the state's long-standing demand of royalty on minerals, based on ad-valorem instead of the present tonnage.

Shri Munda also lambasted the Centre's step-motherly treatment towards Jharkhand as far as pending water resources projects were concerned. He said the 2,000MW NTPC project in North Karnpura, whose foundation stone was laid by former Prime Minister Shri Atal Bihari Vajpayee, was still pending with the UPA Government.

The Chief Minister said usually in coalition governments

Smt. Swaraj further said, "It is difficult to understand the relationship between UP and Central Government as some time they appear friends and sometimes foes". Addressing the rally BJP National Secretary Shri Varun Gandhi severely criticised the Mayawati Government and said that her name and corruption have become synonymous. He said, "While Mayawati was making all out efforts to benefit the rich in the state it has almost

crushed the poor on every



possible front".

He gave a clarion call to the *Karyakartas* to work for the welfare of the common people. He also said, "If we do not take pains for our supporters and work for the welfare of the common people then we can't fulfill the aspirations of the people".

# In 'Cricket diplomacy' Manmohan bowled a no ball, out for a duck

n March 30 they came to Mohali — Pakistan's Prime Minister Sved Yousuf Raza Gilani and India's Prime Minister Dr. Manmohan Singh. They could not conquer either the hearts of the spectators who had thronged the stadium for the India-Pakistan World Cup semi final nor of the people of India and Pakistan. This only because they were just two of the VVIP spectators who had come to play politics on the sidelines of the stadium though, for brief interregnums, they did also enjoy the fine and superb cricket played between two traditional rivals and great cricket giants.

There is no gainsaying the fact that Dr. Manmohan Singh's zeal and sentiment for dialogue is unyielding and, above all, a one-sided affair with Pakistan never reciprocating in the real sense with the same warmth of

feelings as does the Indian Prime Minister. To continue the dialogue with Pakistan has become an obsession with Dr. Singh who wishes to continue his courting come what may. With unabated regularity he goes on repeating that the dialogue must go even when Pakistan never keeps its word.

When did the exchange of views with Pakistan ever stop? Numerous attempts were made for peace during the last over 63 years. Meeting of minds followed the 1965 war. So did it after 1971 war. A new hope got kindled each time. But each time it ended up in smoke for India — Pakistan getting away with the fruits of dialogue and the empty basket falling in India's kitty. The Tashkent Declaration 1966 and the Shimla Agreement 1972 are dead letters today just parts of old history mocking at the proficiency of our diplomatic skills.

### No substitute for dialogue

At the same time it has to be admitted that there never is - and can never be - a substitute for dialogue. It must go on. But, at the same time, the other party too should return the compliment with the sane spirit and warmth. A one-sided affair is always a failure. It either ends in frustration and, at times, in a suicide. As it is today, Pakistan has been getting away with the booty and false hopes to the share of India. If the channels of communication have to be kept alive, Pakistan has to return the gesture and be genuinely honest.

In fact, by taking the initiative to invite both Pakistan President Asif Zardari and Prime Minister Sved Yousuf Raza Gilani to witness the semifinal Dr. Manmohan Singh tried to hit two birds with one stone: to make yet another attempt to engage Pakistan in unending dialogue process and, as some reports suggest and some people feel, to divert the attention of the people from the perennial embarrassment UPA was encountering because of innumerable scams government is neck deep and the uncharitable comments it had to swallow in different courts on its acts of commission and omission in dealing with various cases of corruption.

#### "Cricket diplomacy"

without any tangible result. Pakistan government has not as yet given even the faint hope that it sincerely and honestly means business to generate friendly relations by curbing terrorism and doing something concrete not to allow Pakistani soil to be used for the perpetration of terrorist crimes against India.

#### **Breaking news sensation**

Aided and abetted by the media with insatiable hunger for sensational 'breaking news', a balloon was propped high in the sky heightening hopes around the two VVIP spectators. It looked as if the talks would burst into showering miracles all over the two countries. They tried to shift the focus from the cricket match on the ground between the two teams to the VVIP gallery occupied by the two prime ministers of neighbouring April 16-30, 2011 Q 15

everybody concurred.

Cricket - and for that matter, any sport – has nothing in common with diplomacy and politics. Α spirit sportsmanship and camaraderie reigns supreme in any game or sport. Diplomacy is poorer by the absence of this spirit. Honesty and transparency, the strong points of any sport, are out of place in the game of one upmanship in diplomacy table. In sport one means what one speaks or does; in diplomacy one does not mean what one speaks and does not speak what one means. It was, therefore, nothing short of a vain attempt at venturing to fight untruth with the weapon of lies.

It is true that playing sports matches between two nations does generate a spirit of sportsmanship and greater affection and understanding between the two, but these certainly do nothing to influence the attitude of the two governments. Recall the goodwill and the friendly gestures of the Pakistani visitors to India to witness the cricket semi-final, but these were not matched by the government of Pakistan.

#### 'Ping Pong diplomacy'

Perhaps for the first time when sports came to the rescue of two countries at loggerheads to open up was in China. While in Japan as part of a world tour, members of the US team and its Chinese counterpart exchanged informal greetings and small gifts. As a result, the Chinese team invited the US table tennis team to visit China. They went to China in April 1971. It was for the first time that any American team visited the mainland China by allowing the US ping-pong team. That was the starting point of the opening up of relations between the two warring nations. This came to be known as "ping-pong diplomacy."

But no sport has ever proved to be a panacea for the ills that plague the relations between two countries, much less the type of fierce troubles we have with Pakistan. If sports were to pave the way for good relations between strife-torn countries, nations would have just went in for sports matches instead of any diplomatic contacts.

And that happened too with both India and Pakistan. The media bubble burst much before the people expected. As the two prime ministers were spending their time watching India-Pakistan cricket semi-final at Mohali, Indian and Pakistani



officials were bickering over detention of their respective staff in their diplomatic missions in India and Pakistan The news was kept a secret till the next day when the festivities over India's win were at their pitch. That, in short, was the immediate outcome of the much hyped 'cricket diplomacy'.

Although an agenda for the meeting had been thrashed out, yet there was no formal joint statement or a joint press conference to give details of the outcome.

#### Victory for cricket

Pakistani PM Gilani said: "It is not about winning or losing but it is a victory for the game of cricket." He stood up, clapped in appreciation of the outcome and called it a good game. He said the talks were wide-ranging and covered all issues, including Kashmir.

Summing up the outcome, India's foreign secretary Mrs. Nirupama Rao said: "The meeting was held against the backdrop of a sporting contact which epitomizes people-topeople exchanges and the spirit of a good and constructive game. The meeting was truly cricket in nature," and added that terrorism was among the issues discussed. BJP President Shri Nitin Gadkari had already cautioned the nation not to expect too much from the much hyped 'cricket diplomacy' going by the non-cooperative attitude of Pakistan towards resolving problems between the two countries. And that happened. Dr. Manmohan Singh went to Mohali empty-handed and he returned empty-handed.

#### NDA leaders meet Prime Minister

#### **Demand Special category Status to Bihar**

Press statement by NDA Leaders on grant of special category status to Bihar on 25 March 2011

delegation of NDA leaders led by NDA convenor Shri Sharad Yadav, MP called upon Prime Minister Manmohan Singh demanding Special category Status to the state of Bihar. The delegation comprised of Bihar BJP State President Dr. C P Thakur MP, former Chief Minister of Bihar Shri Ram Sunder Das MP, BJP National Spokespersons Shri Shahnawaz Hussain MP and Shri Rajiv Pratap Rudy MP, Dr Ranjan Prasad Yadav MP and Shri Ramchandra Prasad Singh MP.

Bihar has been at the lowest ranking in respect of almost all social and development indicators. This situation has been due to various historical and geographical factors. The central government has provided special category status to various states in North-East, Jammu and Kashmir, Himachal Pradesh and Uttrakhand which has helped these states in attracting private investment and augmenting their financial resources to undertake development in their respective states. Bihar's situation has been worse as compared to the currently designated "Special Category" states in terms of various social and development indicators.

A comprehensive document titled "Special Category Status – A Case of Bihar" was forwarded by Chief Minister of Bihar to Hon.

Prime Minister on 23rd May, 2009. State Legislative Council, Bihar also passed a resolution on 31st March, 2010 demanding a special category status for Bihar so that the State can graduate to the category of high income states. The resolution was forwarded to the Hon. Prime Minister by the Chief Minister. Unfortunately, no action has been taken by the Central government yet.

The State of Bihar qualifies on all of the criteria of considering a state as in the special category. Poor infrastructure, poor resources base, remoteness to larger markets, geographical isolation, inaccessible terrain and financial viability are some of the criteria used by the Planning Commission and Union Ministry of Commerce and Industry which Bihar is found to be equally qualified. Keeping in view Bihar's economic backwardness and development deficit and Bihar meeting all criteria, the delegation demanded from Hon Prime Minister that Bihar be granted "Special Category" status immediately which will help Bihar in attracting private investment due to tax and duty concessions granted to such states and augmentation of financial resources for meeting development deficit. The delegation informed the Prime Minister that this is required for both inclusive development and political stability of the country.■



### It was not organisation of Commonwealth Games but sheer 'Loot of Common Wealth': Ravi Shankar Prasad

he Fifth report of the High Level Committee (HLC) headed by Mr. V K Shunglu, once again confirms that there were gross acts of omission and commission. which facilitated undue gains to the contractors, leading to wasteful expenditure, which contributed to overall loss to the Government. The Report specifically mentions that "the malaise runs deep and cannot be dismissed as a "one off" aberration for which relatively junior functionaries alone can be held responsible. Officers of the Organisation concerned, who were involved, would have to be identified on the basis of further investigation and suitable action be taken". The BJP would like to ask the Prime Minister to tell the nation as to what action he proposes to take against those involved and at what level.

The report of the committee has pointed out glaring irregularities in award of contracts and tenders, poor oversight and deliberate lack of monitoring, which led not only to undue advantage to few in contracts but also collusive bidding, hasty decisions, cost escalation and wasteful expenditure. The total loss was Rs. 1600 Crores in Stadium projects and the cost of delays alone amounted to Rs. 800 Crores. In all this apart from the Delhi Government, DDA, CPWD, NDMC, PWD bodies are involved. The committee has

already earlier stated that the Chief Minister Smt. Sheila Dixit concentrated all the financial power in her hand while the organising committee headed by Mr. Kalmadi indulge in reckless acts of corruption and financial mismanagement causing severe loss of the taxpayers' money.

From the Analysis and Conclusion of the Report it is apparent that there was a conspiracy from the very beginning to cause deliberate delay in the conclusion of the project in time, escalate the cost, seek more fund and award contracts at very high cost because of the short time span available. This would be evident from the fact that the organising committee awarded only 47 out of 542 contracts in between Oct. 2006 and Dec. 2009 (4 years) and

when there was no time left it was forced to award 495 contracts in just 9 months i.e. January to September 2010. In fact, the highest numbers of contracts were awarded in September 2010 while 75 contracts were awarded in Oct. 2010 when the games were to start in November 2010. Therefore the committee has noted that the budget was revised at will and in almost all projects significant cost escalation has been observed. The committee has noted "it appears as if to economise was criminal and to splurge was civil".

Apart from the role of the Delhi Government the Central Government exercises direct supervision and control over many bodies involved in the Games organisation like the CPWD and DDA, which comes under Ministry of Urban Development. As far as, sanction of additional funds are concerned the same was done by high powered committee having many officers of the PMO as well. Now when the Shunglu committee in its report has said other senior officers who were involved should be identified on the basis of further investigation and suitable action be taken against them; then the BJP would like to ask the Prime Minister would he allow fair and transparent investigation into the role of those who supervised, monitored, (Obviously, in the most disastrous manner) and

## Assam also has the most corrupt government: Arun Jaitley

'The popularity of the Congress-led governments in both the Centre and Assam has been declining fast'

Leader of the Opposition in the Rajya Sabha, Shri Arun Jaitley in his election campaign in Assam claimed that the ruling Congress in Assam



was facing double anti-incumbency factor and there was a clamour for change in the State. The popularity of the Congress-led governments in both the Centre and Assam had been declining fast because of massive corruption, price rise, and inflation, he said.

Shri Jaitley said that the Congress failed to get a majority in the 2006 assembly election in Assam and had to form a government in coalition. But this time, the number of seats of the ruling party would further decrease as a strong wave of change was blowing.

Stating that a strong BJP was necessary to defeat the Congress in Assam, Shri Jaitley said that this was what his party was trying to achieve — expanding its base and increasing the number of seats.

He alleged that the Congress was resorting to ugly and vulgar demonstration of wealth. All the money flowed from scams in the Dima Hasao Autonomous Council (erstwhile North Cachar Hills) and was amassed through corrupt means.

Shri Jaitley alleged that the Congress-led government at the Centre had only two identities- that of a most corrupt government and that of price hike and inflation.

"Assam also has the most corrupt government," he alleged.

The Congress had only two options to win the election — using money power and resorting to vote bank politics. ■

#### Arun Jaitley questions credibility of CBI chargesheet in 2G scam case

Leader of Opposition in Rajya Sabha Shri Arun Jaitley during his election campaign in Tamilnadu on April 3 questioned the credibility of the chargesheet filed by the Central Bureau of Investigation (CBI) in the 2G spectrum allocation scam case . He said the report omitted core issues, making no mention of the loss the scam caused to the exchequer. He alleged that the probe timetable was influenced by Tamil Nadu Assembly polls, scheduled on April 13. "The chargesheet has left out the core issues. The issue of loss to the exchequer on account of allotting spectrum at 2001 price in 2008 has not been significantly dealt with," Shri Jaitley said. He said the investigative agency should have abstained from acting on political considerations as there were serious allegations of favour shown to former telecom minister A. Raja's party, the DMK. "I think CBI has bent backwards a little bit. They repeatedly said the prime minister was defied or misled. I don't think the charge-sheet should give a political clean chit to anybody. It should deal with criminality," Shri Jaitley said.





### Congress cheated Assam people : Gadkari

BJP president Nitin Gadkari in his poll campaign in Assam accused the Congress of betraying the people of Assam by claiming to have established the petroleum institute in Sivasagar when it was being set up at Rae Bareli, the constituency of Congress president and UPA chairperson Sonia Gandhi. He was addressing a huge gathering in Naharkatia. Referring the Rajiv Gandhi Petroleum Institute at Sivasagar whose foundation stone was laid by Prime Minister Manmohan Singh last month, Shri Gadkari said, "Information provided to us by government sources reveals that the main institute is being set up at Rae Bareli and what Assam is getting in the name of petroleum institute is peanuts.

This is total injustice to the people of the state, which produces so much crude oil and natural gas. Shri Gadkari promised that if voted to power, the BJP would ensure that Assam had a proper petroleum institute. "We will also see that the students in the state have enough engineering and medical colleges. We will build international standard schools in the government sector," he announced referring the instances of Gujarat and Bihar where party has been ruling. In an obvious attempt to woo the electorates he went on saying, "We will provide free tractors and other modern farming equipment. We will ensure round-the-year irrigation to the fields, we will provide seeds and whatever assistance is required for growth of agricultural output of the state." Shri Gadkari said if his party comes to power in the state, it will increase the daily wages of the tea garden workers to `100.

## Root out corruption at all levels of government : Advani

BJP Parliamentary party chairman Shri L. K. Advani along with NDA Convenor and President of JD (U) Sharad Yadav arrived for a public meeting in Dibrugarh District on march 31st.

Giving a call for a "war" against corruption, Shri L K Advani said the menace has engulfed the UPA at the Centre and the Congress-ruled Assam. "Corruption has become a deep-rooted problem which has engulfed the UPA-led government at the Centre. People should be ready for a 'war' (war) to root out corruption from all levels of the government," he said. He was addressing an election rally in the tea—tribe dominated Melamara in the Golaghat Assembly constituency. At another rally at Balipara in the Rangapara seat in Sonitpur district, Shri Advani said, "The price rise in the country is not due to economic mismanagement, but due to corruption and dishonesty of the Congress at the Centre and Assam.

"Our NDA is not in power at the Centre now. I can say with pride that the situation is much better in all states where we are in power," Shri Advani claimed. At the state level, sectors like health, education and employment were facing various problems, he said. "These three sectors have been neglected particularly in remote areas," Shri Advani said.

sanctioned extra funds in a very hurried manner in top level bodies including those in the PMO.

This is the least the country expects from the Prime Minister because he set up this committee and promised follow up action as per the report. Now, Smt. Sheila Dixit, Delhi CM has openly questioned the report and in effect the Prime Minister. The BJP demands that all those responsible regardless of their stature or, the level from which they operated must be brought to book in a fair investigation. This is very important in view of the clear finding of the committee "that there was a method in the madness and the undue delay on projects was perhaps a deliberate attempt at higher levels to create a sense of panic with a view to giving undue advantage to all concerned." Who are those sitting at higher levels are required to be identified and they must be suitably punished, the BJP demands.

The Prime Minister has already messed up the 2G Scam and the corruption relating to black money. But for strong Parliamentary pressure as well in the media and the intervention by the Court, the full dimension of corruption would have been allowed to remain under cover. Till date Mr Suresh Kalmadi has not been arrested and the Delhi Chief Minister who has a lot to answer is questioning the report itself. If the Prime Minister again maintains a conspicuous silence then it would be the final confirmation of his patronage of the corrupt.■



## Congress economic policies wrong: Rajnath

ddressing rally Thowra in Assam on March 29 former BJP President Shri Rajnath Singh alleged that the economic policies of the Congress were "very wrong and not suited to the needs of the people" and this mainly



responsible for inflation and subsequent miseries of the people. "The Congress was in power for majority of the 63 years (after Independence) but failed to provide the people with their basic needs and solve the myriad problems being faced by them", Shri Singh told a campaign rally organised here for BJP candidate Sibu Prasad Bodsa. "In Madhya Pradesh, the BJP government gives 26 kgs of rice for Rs three per month to BPL families and if we come to power, we will adopt the same policy in Assam", he added. The former BJP President also addressed campaign rallies at Bokakhat and Sarupathar for party candidates Deba Pradip Bora and Dinesh Bhilwaria respectively.■

Modi raises issues of Bangladeshi infiltration & insurgency in Assam

ujarat Chief Minister Shri Narendra Modi during his election campaign in Assam raised the issue of illegal infiltration by Bangladeshi. Addressing rallies in Naoboicha and Dhemaji said, Illegal infiltration by Bangladeshis had created "havoc" in Assam and neither the Congress nor Asom Gana Parishad governments has



made any effort to stop the influx."Gujarat has borders with Pakistan while Assam has with Bangladesh. In my state Pakistanis have not been able to create any problem, but in Assam Bangladeshis have created havoc, he said. "BJP will never allow Assam to become a Bangladesh controlled state ... The party is committed to resolving the issue of Bangladeshi migrants and the problem can be solved only if the party comes to power, he further added"

Referring to insurgency in Assam, Shri Modi said there has been no progress on peace talks and the Congress government is not at all serious about solving the problem. "BJP is very serious on this issue and will strive to find a permanent solution to the problem once and for all," he said. Shri Modi lamented that Assam with its mineral resources of coal and oil, was comparable to the Arab world but it had not been properly utilised and the people had not benefited at all.

"In Gujarat we have natural gas pipelines in villages and there is possibility of the same. But the Congress government has not taken any initiative in this regard," he added. ■

### Shunglu committee report tears UPA apart

The high-level Committee headed by former Comptroller and Auditor General (CAG) Shri VK Shunglu, appointed by the Prime Minister Dr. Manmohan Singh on October 25 last year to probe into charges of massive corruption in various projects related to the Commonwealth Games 2010, has submitted its first report on 31st January 2011.

As per the reports the OC chairperson who also happens to be a Congress MP, other members of the OC, Delhi Chief Minister, the Union Sports Ministry, Delhi Lt. Governor many Congress men and in some cases the higher echelons of the Congress led Union and State Government were directly or indirectly involved in corruption. These revelations have not only stunned the nation but have also torn the moral fabric of the Congress party apart by exposing its hypocrisy in fighting corruption.

India won the bid to host the CWG in Delhi, in November 2003, and it took 16 months for the UPA government to put in place the Commonwealth Games Organizing Committee

and the 35-member committee included Rahul Gandhi, Kapil Sibal, Jyotiraditya Scindia, Ajay Makan, Jitin Prasad and Sandeep Dikshit among others.

The first story about malpractices and rampant corruption in Commonwealth Games came to light on July 30, 2010 when the issue of payments to UK-based AM Films with no written contract agreement came to light. The Commonwealth Games Organizing Committee is alleged to have paid AM Films (an Indian-owned firm in London), over 450,000 pounds (over Rs.30 million) for services during Queen's Baton Relay inaugural without proper tendering and paperwork. Following this a large number of scams related to the execution of CWG have been unearthed and the Organizing Committee head Suresh Kalmadi's role has been under suspicion.

Right before the Commonwealth Games, charges of wrongdoings, corruption, favoritism, malpractices, organised loot of public money and cost and time overruns came to public domain. Rampant corruption was found in the

award of tenders for different projects of the games including the stadium and other infrastructure and for granting of contracts in hiring or purchase of equipment such as air conditioners, treadmills and even toilet papers. callousness and insensitivity of the government agencies and sports bodies in unabashedly wasting the taxpayer's money resulted in the games budget, initially billed at Rs. 2000 crores, shooting up to a whopping Rs. 70,000 crores.

Virtually every company hired to provide services or equipment for the games was paid exorbitant amounts for their services and contracts were often handed out to companies that were ineligible. Several of Kalmadi's close associates from the Organizing Committee were found involved in the CWG scam.

After these misdeeds came to the limelight, owing to commendable works of the media and the Opposition parties, the Prime Minister was left with no alternative but to institute an inquiry by the former CAG Shri V. K. Shunglu.



The first report of the Shunglu committee was on the irregularities related to the broadcasting rights. The second report is on the Games village and the third report relates to the City infrastructure, and other three reports are on Commonwealth Games Organising Committee, Games venues-related matters and Games organisation.

The first report unveils the huge irregularities in awarding broadcasting rights during the sporting extravaganza and recommended strict action against suspended Chief Executive Officer of Prasar Bharti B S Lalli and former Director General (Door darshan) Aruna Sharma under relevant Sections of IPC and Prevention of Corruption Act for their alleged acts of omission commission. The initial report has indicted Lalli and the other officials for allegedly causing Rs.135 crore loss to the government exchequer in awarding to the British firm the broadcasting rights for the Commonwealth Games.

The high-powered committee has further slammed sacked Commonwealth Games Organising Committee (OC) chief Suresh Kalmadi for being the leader of a "sham OC with much lesser accountability and transparency". The panel, strongly blamed Kalmadi and his coterie for bringing shame to the nation for **CWG** mismanagement. It also came out with yet another 103-page report questioning his appointment. The report further said, "The documents reviewed for Kalmadi's appointment were not without tampering and undue April 16-30, 2011 O 22

changes". "We have found material changes in official documents by Kalmadi to get the post of OC chief and also to have sweeping administrative control over it," the report says. The report goes on to add that, "We have therefore no hesitation in coming to the conclusion that a document (relating to the appointment of OC chairman) was created by Kalmadi or at his behest in the IOA for being specifically used to secure his including ends, chairmanship of OC and justification for the commitments made by him at Montego Bay without any authority", citing instances of Kalmadi's approach to get the key post.

"It would also be pertinent to mention that all attempts made by the ministry of sports to open a dialogue with Kalmadi between November 2003 and September 2004 on the action to be taken for CWG 2010 were unsuccessful because Kalmadi was unwilling to open negotiations till he was assured of OC chairmanship," the report points out.

Questioning the OC's constitution, it says that on February 10, 2005, Kalmadi got a society named OC registered under the Societies Registration Act, 1860. This society, its memorandum, rules, executive board and membership should have been approved by the Group of Ministers. But no such approval was taken.

It also takes a dig at the manner in which the government accepted, without due consideration, the Host City Contract to organise the sporting extravaganza in the Capital.

Such was the mess in

organising the Games till the last minute that a committee of secretaries (CoS) headed by the cabinet secretary too was "unable to get the agencies to complete the works in time. It is also observed that incorrect lack reporting and coordination at the lower levels prevented the CoS from taking corrective action at stages earlier than they actually did. Early warnings were ignored by the implementing agencies". The Committee also held Kalmadi responsible for appointing his close associates inexperienced staff in the OC for individual gains.

The panel submitted two independent reports - one on the Games Village and the other on city's infrastructure development for the sports event, which nails the role of Delhi government, its agencies and central agencies.

In its other reports the Shunglu committee found procedural violations by Delhi Lt Governor Tejinder Khanna and Delhi Chief Minister Sheila Dikshit for scam involving 2010 Commonwealth Games.

Details of the Second Report also have held the Delhi government and particularly Delhi Chief Minister responsible for delaying the works leading to "collusive/partial bidding" and "manipulation of documents."

The report has questioned the role of Delhi Chief Minister Sheila Dikshit in the construction of the Barapullah elevated road, the Ring Road bypass, bus shelters, city beautification; tourist infrastructure (sanctioned in the name of Games) street-scaping, street-



lighting, signage projects on the grounds of poor oversight and losses due to faulty tendering and cost overruns. In the third report it has dealt with the defective street-scaping - at times where none was needed and incomplete work in other instances - along with poor signage which led to substantive losses. Losses in the three projects add up to around Rs 200 crore. The flyover adjoining the Games Village just

past the bridge across Yamuna was built in the face of objections of the Public Works Department and the Delhi Police who found it unnecessary. In this case, the DDA and Delhi government are in the dock. It says that the Delhi Government was responsible for a loss of 60 crore rupees, that tender norms were violated in procurement of bulbs for street lights during the CWG directly pointing fingers at Delhi CM Sheila Dixit.

The Shunglu
Committee, probing corruption
in organising the
Commonwealth Games (CWG),
has in its second report indicted
Delhi Lieutenant Governor (LG)
Tejender Khanna, along with
some top officials of the Delhi
Development Authority (DDA)
and private developer Emaar
MGF.

The committee clearly stated, "It is a shame that the people occupying constitutional posts are involved in it (CWG Scam). He raised question on how LT Governor Tejinder Khanna being ex-offico chairman of Delhi Development Authority offered bailout package for Games village April 16-30, 2011 Q 23

developer Emmar MGF. The Committee states that there was also a discrepancy with the tender requirements.

The Committee also indicts Delhi Lt. Governor Tejender Khanna for causing a loss of more than 260 crores during the Commonwealth Games. The committee has blamed Lt. Khanna for neglect and his decision to give a bailout package of around Rs 730 crore



to MGF and fixed the overall loss for development of CWG Village flats to 222 crores.

The panel has indicted Emaar MGF, the company which built the CWG Village, for causing losses to the exchequer. 33 flats at the village were sold at a higher price, which hiked the overall price from Rs 134 crore to Rs 222 crore. The report further states that the corruption and the delays led to a loss of Rs 220 crore to the exchequer. It says that unauthorized payments were made to Emaar MGF and that at least Rs 64 crore was paid contrary to the project development agreement. The carriage cost of unsold

apartments has been pegged at Rs 35 crore per annum.

In its concluding remarks the report said the cost of construction and purchase of equipment etc. has been largely overshot. The Planning Commission, Ministry of Urban Development and the Ministry of Sports had approved the costs. Large builders have been kept out almost on a planned way, thus leading to collusive bidding.

The Fifth report of the Committee, once again confirms that there were gross acts of omission and commission, which facilitated undue gains to the contractors, leading to wasteful expenditure and which contributed to overall loss to the Government. The report of the committee has pointed out glaring irregularities in award of contracts and tenders, poor oversight and deliberate lack of monitoring, which led not only to undue advantage to few in

contracts but also collusive bidding, hasty decisions, cost escalation and wasteful expenditure. The total loss was Rs. 1600 Crores in Stadium projects and the cost of delays alone amounted to Rs. 800 Crores.

In all, apart from the Delhi Government the DDA, CPWD, NDMC and PWD are also found to be involved in these irregularities. The committee has found that the Chief Minister Smt. Sheila Dixit concentrated all the financial power in her hand while the organising committee headed by Kalmadi indulged in reckless acts of corruption and financial mismanagement



causing severe loss of the taxpayers' money.

The Shunglu committee, whose detailed and well documented reports have sparked off a deep unease in the government, pointed out that "The Jaipal Reddy-headed GoM set up to oversee the Games had failed to deliver. Pointing out that a little over Rs 28,000 crore was spent on organizing the Games, which was a "galactic jump" from Rs 300-400 crore estimated in April-May 2003 and reiterated by Kalmadi in August 2003 prior to the Cabinet approval in September 2003", the committee said that at no stage was an overall Budget prepared by the Sports Ministry or required by the finance ministry or Cabinet.

Reacting to the report the Prime Minister Dr. Manmohan Singh said he has taken a "serious view" on the report of the Shunglu Committee which has found irregularities in the award of broadcasting rights for the Commonwealth Games and will take "stern action" on it. But on the other hand, within hours of leaks through the media of observations of the panel's second and third reports, Delhi Chief Minister Smt. Shila Dikshit trashed the report as "totally unfair, inconsistent and as not based on facts", living up to the tradition of double-speak followed by the Congress Party since its inception.

The magnitude of the CWG scams is such that even agencies and departments under the Congress led UPA government could not push them under the carpet. There are no two views about the fact that these scams are of serious nature and the truth in black and white is before

the nation. Congress party and its leadership not only stand exposed, but it is also disarmed by the fact that the findings cannot be dubbed as propaganda of the Opposition party anymore to evade public ire. They are real and the nation will not tolerate the shielding of the criminals involved in this organised monumental corruption.

But surprisingly, even after the unearthing of so many scams, leaders Congress are unabashedly talking of "ZERO TOLERANCE CORRUPTION". We have every reason to believe that these scams are not just systemic failures much less any kind of just aberrations. These scams are some kind of a planned loot of public money. This is nothing but an attempt to subvert the system to suit personal designs.

With corruption reaching a point of inflexion, the nation is interested in knowing only one thing and that is whether the Congress led UPA government is sincere about fighting corruption? If the government is sincere, why is it shying away from taking action against the people charged with corruption and nepotism? Why the government is dithering to fight corruption head on? Starting from Suresh Kalmadi to Shiela Dixit, why all those guilty have escaped punishment? These are not just episodes of corruption. These are also examples of how successive Congress governments have ditched the people who elected them to protect their interests.

It is high time the nexus between the partners in the Commonwealth Games loot and those providing them political patronage by condoning this mess are exposed. People of India have a solemn constitutional right to know who the real culprits of this national shame are. The truth must prevail and shall prevail only if a comprehensive inquiry is conducted and the guilty are brought to book.

### Dr. BR Ambedkar: A visionary leader

s the nation celebrates 120th birth anniversary of Dr. Babasaheb Bhimrao Ambedkar on 14 April 2011 the people remember him as chief architect of the Indian constitution, a social

revolutionary and a Dalit Babasaheb thinker. represents a multifaceted personality contributing immensely to enrich various facets of national life. Apart from earning a number of doctorates from prestigious Columbia University and the London School of Economics for his study and research in law, economics and political science he wrote fearlessly on various issues as an academician and as a political activist. His writings may be broadly divided into various parts, viz. the writings of a political activist, an academician, a

nationalist, a spiritual leader and so on. As a political activist and as a mass leader, Babasaheb was raising issues far ahead of his times, hence a radical approach was required to galvanise support for his agenda of social reform so as to bring the issue of caste discrimination and untouchability in the central focus. While as an academician he tried to frame scholarly and well researched responses on the burning issues of the day which remain relevant even today.

Babasaheb was born on 14 April 1891, in a Mahar family then staying at Mhow, now in Madhya Pradesh. His family originally hailed from the town of Ambavade in the Ratnagiri district of modern-day Maharashtra. As a school going child he had to face various kinds of discrimination owing



to low status of Mahars in the caste hierarchy but he remained undeterred in his resolve to pursue higher education. As a student from Elphinston College he was granted a scholarship of twenty five rupees a month from the Gaikwad ruler of Baroda, Sahyaji Rao III for higher studies in the USA. He went to USA for his doctoral studies and obtained degrees in economics and political science. On his return he joined service of Baroda state government and also started as a social activist fighting against caste discrimination and

untouchability then widely prevalent in Indian society. His activism and scholarly espousal of the cause of the deprived and oppressed sections soon saw him emerging as a political leader of national stature.

far Babasaheb writings in India have been selectively read within a particular framework showing him a champion of deprived and oppressed sections of Indian society. He is seen as a chief architect of Indian constitution who laid the foundation of liberal democracy in the country expecting the state to take welfare measures in the interest of weaker sections of the society. But other side of his personality remains unexplored. academician and thinker in him, his advocacy for exchange of population at the

time of partition, his concerns for preserving cultural contours of Indian civilization, his decision to embrace Buddhism not only as a political act but as a result of a honest spiritual quest, his rejection of Islam, Christianity and Marxism and his reading of India's past – and many more such other dimensions of Babasaheb's personality still awaits to be studied, researched and explored.

Speaking on the third reading of the draft constitution Babasheb said in voice choked with emotion, "On 26th January 1950. India will be an

independent country (Cheers). What would happen to her independence? Will she maintain her independence or will she loose it again? This is the first thought that comes to my mind. It is not that India was never an independent country. The point is that she once lost the independence she had. Will she lose it a second time?"

He further answers his own question emphasizing that these apprehensions were rooted in the history of India wherein the country had to face the ignominy of defeat and suffer at the hands of conquerors due to treachery of its own people. He said on the occasion, "What perturbs me greatly is the fact that not only India has once before lost her Independence, but she lost it by the infidelity and treachery of some of her own people. In the Invasion of Sind by Mahommed-Bin-Kasim, the military commanders of King Dahar accepted bribes from the agents of Mahommed-Bin-Kasim and refused to fight on the side of their King. It was Jaichand who invited Mahommed Ghori to invade India and fight against Prithvi Raj and promised him the help of himself and the Solanki kings. When Shivaji was fighting for the liberation of Hindus, the other Maratha noblemen and the Rajput kings were fighting the battle on the side of Moghul Emperors. When the British were trying to destroy the Sikh Rulers, Gulab Singh, their principal commander sat silent and did not help to save the Sikh kingdom. In 1857, when a large part of India had declared a war of independence against the British, the Sikhs stood and watched the event as silent April 16-30, 2011 Q 26

spectators."

On the question of India embracing democratic form of the government and whether the democratic Constitution will survive the test of time and whether India will be able to maintain it or will lose it again, he had very convincing answers. He said, "It is not that India did not know what is Democracy. There was a time when India was studded with republics and where there were monarchies. They were either elected or limited. They were never absolute. It is not that India did not know Parliaments or Parliamentary Procedure. A study of the Buddhist Bhikshu Sanghas discloses that not only there were parliaments - for the Sanghas were nothing but Parliaments - but the Sanghas knew and observed all the rules of Parliamentary Procedure known to modern times. They had rules regarding seating arrangements, rules regarding Motions, Resolutions, Quorum, Whip, Counting of votes, voting by Ballot, Censure Motion, Regularization, Res Judicata, etc. Although these rules Parliamentary Procedure were applied by the Buddha to the meetings of the Sanghas, he must have borrowed them from the rules of the political Assemblies functioning in the country in his time."

Envisioning the divisions that may be created by democratic form of government and parliamentary democracy, he was anxious to guard India's unity and independence at any cost. He was aware of the different factors in the society which might strengthen centripetal tendencies yet he had

faith in the democratic institutions that were deeply rooted in Indian ethos since ancient times. Exhorting the people of India to guard the hard earned independence he said, "Will history repeat itself? It is this thought which fills me with anxiety. This anxiety is deepend by the realization of the fact that in addition to our old enemies in the form of castes and creeds we are going to have many political parties with diverse and opposing political creeds. Will Indians place the country above their creed or will they place creed above country? I do not know. But this much is certain that if the parties place creed above country our independence will be put in jeopardy a second time and probably be lost for ever. This eventually we must all resolutely guard against. We must be determined to defend our independence with the last drop of our blood."

As a nationalist Babasaheb always attempted to keep national interest at the foremost. His relentless championing the cause of deprived and depressed sections of the society has resulted in his image being stereotyped around certain issues mainly looking at him as a Dalit icon and relegating his contributions other background. Babasaheb was a mass leader, political and social thinker, academician, scholar and above all a nationalist rooted in the cultural ethos of Indian civilization. While the country feels indebted for his immense contributions in the nation building process, many other aspects of his multifaceted personality remains yet to be explored.



## Budgetary Impact in Madhya Pradesh: 2004-05 to 2011-12

he State Finance Minister, Raghavji Bhai has just presented his eighth consecutive budget for the year 2011-12. With an overall budget size of nearly ₹ 66,000 crores, the 2011-12 budget has shown a lofty revenue surplus of ₹ 3,866 crores. While the planned expenditure has been estimated at ₹ 25,578 crores, up from ₹ 21,939 crores in 2010-11, the state's own tax revenues are expected to touch ₹ 23,118 crores in 2011-12, up from ₹ 18670 crores in 2010-11.

The impact of budgets can be analysed from two angles: One, whether they have promoted sound fiscal management? And, two, whether they have channelised government expenditure into useful areas?

Has the government handled the state's finances with competence? In 2003-04, while the revised estimates of the last budget of the Congress government in the state showed a deficit of ₹5204 crores, BJP government's very first budget of 2004-05, showed a revenue surplus of ₹ 1486 crores. While the revenue surplus was (-) 4.56 percent of the State GDP in 2003-04, it has consistently improved over time and is (+) 1.97 percent of the State's GDP in the revised estimates for 2010-11. Converting a revenue deficit into a revenue surplus is an impressive achievement as most states continue to report revenue deficits. Likewise,

while the state's fiscal deficit was 7.46 percent of the state's GDP in 2003-04, it has reduced to 3 percent of the State's GDP in 2011-12. It may also be mentioned here that the state has already successfully met the two fiscal consolidation targets laid down by the 13th Finance Commission for states, namely the complete elimination of revenue deficits and reducing the fiscal deficit to 3 percent of the GDP by 2014-15. That the fiscal

management in the state is sound is also testified by the fact that the state has virtually stopped availing the 'Ways and Means Advances' and 'Overdraft' facility offered by the RBI. In the 2005-06 budget, for the first time in 16 years, the state did not have to resort to the overdraft facility and equally significantly, the same year, for the first time in 32 years, the state government did not avail of the Ways and Means Advances even for a single day. Trends in revenue receipts have also been encouraging over the last eight years. While the state's own tax revenues were ₹ 10879 crores in

the revised estimates for 2003-04, it has more than doubled to touch ₹ 23,118 crores in the 2011-12 budget.

However, it is being argued in some quarters that the state public debt levels are alarming as they are expected to cross ₹ 53,000 crores by March 31, 2011. Debt, per se, is not bad. Economists analyse debts on the basis of two criterion; namely, inter-generational equity and sustainability. If debts are used for spending on productive areas such as power, irrigation, roads etc then the state's economy would strengthen in future and the 'future generations' would benefit. The state's budget documents reveal that while capital expenditure as a percentage of net public debt was a meager 37 percent in 2003-04, it has increased to a huge 157 percent in 2010-11

clearly implying that future generations may benefit from the present debt. For the debt to be sustainable, the 11<sup>th</sup> Finance Commission had suggested that the interest-revenue receipts ratio must not exceed 18 percent. While this ratio was 23.14 percent in 2003-04, it has dropped to 9.67 percent in 2010-11 signifying that the state debt levels are sustainable.

Have the state budgets allocated funds in the



desired areas over the last 8 years? Economists regard all plan expenditure as developmental expenditure; a continuous rise is observed in the plan expenditure in successive budgets of the state – beginning with ₹ 7,831 crores in 2004-05, ₹ 9,605 crores in 2005-06, Rs 11033 crores in 2006-07, ₹ 14,216 crores in 2007-08, ₹ 15,706 crores in 2008-09, ₹ 20,259 crores in 2009-10, ₹ 25,111 crores in 2010-11. Even more commendable is the component of plan capital expenditure at ₹ 9,404 crores in 2010-11 which was 37.4 percent of the plan expenditure, which may not have a parallel in most state budgets.

A recent study by the RBI titled 'State Finances: A Study of Budgets 2009-10" has also corroborated that the MP has been increasing its public expenditure on development heads in the recent past. While the share of developmental expenditure as a percentage of State GDP was 11.4 percent during 1995-2000, it increased to 14 percent in 2000-05 and further increased to 16.4 percent during 2005-10. The state has also done well in recent times if one were to take the inter-state comparisons of developmental expenditure-State GDP ratios.

During 2005-10, among 'Non-special Category' states, barring Bihar(21.1 percent) and Jharkhand(17.3 percent), Madhya Pradesh's 16.4 percent figure exceeded Andhra Pradesh(15.5 percent), Goa(16 percent), Gujarat(9.5 percent), Haryana(10.2 percent), Karnataka(14.2 percent), Kerala(8.5 percent), Maharashtra(9.6 percent), Orissa(12.8 percent), Punjab(9.1 percent), Rajasthan (14.3 percent), Tamil Nadu(11 percent), Uttar Pradesh(15. percent), West Bengal(8.4 percent) and equalled Chattisgarh's 16.4 percent.

Have these rising developmental expenditures stepped up the economic growth in the state? If one were to go by some recent data, some encouraging signals emanate from the state's growth record.

The state's GDP has grown by 7.49 percent in 2005-06, 7.22 percent in 2006-07, 6.64 percent in 2007-08, 8.67 percent in 2008-09 and 8.49 percent in 2009-10. For an erstwhile *bimaru* state these growth rates are definitely welcome.

Clearly, the Finance Minister's commitment to improve the fiscal and economic condition of the state is reflected in the state budgets over the last 8 years. ■

Customs officials while carrying the huge volume of money. Monserrate was released by the Customs authorities on the same day after being grilled for 18 hours by the authorities.

"It is possible that he is investing in hotels in Dubai or even has links with Dawood Ibrahim, which means this money is being indirectly being used to fund terrorists," Shri Naik informed media persons after a meeting of BJP leaders.

He assured that BJP would take up this issue at the National level as part of the BJP's ongoing campaign against black money and demanded a thorough probe into the issue.

Meanwhile BJP State president Shri Laxmikant Parsekar assured that BJP would fight to ensure that the Minister is dropped from the Cabinet and hinted that there could be other Ministers involved. Shri Parsekar said we are sure this is not the first time the minister is making such a trip. It so happens that this time he has got caught. Secondly, is that his money alone or he is carrying money of



other Ministers too? He asked.

He said Monseratte, a Congress legislator from the Taleigao constituency who was formally inducted into the Congress party in June last year, is also being probed by the Central Bureau of Investigation (CBI) for leading a mob which attacked a city police station in which several persons were injured and several lady police constables complained of being molested.

Shri Laxmikant Parsekar further said incidentally, at the time of Monseratte's induction in the party, the Congress president Smt. Sonia Gandhi had cleared the entry of the tainted Monseratte and had been endorsed by the Congress High Command in Delhi.

## Farmers to get loan at 1% from next year: Shivraj Singh

ddressing an Antodaya Mela held at Shahdol, Madhya Pradesh Chief Minister Shri Shivraj Singh Chouhan has said that the BJP Government in Madhya Pradesh is committed to work in the interest of poor farmers. He said the farmers will be
