BJP leaders arrested while protesting in support of farmers

n 07 May 2011, Bhatta Parsaul, a village in Bulandshahr district in Uttar Pradesh, witnessed brutal police assault on the farmers at the behest of Mayawati and allegedly entered the houses of the agitating farmers and assaulted women and children. The Mayawati government in Uttar Pradesh and Congress governments in Maharashtra



government in Uttar Pradesh. Bhatta Parsaul which has been the epicentre of a bloody battle over forcible land acquisition of the farmer had to face the antifarmer dictates of the UP government attempting to ruthlessly suppress the voice of the people. The village which is home of several retired police and army personnel having a population of around 10,000 people was assaulted by the UP police which set houses on fire and Haryana have been in the forefront of bulldozing the rights of the farmers over their lands as these governments have been pursuing the policy of forcibly snatching their lands without giving proper compensation.

Former BJP National President Shri Rajnath Singh and Leader of Opposition in Rajya Sabha Shri Arun Jaitley along with BJP National Vice President Shri Mukhtar Abbas Naqvi and a number of State BJP leaders were taken into preventive custody by Uttar Pradesh police on May 12 after they sat on dharna at Ghaziabad in support of agitating farmers in Bhatta Parsaul village in

Greater Noida.

Shri Singh started his 24-hrs Upavaas at 1100 hrs in Ghaziabad and was joined by Leader of Opposion in Lok Sabha Smt. Sushma Swaraj, Leader of Opposition in Rajya Sabha Shri Arun Jaitley, NDA Convener and Janata Dal(United) National President Shri Sharad Yadav and BJP National Vice President Shri Mukhtar Abbas Naqvi. Undeterred by his Shri arrest Singh continued his upavaas even in police custody.

The action by an

insensitive Mayavati government in Uttar Pradesh which had resorted to use of brutal force against the farmers who were protesting against the forceful acquisition of lands by the government had forced BJP leaders to launch protest with Shri Rajanth Singh sitting on 24hrs *upavas*. Saying that the farmers in the state were being deprived to benefit some builders Shri Singh demanded that the state government should

immediately stop acquiring land in Bhatta Parsaul until the Land Acquisition Amendment Bill is passed by Parliament.Talking to reporters Shri Singh said the situation here was getting out of control and claimed that his fast is a show of the party's solidarity to the farmers' cause.

He said that he will raise the issue of land acquisition in Parliament, and added that the Uttar Pradesh government should avoid further acquisition of land so that unnecessary bloodshed is avoided. He also said that law and order does not exist and corruption was rampant. On the second day of his upavaas on May 13 Shri Singh ended his 24-hours-long fast after drinking a glass of juice offered by Leader of Opposition Smt. Sushma Swaraj.

While ending his fast Shri Singh said Prime Minister Dr. Manmohan Singh should come forward to save the lives of the farmers and a new act should be enacted regarding land acquisition without any further delay. He added that Sushri Mayawati and UPA government were hand in glove on the issue of land acquisition. Mayawati government is anti-farmer government and a commission should be constituted to inquire into atrocities committed by police on farmers in Greater Noida, he demanded.

The farmers are demanding increased financial compensation for the land they claim has been forcibly taken away from them to build the 165km Yamuna Expressway, between New Delhi and Agra. BJP sweeps all three seats in Karnataka bypoll

The Karnataka BJP has once again proved and continued its winning ways. The party on May 13 bagged all three seats in the crucial by polls held on April 9. The results also prove that the Opposition's war-like campaign to destabilise the BJP government had few takers. Both the Congress and JDS led high-voltage smear campaigns against Shri Yeddyurappa but these efforts did not find resonance with voters.

The BJP bagged all three seats, wresting two from the Congress and one from the JD(S). BJP candidates Shri CP Yogeshwar won by 12,000 votes in Channapatna in Ramanagaram district, Shri SV Ramachandra bagged Jagalur in Davangere district by 4,433 votes and Shri M Narayanswamy took the Bangarpet seat in Kolar district by 4,044 votes.

For the first time, the BJP wrested Channapatna seat from the JD(S).

Interacting with media persons after the massive victory Chief Minister Shri BS Yeddyurappa said it was an answer to the false onslaught of the Opposition's charges. He termed the BJP's victory in all three seats in the April 9 bypolls as a befitting reply to the reckless charges hurled at his Government by Opposition Congress and JD(S).

He said people have now given their reply to the allegations made against my Government. Let the Opposition learn from this and desist from making baseless allegations hereafter. With this victory, BJP's strength in the 225-member Assembly has increased to 109. (FOC)

BJP wins Bastar bypoll with big margin

BJP candidate for the Bastar Lok Sabha byelection, Shri Dinesh Kashyap won the seat by defeating his nearest Congress rival by a margin of more than 86,000 votes.

What is more important to note is that the Congress, which is the main opposition in the State Assembly, once again suffered a humiliating defeat in this tribal reserved seat. (FOC)

other comes barely within days of the bonhomie between the three rivals in the state politics, witnessed in Parliament's Public Accounts Committee, which probed the 2G scam. Last August too, proceedings in both houses of Parliament were stalled after BJP along with some opposition parties vehemently protested the deaths of three farmers in police firing in Mathura district of Uttar Pradesh. A platoon commander of the Provincial Armed Constabulary was also killed in the violence. BJP has since then resolved to fight for the rights of farmers and resist forcible acquisition of farmer's lands. ■





Recall Karnataka Governor : BJP

n the wake of Supreme Court judgment on the disqualification 16 of Karnataka MLAs, the Governor of Karnataka Shri HR Bhardwaj acting in contravention of all established norms and constitutional provisions declined to convene a session of the State assembly for a floor test as per the request of Karnataka CM Shri BS Yeddyurappa. What was very unfortunate to note that he went ahead with his recommendation for the imposition of President's rule in the State. Led by BJP National President Shri Nitin Gadkari Karnataka Chief Minister Shri BS Yeddyurappa paraded 121 Bharatiya Janata Party (BJP) MLAs before President of India and submitted a memorandum at the Rashtrapati Bhawan on May 17 to show that his government still enjoyed a majority in the State Assembly.

BJP National President Shri Nitin Gadkari along with Shri BS Yeddyurappa reached the June 1-15, 2011 Q 8

Rashtrapati Bhawan accompanied by Leader of Opposition in Lok Sabha Smt. Sushma Swaraj, Leader of Opposition in Rajya Sabha Shri Arun Jaitley, Former BJP President Shri Venkaiah Naidu, **BIP National General Secretaries** Shri Ananth Kumar and Shri Dharmendra Pradhan (Karnataka State BJP Prabhari) and other senior BJP leaders to apprise the President Smt. Pratibha Patil of the unconstitutional conduct of Shri H.R.Bhardwaj, the Governor of Karnataka. They urged to President to revoke the Presidential pleasure and to recall his services as Governor of Karnataka. The BJP MLAs were paraded before the President at around 6 PM and Yeddyurappa requested the President not to take any action on Shri Bhardwaj's report.

Submitting a list of 120 MLAs of Karnataka with their names and signatures enclosed with the memorandum Shri Yeddyurappa said, "I informed the President that the Governor had been trying to topple my government. I told the President that we have the support of 121 MLAs. We demanded that the government should be protected. We asked the President not to impose President's Rule in Karnataka."

Shri Yeddyurappa in his memorandum wrote to the President, "The Governor being a Constitutional Head of State, is governed by the advice of the Council of Ministers. However, the Governor of Karnataka appears to think otherwise. He has refused to act in accordance with the decision of Council of Ministers on several occasions. Recently, a decision was taken to call for Legislative Session w.e.f. 16.05.2011." Despite this, the Governor has failed to give consent for calling the Session, Shri Yeddyurappa said referring to the Judgement of Supreme Court in the case of B.P.Singal Vs. Union of India (2010) 6 SCC 331.

"Since the day of being sworn in as Governor of Karnataka on 05.06.2009, Governor Shri H.R.Bhardwaj has converted the Raj Bhavan into a political weapon for harassing the State Government. He has been acting in a partisan manner. He has made several public statements criticizing the functioning of the Government, Chief Minister and his Cabinet colleagues. The Governor has stated publicly that he is first and foremost a Congressman. This itself shows that he has entered the office as an active politician and as a neutral not Constitutional Authority", said Shri Yeddyurappa in а memorandum submitted to President Smt. Pratibha Patil.

It is to be noted that the popularity of the Karnataka Government has not been in doubt and BJP, under the leadership of Sh. B. S. Yeddyurappa has swept through most bye elections, municipal elections and panchayat polls. More recently, the BJP won all the three seats in bye-elections to the Karnataka Vidhan Sabha, the results of which were declared on 13th May, 2011. After disgualification of 16 MLAs, the effective strength of the House was 207. The BJP, on 13th of May, 2011, had the support of 110 MLAs in a House of 207.

The eleven disqualified MLAs of BJP after the removal of their disqualification by Hon'ble Supreme Court have already announced their support to BJP. Pursuant to this development, the Chief Minister urged the Karnataka Governor to permit him to call the Session of the June 1-15, 2011 O 9

Karnataka Vishan Sabha to prove his majority once again. Surprisingly, instead of summoning the Assembly, the Karnataka Governor recommended the imposition of President's Rule in the state, in spite of the fact that the Chief Minister enjoys the confidence of 121 MLAs in the house of 224.

Earlier on 16 May 2011 a Memorandum was submitted by NDA leaders to the Prime Minister on Karnataka issue which stated that, "The Governor has committed a series improprieties of and unconstitutionalities. Even though the Government enjoys majority support, the Governor failed to follow the advice of the Council of Ministers in convening the State Assembly on 16.05.2011. A Governor has no jurisdiction or authority to decline to accept the advice of the Council of Ministers which has a popular majority to convene a session of the Assembly. He gives interviews to the media that a floor test in Karnataka is not the best test. He is now believed to have written to the Government of India purportedly proposing action under Article 356 of the Constitution. There is no basis for his doing so."

The memorandum demanding the recall of the Karnataka Governor Shri HR Bhardwaj stated, "This is not the first time that the Governor of Karnataka, Shri H. R. Bhardwaj tried to create a political controversy when nothing exists. We on behalf of the National Democratic Alliance are constrained to approach you requesting the Central Government to out-rightly reject

He said, "We have won all the three seats in bye-election. The MLAs who have been reinstated following the Supreme Court order are supporting BJP. We have majority, the Governor does not reply when the Chief Minister writes to him seeking permission for a floor test but recommends dismissal of the government to the Home Ministry," he informed the reporters. ■

BJP Parliamentary Party Chairman Shri L K Advani delivered the valedictory address while Leader of Opposition in Lok Sabha Smt. Sushma Swaraj, Leader of Opposition in Rajya Sabha Shri Arun Jaitley, Former BJP Presidents Dr. Murli Manohar Joshi and Shri Rajnath Singh also guided the proceedings.

At the end of the deliberations, the Conclave adopted a Resolution in view of UPA's wanton disregard for the federal structure and its recent attempts at politicizing the proceedings of the Public Accounts Committee (PAC) which we are publishing for our esteemed readers.

Resolution as adopted :

We, the Chief Ministers, deputy Chief Ministers and other functionaries belonging to the Bharatiya Janata Party (BJP), reaffirm our commitment to the cause of National Reconstruction through Good Governance. With Nationalism as our inspiration and Development as our instrument, we are confident that we will continue to march successfully on the path of Antyodaya.

Good Governance is the key component of national polity, but under the UPA, it has become a casualty. It is our firm belief that Good governance includes the rule of law, transparency and accountability, as well as true democracy and participation. BJP has always considered Corruption as an assault on the inherent dignity of a person and a betrayal of one's responsibility to others. We recognize that all citizens have a

duty to resist corruption in all its forms and this conclave undertakes to lead and support all such efforts.

Under the UPA, corruption has increased manifold and also has betrayed our countrymen in multiple ways. The corrupt regime of UPA has lowered our national prestige, deprived the marginal sections the benefits of welfare schemes and greatly slowed down the pace of our national development. The

cancer of corruption is eating into the vitals of our national polity and public life.

Never before in the past, had government at the centre faced such a grave crisis of credibility arising out of innumerable scandals involving people in the ruling establishment in such a large number. Against this backdrop, systematic efforts are being made to paint all the political parties with the same brush.

We firmly resolve to resist all such attempts. At the same time, we also undertake to look within. We also undertake to reform the system and rededicate ourselves to the cause of a corruption free India. It is a matter of great satisfaction that several of the BJP State governments have won laurels for their excellent achievements. We resolve to build on this further.

The UPA has been taking a crass partisan approach on several issues of concern not only in the context of National Development but also National Security. Scores of vital legislations passed by the BJP governments are pending approval by governors for a long time, for political reasons. This conclave condemns this partisan approach and resolves to fight it in every possible way.

We undertake to reach out to the people more effectively and reassure them about our commitment to Good Governance, Transparency and Accountability. To that end, this Conclave resolves to make every attempt in a determined way towards achieving the following goals.

a) Establishing an in house mechanism for reviewing the June 1-15, 2011 Q 11 performance of our Governments periodically and exploring the possibility of taking measures for –

- Improving delivery mechanisms at various levels.
- Making the processes of governance; particularly the decision making, more open and inclusive
- b) Evolving a framework for Open Government while introducing greater transparency and accountability in budget preparation, execution, and supervision of expenditure as also establishing competitive public procurement procedures.
- c) Establishing a practice of declaring the figures of the State GDP and improvement on social indicators periodically
- d) Developing an effective partnership with various sections of the society in not only the effective implementation of welfare schemes and development projects but also eradicating corruption.
- e) Setting up a mechanism for punishing corrupt employees and elected public representatives administratively and legally and an element of deterrence is reinstated at various levels.
- f) Enhancing the level of using Information Communication Technology (ICT), as a tool for introducing greater access to all information in public domain, as well as bringing in greater transparency and accountability by using devices like E-Tendering and

E-Procurement.

- g) Exploring the possibility of reducing the element of discretion in the disbursal of benefits.
- h) Reviewing the replicability of legislative measures taken by some States for strengthening accountability of public servants and ensuring a time-bound and effective service delivery to the people at large.
- i) Evolving consensus about some important electoral reforms aimed at curbing the role of money power. Also, exploring the possibility of experimenting with various electoral systems in local elections to find out as to which of them is more conducive for a cleaner democracy.
- j) Setting up two Ministerial Study Groups to suggest common measures for improving the quality of Urban Governance and Rural Governance with its focus on providing hasslefree administration as well as strengthening local self governance through greater decentralization, devolution of funds, functions and functionaries.
- k) Strengthening the basic federal structure of our constitution while withstanding all efforts of the UPA government to weaken the same.
- Fighting against the policy of discrimination against the BJP ruled states as well as misuse of central agencies to harass and intimidate several opposition ruled states; adopted by the UPA government.



- m) Evolving further debate on the recommendations of Sarkaria Commission including those about the Role of Governor and following up for the implementation of its recommendations.
- n) Continuing with its war on terrorism and efforts for strengthening national security without getting influenced by vote bank politics. We also undertake to extend all cooperation to the central government for this cause.
- o) Evolving a mechanism facilitating Party Organisation to work as a bridge for the redressal of public grievances. ■

Result of each assembly is state-specific : BJP

BJP Parliamentary Board met in New Delhi on May 13, 2011 to discuss the results of the election to the five state assemblies.

The BJP was of the opinion that the result of each assembly was state-specific. An anti-incumbency wave factor due to lack of actual development has impacted the result in West Bengal. Corruption and family nepotism has influenced the election results in Tamil Nadu. The BJP regretted that the lack of opposition unity resulted in the absence of a credible alterative in Assam.

The global decline of the Marxist ideology appears to have belatedly arrived in India. The results of the bye-elections in Chattisgarh and Karnataka was satisfying for the BJP.

The BJP congratulated the winners of these elections in each state and hoped that they would be able to live up to the faith that the voter have reposed in them. ■

M. Venkaiah Naidu and other BJP leaders arrested in Hyderabad Congress govt. should purchase paddy at assured MSP in Andhra Pradesh : M. Venkaiah Naidu

On May 18 in Hyderabad, scores of BJP workers led by former National President of Bharatiya Janata Party, Shri M. Venkaiah Naidu, along with a huge number of farmers marched towards the Secretariat of the Andhra Pradesh from Indira Park demanding remunerative prices for the farmers and enhancement of Minimum Support Price (MSP) of paddy. The police prevented Shri Naidu and other leaders from proceeding further towards the Secretariat. With the protesters insisting on proceeding further to the



Secretariat, the police arrested Shri Naidu along with Shri G. Kishan Reddy, AP State BJP President, Dr. K. Lakshman, National Secretary, Shri Murlidhar Rao, National Secretary, Shri Bandaru Dattatreya, former Union Minister, Shri N. Indrasena Reddy, senior BJP leader and Shri J. Shyam Kishore, President of Kisan Morcha – AP State unit and many others.

Shri Naidu said "Farmers are resorting to distress sale of paddy at Rs.825 per quintal loosing around Rs.175 – 200 per quintal." He demanded that the Government should involve FCI to purchase paddy at MSP and also allow export of rice so as to create buoyancy in market. He further said that the Congress would not get minimum support in the next election. As prohibitory orders are in force in the State, the police said they were arresting the BJP leaders and were taken to Gandhinagar police station.

UPA regime is a saga of betrayals

he Congress-led UPA, now popularly reclaimed by the people as Unethical Alliance Practices and Unfulfilled Promises Alliance, at

the Centre in its second stint has completed two years in office. To say the least, its performance is thoroughly disappointing. Not to speak of any positive significant and achievements, it has failed miserably to live up to even the basic expectations of the people. People have given it mandate for a

second term in the hope of reaping benefits of the promises doled out by it during elections. Promises piled up but remain unfulfilled - Ornamental timebound agendas announced but remain unimplemented. The UPA-II started its term with a flurry of announcements of 100day agenda by several Ministers. More than 700 days later, hardly Minister remembers those agendas. There has been a huge disconnect between the rulers and the ruled.

The UPA-II regime is marked by absence of good governance. The list of unfulfilled promises is unending; right to food, right to education (only bill no political will), Bharat Nirman, physical infrastructure in rural areas, six lane highways, nine per cent growth rate, law and land acquisition and

report to the people from time to time - nothing has been fulfilled. Apart from this over two dozen bills have been lapsed and 20 bills are pending for the past five years.

The head of the UPA, the Congress, is a divided house. Ministers have given up collective responsibility and blame each other for misgovernance. Cohesion and cooperation have become conspicuous more by their absence. The Ministers choose to adversely comment on their Governments departments on a foreign soil. Minister reads speech of another country at the highest international forum. Ministers, including the Prime Minister, are least bothered of the credibility of the institutions while taking critical decisions based on inaccurate facts and

appoint a corruption case accused as the Chief Vigilance Commissioner and made a partisan appointment in Election Commission. The

> appointment of Prasar Bharati CEO who had to removed, be and appointment of NHRC Chairman, is no difference. The Government suffers from serious competence deficit.

> The Government let down the nation by consciously selecting Ministers in key infrastructural ministries such as Telecom and

Highways who were low on the integrity quotient. It has failed not only to take any steps in furthering the reform proposals also in creating but infrastructure of global standards, neither the flagship schemes have resulted in any asset creation. Further, the interest rates have become so high rendering our industry noncompetitive.

The two fundamental issues on which the UPA-II has completely failed are corruption and price rise.

Corruption

The UPA-2 has been the most dishonest Governments in the history. It is irony that a distinguished economist believed to be the most honest is heading the most corrupt regime in the independent India. The 2G scam involving a sum of '1,76,000 crore, perhaps the biggest scam ever that took place in the country, is the biggest shame on the UPA-II. Scams are stupendous and stunning. The scams that have seen the light are the scam of export and import of food grains involving thousands of crores of money, the CWG Scam involving 70,000 crores, the IPL scam, the S-Band spectrum scam involving the PMO, the Adarsh Soceity scam involving senior army/IAS officers and Ministers and startling and shocking telephone tapping to mobilise support and harass political opponents.

Inflation

The biggest failure of this Government has been its sheer inability to contain the spiraling price rise of essential commodities. The rise has been so continuous and so steep that the common man is unable to have even one-meal-a-day. The tremendous rise in food prices has hurt the poor the most. Price rise and food inflation is the comprehensive failure of economic policies including lack of foresight and proper planning, lack of leadership, sheer incompetence, massive corruption in export and import of food grains at all levels in Government.

For almost three years we had a double digit inflation in the Wholesale Price Index. Fiscal consolidation is no longer the priority of the government. The prices of essential food items are sky high. The petrol prices have been increased 20 times in the name of rationalisation. **Neglect of agriculture**

sector

The UPA's policies have <u>been anti-farmer</u>. It has totally June 1-15, 2011 O 14

neglected the agriculture sector Food items became costlier and also scarcer. Farmers suffer on all counts. Thousands of farmers are committing suicide. The MSP of the paddy has not been raised by the Centre for the last two years. Not even one tonne of storage capacity is added in last seven years. There is no effort to implement Prof MS Swaminathan Commission's recommendations.

Security & Goof-ups

Security of the country seems to be the least priority on Government's agenda. Our defense preparedness is suffering because the ministry cannot take decisive action. The inexcusable goof-ups in the list of 'most wanted' given to Pakistan by the Home Ministry have made our nation a laughing stock in the international community. It shows the casual approach of the Government on such a sensitive security matter. There is no political leadership to guide the government and hence there is a divergent approach between the Party leadership and the Government.

Even on important and sensitive issues like internal security and Maoists, the ruling party is a divided house. Internal contradictions and lack of support between the ministers and coalition partners is forcing the Government to compromise on the security of the nation. The master minds of 26/11 are still roaming around freely in Pakistani streets and our ministers are busy having academic discussions with their Pakistani counterparts.

The threat of Maoist violence in several states and districts still remains. Nobody knows as to



what is the Government policy towards Maoism!

Black money

The Centre is taking no action against those who have stashed thousands of crores of unaccounted money illegally in foreign shores despite repeated rebukes from the Supreme Court. Certainly their identities are to be made public. Why the government is so active in maintaining the secrecy for which after all the defaulters have to be prosecuted? Why the UPA Government is so keen and hell bent on protecting the taxevaders?

Constitutional impropriety and stepmotherly treatment meted out to non-UPA States

The only achievement of the UPA-II is misusing the constitutional institutions for political ends. The Congress party is adopting all unethical, extra constitutional and immoral method by misusing various institutions to further its political interests, harass political opponents and also muster support as and when needed. BJP stages nationwide protest against petrol price hike

It's in the numbers

On Governor Bhardwaj's reluctance to convene the House Bhardwaj has revealed himself as a combative litigant with a single-point agenda: to remove the CM. This is unbecoming of the high office of the governor, an office that needs to be preserved with dignity and decorum.

RNATAKA Governor Bhardwaj's H.R. persistence in preventing Chief Minister B.S. Yeddyurappa from substantiating his claim of majority support by convening a session of the assembly is a grave constitutional impropriety. It is well settled by the Supreme Court that majority support cannot be determined by the subjective assessment of the governor in the Raj Bhavan, because the constitutionally ordained method for determining whether a party commands majority is by a floor test in the House. It is also settled law that the governor must act according to ministerial advice. Therefore, he is obliged to convene a session of the House as requested by the ministry. His failure to do so is a dereliction of his gubernatorial duty.

What are the purported reasons for the governor's refusal to convene the House?Surmises conjectures and about manipulation of votes by horse trading and unethical practices. It interesting is to learnwhathappenedin2005when Nitish Kumar was prevented by governor Buta Singh from staking his claim to form the government in Bihar on the allegation that a majority could be cobbled by distortion of the June 1-15, 2011 Q 20

system due to allurement and bribery. In his report, Singh stated that a situation had emerged in which no political party or group appeared to be able to forma government that could command a majority in the House. According to Singh, this was acase offailure of constitutional machinery. Therefore, president's rule was recommended in the state.

Based on the governor's report, the Centre imposed president's rule in Bihar.

The Supreme Court in its landmark judgment of January 2006 in Rameshwar Prasad v Union of India struck down the imposition of president's rule. The court endorsed the recommendation of the Sarkaria Commission and reiterated the principles laid down in S.R. Bommai's case that power under Article 356 cannot be exercised for the purpose of securing good government, nor can it be invoked merely on the ground that there are serious allegations of corruption. That has to be dealt with in different fora and not by dissolving an elected legislative assembly which commands the confidence of the House as previously laid down in Bommai's case.

The Supreme Court held that the governor's action was "a clear case where attempt was to somehow or the other prevent the formation of a government by a





political party -an area wholly prohibited insofar as the functions, duties and obligations of the governor are concerned. It was thus а wholly unconstitutional act". Thereafter the court made extremely significant observations: "If a political party stakes claim to form a government and satisfies the governor about its majority to form a stable government, the governor cannot refuse formation of the government because of his subjective assessment that the majority was cobbled by illegal and unethical means. No such power has been vested with the governor.

Such a power would be against the democratic principles of majority rule. The governor is not an autocratic political ombudsman. If such a power is vested in the governor and/ or the president, the consequences be can horrendous. The ground of maladministration by a state government enjoying majority is not available for invoking power under Article 356" for imposing president's rule.

This clear judicial precedent Bhardwaj has chosen to ignore. It is a grievous error not to learn from lessons of the past in deciding one's future course of conduct. Bhardwaj has, in a recent press release, sought to justify his action by relying on the recent judgment of the Supreme Court which held that the disqualification of 11 BJP MLAs by the speaker was invalid. The court in validated the speaker's order on the ground that there was breach of natural justice because adequate opportunity was not given to the legislators, that the speaker had June 1-15, 2011 Q 21

acted in hot haste and that his action displayed a partisan trend.

There is not a single para or sentence in the said judgment that passes any strictures on the chief minister or indicts the state government. There is no finding whatsoever of collusion or conspiracy of the chief minister with the speaker. It is incomprehensible how this judgment can justify imposition of president's rule on the ground of failure of constitutional machinery when there is no deadlock or impasse which prevents the assembly from functioning normally.

This is totally unbecoming of the high office of the governor, an office which needs to be preserved by dignity and decorum and by not indulging in partisan politics.

"GOOD SHOW" by Anurag : *The Week* Rahul puts a "BAD SHOW"

n its issue of May 15, 3011 the weekly **L**newsmagazine *The* Week came out with a special story headlined "HUSH PUPPIES" on the performance of young MPs in Parliament during the last two years. "They came with a bang, and fell quiet" states the subheading. "Young MPs who were expected to bring change, changed nothing". The report further added: "But



two years (after their election in May 2009) down the line, they have failed to live up to the expectations. Rather than bringing about any change, they have quietly become part of the system".

The assessment of the Weekly gave five MPs a "GOOD SHOW" and five as "BAD SHOW". It has mentioned the name of BJP MP and BJYM National President Shri Anurag Thakur as the first. Among the MPs whose score the *Week* has given, Shri Anurag Thakur, second time MP from Hamirpur parliamentary constituency in Himachal Pradesh, is the youngest who recorded an 86 percent attendance in the house, participated in 39 debates and put 283. Though two more MPs have been included in the "GOOD SHOW" category, yet they have either participated in less debates or put less questions.

Prominent among the "BAD SHOW" category is the Congress General Secretary Shri Rahul Gandhi who, the *Week* says, has put zero questions and participated in no debate. His attendance record too stands at 47 percent.



For Congress thodi khushi, zyada ghum By Amba Charan Vashishth

he results of the assembly elections concluded in five L States recently have not been up to the BJP's expectations. But for the Congress-led UPA-II too, beleaguered by a "scam a day" syndrome there is hardly much to smile. The results are a mixture of thodi khushi and zyada ghum (less mirth, more disappointment). For this party the only consolation is that though it has lost much, yet everything has not yet been lost as it managed to retain power for the third time in a tow is Assam.

KERALA: A razor-thin win

In Kerala Congress-led UDF did succeed in being voted to power dethroning CPM-led LDF but with a whisker thin majority of two, thanks only to the CPM which persevered hard to ensure the defeat of the V. S. Achutanandan government. Till the last moment CPM had maintained the suspense whether Chief Minister V. S. Achutanandan would be allowed to contest again or not. When finally he was allowed to contest, it turned out to be a contest not between the CPM-led LDF and Congress-led UDF but Achutanandan versus the CPM plus the UDF. A Hindi daily has aptly headlined the report saying "Achutanandan won even in his defeat". The rallies addressed by Prime Minister, Dr. Manmohan Singh, Congress President Smt. Sonia Gandhi and heir-apparent Shri Rahul Gandhi, as per media reports,

were "noted for their poor attendance".

A stunning victory in 2009 Lok Sabha elections winning 13 out of the 20 seats in the State was, then, construed as a deathknell signal to the ruling UDF whenever the assembly elections are held. In two years, the Congress-led UPA seems to have lost – and CPM-led LDF regained – ground. This time Congress could just win in 38 seats against 45 by CPM. The Congress-led UDF gained just 72 seats in a house of 140 while UDF was successful in 68.

Shri Achutanandan who refused to form a rag-tag government with some disgruntled MLAs from other parties and declared that he would prefer to sit in the Opposition.

WEST BENGAL: Congress piggy ride

Sushri Mamta Banerjee led TMC overran the West Bengal Red fort which had remained invincible for the past 34 years. On its own Didi won a landslide victory scoring 184 seats (in a house of 294) out of 227 it contested. Congress won 41 seats. The TMC-Congress alliance scored more than threefourth majority scaling a total of 228 seats. 26 ministers, including the Chief Minister Shri Budhadev Bhattacharya, lost the election. It was a remarkable win - a win for Didi alone. Congress won riding the piggy back of TMC and was more attributable to the Didi wave than to Congress's own popularity. Notable is also the fact that TMC was formed by Sushri Mamta Banerjee as a revolt against the Congress policy of not forcefully opposing the Left front government in West Bengal. By dint of its persistent struggle against the Left government TMC overtook its parent organization by giving CPM a hard time even when Left parties were supporting the Congressled UPA-I at the Centre. Congress then looked askance whenever CPM government in West Bengal committed atrocities against the people, particularly farmers.

TAMIL NADU: Total Cong-DMK rout

In West Bengal it was a total rout of the Congress-led UPA-II in the State with DMK contributing a major chunk of the defeat. 17 DMK ministers had to lick the dust of defeat. But Congress's own loss was no less. It could hardly win 5 out of the 63 seats it contested. The voter punished both the DMK and the Congress for their act of promoting corruption and protecting the corrupt in scams. DMK indulged The in corruption and Congress extended its hand of patronage on the perpetrators of corruption. DMK's tally was reduced to just 23 in a 234-member house.

Notable has also been the total rout of the Congress and DMK alliance candidates in the assembly segments forming part of Sivaganga parliamentary



constituency represented by Home Minister P. Chidambaram. **PUDDUCHERY: Congress out**

The Congress-DMK alliance government was voted out in Pudduchery too. Shri N. Rangasamy, a Congress chief minister till 2008, was removed by the Congress high command. He formed the All-India Namathu Rajyam Congress and contested election in association with AIDMK and won 15 seats in a 30-member house, with 5 seats going to AIADMK. Congress strength was reduced to 7 from its earlier tally of 10 and DMK's to 2 from 7.

Rahul brigade flops


The Rahul's experiment to induct youth leadership by imposing candidates handpicked by him failed both in Kerala and Tamil Nadu. Almost all the candidates, about 10 (out of 63 seats Congress contested) nominated by Congress General Secretary Shri Rahul Gandhi were humbled, with huge margins. State Congress President Shri K. V. Thangkqabalu was defeated by a huge margin of about 30,000. (www.hindu.com/2011/05/15/ stories/2011051564330900.htm) The results stand in contrast

to the boast made by Shri Rahul Gandhi during one of his tours to Tamil Nadu in 2010 to build the party strong enough to return to the past glory of a ruling party on its own. This claim had raised eyebrows among the DMK leadership which took the remark as a challenge to the regional party.

In other States too, Rahul's young buddies did fare no better. Only eight out of 18 "Amul <u>babies" could win in Kera</u>la and June 1-15, 2011 **Q** 25

three out of eight in West Bengal. Congress humiliation in AP

The worst electoral drubbing the Congress party ruling in the State and at the Centre received was in Andhra Pradesh when all their efforts to defeat the late AP Chief Minister YSR's rebellious son Shri Y. S. Jaganmohan Reddy from Kadapa parliamentary seat and his mother Smt. Y. S. Vijaylaxmi from Pullivendula assembly fell flat. Shri Jaganmohan won by the highest ever record margin of 5,21635 votes. Both his Congress and TDP rivals lost their security deposit. Jaganmohan Reddy's win is all the more remarkable as compared to the then Prime Minister P. V. Narasimha Rao's victory from Nandyal constituency in Andhra Pradesh by a margin of more than 5 lakh votes. It is worth recalling that Shri Rao had contested when he was already a Prime Minister and the TDP had not put up its candidate against him. But here Shri Jaganmohan Reddy was



pitted against the whole might of the Congress government in AP and UPA government headed by Prime Minister Dr. Manmohan Singh and Congress President Smt. Sonia Gandhi at the Centre.

Another interesting aspect of this bye-election was an attempt made by the opponents of Jagan and his mother to confuse the voter, particularly the illiterate and semi-literate ones, by putting up 10 Jagans and six Vijaylaxmis in the election. This dirty trick too failed to click.

A zero for Congress in bye-elections

In other bye-elections to eight assembly constituencies and one Lok Sabha seat, the Congress failed to open an account. BJP made a clean sweep of all the three bye-elections in Channapatna, Jagalur and Bangarpet constituencies in Karnataka snatching two seats from Congress and one from JD(S). BJP also retained the Bastar Parliamentary seat in Chhattisgarh winning it by a respectable margin of over 86 thousands votes over Congress candidate.

Usual Sonia-Rahul euphoria missing

Whenever and wherever the Congress won, even a byeelection, a hype was always generated that it was solely and solely due to the mother-son duo of Smt. Sonia Gandhi and Shri Rahul Gandhi. But this time deafening is the rare silence and absence of this euphoria by the Congress. The usual drumbeaters seem to have vanished into the blue.

The report described forced conversions as "one of the biggest concerns for minority and vulnerable communities in Pakistan for many years".

Several members of the Hindu community became victims of abduction and violence in Baluchistan, where they had

lived in relative safety for generations", the report said. The Report also warned that "Worse Times are in store".

ddressing the closing session of the one-day All-India Lawyers Conference at CMS Degree College, Lucknow on 15 May 2011, BJP National President Shri Nitin Gadkari held Prime Minister Dr. Manmohan Singh and UPA Chairperson Smt.
