### UPA's hall of shame scam after scam

Although the Congress had started indulging in corruption since the time of independence but the kind of loot which we witness today was never seen before. It appears as if a cut-throat competition of becoming the biggest scamster is going on between the ministers of UPA. There is no end to scam and loot under UPA government. After the CWG loot, Adarsh society scam and 2G Spectrum scam, now a scam in the sale of S-band has come to the fore. It is an irony that CVC PJ Thomas is facing grave charges of corruption yet he is heading an institution supposed to fight corruption. The government is saying that it was not aware of the corruption charges against Thomas. It is a frivolous excuse. How come the government was not aware of the past of a person getting appointed to such a sensitive position? Such irresponsible approach is dangerous for the country. Even after that Thomas shamelessly remains clinging to the post crossing all limits of propriety and challenging the system. Such a situation is very disturbing. It is not good for democracy.

### Raja's arrest not an end in itself: Gadkari

Under immense pressure from Opposion CBI had to arrest former telecom Minister Shri A Raja. Earlier pressure by BJP forced UPA government to get Raja resigned from the IT and communication ministry. A. Raja is accused of the biggest scam (2G spectrum) in the history of mankind. Due to the scam Public exchequer has lost unprecedented amount of Rs.1, 76,379 crore. BJP leaders lambasted Prime Minister Shri Manmohan Singh for not acting against Raja for three years, the party called his "silence" as an attempt to "save his chair".

By National President Shri Nitin Gadkari said Raja's arrest was not the end in itself. "Who is the godfather behind him. It should come to light who was his boss," he said.



Shri Gadkari added the decisions made by Raja and other ministers had the clearance of the Cabinet and the PM "somewhere or other during the process".

"The arrest of Raja would not dent its campaign against

the UPA. "Others cannot get away by sacrificing Kalmadi and Raja, though the two may be guilty. The government cannot make them scapegoats and get away," Shri Gadkari said.

"You did not act for three years and allowed him to indulge in wrong doings and corruption. After three years, you arrest him but that money cannot be brought back," said Leader of the Opposition in Rajya Sabha Shri Arun Jaitley.



"The allocation of spectrum at a grossly under stated value and selection of persons as an act of favoritism to whom it is to be allotted took place in 2007, early 2008. More than three years have elapsed and for over three years this

government was in denial," Arun Jaitley said.

He maintained that the government kept defending Raja despite the opposition, media pressure and repeated debates in Parliament.

"The Prime Minister maintained even late last

year that Raja did nothing wrong, he did what his predecessor did. (Kapil) Sibal maintained a fortnight ago that Raja had caused no loss to the exchequer," Jaitley said.

Alleging that the government was involved in this "cover-up exercise", BJP insisted that Raja's arrest was a "belated action" which had come under pressure from the judicial system, Parliament, the public and media.

"I wish the Prime Minister, instead of living in denial, had acted three years ago so that this huge, monumental loss to the public exchequer had not taken place," Shri Jaitley said.

However, BJP maintained that its stand on JPC would not be diluted.

"Our stand on JPC remains because it is on much larger issues. Why was the Telecom portfolio kept only for DMK? Why within DMK it was kept only for A Raja? How and why some policies were framed? And the role of middlemen," Shri Jaitley said.

He claimed that these issues did not relate directly to the "culpability" of A Raja and so a JPC was needed to look into the larger issues.



Criticizing the telecom minister Shri Kapil Sibal, Rajya Sabha MP **Shri Venkaiah Naidu** said, "He(Sibal) had argued that in allocation of 2G spectrum there was zero loss to the exchequer. He had criticised the Opposition, taken on the

CAG crossing all limits of parliamentary and constitutional propriety and had given a clean chit to Raja."

# String of scandals have exposed true face of Congress : Gadkari

Instead, the

Congress leadership has not made any effort to do so he said.

Shri Nitin Gadkari charged that

regional parties such as Lalu Prasad's Rashtriya Janata Dal had been plundering the State, along with the Congress, for the last decade and a half, till the NDA formed its government in 2005. He said the people of Bihar has given fitting reply to these plunderers and expected that the NDA government will perform as per the expectations of the people. Addressing the rally Leader of Opposition in Rajya Sabha Shri Arun Jaitley said that the 2G spectrum irregularities were unparalleled and the

Raja, while accusing the present Communications Minister Kapil Sibal of providing evasive and misleading answers that glossed over the losses incurred in the allocation of 2G spectrum licenses.

# Rajnath flags off Nav Jagran Rath Yatra

Shri Rajnath Singh on January 30 flagged off the party's 15-day *Nav Jagran Rath Yatra* from West Bengal's Cooch Behar district. The rally is to tour through several districts of the State and will be concluded at Rani Rasmoni Road in Kolkata on February 15.

Reason behind launching of the *Yatra* is to highlight the worsening law and order situation, rising prices and worthlessness of West Bengal's ruling Left Front and Opposition Trinamool Congress.

Launching the *Nav Jagran Rath Yatra*, Shri Rajnath Singh said the State should look for a viable alternative to the CPI(M), which had proved itself worthless. "It is time the people drive them out of Bengal," he said, calling upon the

voters to back the BJP.

The party had long term plans for Bengal, he said. "We have not come here as those who also ran," he said, adding that it was not going to "quit after the elections leaving back a faint footprint."

Rajya Sabha MP and party incharge of West Bengal Shri Chandan Mitra said, "No Party other than the BJP could deliver the state from the misrule of the CPI(M), apart from delivering the goods by bringing in all round development. For the first time during the NDA regime, the nation saw a record amount of developmental work taking place.

"West Bengal is a poor state and TMC is as much responsible for it as the Congress. The Left rule in the last 34 years has also affected the state. Similarly, corruption is a big issue. The state government has given reservation to Muslims in jobs. We are opposed to reservations on religious grounds and will expose this pure votebank politics," said party's West Bengal in-charge Chandan Mitra.

The BJP could give the only viable alternative to the current regime by ushering in a plethora of development schemes, Shri Mitra said during the start of the rally even as thousands of locals thronged the two sides of the road till Alipurduar in Jalpaiguri district. The BJP -which had polled more than 7.5 per cent votes fighting alone in 1996 elections -came second in the Alipurduar parliamentary polls of 2009. The yatra would cover various districts and would culminate at Esplanade in Kolkata on February 15.■





# DMK was outsourced by Congress for looting people's money: Gadkari

ddressing a huge rally in Chennai BJP National President Shri Nitin Gadkari said , "For the 2G spectrum scam, the Congress had outsourced the DMK for making money with A Raja playing the lead role and Karunanidhi masterminding it."

Shri Gadkari was addressing the rally on the concluding day of the 40-day *Thamarai Yatra* (lotus yatra) which had been commenced across the State since November by BJP Tamilnadu State President Shri Pon Radhakrishnan to demand educational assistance to poor Hindu students.

Speaking in the rally Shri Gadkari said Congress is responsible for making 2010 "a year of scandals". The 2G scam, Commonwealth Games, Bofors case and Adarsh Housing Society scam, he said, placed the

total money swindled to 2,50,000 crore. He has alleged that the DMK was "outsourced" by the Congress for looting the people of the country in the 2G spectrum allocation. While Tamil Nadu Chief Minister M Karunanidhi masterminded the "loot", former Union Telecom Minister A Raja played the key role.

He accused the Congress party for looting the people's money by using the DMK as a commercial shop. Shri Gadkari claimed that BJP was not making mere allegations on the spectrum scam, but was quoting from the CAG report.

Though AICC general secretary Shri Rahul Gandhi claimed that there was no dynastic rule in the country, Shri Gadkari observed that it was the young Gandhi who would benefit.

Talking about the black money, Shri Gadkari called upon

the UPA Government to disclose the names of Indians who have stashed away money in the Swiss banks.

"I want to ask a million dollar question to the Congress party. Why are you not declaring the names of those who have deposited the black money in Swiss bank accounts?" asked Shri Gadkari. He said that it was not just a issue of evading tax but a mind boggling crime.

"When NDA comes to power, we will bring all the black money back to India and spend it for the inter-linking of rivers to help the water-starved southern States, " he said.

He asked the people to choose who they should follow — Rahul Gandhi who is against

interlinking of rivers or former President APJ Abdul Kalam, who was for the interlinking.

Sympathizing with the



Tamils, Shri Gadkari said that it was the democratic duty of Sri Lanka to give fundamental rights to Tamils and assured that the NDA will support all efforts to get the fundamental rights for the Tamils. He not only promised to raise the issue in Parliament, but also announced a donation of '10 lakhs for the welfare of Sri Lankan Tamils from the BJP's Seva Committee.

"Being in power, both at the centre and the state the Congress-DMK combine has failed to control the rising prices," said Shri Gadkari. He added, "This rise in prices of essential commodities has made the life of common man miserable."

Addressing the media in Chennai, Shri Gadkari said: "It is very alarming to note that more than 500 fishermen have lost their lives in the bullets of Sri Lankan navy while fishing in the coastal water of Tamil Nadu. During this visit in Chennai it is noticed that there is sheathing anger in the fishing community."

People of Tamil Nadu have expressed anguish over the inaction of the DMK-led government in the state and the insensitive and casual attitude of the Congress-led UPA government at the centre, he said. He added, "It is sad to recall that we have lost two lives in the last fortnight alone. BJP has taken a serious note of the situation and would raise the issue in and outside the parliament."

He said , "The lack of administration is visible. It is appalling to note one industry after another is seeking destinations outside the state. The automobile industry, which developed around <a href="Striperumbatur">Sriperumbatur</a> ("Detroit of February 16-28, 2011 Q 10

East") is unsure of its sustainability for reasons, which are extraneous to the market constraints. The failure of the state government in addressing these outstanding critical issues have resulted in this industry looking for greener pastures elsewhere. Skilled labour, which is in abundance in Tamil Nadu, are at the risk of loosing their jobs."

He added "BJP believes that Tamil Nadu's fullest agricultural and industrial potential can be realized if a permanent solution is found for its perpetual water shortage by inter-linking rivers. The secret of Gujarat's agricultural success has been the efforts taken by the BJP-led government in the state to interlink its rivers. The state has so far inter-linked fourteen of its river to Narmada.

BJP would like to reiterate its position that this would be one of the first things it would address if it is elected to power."

### BJP team visits Odisha to study daal scam

BJP team, led by the party's national Secretary Shri Kirit Somaya, arrived Bhubaneswar on February 07 on a two-day visit to the State to study the multicrore Daal scam before submitting a report to party president Shri Nitin Gadkari. Interacting with media persons Shri Somaya accused the Naveen Patnaik led State Government of being corrupt and inhuman. He

The team is also scheduled to visit Jajpur, the home district of Pramila Mallick, who was virtually sacked from the post of Women and Child Development Minister for her alleged involvement in the scam.

Chief Minister Naveen Patnaik, who was all along a silent spectator to the poisoning of the millions of kids should also come under the purview of the inquiry as an abettor, said State BJP President Shri Jual Oram.

#### India needs repatriation of 'Black Money'

According to the data provided by the GFI (Global Financial Integrity), India has

more black money than the rest of the world combined. India has almost 22.5 lakh crores of black money stashed away in Swiss banks and other tax heavens This amount is nearly half of the total GDP of the country and around 13-14 times of our total foreign debt. At a time when the Government is grappling with the malady of heavy fiscal deficit, bringing the black money back to the country will give our economy a much needed boost.

The Government has also acknowledged this fact on several occasions and even promised to work towards repatriation of Black Money to India.

Unfortunately the country is yet to witness the seriousness and tenacity to take any meaningful step in this direction. The Government seems to be hiding behind international treaties and other legal February 16-28, 2011 O 12

made amendments in existing laws to bring the money back to the home country. The United Nations has passed a Convention on corruption and now laws are being drafted for the repatriation of money. The question arises what is stopping the UPA Government to work on similar lines?

The UPA Government has deliberately delaying and diverting the process of recovery because it is afraid that a quick response on this issue will expose many money trails which will establish its links to higher ups in the Congress party.

# BJP priority to serve the poorest among the poor : Gadkari

meeting of Scheduled Castes Ministers and other Ministers holding Social Justice Portfolio from BJP/NDA ruled nine States took place on 3rd of Feb 2011 at Parliament House Annexe, New Delhi. This meeting was in continuation of the agenda adopted at National Convention on Good Governance held in June 2010 at Mumbai.

While inaugurating the meeting BJP National President Shri Nitin Gadkari called upon these Ministers to effectively and expeditiously implement various welfare schemes for the benefit of the downtrodden and needy sections of their respective States. He urged them to ensure corruption free administration in their respective Departments and Ministries.

Emphasizing the spirit of 'Antyodaya' Shri Gadkari asked them to craft policies to serve the last man in the queue and aim at reaching out to the most marginalized sections of the society.

He appealed them to execute development oriented schemes for the all round development of poor and oppressed by ensuring absolute transparency and performance audit of all welfare schemes.

Shri Gadkari emphasized the need for eradication of untouchability and bringing social harmony among various sections of society. The BJP President stated that the misleading and malicious campaign by the Congress and its allies being BJP as anti-Dalit and anti-poor has now been

dispelled as majority of these sections are satisfied with BJP/ NDA Governments which are committed for their overall development.

Addressing the meeting, Smt Sushma Swaraj, Leader of Opposition in Lok Sabha, said that in BJP ruled States we have ministers holding key Portfolios from SC community, which establishes that the party values the capability & merit to govern rather than considering their caste background. She asked them to use this opportunity to serve the society at large and their community members particular, as it is their responsibility to uplift these sections.

The Leader of Opposition in Lok Sabha stated that "You have got an opportunity to serve the



people, so introduce and execute at least one welfare scheme that can modify the life style of the poor and oppressed sections which will revolutionize the whole community.

While emphasizing the need to educate Dalit youth she said that all the impediments should be removed.

All the Ministers narrated various welfare schemes being executed in their respective states and the progress thereof. They also highlighted the biased approach of the Congress led UPA Government in the matter of releasing funds to their States almost before the end of financial year with the result that they find it difficult to use the entire fund in time.

They requested BJP Central leadership to take up their grievance to Central Government.

All the participants agreed that the Rangnath Mishra Commission Report, if accepted by the Central Govt, it will adversely affect the development prospects of Scheduled Castes. They therefore decided to continue with their protest against the Rangnath Mishra Commission Report, which has recommended the inclusion of the converted Dalit Christians and Muslims in the category of Scheduled castes.

#### NDA endorses BJP Task Force Report on "Indian Black Money Abroad in Secret Banks and Tax Havens"

The NDA discussed the contents of the Second Report of the BJP Task force on "Indian Black Money Abroad in Secret Banks and Tax Havens". Drawing authoritative references, this report has dealt with the issue multi-dimensional perspectives of global economy, geo-politics and global financial distress. It spells out some national efforts that are needed to stop this outflow and to retrieve the lost wealth. The First Report was submitted to the BJP in April 2009. The NDA has broadly endorsed the Task Force's Report.

A copy of the second report and its executive summary is being distributed to the media and will be put on the website of the BJP.

The IMF estimates the global black economy at US \$18 billion which is considered an underestimate. The Finance Minister of India too has estimated that the quantum of Indian wealth stashed away in various tax havens may total to several lakh crores in Indian rupees!

The Supreme Court of India has characterized the amounts stashed away as "theft" and "plunder". The Government of India tends to treat the issue as a matter only of tax evasion. The Global Financial Integrity, a global NGO committed to financial transparency, says that

the Indian monies stashed away abroad consist of "tax evasion, corruption, bribery and kickbacks and criminal activities". Simply put, black money and its being stashed abroad are unpatriotic acts and they tantamount to financial terrorism. As early as 2007, Shri MK Narayanan, the then National Security Advisor expressed his concern regarding

On the basis of the said law, the Government of India may ask the world governments and the different banks committed to secrecy such as the Swiss Banks, to recognize Indian government as the beneficiary of the undeclared wealth, bank account and other assets of the Indian nationals till the owner of the wealth, bank accounts and other assets is able to prove that he had acquired it by fair means and from legally valid sources.

Finally I appeal to the people of India, the judiciary, media, intellectuals, academics, and all public-spirited citizens to exert pressure on the Government and political leaders and compel them to act decisively on the issue forthwith.





### Flying the Republic's flag

That legal right does the J&K state government have to detain and deport the two leaders of the opposition?

The Ekta Yatra of the BJP's Youth Wing covered 3500 km and passed through 12 states. It was a peaceful display of nationalism. The Yuva Morcha wanted to assert every Indian's right to fly the national flag on every inch of Indian soil. "Why do it in Kashmir and not in Chhattisgarh?" asked J&K Chief Minister Omar Abdullah. A good question, which he himself should endeavour to answer. The chief minister of no other state had an objection to hoisting of the national flag. It is only he who objected.

The environment he created in the Kashmir valley is such that an attempt to hoist the national flag in Srinagar will "provoke" the separatists. It will be seen as an anti-Kashmiri move. He, therefore, launched a war on the Yatra.

The national flag is a symbol of India's honour and pride. Pandit Nehru described it in the Constituent Assembly as "a flag of freedom not for ourselves but a symbol of freedom for all people who may seek it." The



member from the Anglo-Indian community, Frank Anthony said that "while this is a symbol of our past, it inspires us for the future. This flag flies as a flag of the nation and it should be the duty of and privilege of every Indian not only to cherish and live under it but if necessary, to die for it."

The Supreme Court, while hearing the case of Naveen Jindal, now a Congress MP, described flying the flag as free speech, intended to highlight nationalism, patriotism and love for the motherland. The use of the national flag to express these sentiments is a fundamental right. When several separatists met at an auditorium in New Delhi three months ago to assault the very idea of India, calling it an unnatural nation-state that is

bound to disintegrate, they openly advocated segregation of its territory from the Indian union. This seditious exercise was described as free speech. The Central government expressed its inability to take any action. However, the Chidambaram combination, while expressing their inability to take action against seditious speeches, decided to prevent the exercise of nationalistic free speech when it came to carrying the national flag in Jammu & Kashmir.

Many have asked the question as to why anyone should have an objection to the carrying of the national flag. The answer indeed is intriguing as I endeavour to search for it.

Along with two of my colleagues, I landed in Jammu on the afternoon of January 24. Some policemen entered our aircraft and handed me an order, ostensibly under Section 144 of the Code of Criminal Procedure, which read as follows: "Whereas it has been reported that Shri Arun Jaitley is also landing in the district and there are inputs that the persons of these profile individuals (sic) is proning (sic) to create law and order problem besides heightening tension in



the district. Moreover, the security forces are extremely tied up with the law and order duties and maintaining very high level of vigil and surveillance that any further assignment connecting (sic) with the law and order problem are (sic) providing necessary security as per SOP to the high profile individuals under security cover, may not be possible."

We were, therefore asked to leave the district and the state of

Jammu & Kashmir. I had no doubt on the receipt of this order that it was illegal. The intention of the state government was suspect as its grammar. How could the power to issue a prohibitory order be used to extern us from the state?

We were there only to address a public meeting in Jammu and return. We were illegally detained at the airport for over six hours. We were not allowed to move out of the airport. After this illegal detention, we were misinformed that we were being taken to prison, and were "abducted." We were put in separate vehicles and driven for the next two-anda-half hours and dropped outside J&K, at Madhopur in Punjab, at midnight. Fortunately, our political colleagues in Punjab became aware of our presence at the border and arrived in large numbers to put us in their vehicles and find suitable lodging for us.

The next afternoon, we reentered the state carrying the February 16-28, 2011 O 18

Where is the source of power to physically put the two of us, along with our colleagues, in a vehicle, and without a legal order in writing throw us outside the state? Can the power under Section 144 of CrPC to issue prohibitory orders be utilised to arrest people for holding the national flag in Srinagar -even a solitary political worker? Where is the source of power for committing all these illegalities? In Srinagar all those who reached the Lal Chowk and the Dal Gate holding the national flag were arrested and physically assaulted. Some have even suffered fractures. I have personally brought this to the notice of the CM and DGP of the state.

The BJP Yuva Morcha's exercise has energised the BJP cadres. It has exercised public opinion. The political consequences of the debate apart, what was the message that the Chidambaram Omar duo was

trying to convey? They hijacked trains to prevent political workers from reaching the Jammu border.

They shabbily treated the leaders of opposition with the utmost discourtesy, detaining them illegally and deporting them without authority of law. They reduced the republic to a relic: on Republic Day, holding a national flag became a ground for arrest and torture. Why did they do so?

Omar Abdullah wanted to convey a message to the Valley: "I stopped the BJP rally." He wanted to increase his acceptability there even if it created an adverse opinion against him in the rest of the country. The home minister apparently agreed without realising the longterm consequences. He joined Omar in psychologically surrendering to the separatists' psyche. They converted the flying of the national flag into a prohibited activity.

The fact that many BJP workers reached Lal Chowk and flew the national flag even at the cost of their personal safety was an assault on the arrogance of the state administration.

The Ekta Yatra is over. But the political debate continues. How do you politically and emotionally integrate the state of J&K with the rest of India? Is it by weakening the political and constitutional relationship, something that started in 1950, or by strengthening it?

Most of India knows the answer. I only hope that the Chidambaram-Omar duo abandons living in denial.



The team will soon submit a final report to a high-level committee of the BJP on February 11, which will then, submit the reports to the President of India and other investigative agencies, including the CBI and the Comptroller and Auditor General of India on February 15, he said.

Smt. Bijoya Chakraborty said the Congress-led SPF Government in Manipur has been siphoning off funds meant for the development of the State for quite a long time.

The team also assured the fishermen of Loktak Lake that necessary steps will be initiated by the party to revoke the Loktak Lake (Protection) Act, 2006 under which fishing and other activities will be banned.

They also urged the concerned State Government to take up rehabilitation process of the 25,000 fishermen of the Loktak Lake before they are flushed out from the lake in the name of conservation.



The report reads, "India has slipped to 87th spot in Transparency International's latest ranking of nations based on the level of corruption, with the global watchdog asserting that perceptions about corruption in the country increased in the wake of the scam-tainted Commonwealth Games."

Transparency International's 'Corruption Perception Index' report covering the public sector in 178 countries shows that India fell by three positions from its ranking of 84th in 2009.

With an integrity score of 3.3, India is now ranked 87th in the world in terms of corruption. Neighbouring China is ahead of India in the list at 78th place, with a score of 3.5. It was at 79th position in 2009.

"India has gone down in the ranking as well as integrity score and this is a matter of concern and regret. It appears that the level of governance has not improved despite India having a skilled set of administrators," Transparency International India Chairman P S Bawa said here.

The rankings, on a scale of 0 to 10, are based on the extent of corruption and each government's ability to punish and contain corrupt activities, among other criteria. A score of

According to the report: "The perception about corruption in India seems to have increased primarily due to alleged corrupt practices in the recently held Commonwealth Games (CWG) in Delhi."

As many as four investigating agencies — the Central Vigilance Commission (CVC), Enforcement Directorate (ED), Income Tax Department and Comptroller and Auditor General (CAG)- are looking into allegations of corruption against the organisers of the CWG, which concluded here earlier this month.

The top three countries with the lowest level of corruption globally, as ranked by Transparency International, are Denmark, New Zealand and Singapore.

Denmark was ranked first in the report, with an integrity score of 9.3, while New Zealand and Singapore came second and third with a similar score.

Bhutan was the best performer in the South Asian region and was ranked 37th, with an integrity score of 5.7.

The report is based on 13 surveys conducted throughout the year by various international bodies, including the World Bank, the European Union, the International Monetary Fund and the Freedom House Foundation.

### Buying time and secrecy?

The apex court of the country had to once again come to the rescue of the country and fill the executive vacuum left by the Congress-led UPA. Its observations on the revelation of the names of Indians holding money in Swiss accounts are rather embarrassing. Adding to the shame is a wishy-washy press conference by the finance minister which obscured the issue, rather than clearing it up.

Usually the Supreme Court refrains from making harsh comments, but it seems that the judges were aghast at the government's arguments -hence phrases like "pure and simple theft" and "gigantic amounts plundered from national economy" and "how many zeros are there in that".

The necessity of such words, usually not part of court language, should turn any government red with shame. The bench vividly expresses bewilderment and anguish that, while the West is growing more active in producing evidence for illegal transnational transactions, India has taken a complete U-turn on the issue.

Worldwide, countries have joined ranks to battle against tax havens, and have consistently been working to end banking secrecy which veils underhand transactions. The most recent example: UBS, the largest Swiss bank, was compelled by the US administration to reveal the

names of tax evaders under the threat of being sued. The Swiss authorities amended bank laws and gave the desired data to the United States.

Our prime minister instead says that black money information cannot be made public because of international treaty obligations. The worst was when he himself said that there is no instant solution to bring it back. While doing so, the PM had completely forgotten his earlier commitment to the nation: he said he would initiate steps to recover more than one lakh crore rupees illegally stashed in Swiss banks

within 100 days of assuming power.

The former Himachal Pradesh chief minister and Rajya Sabha MP, Shanta Kumar, raised this issue recently. In a parliamentary delegation to participate in the UN General Assembly on the anti-corruption convention in October last year, Swiss representative Matthias Bachmann told him the Swiss government was committed to returning what it considers to be "stolen money" -and, besides, they had signed and ratified the UN convention against corruption. Indeed, the Swiss ambassador has categorically stated that there is no request whatsoever from the Indian government to reveal the names of those people whose money has been kept in Swiss banks. Such absolute inaction in this regard makes the Manmohan Singh government in some way culpable.

Shanta Kumar stated that out of 142 signatories of the UN convention on corruption, only 22 have not ratified it; India figures prominently amongst them. A GoM is still debating whether corporate and private houses have to be brought under the convention or not -indeed a flimsy excuse.

Apparently, the government is overtly and covertly attempting to cover up the black money issue.

While no one knows the actual amount, several sources



claim more than Rs 130 lakh crore was stashed away by 2001, which exceeded Rs 285 lakh crore by 2007, showing an increase of more than 80 per cent in six years. There is nothing surprising about this; that several wealthy Indians have quietly siphoned money to Swiss banks and tax havens around the world, while evading taxes and being conduits for illicit deals, is obvious. There could be wild allegations made against the top brass of the Congress, a fine political opportunity to many for mudslinging. And the more time passes, the more time there is for those under the scanner to shift their cash to safer houses.

And this in spite of the fact that, on July 30, 2009,

It is noteworthy that, whether it is the 2G scam, whether it is Swiss bank money, or any other issue related to corruption under the UPA, the SC has been compelled to intervene.

In the light of the SC's remarks, it would be desirable for the PM to clarify whether he chose to mislead the House by making a statement which has been contradicted by the SC. It is a matter of propriety and also a matter of privilege of the House. A straight answer from the PM would enable Mr Clean to keep his conscience clear.

The finance minister's press conference just raised more questions; his suggested five-pronged strategy fully establishes the government's intentions to postpone the core issue: disclosing the names of the guilty.

The delays and time-buying techniques all deserve a reply from no one other than the prime minister.

# UPA caught up in a new spectrum scam

PA Government at Center again was caught up in another new spectrum scam. This time this scam is related to allocation of 70 MHz of S-band spectrum by Antrix Corporation, the commercial arm of the ISRO, to a private firm, Devas Multimedia Private Ltd, owned by former ISRO scientific secretary M G Chandrasekhar.

The Hindu newspaper reported that CAG had estimated that the allocation without bidding had resulted in a loss of over Rs 2 lakh crore to the national exchequer — which would make it more than some of the estimates of the loss from the 2G scam.

It is pertinent to note that the Department of Space comes directly under the Prime Minister.

BJP nationalspokes person Smt. Nirmala Sitharaman, reacting on this new episode of scandal said, "Whole affair was vitiated by "The BJP demands that the fraud". government nullify the agreement for the allocation of S-band spectrum to a private firm and establish a comprehensive inquiry to establish the criminality behind the allocation. The government must recover the revenue lost to the government as well. We demand an immediate explanation from the Prime Minister," She said, noting that the Department of Space that looks after ISRO is controlled by the PM. The party also pointed out that while government-owned BSNL and MTNL acquired licences for 20 MHz of Sband Spectrum for about Rs 12,487 crore, Devas was apparently allocated 70MHz in that band for just about Rs 1,000 crore.

The nervousness of the government can be gauged by the fact that while on the one hand Dr. Manmohan Singh stands by "the power of judicial review .... to enforce accountability" and, on the other, his government even challenged the authority of judicial review. In the Supreme Court on January 18 it strongly defended the appointment of controversial bureaucrat PJ Thomas, facing a corruption case in a Kerala court, as Central Vigilance Commissioner, saying he was an "outstanding officer" with "impeccable integrity". In an affidavit it said there was no need for "consensus" of the three-member high powered committee for his appointment and claimed that no statutory norms were violated. It added: "It is well settled that a question of suitability should be left to the wisdom of the appointing authority".

Our Prime Minister is alive to the provisions of the Constitution earmarking separate compartments of functioning for the legislature, executive and judiciary but is oblivious, ironically, of that Article which makes the council of ministers "collectively" responsible for all its acts of omission and commission to the house of the people.

#### Avoid discrimination against BJP ruled states: Gadkari

BJP National President Shri Nitin Gadkari has written a letter to the Prime Minister Dr. Manmohan Singh highlighting the plight of calamity hit farmers of Madhya Pradesh and supporting the demand for financial assistance by the State Chief Minister Shri Shivraj Singh Chouhan. In view of central government's apathy to the State's demand Shri Chouhan has threatened to go on fast on February 13, 2011. Seeking personal intervention the matter Shri Gadkari has appealed to the Prime Minister to rise above partisan considerations and avoid discrimination against BJP ruled states. We are publishing the full text of the letter below for our esteemed readers.

Date: February 3, 2011

#### Dear Dr. Singh Namaskar,

As you are aware, Madhya Pradesh has been hit by extreme cold weather conditions causing immense damage to the standing crops in several parts of the state. Crops like Tur, Gram, pulses and Potato have been badly destroyed in many areas due to frost and icing cold. More than three million farmers have been severely affected. The State government survey reports have revealed that crops have been destroyed in 46 out of 50 districts, to an irrecoverable extent. According to the initial estimates of the State Government, Rabi losses have reached Rs. 7,600 crore.

The Madhya Pradesh government, under the leadership of State chief Minister Shri. Shivraj. Singh Chouhan has taken immediate measures to provide relief to the farmers. As an ad-hoc relief, the state has decided to waive the interest on Rs. 5,200 crore short term agriculture credit, nullify non-licensee moneylenders credit to farmers and fix the rate of interest for private moneylenders. The State Govt. has also increased relief funds from Rs. 500 crore to Rs. 700 crore for frost-hit farmers this week.

The Madhya Pradesh government has already placed its demand for financial assistance to the tune of Rs. 2,442 crore from the centre. Besides, the State Government has also demanded postponement of the bank loan recovery of public service undertaking banks and inclusion of farmer as a unit in the crop insurance scheme.

The State Chief Minister Shivraj Singh Chouhan has apprised me of the serious situation in the state. He was thoroughly disappointed at the Central Government's total apathy towards the plight of the farmers in Madhya Pradesh and has threatened to go on fast on February 13, 2011 to protest against the Central government denial of adequate financial support to the state to provide relief to the farmers.

It is highly unfortunate that the centre chose to ignore the demands officially placed by a Chief Minister and announced a token relief through political emissaries to placate the state Congress party president for narrow political considerations. We take strong exception to such political gimmicks at the level of the Prime Minister's Office. The BJP takes a serious note of this unprecedented attitude of the central government which is against all norms of healthy centre-state relations.

I urge upon you to rise above partisan considerations and avoid discrimination against the BJP ruled states. The interests of the farmers in Madhya Pradesh facing adverse climatic conditions and resultant severe losses should be of paramount importance to both the central as well as the state government.

I seek your personal intervention in this serious matter and earnestly hope that the expectations of the people of Madhya Pradesh would be given a serious thought and adequate financial assistance released to the state government without any further delay.
