


its imminent decline.

BJP demands Gita be declared a national book

Move to ban Bhagwad has been criticised widely Gita afoot in Siberian city of Tomsk it is an outcome of uneasy ties between ISKCON and Russian Orthodox establishment. Public prosecutor Victor Fyodotov who moved local court. at the instigation of local church Fyodotov wants "Bhagwad Gita, As It Is", with commentaries by ISKCON founder Swami Prabhupada banned. The case is about banning a book published by Bhaktivedanta Book Trust 20 years ago.

BJP has condemned the move to ban Geeta. The BJP even demanded that the Gita be declared a national book to protect it from being dishonored ever again. Leader of Opposition in Lok Sabha Smt. Sushma Swaraj said, "Srimad Bhagvat Gita must be declared a National Book so that no country can ever engage in any act of insult to this book in the future. The government should be proactive. This ban must be removed."

There is also criticism that the government has delayed its intervention, ignoring ISKON's red alert on a possible ban, an alert sent to the prime minister's office and to Sonia Gandhi on 1st November.■



Check price rise or Quit : Sushma Swaraj

Te have repeatedly been warning the government on the issue of inflation, but for the reasons, best known to the government, no visible action seems have been taken. The government is indifferent to the issue of inflation and is trying to confuse the people through

statistical jugglery. Simply doling out statistical figure could not fill the empty belly of the inflation hit common man.

The government has changed the parameter of poverty. The planning commission in affidavit filed in the Supreme Court has mentioned that the expenditure in excess of Rs. 32 in urban areas and of Rs. 26 in the rural areas raises on individual above the poverty line. And, anybody who is spending in excess of Rs. 32 in urban areas and Rs. 26 in rural areas is not eligible for the subsidies

given by the government and is gets out of the category of BPL. Such persons are considered to be affluent by the government. It may be correct that income level of 20% people may have gone up, but all this has widened income disparity. I urge upon the government to look at the plight of hawkers and petty traders who find it difficult to make their both ends meet despite doing very hard labour. I would like to know from the honorable Finance Minister whether the income of

such people has gone up. On the contrary, what all they had saved, has also been neutralized by the impact of inflation.

The government often mentions that reasons for inflation are the higher prices being given to farmers. However, the farmers are still committing suicides in Maharashtra and

Only the one who can speak the language of the common man is in a position to make the people understand the economy of the country. Those who indulge in jugglery of figures and speak figuratively cannot understand

the economy of the country nor can they provide solution to its problems. I would like to say that the rising level of income you are talking about is merely a sham. It is true that the income of few people has risen so much that they can afford to eat in five star hotels but I want you to look towards hawkers, vendors etc.

who toil hard to feed their families. I would like to know from the hon. Finance Minister as to whether their income has risen even by a single rupee. That is why I would like to remind you that the people I have mentioned have not witnessed an increase of even a single penny in their income despite constant use of phrase 'with rising levels of income'. is only selling one produce but all other things he has to purchase. However, you are not concerned about it.

Manmohan Singh's lack of leadership is a major obstacle to further reforms : Jaitley

he Hon'ble Finance Minister has proposed some demands for supplementary grants. The Finance Minister is the best judge of the money that his government requires. However, this is an occasion to take a serious look at the state of economy.

Last week, while replying to the debate on Price Rise, the Hon'ble Finance Minister raised some important issues. The global economic situation is challenging and India has struggled hard to take all steps to shield its economy from global crisis. He urged that more steps were needed and that the cooperation of the states as also the political parties was required to accelerate the rate of Indian economy. I would only partly agree with him.

The Present situation

It is undoubtedly true that there is a global slowdown in the post-subprime crisis. The Eurozone crisis has also contributed to the challenging situation. The hardening of crude oil prices presents a grim challenge. But then India did survive the effect of East Asian

crisis over a decade ago. Despite the global slowdown following the subprime crisis, we did maintain reasonable growth levels for over two years. What has happened now?

The Indian situation

The present state of economy is best described as hereunder.

► For over two to three years, both headline inflation and food

inflation are unacceptably high. The marginal reduction in rise of inflation does not mean that the prices are coming down. It only means that the rate of rise of prices is slower than what it was sometimes ago.

► Even though oil prices globally have risen, the *ad valorem* taxes

- charged at both centre and state levels, deals a dual blow to the taxpayers.
- ▶ There is a visible slowdown in the major infrastructure projects in county. The choice of ministerial personnel, who lead the infrastructure departments, have left much to be desired.
 - The Fiscal deficit targets are unlikely to be achieved. A 4.6 percent fiscal deficit this year, projected in the Budget, clearly appears unachievable. Interest rates have been hiked 13-times as the only effective step to contain inflation. The result of the hike has been to adversely affect competitiveness of the Indian industry. It has also dealt a severe blow to the sectors like manufacturing, automobile, real estate and housing.
 - For over three to four years no major decisions were taken by this Government in the policy domain.
 - Excessive corruption and scams, which have hurt governance, has lowered the credibility of India before the world. Corruption adds to the cost of a project. It leads to a backlash, where public opinion, media and judiciary, inflict a severe blow to those responsible.
- Formulation and implementation of policy are being vitiated by corruption. It leads to prospect of an investor in jail indefinitely.
- ► Investors are now carrying tales of Indian experience. Investment flows are declining. Indian



investors are now planning and making investments outside the country. The rupee has weakened as a currency. You find a paralyzed government, with Ministers pulling in different directions. There is a fall in the FDI inflows resulting in a serious loss in the business confidence and the investment environment in the country. This is going to have serious consequences on both job

Why this Paralysis

An enthusiastic nation needs a Government, which has determined leadership with credibility and an *aura* (Saakh) of the Government: The Saakh (aura) is with regard to the authority and credibility to the government.

When the Finance Minister speaks in support of the larger consensus, between the Centre and the states, between government and the Opposition on economic issues, is there consensus within the UPA? The proposed FDI in retail has been suspended not merely because of the national opposition to it but because there was a division in the UPA. The allies were opposed to it and the party was lukewarm to the proposal.

On FDI in retail

During 1998-2004, the NDA government never allowed FDI in retail. We were not against the very concept of FDI, in fact we opened many sectors, but this is one sector we did have reservations. I have opposed this proposal on several

grounds, some of which I will illustrate.

- Our manufacturing sector, at best, is modest. International investors will source internationally and most merchandize sold in the first instance would be sourced from the low-cost economies of the world. It will be ill-advised to open the sector till such times we can implement effective reforms to reduce the cost of our own manufacturing by introducing steps such as affordable interest rates, better infrastructure, better trade facilitation, low cost of power
- ▶ Structured international retail does not create additional markets. It will only displace existing markets. It will cost India jobs, both in manufacturing and in retail.
- ▶ In an economy, where over 58 percent of the economy is services sector and 51 percent of Indian workforce is self-employed, it will be ill-advised to displace this workforce, without reforming significant sectors of economy.
- ▶ There is no presumption that the elimination of middle-men (which will cost jobs) will ipso facto benefit the farmers. Recent data of the International Farm Comparison Network milk producers indicate that in the US 38 percent of the US dollars are spent on farmers and in UK only 36 percent goes to farmer. In India, where the milk sector developed its own cold chains and backend support, 70 percent of the consumer rupees spent goes to the milk producers and in case of cooperatives the figure is as high as 80 percent. We need to



replicate the AMUL model rather than blindly allow FDI in retail as at present.

The Congress stand on FDI retail in 2001-2002

The Congress party during the NDA government repeatedly raised this issue in Parliament. Shri Priya Ranjan Dasmunshi described the decision of FDI in retail as an 'antinational' measure. Other top leaders, since then, have been highlighting the dangers of FDI in retail at this stage.

GDP Decline

When the FM presented Budget 2011, he was very optimistic that he would achieve a growth rate of 9 per cent with an outside band of +/- 0.25 per cent in 2011-12. But the trends of growth in GDP have cast a pale of shadow over these budgetary projections. The first quarter GDP growth rate was only 7.7% in 2011-12. The second quarter GDP growth has been further lowered to 6.9%.

The sharp fall in GDP is because of the slowing IIP (the Index of Industrial Production). In fact, it is disappointing to note that the IIP has become negative in October 2011 at (-) 5.1% after recording a sluggish 1.9% in September 2011. If the October 2010 figure of 11.3% is compared, the fall is a staggering 16.4% decline in manufacturing. The signs of a slowdown were visible in September 2011 itself as the IIP growth was only 1.9% as compared to 6.1% in September 2010. The IIP growth in April to October 2011 is a meager 3.5% as compared to 8.7% in the April-October 2010.

The industrial growth slowdown is markedly severe in Mining and Construction. The growth in Mining is (-) 7.2% in October 2011 as compared to a robust 6.1% in the same period in January 1-15, 2012 O 11

2010-11. In fact, during April-October of 2011-12, the growth is negative at (-) 2.2% as compared to 6.9% in April-September of 2010-11. The manufacturing sector is showing all signs of a major slowdown. The quarterly growth rates which increased from a low of 4.3% in first quarter of 2009-10 to peak at 15.2% in the last quarter of 2009-10 declined steadily during 2010-11. In October 2011, the growth in manufacturing has slided into the negative zone at (-)6% as compared to a high of 12.3% in October 2010 (a decline of 18.3%). In fact, the manufacturing growth during April-October 2011-12 is a meager 3.7% as compared to 9.4% during the same period in 2010-11. The sectors that have been worst affected are 'Electrical machinery and apparatus' at negative growth of 58.8% followed by negative growth rate of 12.1% in 'Machinery and Equipment' and 11.4% in 'Rubber and plastics products.' The growth rates in the April-September 2010-11 period in Basic Goods is (-)0.1%, (-)25.5% in Capital Goods and (-) 4.7% in Intermediate Goods. In fact, the growth in overall consumer Goods has become negative at (-)0.8%. The sharp decline in Capital goods is rather ominous as it points to the investment worsening environment. The fall consumption is a pointer to the real possibility of a contraction in consumption spending which would have serious deleterious consequence for the economic growth in the near future.

With interest rates tightening and inflation leading to rising input costs, the economic growth story appears to be completely derailed.

Capital Goods

In fact, if the components of IIP are analyzed, it is seen that

growth in Capital Goods which was 21.1% in October 2011 is now a negative of 25.5% in October 2011. The growth in capital goods in April-October 2010-11 was 17.1% but has since reduced to (-)0.3% in April-October 2011-12. Similarly, in intermediate goods, the growth in October 2011 is a (-) 4.7% as against 9.7% in October 2010. The growth in intermediate goods which was 8.6% in April-October 2010-11 declined to 0.6% in April-October 2011-12.

The slowdown is reported in many sectors across the economy: Electrical machinery and apparatus: (-) 58.8%; Machinery and equipment: (-) 12.1%;Rubber and plastics products: (-) 11.4%;Cable,Rubber Insulated:(-) 82.9%;Cement Machinery: (-) 74.6%;Insulated Cables/Wires all kind: (-)38.2%;X-Ray Equoipment: (-) 35.8%;Plastic Machinery including Moulding Machinery:(-) 32.2%.

There has been slowdown in the Core infrastructure supportive industries such as steel, cement, fertilizers, coal, oil and gas . A contraction of 4.8% in coal and 8.5% in natural gas during April-September 2011-12 as compared to April-September 2010-11 shows that the economic engine is slowing down. The overall growth in Core sector industries has declined to 4.9% in April-September 2011-12 as compared to 5.6% in April-September 2010-11.

Credit Squeeze

The monetary market has undergone a process of tightening as RBI increased the Repo rates 4 times so far in the current financial year, a cumulative of 150 basis points. The RBI has so far tightened rates 13 times. With the cost of borrowing moving northward, business is finding it all the more disheartening to pump fresh



investments.

Revenue Situation

The revenue position of the Government is also not satisfactory. The budgeted revenue projections (18%) were based on an assumed GDP growth rate of 9% and an anticipation that inflation would remain pegged at around 5%. In the current scenario, the GDP has already slipped to 6.9% and given the inflationary trend close to double digits and the international situation, with US and EU economies faltering sovereign debt defaults/downward ratings, one would not be surprised

certainly indicative of the shrinking health of the economy.

Fiscal Deficit

This brings us to the issue of the fiscal deficit. Containing the fiscal deficit to the levels promised in the Budget (4.6% of GDP) is important to manage and contain public debt to sustainable levels in the long term and inflation in the short term which is the major concern. The current situation is that fiscal deficit as a percentage of the revenue receipts of 2011-12 (BE) is 68% as compared to 34.9% of the corresponding period in 2010-11. The revenue deficit is at 72.2% of

With ballooning fiscal deficit funded by increased public borrowings, the economy which appeared to be coming out of the grip of high inflation of around 20.2 % in February 2010 to 9.3% in January 2011 is once again being lapped up by another vicious inflationary spiral as the inflation is inching up again towards the double digit figure.

if the current years' GDP falls further. That would throw the revenue receipts off gear completely. The signs of a major slippage in revenue growth are already there. The overall revenue receipts of the Government has recorded a decline of 23.3% if the figures of April-September 2011-12 compared are with the corresponding period of 2010-11. Tax revenue (net) during April-September 2011-12 recorded an increase of only 9.1%. The slippage in non-tax revenue is a whopping 69.2% reflecting the Government's inability to push through the much promised disinvestment measures. The tax revenue growth is also very sluggish as the growth in the April-September 2010-11 was 25.7%, much higher than the 9.1% in the current year. The drastic reduction is

revenue receipts of 2011-12 (BE) as compared to 27.1% of the corresponding period in 2010-11. The primary deficit is at a whopping 109.3% of the revenue receipts of 2011-12(BE) as compared to 23% of the corresponding period in 2010-11. The fiscal deficit so far in 2011-12 is a whopping 110.7% higher than the same in 2010-11 for the corresponding period while the primary deficit so far in 2011-12 is a whopping 420% higher than the same in 2010-11 for corresponding period. Government has already decided to borrow Rs. 53,000 Crores more from the markets than budgeted. This can hardly be called fiscal consolidation ..it is in fact fiscal derailment. With no scope for another windfall bonanza like the 3G auction, the Government seems

to be in a desperate situation. The UPA which has all along given lip service to disinvestment now seems to be clutching this as the last straw to bail itself out. With a Government crippled from within, there is not even a ray of hope that anything significant would happen.

Inflation

With ballooning fiscal deficit funded by increased public borrowings, the economy which appeared to be coming out of the grip of high inflation of around 20.2 % in February 2010 to 9.3% in January 2011 is once again being lapped up by another vicious inflationary spiral as the inflation is inching up again towards the double digit figure. The inflation in October 2011 is reported at 9.73% and that for September 2011 at 9.72% which is only marginally lower than the highest recorded in this year at 9.78% in August 2011, in fact, the highest in the last 13 months. The marginal decline in inflation may be temporary considering that no major initiatives have been taken to augment the supply side in a significant manner. The double digit inflation in food items persists at 11.78% in 2011-12 so far even though it may be lower from 20.05% in 2010-11. Sustained high inflation is the cause for slackening business confidence and a declining trend in investments.

FDI inflows Declining

FDI in India has been on the decline since 2008. In 2008, the FDI was 42.5 billion USD which reduced to 35.7 billion USD in 2009 and 24.6 billion USD in 2010. (UNCTAD report). As per the DIPP, the pure equity FDI inflows in India declined from 27.33 billion USD in 2008-09 to 25.83 billion USD in 2009-10 to 19.4 billion USD in 2007-08. The trend in the current year is not too encouraging as in April 2011 only 3



billion USD inflow is recorded. As per a UN report, FDI inflow increased significantly in other BRIC countries during the same period. India's position in FDI slipped from 8th to the 14th position. Even Bangladesh has registered a growth in FDI during this period.

Indian Industries moving out

On the other hand, there is a trend of Indian industries investing abroad in greater measure as they find other economies as more conducive. The outbound FDI which was in the range of 20 billion USD in FY 2009 and FY 2010 has more than doubled in 2011 to 44 billion USD. With capital flight, there is loss of jobs and growth opportunities. The UPA has miserably failed in inspiring the investors both inland and external.

Exports

There seems to be some good news on the Exports front which increased by 45.96 % in April-October 2011 as compared to April-October 2010-11 while imports grew at 30.96% during the same period. During October 2011, exports grew at 10.82% while imports grew at 21.72%. To a dispassionate viewer, this data would be rather puzzling. We all know that the US and EU economies are going through a very trying time. They are traditionally India's trading partners contributing the maximum export demand. If these economies are not importing as much as they should be, the question arises as to who is importing from India. There are media reports that a recent IMF study showed that imports from India as reported by other countries do not add up to these exports figures. The Commerce Ministry has also admitted that there have been some misreporting of data. But the more disturbing are the reports that black money stashed abroad is being illegally brought back as export proceeds through over invoicing. But if the Government is serious to know the truth and plug the loopholes, it should examine these allegations seriously instead of trying to bask in glory where none exists.

There has been much talk by the UPA of channelizing investments in to the infrastructure sector through the PPP route. It has been seven years of UPA rule but no major achievement is worth citing.

The need for political consensus

You mentioned the need for political consensus. Undoubtedly, you need political consensus on these issues but can the government of the day say that I will adopt a hostile attitude to the opposition and the state. But you help me out; you cooperate with me when I need you, for certain steps needed to strengthen government. I would urge your government introspect itself of the attitude and your conduct in the past over seven years. I can describe your leadership by splitting it into three parts. Some are Introvertish, some are arrogant, and most others are sulking. You the Hon'ble Finance Minster appear to be an exception. Do you seriously expect such a leadership to take effective steps to build consensus.

Was it a part of consensus building that to win a vote of confidence on the Nuclear Deal, 19 members cross-voted or abstain on account of dubious measure used by our government? Was it consensus building that the MPs, who complained as whistle-blowers were arrested? Was it part of consensus building that you

consistently misuse the CBI in the states like Gujarat, UP and Andhra Pradesh. Have you counted the legislations that your Governors have held up for giving ascent in various non-Congress State Governments. Even in small matters like construction of national highways, non-Congress ruled states consistently are discriminated against. If you want to build consensus, you need a big You need a nondiscriminatory approach; you need to be fair; you need to consider the Opposition as an essential part of India's democracy and not a political enemy. Will you implement the Goods & Services Tax (GST) if there is a lurking suspicion in the states that the Centre will act as Big brother and not in a fair manner.

I agree with you that we need a political consensus in the larger interest of the nation. I only have a caveat to add. Steps for consensus building must begin from the Centre. A hostile centre and a hostile ruling party can never build consensus.

I hope your government realizes realistically where you stand. On February 24, 2011 while replying to a discussion on motion of thanks on President's Address. the Hon'ble Prime Minister advised me to read the appreciation of the whole world on India's economy. He asked me that I educate myself on those points. I have followed his advice. I will only read two recent comments in the Wall Street Journal. The article started with the sentence "Manmohan Singh's humiliation is complete" and it ended with the sentence "Indian may hail Singh as the Finance Minister who ushered in liberalization in 1991, his lack of leadership has become a major obstacle to further reform.

rice rise is a silent killer. It is an assault on common man. In February 2010, the hon. Finance Minister had promised that high food inflation would ease in four months. But, nothing has happened. They are not able to understand why these prices are rising. There is no remedy. The Government has tried combination of fiscal, monetary market intervention measures. But all of them have failed. Lack of foresight, lack of proper planning, lack of leadership and on the top of it, sheer incompetence, wrong economic policies, massive corruption in export and import are the main reasons for the price rise. It is because of the Government's mismanagement and wrong economic policies only. Inflation has caused several essentials condiments, spices, eggs, fish, meat, milk and pulses out of the common man's reach. If the growth is moderate, inflation is acceptable. The growth rate is also going down. Hike is everywhere. 24 Hike in the interest rates, hike in fuel prices, hike in fertilizer prices, hike in EMIs are turning Aam Aadmi's budget into a nightmare. Instead of taking poverty alleviation measures, the Government thought that they can reduce poverty by fixing the daily earnings of a person at Rs. 32 per day. Can anybody survive with Rs. 32 per day?

Even the rupee value is going down. It falls to an all-


time low. What has been done with regard to the report submitted by the Committee headed by Shri Narendra Modi? recommendations with 64 detailed actionable points have been made. recommended that all essential commodities should be kept out of the future markets. Setting Price Stabilization Fund, rehabilitation of the agriculture markets, expanding the priority-sector lending,

dissemination of information at all level, unbinding of the Food Corporation of India. These are some of the major recommendations.

The Government, is not able to explain to the people what is the action they have taken on the report. The price of petrol has been increased eleven times in twelve months in the name of rationalisation. It has an effect on the essential commodities. The price rise is mostly taking

place in food articles. The price of every item, sugar, rice, steel,

coal, tel, dal, etc., has gone up considerably. If vou attribute this food inflation to l o w e r production, it is not correct because there is record production. Union Government should take a serious view on the suicides being committed by farmers

BJP MPs were in the forefront in raising the issues of people's concerns in the winter session of the parliament. While Shri Prabhat Jha raised the issues of farmers' debt and suicide and railways, Shri Raudra Narayan Pani raised the issue of farmers' suicide in the Rajya Sabha. Every second farmer is deht ridden : Prahhat Jha

Rajya Sabha MP and BJP Madhya Pradesh President Shri Prabhat Jha speaking in the Rajya

Sabha said "It has always been said that India is an agricultural country. As per the NSSO report every second farmer is ridden under the loan. Situation has become so miserable that since 1995 to 2010 more than two lakh farmers have committed suicide. Though UPA led government has always been saying that they have written off the loans of farmers but despite that more than sixteen thousand

farmers have committed suicide." He added "In the recent 30 days more than 107 farmers have committed suicide. Farmers are selling their organs to repay their loans. Can we say that we are an agricultural country? We are having agricultural economy." He demanded that problems of farmers may be resolved.

Seven thousand railway stations are waiting for modernization: Prabhat Jha

During the last 60 years expansion of railways has not taken place as it was required. Its financial

> condition is also not good. Declarations were made to modernize railway stations but due to paucity of funds about seven thousand railway stations in the country are waiting for modernization. You declared that some stations would be converted into model stations but proper action has not been taken in this regard. In the field of transport there is a decline in the share of railways. In 50's decade it was 89% with share of road transport 11%. In the year of 2010-2011

railway's percentage is 20 and that of road transport is 80. Railway bridges and rail lines are also not in good condition. You have not achieved the target of laying new rail lines. Unmanned railway crossings have not been removed completely so far. Anticollision equipments were said to be fixed in three railway zones but nothing has been done. ■

UPA Govt responsible for farmer suicides : Rudra Naravan Pany

At present the farmers are committing suicides in a number of States like Punjab, Maharashtra, Andhra Pradesh, Odisha, Kerala and West Bengal of the country. Like in other States, the incidents of farmer suicides is also growing day by day in Odisha. Every day 47 farmers commit suicides and a suicide takes place in half an hour in the country. About 252 farmers had committed suicides from 2009 to 2011 in three years only in Odisha. We should resolve that such unfortunate incidents must be stopped. I hold Congress led UPA Government, which is in power since 2004, responsible for it. The Council of Land Reform was set-up under the chairmanship of Prime Minister more than three and half years ago in the country, but it has so far not met even for once.



Please, take a serious view on the suicide being committed by the farmers in Odisha. I request the hon. Minister to provide information regarding the same while making his reply. The CCI do not make reasonable payment to the farmers for their produces and the same is grabbed by the middlemen. I therefore request the hon. Minister that he should take notice of the irregularities being committed in the CCI.

Even an accident which resulted in his leg getting damaged from four places and the bone had to be replaced by a rod has failed to deter him from taking break from his relentless tour programmes. Simplicity and humility is his hallmark. No karyakarta, howsoever simple he might be, cannot say that he could not get an appointment from Nitinji. His approach is to seek solution. He never judges a suggestion on the basis of the age of the person. Even if a suggestion which is in the

interest of the organization comes from a junior most *karyakarta*, he accepts it. He has rare capability to involve everyone by giving respect to the seniors, befriending his equals and by remaining affectionate to his juniors. He is always full of honesty, commitment, accountability and ethics and wants to see these qualities in even the most ordinary karyakarta. He holds Atalji and Advaniji as his role model. Shri Rajeev Dhawan told an SC Special Bench of Justices B S Chauhan and Swatanter Kumar that it is "impossible" to believe that the

police had not kept the Home Ministry informed at all times. "It is not possible to believe that all the information was not being



sent to the home secretary. It is further rimpossible to believe that it was not being sent to the home minister. The Home Ministry a n d commissioner of police were

working together to decide as to what is to be done with Baba Ramdev," Shri Dhawan submitted.



Centre should dismiss Kerala government : BJP

The State unit of the Bharatiya Janata Party at its executive committee meeting urged the Centre to dismiss the Congress led Kerala government for the continued attacks on Tamils living in Kerala over the Mullaperiyar issue and the deteriorating law and order in the State. This was one of the resolutions adopted by the party at its two-day State Executive meeting held at Mettupalayam, near Coimbatore. The meeting was attended by State BJP President Shri Radhakrishnan, Vice-President Shri H. Raja, former State party presidents Shri L. Ganesan, Shri K.M. Lakshmanan, State secretary Shri G.K.S. Selvakumar and Coimbatore district party president Shri R. Nandakumar.

A resolution adopted on December 17 said the continued attacks on Tamils and their properties by anti-social elements were instigated by politicians. The resolution said the attacks on Ayyappa devotees, buses and shops belonging to Tamils were clear indication of the deteriorating law and order situation in Kerala and urged the Centre to dismiss the government.

The resolution said that whichever party came to power in Kerala since 1963 refused to provide water to Tamil Nadu and raise the height of dam beyond 120 feet. The resolution said agriculture in Madurai, Theni, Dindigul, Sivagangai and Ramanathapuram districts were hit by the inadequate supply of water.

The resolution said the Congress led Centre remained a mute spectator to the Kerala government's stand and continuing attack on Tamil people. Other resolutions include action against protesters

blocking the commissioning of the Kudankulam Nuclear Power Plant, bringing down the price of fertilizers, release of five fishermen held by Sri Lanka and calling for a permanent solution to Tamilnadu fishermen being attacked by Sri Lankan Navy.

A resolution demanding the State government to reduce the price of milk and bus fare, drop the proposed power tariff hike, drop the proposal of opening elite TASMAC shops and immediate implement the *Avinashi-Athikadavu* water scheme was also passed.

A resolution also urged the Congress led Centre to completely withdraw the decision on foreign direct investment in retail trade and called for re-routing of 13 pairs of trains operated on the Podanur-Irugur-Podanur section skipping Coimbatore. (FOC)

UPA hand tainted with farmer suicides

The agrarian economy of India is in shambles today. Needless mention that more than 60% of India's population whose livelihood is invariably linked to agriculture and who constitute the betrayed class of Aam Aadmi are facing existential crisis like never before. The apathetic and corrupt dispensation at the Centre seems to have let loose on the farming community who for ages have constituted the backbone of the country and the result is heart rendering and tragic. Even the repressive Colonial rule looked less tyrannical than the callous and cruel Congress led UPA rule which has forced lakhs of farmers cutting across states to commit suicide during its last seven years.

More one analyses the issue of farmer suffering in the country, more perplexing it becomes as the UPA for all these years trumpeted high economic growth as its major achievement while half of India was getting trampled under the weight of UPA's indifference and criminal negligence of the farm sector. There is no denying the fact that economic growth has taken place, but the question is who cornered the benefits, leaving peanuts for the Aam Aadmi? The growth story indicates that the UPA rule has obviously looked after a section of society well comprising the likes of A Rajas, Kalmadis, Chidambarams and Hasan Alis, while the Kalavatis

of Vidharva, Aam Aadmi of Bundelkhand and farmers of the rest of the country were being forced to take extreme steps in a welfare state like ours.

While looking at the issue of farmer suicides from the prism of politics may be improper, but how can one ignore the fact that the rising graph of farmer suicides under the Congress led UPA rule also coincides with the startling numbers of suicides cases being reported particularly from Maharashtra and Andhra Pradesh again ruled by the same Party which cannot be a mere coincidence but a proof of the deceit and treachery inflicted on the farming community over and over again by the Congress wherever it ruled.

While negligence of agriculture sector in the policy matrix, declining public investment and an overenthusiasm to withdraw farm subsidies under UPA rule may be attributed as the reasons for farmer distress witnessed in India, the response has been even more surprising and ill-conceived.

The Congress, faced with the criticism of being callous and responsible for the suicides of thousands of farmers right before the Parliamentary elections in 2009, announced farm loan waiver to the tune of Rs 70,000 crore in the budget of 2008-09. But, according to the National Crime Records Bureau, the loan waiver year of 2008 saw 16,196 farmer suicides in the country.

This was not an aberration but a pattern which has become synonymous with UPA rule. The following figures stand witness to this observation,

The magnitude of the crisis can be observed from the fact that more than 48,000 farmer suicide cases have been reported since 2008, when the farm loans were waived, and till 2010, with the data of 2011 still awaited. That every hour two farmers commit suicide and between 2004 and 2010, over 120,000 farmers committed suicide in India would put even the poor African nations to shame and the Congress led UPA can't escape blame for this horrendous statistics.

While on the one hand the farm loan waiver of Rs 70,000 crore in 2008 was publicized as a historic by UPA government, on the other hand it gave tax concessions of more than 15 lakh crores to corporates and industries during this period, as is evident from the Revenue Foregone Statements of the Finance Minister, without much of a fuss. The Government run by a band of economists have run a systematic campaign over



the years to project that all tax concessions to the industries and corporate are incentives and good for the economy while all subsidies to the farmers, the poor and the needy are bad and unproductive hence need to be curtailed. This approach has ruined India's agricultural sector, paralyzed India's rural economy and created a sense of despair among the Aam Aadmi forcing them to end life than live under this brutal and atrocious regime. Not only that the farmers were denied of cheap loans, or subsidized inputs and fair procurement policies, but in many places the land of the farmers was usurped under gun point to facilitate non-descript private investment in the name of SEZs. Even the former partner of UPA, the Left Parties did not hesitate to acquire land at gun point resulting in heavy loss of life and property in West Bengal. If all these were not enough, the farming community was threatened with FDI in the retail sector which would result in an unfair competition between the well entrenched MNCs and the poor farmers devoid of financial might, technology and scale economics which characterize the MNCs.

Farmer suicides have now acquired epidemic proportions in India and negligence of farm sector still continues unabated under the UPA rule. But, there are islands of hope in times of great despondency. The UPA need not look at global best practices, the least it can do is to replicate the agricultural success stories of states like Gujarat, Chhattisgarh and Madhya Pradesh, but that would require political neutrality and going

beyond narrow partisan politics which the UPA has hardly ever followed. While India languishes with an average 2.7% rate of growth in agriculture, Gujarat has clocked an average of 8% in the past decade followed by 6.7% of Chhattisgarh and 6.2% of Madhya Pradesh, as according to the latest CSO data. The above goes to suggest that while the Congress led UPA made empty promises on inclusive growth, it is the BJP led NDA ruled states which achieved this in reality.

Agricultural distress is a reality in India today and the

need for succor to the 500 million farming community can't be emphasized more. With twothirds of farmers outside formal credit system, declining investment in irrigation, declining subsidies as a proportion to GDP, and with severe crisis gripping the rural with economy unemployment, high rate of migration and food security concerns, one of the initiatives like loan waiver can hardly comfort the farming community of India. Congress led UPA government must wake up before it is too late. ■

Congress spent crores on Rajiv, Indira ads

Government had spent Rs 4.79 crore and Rs 2.46 crore on print media advertisements on the occasion of birth anniversaries of former Prime Ministers Rajiv Gandhi and Indira Gandhi respectively. These details were shared with the Rajya Sabha by minister of state for information and broadcasting CM Jatua while replying to a question in the Rajya Sabha. Stating that no campaign was released through electronic media on the occasion of Rajiv Gandhi's birth anniversary, Jatua said that "Rs 4,79,73,656/- was spent on print media advertisements on the occasion of birth anniversary of Rajiv Gandhi in 2011." The health ministry spent the highest amount of over Rs 95 lakh. Ministry of new and renewable energy spent over Rs 82 lakh followed by tourism ministry which spent over Rs 79 lakh on the occasion. Ministry of housing and urban poverty alleviation spent over Rs 65 lakh, Information and Broadcasting over Rs 58 lakh, while Social Justice ministry spent over Rs 51 lakh for the occasion.

Women and child development ministry (Rs 25 lakh) and micro, small and medium enterprises (Rs 21 lakh), also spent funds on print media advertisements on the day, Jatua said in his reply. On the occasion of birth anniversary of Indira Gandhi, the information and broadcasting ministry spent over Rs 60 lakh while social justice ministry spent over Rs 56 lakh.

Micro, Small and Medium enterprises ministry spent Rs 41 lakh, Ministry of Development of North Eastern Region spent Rs 25 lakh while ministry of Statistics and Programme Implementation spent amount over Rs 22 lakh. Water resources and women and child development ministries spent over Rs 19 lakh each, Jatua informed the Rajya Sabha.(PTI) ■

BJP submits privilege motion against Chidambaram

The Bharatiya Janata Party (BJP) on December 19,2011 submitted a privilege motion against home minister P Chidambaram, who has been in the focus of opposition ire for allegedly disrespecting Parliament by speaking to the media on a controversy over helping a former client.

Lok Sabha MP Yashwant Sinha submitted the notice to Lok Sabha speaker Meira Kumar after a meeting of the Parliamentary party chaired by Shri LK Advani. Shri Sinha reminded the speaker of the notice after Question Hour was over and wanted to speak on it. "You have not given a notice to speak. You are senior member and you should know the rules. Please sit down," the speaker told the BJP leader.

Another BJP leader, SS Ahluwalia, said the notice related to the "disrespect" shown by the home minister by making a statement outside of the house when Parliament was in session. "Chidamabaram has talked to the media outside when the Parliament session is on.

Instead of making a statement inside Parliament, he decided to give a statement to the media. This amounts to disrespect of Parliament. Yashwant Sinha has moved a notice of privilege against him," Ahluwalia told reporters.

The BJP-led opposition has been gunning for Chidambaram over his alleged help to a former client in quashing police cases of forgery against him. After days of furore in Parliament over the issue, the home minister at a media conference last week said he was "deeply hurt" and rejected the opposition charge that he had misused his office while withdrawing prosecution against S.P. Gupta, the businessman he represented as a lawyer.

The government and Prime Minister Manmohan Singh have strongly backed the home minister.

Ahluwalia said it was "not proper" on the part of the prime minister "to give a clean chit to Chidambaram".

"This is not right. All papers should be put before Parliament. There should be discussion and then Parliament will decide what is right or not," the BJP leader said.■

Development of defence infra essential in States bordering China : Khanduri

Speaking during the Field Marshal SHFJ Manekshaw Memorial Lecture on 'Bordering



States: The Bulwark of National Security' in New Delhi on December 17, Uttarakhand Chief Minister Shri Bhuvan Chandra Khanduri has cautioned the Congress led UPA government at the Centre against the tardy development of d e f e n c e

infrastructure in States bordering China. He said connectivity in most of the Border States has been neglected and thus poses a grave security hazard. "Reaching some border posts in India still takes two to three days. Comparatively China has gone far ahead with deployment of big vehicles, helipads and extensive border road network in its area," Shri Khanduri said.

He said besides strategic deployment of security forces in these areas, the road, rail, air network, schools, hospitals and other infrastructure was required to be built. He, however, lamented that development in Border States was not being done the way it should have taken place and insisted that there was an urgent need to improve the Border Area Development Programme. This, according to him, was also the reason for bulk migration of people from these States. Unless better facilities are made available to people in Border States, the problem will persist. Infrastructural leap in these areas will not only ensure preparedness of the country during emergency but will also be a deterrent to hostile neighbours, he maintained.

The Chief Minister also emphasised on constituting a centralized branch of intelligence agencies which is specialized in collecting vital information regarding infiltration, fake currency, explosives and drugs along the borders. Any disturbing development or tension at local level,



as in the case of China, can have serious implications on the nation as a whole. This can only be prevented through better amenities in States, Shri Khanduri said.

Earlier, introducing the topic, former deputy chief of the Indian Army Lt General NS Malik said all Border States were vital in ensuring the internal and external security of the country. He said all military operations offensive or defensive were carried out in the Border States and so their development cannot be compromised with.

Speaking on the occasion former Indian Ambassador to the United States Ronen Sen recalled the command of Field Marshal Manekshaw during the 1971 Indo-Pak war. The lecture was organised by the Conclave of Defence Services Veterans.

DELHI

10 lakh people signed anti-Govt forms : BJP

The Delhi BJP president Shri Vijender Gupta said that over 10 lakh people have signed anti-Government forms and resolved to dislodge the UPA-II Government at



the Centre and the Sheila Dikshit Government in Delhi. The two-day signature campaign ended on December 18. Shri Vijender Gupta also participated in the campaign at Ghazipur, in east Delhi, and told the workers and the people that they should resolve not to vote the Congress Government to power again.

White paper issued by BSP government was a bundle of lies : Naqvi

Reacting to the white paper issued by the BSP Government in Uttar Pradesh about the g o v e r n m e n t advertisement issued during its tenure, the BJP has said that it would have been better if the government have issued



a black paper about its black deeds. The BJP National Vice President Shri Mukhtar Abbas Naqvi while addressing a press conference at the state party headquarters on December 16, 2011 in Lucknow also demanded a high level probe monitored by the High Court in the bungling of Bundelkhand package. He also demanded the termination of Cabinet Minister Nassemuddin Siddiqui for his alleged role in looting of the Bundelkhand economic package and registration of case against him.

The BJP National Vice President also said that *Sushri* Mayawati led BSP Government in Uttar Pradesh should be given a place in the Guiness Book of World Record for its twin achievements - arrogance and scams. Shri Naqvi said that the white paper issued by the BSP government was a bundle of lies and it skipped the pertinent queries sought by the people.

He alleged that Congress's concern about the Bundelkhand economic package was just eye wash as the Congress led UPA Government remained a mute spectator when the money was looted by Mayawati government just because Congress needed support of BSP at Centre.

Shri Naqvi said that Congress and Rahul Gandhi were not concerned with the poor people of the country. The BJP state spokesman also alleged that as announcement of the Assembly elections was round the corner, Chief Minister Mayawati was holding Cabinet meetings through bi-circular to oblige the near and dear ones by giving them red beacon. "Not a single day passes without exposure of corruption by some minister of the Mayawati government but the Chief Minister has no courage to act against them (the ministers)," he said. He said that Cabinet minister Naseemuddin Siddiqui was busy in destroying documentary evidences against him by misusing his official position. Shri Pathak urged the Election Commission to take cognizance of the transfers of police and administrative officers these were being done to take undue benefit in elections through the blue-eyed officials posted at desired places.
