

Democracy murdered in Rajya Sabha by naked misuse of power

The last week of the last month of 2011

Date: 29 December

Place: The upper house of parliament where voices in defense of democracy reverberate.

The democracy was murdered there in the presence of the Prime minister and the Finance Minister right in the middle of night by naked misuse of power. It was really pathetic to see that Congress led UPA had no qualms of conscience in undermining the dignity of the parliament and implicating its name in the murder of democracy. The sight of the murder of democracy witnessed by the entire nation which was relayed live on all the TV channels. Not only Lalu-Mulayam-Jaylalitha-Karunanidhi-Ramvilas-CPM-CPI including independents but everyone was awaiting the amendments in the Lokpal Bill. All of them had complete faith that Congress will bring in these amendments honestly and make the weapon of Lokpal more effective against corruption. But their hopes were belied.

The situation witnessed in Rajya Sabha after the government's failure to get constitutional status for government's Lokpal Bill in Lok Sabha gives rise to many doubts over UPA's ability to get the Lokpal Bill passed in the parliament. The approach of the Congress makes it clear that it doesn't want corruption in country to end. Congress has extended its full support to the corrupts. Congress wants to save the skins of the corrupt within its own fold. In his effort to save the Home Minister implicated in 2G spectrum scam, the prime minister has lost whatever credibility he had in the eyes of the people.

Why the government is shying away from amendments in government's Lokpal Bill? Will the voice against corruption be muzzled in the country? If people say that Congress is the progenitor of corruption then what is wrong in it? India wants an answer to this question from the Congress while people will have to see through the intention of the Congress. Who are giving protection to the corrupt? Who wants to see that corruption gets a new lease of life in the country?

The manner in which the Congress fled from the house only points to the fact that

President as protector and guardian of Indian Constitution must act during Constitutional breakdown : BJP

BJP leaders on January 2012 met the Hon'ble President of India Smt. Pratibha Patil to protest against the Government's complete subversion of Indian Parliamentary institution over the Lokpal Bill by not holding a vote in the Rajya Sabha. It sought the President's intervention to re-convene the House to enable voting on the crucial anti-graft legislation. The BJP delegation led by BJP National President Shri Nitin Gadkari, Parliamentary Party Chairman Shri LK Advani, Leaders of Opposition in both Lok Sabha and Rajya Sabha Smt. Sushma Swaraj and Shri Arun Jaitley met Smt. Patil and handed over a memorandum to her seeking the special Parliament session. Full text of the memorandum is given hereunder:

Dated: January 5, 2012

Mahamahim Rashtrapati ji,

We, the Members of Parliament belonging to the Bharatiya Janata Party, are constrained to encroach upon your time to place our grievance with regard to the complete subversion of Indian Parliament on the midnight of 29th December, 2011.

The Winter Session of Parliament was extended for 3 days from the 27th to 29th of December, 2011 for the purpose of considering and passing "The Lokpal and the Lokayukta Bill, 2011". The Bill had been passed in the Lok Sabha on the 27th December, 2011. The Rajya Sabha sat throughout the following day i.e., on 28th December, 2011 and Members repeatedly mentioned as to why the agenda for the Bill was not being circulated for discussion. We understand that Your Excellency had approved the consideration of the Bill by the Rajya Sabha in the afternoon of 28th December itself. However, the Government had other ideas. Since they did not have the majority to pass the said Bill, the Government's strategy was to either manage and win over some smaller political parties or, alternatively, to somehow drag the discussion of the Bill and not allow its passage. It was as a part of the strategy that the Bill was not taken up for consideration on 28th December, 2011.

The discussion started at 11 a.m. in the morning of the 29th December, 2011. It was scheduled to be an 8-hour discussion which would have ended by 7 p.m. and a vote taken thereafter. Several Members who had to vote had proposed certain amendments to the Bill. Most opposition parties and certain other smaller parties had made it clear in the course of the discussion that they would insist on three amendments, virtually common in nature, to the Bill being considered for a vote. The BJP itself had made it clear that they would support the Bill as amended by those three amendments. These parties which supported the three amendments themselves constituted the majority of the House. Clearly, the opposition was in a majority and the Government in a minority.

It became an open secret around 6 p.m. that the Government had failed to muster support of any of these smaller parties in the Rajya Sabha. Its' strategy now was to disturb the House and enforce its adjournment so that a vote could be avoided. The Government wanted to claim extra time in order to ensure that the political turn of events might help it to manipulate a majority. Besides prolonging the



discussion, the Government benches started raising an objection that the midnight was approaching and the vote could not be taken.

Rule 13 of the Rules of Procedure and Conduct of Business in the Council of States clearly states that a sitting of Council should conclude at such hour as the Chairman may direct. There have been on several occasions sittings of the Rajya Sabha continuing beyond midnight. Objections have been raised whether the day's sitting would end at 12 of the midnight. The Chair has consistently ruled relying on Rule 13 that the parliamentary day continues as long as the agenda of the day is not exhausted. Thus, 22nd December 1980, 17th September 1981, 8th May 1986, 29th December 1986, 14th December 1987, 11th May 1988, 12th October 1989, 13th October 1989 and 4th June 1991 are some illustrations when the House has sat beyond midnight. Obviously, the objection of the Government was not sustainable.

The Government benches then engineered disturbances; initially through a friendly party and subsequently by its own members. These disturbances were contrived to earn an adjournment so that a voting could be avoided. When governments disturb proceedings and the House is adjourned, it sets a terrible precedent which would always be pointed out by potential disturbers. The legitimacy of the House to question such future disturbances is dented. The effort to avoid a vote through contrived disturbances is a clear subversion of parliamentary democracy. A government which avoids a vote has no moral authority to continue in office. If a state government avoided a vote in a legislature in this manner, it could be argued that governance is not being carried on in accordance with the Constitution. How does the Indian political and constitutional system countenance a central government which does the same? When such a breakdown of the constitutional machinery takes place, the President as a protector and guardian of Indian Constitution must act. The President could advise the government to re-convene the Session and immediately take a vote. The government must be asked to explain the reasons why the House was disturbed through such contrived disturbances.

This incident has left a blot on India's parliamentary democracy. The nation looks up to Your Excellency, The President, to restore the credibility of India's Parliament.

Congress prevents nation from getting strong Lokpal : BJP

he Congress Party led UPA has on December 29,2011 prevented the nation from getting a strong Lokpal. The strategy of the Bharatiya Janata Party and several other opposition parties was clear. We would defeat a weak and spurious Lokpal law but we would insist on amendments which would improve and convert the weak law into a strong law. We would insist on the passage of a strong law particularly in the Rajya Sabha where numbers were on the side of the Opposition. We had categorically mentioned that the consensus amendments amongst opposition parties on three basic issues, namely, protecting the legislative jurisdiction of the States by making a model law under Article 252, by liberating the appointment and removal process of the Lokpal from the clutches of the Central Government and by making the investigative process simpler and the investigative agency more autonomous, was nonnegotiable. The intention was that these three changes be incorporated Government's draft and we would have approved the amended law.

The Government delayed initiating a discussion on the 28th of December and deferred it to 29th December 2011. It wanted to give more time and flexibility to its managers who wanted to

manipulate certain political parties. They did not succeed. Their allies were drifting away. The Trinamool Congress had a serious problem with the State's jurisdiction being usurped. The National Conference had its own objections. It became clear by the

evening that the Government's attempt to manipulate majority had failed. h e numbers w e r e loaded in favour of h amendments which would have created a strong

Lokpal mechanism. honourable Government would have either allowed a vote as per the mood of the House and the Nation or agreed to certain amendments. The UPA wanted a weak Lokpal. It could do neither. It, therefore, decided to subvert the parliamentary institution. It requisitioned a friendly party to organize a disturbance but the friendly party had only three members. The disturbance was not effective enough. Government filibustered with an endless debate which had

become repetitive towards the end. It was working towards an unacceptable argument that at 12 PM midnight the house would automatically stop working. The Government created a disturbance and got the House adjourned. At the stroke of the

midnight hour when the world slept, India awoke to a great fraud being played on its parliamentary democracy.

It is now crystal clear that this Government does not want a strong Lokpal. It merely wants a spurious and a phony mechanism which can be manipulated by the Government. The battle for creation of a strong and effective Lokpal shall go on.

The subversion of the Rajya Sabha last night by the Government by denying it the opportunity to make an effective legislation is a significant moral



scar on this government. The Prime Minister must now live with one more moral stigma. He won the 2008 vote of confidence through bribery. He has now led a government with subverted parliament and prevented it from legislating effectively on the Lokpal.

The UPA appears to be disintegrating. One of its allies had openly declared its intention to vote against it on a key issue. Another ally, the National Conference, had expressed reservations about the Government's resort to Article 253 for making this legislation. This is the beginning of the end of the UPA Government. Its allies will disintegrate and its voter base will shrink.

A big lesson for the UPA after yesterday's midnight fiasco would be that it pays to walk straight. The UPA appears to have lost that habit of being politically correct. Management, manipulation and fixing seem to be its only key areas of preference. Such fixers are good when the going is good. When the going is not so good even they collapse. This is what has happened yesterday.

A Government which shies away from a vote and uses extra constitutional methods to avoid a vote, loses both political and moral authority. The UPA Government has no right to continue even for a moment. We demand that the prime Minister and his Government must now resign and seek a fresh mandate on the issue whether it is their version of Lokpal. Let India decide whether it wants this Government's version of the weak Lokpal or our version of a strong and effective Lokpal.■

Weak Lokpal Bill introduced by UPA will create communal rift : Gadkari

The BJP on December 24, 2011 sounded the poll bugle in Punjab by organizing a huge rally in Jalandhar district. In the rally the party highlighted poor governance of the Congress-led UPA government, corruption,

inflation, black money stashed in foreign banks and a "weak" Lokpal Bill, also highlighted the "unprecedented" development brought about by the SAD-BJP government in the state.

The meet was attended by BJP National President Shri Nitin Gadkari, Leader of Opposition in Rajya Sabha Shri Arun Jaitley, Chief Minister Shri Parkash Singh Badal, Lok Sabha MP Shri Navjot Sidhu and State affairs in-charge Shri Shanta Kumar.

While addressing the rally, Shri Gadkari slammed the Centre on the issue of black money by asking why was the UPA not disclosing the names of those who have unaccounted money in foreign banks. "When the BJP comes to power, it will bring back all the black money and use it to develop rural areas," he added.

Speaking on the Lokpal Bill, Shri Gadkari claimed that a weak Bill introduced by the UPA on the basis of caste and religion will create communal rift among the people. In his address, Shri Arun Jaitley also spoke against the Lokpal Bill, calling it a "highly weak Bill, which abolishes the rights of the State governments and finally results in creating crisis for the country's federal structure". "As this Lokpal will



be created and removed by the government, the UPA will have the institution in its pocket," he added.

Shri Jaitley further went on to term the ruling alliance as not merely a political but a social alliance, which has mitigated the rift created by the Congress between Hindus and Sikhs.

"The huge turnout in SAD's Moga rally and today's rally is a reflection that the people are with satisfied their government," said the chief minister while addressing the gathering. Criticizing the UPA its "step-motherly treatment" towards Punjab, Shri Badal claimed that he was committed to the State's development and had succeeded in his mission of developing infrastructure in rural Punjab.■



A bill full of discrepancies and contradictions : Sushma Swaraj

The Lokpal Bill introduced in the parliament by Congress led UPA government received all round criticism from the people. While the bill was full of contradictions and discrepancies, the government failed to justify its various provisions. It only revealed a game plan of the Congress led UPA which rather than building consensus on the Bill moved ahead to create confusion and discord. In the Lok Sabha, the Leader of Opposition Smt. Sushma Swaraj criticized its various provisions and sought to amend the Bill by making some constructive suggestions. She was right in her criticism while questioning certain provisions which could have never passed the test of judicial scrutiny. It was clear that Congress led UPA was never serious in getting Lokpal Bill passed and all its moves were aimed at hoodwinking the nation and misleading the people by creating confusion and doubts. We are publishing the synopsis of the speech delivered by Smt. Sushma Swaraj in the Lok Sabha on Lokpal and Lokayukta Bill on 27 December 2011 for our readers. The full text of the speech is being published separately in a booklet.

The issue of Lokpal is being debated in the country for L the last one year. The movement launched by Shri Anna Hazare ji has further flared up this debate. The country was waiting with great curiosity that the Government will bring a strong Lokpal Bill during the Winter Session. But, the Bill brought by the Government has many shortcomings, this Bill violates the important provisions of the Constitution, there are enormous discrepancies in this Bill and this Bill has overlooked the sense of the House which was reached during the last Session. Our Constitution has some basic principles which cannot be tampered with. The power to legislate in regard to employees of the State Government is vested with the State Legislatures. A Bill should be enacted under Article 252 so that the State Governments could adopt it as it is or as they wish to do so. This Bill is being enacted to translate into action the Convention of the United Nations against Corruption. That is why



this has been brought under Article 253 of the Constitution. The law enacted under Article 253 is mandatory.

But, as per the Constitution amendment which has been brought, this is optional and the Government do not want to impose it on the States. This Bill is against our federal structure. On enforcement of this Bill, the Lokayukta Acts already in vogue in States will become null and void. The Government admits that this Bill has been brought under Article 253 of the Constitution then it should also be admitted that a law enacted under Article 253 is mandatory not optional.

Government has brought a Bill which is not only an attack on the federal structure of the country but it also dilutes authority of the States which are fighting corruption effectively. My other objection is related to the provision of reservation. The hon. Supreme Court has repeatedly said that the maximum limit of reservation will be 50 per cent but from the provision of this Bill, it is clear that the limit of reservation will be minimum 50 per cent and it can be anything above 50 per cent also. If there is limit of reservation of 50 per cent in Government's jobs then there is no reservation at all in respect of Constitutional posts and institutions. The Standing Committee has also stated that this reservation is not desirable. The Government has not only made a provision for reservation in respect of Constitutional institutions and exceeded the limit of 50 per cent but it has also brought religion reservation. Whatever we are doing today is not going to do



anything good for the country. Religion based reservation will sow the seeds of further division of the country. How we can tolerate that a patently unconstitutional Bill is passed by this House? Therefore, I have asserted that this Bill should be brought under Article 252 and since religion based reservation is not as per the constitution, therefore, it should be as per the constitution. I allege that this Bill is very weak. We had said that the CBI should be free from the clutches of the Government but

have said that the Lokpal is totally in the grip of the Government. This Bill is full of discrepancies and contradictions. The Prime Minister has been brought under the purview of the Lokpal with so many safeguards and riders that no one can even touch him. If there is any complaint against the Prime Minister then the full bench of Lokpal will decide and 3/4th of the judges will decide whether an action should be initiated on it or not. Where from this concept of 3/4 th has come. I

what happened is totally contrary. The CBI could not be freed from the hold of the Government but the Lokpal has also come under the control of the Government. What is the need of the jurist when we have the Chief Justice of India in the appointing panel of the Lokpal. My amendment is that instead of the jurist, the Leader of Opposition in Rajya Sabha should be included in it. The Government side is dominant in appointing the Lokpal and the method of his removal is all the wonderful. more Government will remove and appoint the Lokpal and then claims that it will be very effective, independent and impartial.

How it can be? Therefore I January 16-31, 2012 Q 12

have moved an amendment to make it 2/3rd. Section 24 has been added to this Bill. I do not know where from this section has come. The Standing Committee has not discussed about this provision then where from this section has come?

CBI is such a tool which converts the minority Government into majority. Therefore, we wanted that the CBI should be free from the clutches of the Government but now it has to report to four different authorities. The CBI shall report to the Lokpal for cases related to Group 'A' and Group 'B' officers, for Group 'C' and Group 'D' to the Central Vigilance Commission and to the Courts for the cases referred to it by the respective courts.

The Department Personnel and Training have administrative and financial CBI. control over investigation and prosecution wings of CBI should be separated and it should be brought under the financial and administrative control of the Lokpal so that it may be free from the influence of the Government and work as an independent investigative agency. It will not only enable the Lokpal to have an established investigating agency under its control but also help in creating a strong mechanism to fight against corruption. All the temples, mosques, Gurudwaras, churches and schools have been brought under the Lokpal but 57 lakh employees belonging to lower bureaucracy have been kept out of its ambit. The Government has ignored the sense of the House. The sense of the House was that lower bureaucracy should be brought under the ambit of the Lokpal, the Lokpal and the Lokayuktas should be constituted and a Citizen's Charter should be there.

There is a confusion about the Lokpal and the Lokayuktas. The lower bureaucracy has been brought under the Central Vigilance Commission and the Citizen's Charter Bill is under the consideration of the Standing Committee. We want that a strong, effective and constitutionally valid Lokpal should be constituted.

Therefore, either accept all the amendments suggested by us and improve this Bill or the Bill should be referred back again to the Standing Committee and the Government should bring such a fresh Bill which meets the expectations of the people.

Weak & phoney mechanism to fight corruption is inadequate : Arun Jaitley

The Lokpal and Lokayukta Bill passed in Lok Sabha was introduced in the Rajya Sabha by Congress led UPA government for discussion. The Leader of the Opposition in Rajya Sabha Shri Arun Jaitley in his speech argued that by legislating weak and phoney mechanism the government was trying to create a smokescreen that it has performed its task. He tore into the Bill highlighting its provisions which were an assault on federalism as guaranteed by the Constitution of India and said that the government had introduced a constitutionally vulnerable Bill. We are publishing the synopsis of the speech delivered by Shri Arun Jaitley in the Rajya Sabha on Lokpal and Lokayukta Bill on 29 December 2011 for our readers. 

Alternatively, if we are sincere in our effort to combat corruption

we owe it to our country to legislate effectively.

The present situation

Admittedly, we live in a society where people are losing faith in the integrity governance. Political funding in the world's largest democracy is not transparent. Discretions available to those in

governance at various stages are being misused. Land, mining, liquor, municipalities, natural resources, revenue departments etc. are hotbeds of corruption.

Do we support a phoney and weak bill or do we want to ensure a strong and effective law against corruption. Not only the government, its allies and every



political party in this House will be judged. Those who are willing to proclaim but unwilling to strike will be considered supporters of a phoney and a weak bill.

Was the Constitutional Amendment necessary?

Constitutional amendment which was defeated in the Lok Sabha willl not give any special status to the Lok Pal or the Lokayukatas. It merely provided that there shall be a Lokpal at the Centre and the Lokayukatas in the States. An effective Lokpal can be possible through an ordinary legislation as through a Constitutional amendment. A smoke screen was created by the Champions of the Constitutional Bill by claiming that they wanted to give constitutional status to the Lokpal. A mere status gives no power or authority. It is the Lokpal Bill which gives the power and authority. Giving a constitutional status and providing for a hollow and weak Lokpal was a fraud on power. Even without a constitutional amendment, a simple law would be adequate. But this law was being enacted only to please somebody who had assumed a status without authority to the Lokpal would be a game changer.

It is no part of Parliament's job to legislate a superfluous constitutional amendment. In any case, the proposed Constitutional amendment unless it clarified that it was the exercise of parliamentary jurisdiction under article 252, it would have amounted to usurpation of the State authority.

What are the Issues?

I rise to support the very idea of a strong Lokpal. I equally rise January 16-31, 2012 O 14

to oppose a weak and fragile Lokpal. How do I judge this law? I will elaborate three different criteria.

1) Content of the Bill

The appointment process (clause 4) is controlled by the Government of the day. Three out of 5 nominees of the government are on the selection panel . The criteria for being a member of the Search Committee

is not specified. The removal process (clause 37) is again controlled by the government. If a citizen is aggrieved against the Lokpal, he can only petition through the government which will decide whether to move the Supreme Court or not. If the government finds a particular Lokpal to be inconvenient, it has the authority to suspend him. Why should it be the government instead of the Supreme Court which should have the power to suspend a Lokpal. Does the

Government want a sword of Damocles' to hang over the Lokpal so that should he fall out of line, the government is entitled to suspend him. The staff of the Lokpal (section 10) will be appointed by a panel submitted by the government.

The procedure of inquiry and investigation.

The procedure of inquiry and investigation is absurd. The Lokpal has no power to act suo moto. The Lokpal can act only on a complaint. When he receives a complaint he will first decide whether to proceed in a case and if it decides to proceed further, it can make a prima facie inquiry. He will then conduct a preliminary inquiry through its inquiry wing to decide whether there is a prima facie case or refer it to the CVC who will conduct a preliminary inquiry. In the case of category A & B officials, the CVC will refer the matter back to the Lokpal who will now take a view whether the matter should be referred to the CBI or any other agency or not. While referring the matter to the Lokpal he will hear the delinquent officer and disclose the line of investigation to him. When the CBI investigates the matter it will send the final report back to the Lokpal who will now become the prosecuting agency.

Nowhere in the world the prosecution and investigation come under different agencies. They maintain an arm's length distance. The Directorate of Prosecution has to be professional but it does not have to go outside the CBI. It should not go outside the CBI. Additionally, the power given to the Lokpal to tinker with the CBI's investigation is against all



known canons of investigation. **The position of CBI**

We believe that the appointment of the Director of CBI should be made by an independent procedure. The collegium which appoints him must also appoint the Director of Prosecution. No one should be allowed to interfere in the CBI investigation – neither the Government nor the Lokpal. It is a well settled principle of the

criminal jurisprudence that it is the power of the investigating authority to decide as to how to investigate and whom to prosecute. Section 25 of the Bill needs to be amended where the power administrative and financial control, superintendence and direction over the CBI should be given to the Lokpal.

Similar amendment should be made in the Delhi Special Police Establishment Act.

Non Government organizations

The power under clause 14(1(h) given to the Lokpal to investigate persons who are not public servants but are officials of societies, trusts and NGOs is improper. It is a revenge on civil society that such a provision is sought to be enacted.

Clause 55 of the Bill needs to be amended. It is no business of the Lokpal to start funding and providing legal aid to corrupt officials.

given to the Prime Minister to hold his inquiry in camera lacks appearance of justice.

2. The government has brought a constitutionally vulnerable Bill.

a. Lack of legislative confidence

The State Lokayukata has two functions to perform. — The power to prosecute for criminal offences and the power to hold departmental inquiries against State employees. The power of criminal prosecution is available in the Concurent List i.e. Entry, 1, 2, 11A in List-III. However, the power of taking departmental action against civil servants of the State is a power exclusively in the State domain i.e. Entry 41 of List-II. The power to take

departmental proceedings (Clause 81(3)(b) is exclusively in the State domain.

Article 253 of the Constitution provides for enforcing India's international commitments. Why should the Government of India not prepare a model law and expect the States to follow it. Article 252 gives an adequate flexibility to the Parliament to make such a model law. There is no international

commitment of India which deals with reservation on the basis of caste and religion in any international convention. If the Central government believes that it has power to make State Lok Ayukatas Act then the State powers will be eclipsed and all existing State Lokavukata Acts would be invalid.

The provision of clause 64(5) would be redundant. If the Centre had the exclusive jurisdiction to frame such a law then transition to State law would not be required. Constitutionally the correct course would be to frame a law under Article 252 after obtaining resolution of two States.

b. On Reservation

c. Sense of the House

The sense of the House provided for a Citizen Charter and all civil servants to come under the Lokpal. Somehow, the government has proposed a separate legislation for Citizen Charter. We should be seen as honouring the sense of the House. The C and D category employees should be treated at par with A & B category employees. An additional facility can be given to the Lokpal to frame its own rules under which some of the functions can be delegated or some performed by the Lokpal or its delegatee.

Institution building is a challenging task. We are today attempting to create an integrity institution in India. Let us not subvert the institution even before it is formed. We need to create a powerful and independent Lokpal. Let us not create a subservient Lokpal. effective Lokpal needs an independent CBI. We must not provide for a pliable and weak Lokpal. The Prime Minister has made it appear as though there is a conflict between fighting corruption and federalism. Both can coexist. We are in the process of creating history; if we create bad history, the generations to come will not pardon us. They will be compelled to correct the error into which we are falling.

BJP march against 'murder of democracy'

Terming the failure of the Government to get the Lokpal Bill passed in Rajya Sabha by the UPA Government as planned conspiracy and a murder of democracy, BJP workers on on December 30,2011 staged a protest march from Delhi BJP Pradesh Headquarters to the Parliament.

Thousands of agitated workers were taken into custody at Parliament Street Police Station. Workers led by State unit chief Shri Vijender Gupta raised slogans: Congress ne aadhi raat ko ki loktantra ki hatya, jantantra ki hatya, Manmohan sarkar, isteefa do, isteefa do, jantantra ki hatyari sarkar, barkhasht karo, barkhast karo."

The workers tied black strips over their mouth and marched with black flags. BJP national vice-president Shri Mukhtar Abbas Naqvi was also present and said the history of the Congress has been to betray the people at midnight.

"The former Prime Minister Indira Gandhi had declared emergency at midnight of 24/25 June, 1975 and put lakhs of people in jails across the country. The character of the Congress is despotic and undemocratic. History is witness of the fact that whenever the Congress comes to power, the country has to suffer from corruption, price spiral and terrorism," Shri Naqvi said addressing the protest rally.

Addressing the workers before the protest march, Shri Gupta said the intentions of Congress Government were not good from the very beginning. Leader of the Opposition in Delhi Legislative Assembly Professor Vijay Kumar Malhotra told the demonstrators that now, the objective of BJP is to dislodge Congress Government because till this Congress misrule continues, 121 crore people of the country will have to face corruption, price spiral and terrorism.

Prominent party leaders *Sarvshri* Ramesh Bidhuri, Pravesh Verma, Ashish Sood, RP Singh, Subhash Arya, Yogendra Chadoliya, including other office bearers were present in the demonstration.■

BJP to collect funds from common men to contest election : Prabhat Jha

BJP Madhya Pradesh unit on December 26, 2011 announced that it will contest the next election frugally and collect funds from ordinary people, not moneybags. The party will not seek election funds from the rich and rather collect donations ranging from Rs 5 to Rs 1,000 from public ahead of the 2013 elections, MP State BJP President Shri Prabhat Jha said while speaking in the two-day state executive meet in Gwalior. Tough decisions like this will have to be taken to rid politics of corruption, which thrives because of expensive elections, he said insisting that the party's MP unit will be a torchbearer in this regard. "Let's start from here to bridge the trust deficit faced by politicians."



BJP-SAD alliance set to return to power

Punjab is on the threshold of assembly elections once again. It will go to polls on January 30.

BJP this time again is fighting the Punjab assembly election in alliance with its old time ally the Shiromani Akali Dal (SAD). In the last elections, BJP had contested 23 seats and won 19. After delimitation of constituencies it is the first assembly election in the State. This time again the Party is contesting the same number of seats with the difference that Batala and Garhshankar


constituencies contested by it have been swapped with Amritsar East and Ludhiana West contested by SAD in last Vidhan Sabha.

BJP-SAD alliance is as strong as ever. They are fighting the elections unitedly as one man. Although BJP is contesting only 23 seats yet, in the words of BJP Punjab State President Shri Ashwani Sharma, BJP impact will be felt in all the 117 seats in State.



Shri Ashwani Sharma is the President of Punjab Pradesh Bharatiya Janata Party. For the last about two years when he was unanimously elected to this post, he has infused in the Party the youthful dash and dynamism. He put the party in election mode for the past one year down to the booth level. That is why the Party has taken the announcement of the election schedule for Punjab in its stride. He brims with confidence that the BJP-SAD alliance will bounce back to power with greater majority not "on the basis of tall promises but on the strength of solid performance".

National Convener of BJP's Literature & Publication Cell, Shri Amba Charan Vashishth, spoke to Shri Ashwani Sharma in New Delhi last week before the names of BJP candidates had



been announced. He is himself contesting from Pathankot assembly constituency. Excerpts:

Now that election schedule in Punjab has been announced, how prepared is BJP for the challenge?

BJP is in top gear to face the election. It is not that we became active only after the elections were announced. We had been making preparations for the election for the past one vear in a constructive manner. Our preparations are in full swing down up to the booth level. We had organized a very big rally on December 23 at Jalandhar which was the biggest in BJP history. It was a display of party unity and strength. The rally also held a mirror to how strong the BJP-SAD alliance was. This massive rally was addressed by BJP National President Shri Nitin Gadkariji. Punjab Chief Minister Sardar Parkash Singh Badal and Deputy Chief Minister Sardar Sukhbir Singh Badal were also there and they addressed the people. Punjab party affairs in-charge Shri Shanta Kumar, National Vice-President and Election in-charge Shri Jagat Prakash Nadda were also there. Karyakartas are brimming with great enthusiasm to ensure Alliance's win. In a way the mood of BJP karyakartas appears to be that of celebrating a festival, the festival of elections in the State.

How different from the last is going to be the election scene this time?

The only difference is that last time we were in power and were seeking people's mandate on the promise to usher in a clean and efficient administration. Today, we are in power. The BJP-SAD Alliance has acquitted itself well by coming up to peoples' expectations. We have displayed accountability and transparency. The pace and extent of development during the last five years is in itself a record. People recognise this fact. Actually opposition Congress has nothing to find fault with the pace of progress registered under BJP-SAD alliance. All that they are now doing is only threatening the officers and the public that if we come into power, we will wreak revenge using the words like *maar diyange*, *kat diyange*. They have nothing to challenge our work.



We are more accountable towards the people. Comparatively the Alliance has done exceptionally well in comparison to previous Congress regime.

SAD is reported to have left 23 seats for BJP. Are you satisfied?

Yes. We demanded only that much seats. Two seats swapped between us, but the number of seats BJP will contest remains the same.

Is there any problem between SAD and BJP on number of seats or specific constituencies?

No, there is no problem. The alliance is fighting the election in complete harmony and unity as one unit and one man.

What was the criterion for selection of candidates?

Clean image, winnability, commitment towards the organisation and party ideology and contribution towards promotion and implementation of party programmes and policies..

This time election would be held as per the delimited constituencies. How far is this going to help or harm BJP?

It is the first election after delimitation of constituencies. BJP has swapped two seats with SAD. Yet, it makes not much difference. Our alliance will stand to gain from it.

What are BJP chances this time?

BJP has always played a prominent role in the State politics. We will continue to do so in future also Alliance government is dependent upon BJP. Although BJP is contesting only 23 seats, yet it will make an impact in all the 117 seats. As earlier, this time too BJP's contribution towards formation of a government in Punjab will be vital and crucial.

Are you yourself contesting elections to Vidhan Sabha?

I have never myself taken a decision about myself. Whatever will be decided by the party I will obey it most humbly. I am a disciplined soldier of the party. My only anxiety is that the party wins more seats than last time and the alliance is back in power.

What are the issues that are likely to dominate the electoral scene?

24 hour power supply with establishment of 5 <u>new power projects</u> are the hallmark of Badal government achievements. After one year we shall be selling electricity as do we sell agricultural products in the market. During Congress regime there used to be a 7-hour daily power cut. Business establishments were ordered to close at 7 in the evening.

A record 1,10,000 youth were given employment by BJP-SAD government in a most transparent manner.. Not a single complaint was received by the government. Every section of society was taken care of by the Government during its tenure.

How far is Manpreet Badal factor going to affect the SAD-BJP electoral prospects?

It will have no adverse impact on the alliance.

Two of his nearest supporters have already deserted him.

BSP has announced candidates for all the seats. How would it affect the outcome of the result?

BSP will not harm us in any way. Wherever it makes a dent, it will not adversely impact our alliance.

Why should people vote for your alliance?

Because the people have seen unprecedented development at a fast pace. We are not seeking votes on the basis of our promises but on the strength of our marvelous performance. We have delivered much more than what we promised. Above all, rampant corruption at the Congress ruled Centre, resentment over UPA's proposal to allow 51% FDI in retail trade, rising prices and discrimination against Punjab on political grounds will work against the Congress.

Do you think BJP-SAD alliance will bounce back to power?

Most certainly with greater majority of seats than last time.

What are the positive and negative points of your alliance?

Our Alliance has won people's faith. Congress has no positive plan of action and development. Congress is not coming out with some constructive promises. It is only threatening both the bureaucracy and our supporters with dire consequences after they win elections.



We will go to the people on the basis of our work : Bishan Singh Chufal



As the Election Commission announced the polling dates for State assemblies, Uttarakhand has also entered into election mode along with other four States. The State will go to polls on 30th January 2012 and the counting will take place on 4th March 2012. Uttarakhand assembly has 70 seats with BJP government led by chief minister Maj. Gen. (Retd.) Bhuwan Chandra Khanduri in power in the State. In the last five years of BJP rule Uttarakhand can count on many achievements. Apart from becoming the first State in the country to create a dedicated ministry for bringing in necessary administrative reforms to reduce nepotism and red tape, the chief minister, the entire Cabinet and top officials of the State administration have declared their assets. Not only that the Lokayukta Bill, 2011 has been passed in the State assembly, the government has also passed the Uttarakhand Right to Service Act, 2011, the Uttarakhand Special Courts Act, 2011, and, the Uttarakhand Transfer for Public Servants Act, 2011 creating a new era of hope, development and growth through an accountable and responsible administration. Even though the State faced discrimination at the hands of centre as the

Congress led UPA government abruptly withdrew the special package granted to Uttarakhand by Shri Atal Bihari Vajpayee led NDA government, the BJP government in the State was able to subsidise rice and wheat for both people below and above poverty line in the face of rising prices. On the basis of its achievements BJP hopes to renew its mandate in the coming assembly polls as BJP State President hopes to form the government with two-third majority this time. Dr. Shiv Shakti Bakshi and Shri Sanjeev Kumar Sinha from Kamal Sandesh spoke to Shri Bishan Singh Chufal last week just before the announcement of the first list of candidates in New Delhi. Excerpts:

BJP government has been in power in Uttarakhand for last five years. What are the major achievements of BJP government in these five years which the party plans to take to the electorate in the coming elections?

In the 2012 assembly elections we will go the people on the basis of the work which BJP government did in the last five years. Our first achievement was to implement 108 Pt. Deendayal Upadhyay health services schemes. The people in the remote areas where not even a single doctor was available got immense relief from this scheme and

thousands of lives were saved and better health facilities were provided to infants. We also made provision for 50% women reservation in *panchayat* elections. It strengthened the process of women empowerment. We also started 'Gaur Kanya Dhan Yojana' under which financial assistance was given to the girl students passing intermediate examination. If a girl is born in the family, 'Nandadevi Kanya Yojana' has been started for her. The medical education was made possible in Rs.15,000/- only. Transparency was maintained in recruitments. In Uttarakhand there used to



be written exams followed by interview. In the written exams the candidates used to pass but in interview they used to get less marks. Candidates having access to power used to get selected. The system has been remodeled now. The other work was to provide food grains at cheaper rates. The price rise due to the wrong policies of the UPA government has made the life of the people miserable. We made arrangements for cheaper food grains. Today APL and BPL families are getting ration at cheaper rates in the entire State. The manner in which Honb'le chief minister Shri Bhuwan Chandra Khanduri has brought Lokayukta Bill in the State so that corruption is reduced and public fund is invested in public works and people may get benefit has been appreciated everywhere. We will also go to the people with this achievement. Right to Services has enabled the people to get their papers in time. The other important achievement is about restoring rights over land. As per Forest Act 1980 the rights of the people over land were restricted which impeded the developmental works. Now that draconian provision of the law has come to an end and people can carry out developmental works on the civil and barren lands without seeking permission of the government of India. It has also enabled distribution of land to the landless. We will go the people with these developmental works.

When BJP forms the government the role of the organization becomes important as BJP is an organization based party. In the party, ideology and discipline are considered very important. How the organization and government worked together so that the achievements of the government were taken to the people by the organization?

In the last five years the organization and the government worked in complete harmony. We tried to take the achievements of the government to people through the organization. We have six Fronts and 35 Cells. They have their own team of office bearers. Our executive committees from mandal to district level have been constituted.

We have organised many programmes

through these committees. We have organised training programmes from mandal to district levels. The training programme of Mahila Morcha and Yuva Moracha have been organized. In these training programmes sessions were organized on how to propagate the achievements of the government among the people. It has helped people to get a lot of information. Today, the organization has reached upto booth level in the State. A team has been constituted in the State which is taking the developmental works of the BJP government in the last five years to the people. Our MPs in the parliament are also raising the issue of discrimination meted out the State in denying industrial package, natural calamity relief and economic package by the Centre, we are making people aware of this sort of discrimination. We are a cadre based party. There is complete harmony between organization and government. We all are united in our aim to form the government in 2012 elections.

The organization has the responsibility to give good leadership to the people. Since the elections have been announced, how the party plans to select its candidates so that good candidates get elected by the people?

In view of the elections this time we have constituted teams at *mandal* and district levels to select good candidates. The names were identified after consulting all the activist of the party and on the basis of their recommendations. The State Selection Committee then considered these names. The basis of the candidate selection is the image of the candidate and his chances to win election. The name of such types of candidates were identified from among the activists and sent to the Central Parliamentary Board after considering them at the State level. The State Selection Committee has laid emphasis in its discussion with State election In-charge Shri Thawarchand Gehlot that the names of the candidates be finalized unanimously.

Party General Secretary and our chief Party ideologue, Pandit Deendayal Upadhyaya wanted me to set up the party's parliamentary office and assist the small group of MPs the party had. Since then I have been closely associated with the party's parliamentary wing. The association continues till today.

Looking back at the year just ended I issued a statement complimenting the party's new President Nitin Gadkari under whose leadership the party had become "considerably stronger and more vibrant."

So far as the two Houses of Parliament are concerned, public opinion has been unanimous that both our party leaders January 16-31, 2012 O 22

Sushma Swaraj and Arun Jaitley have always made outstanding contributions to the deliberations of Parliament. The Party is justifiably proud of them, who are Leaders of Opposition in the two Houses.

It is not only their individual performance in the House that evokes admiration, and raises the level of debate, but also their management of the parties which makes the BJP a really formidable opposition in Parliament.

Since Jana Sangh days, during the Session period, all party MPs from both Houses meet religiously every Tuesday, and discuss what has transpired in the earlier week, and what is likely to come up during the current week. BJP MPs tell me that Congress MPs privately envy how BJP members have easy access to their leaders and how at these weekly meetings, have no difficulty raising issues unhesitatingly.

It was during my incarceration in the Bangalore Central Prison during the 1975-77 Emergency that I read Alvin Toffler's FUTURE SHOCK, and became an admirer of the author. Later I read his THIRD WAVE and POWERSHIFT. Powershift

is an engrossing book which focuses attention on three major sources of power: the army, wealth and knowledge and traces the history of how power has been shifting from one to the other, and how in the present era, knowledge societies have come to wield exceptional influence.

Last week a friend from New York presented me the latest book on the same subject by a scholar who has specialised on how power has evolved in the modern world. This book, titled THE FUTURE OF POWER is authored by Joseph S. Nye, Jr., a former Dean at the Kennedy School of Government at Harvard University.

In the era of Kennedy and Khrushchev, Nye writes, power resources were measured in terms of nuclear missiles, industrial capacity, and number of men under arms and tanks lined up ready to cross the plains of Eastern Europe. But the global information age of the twenty-first century is quickly rendering these traditional marks of power obsolete, remapping power relationships.

The book is said to be "a new power narrative that considers



the shifts, innovations, bold technologies, and new relationships that will define the twenty-first century."

The book uses three epithets repeatedly to qualify power: hard power, soft power and smart power. In his preface to the book the author quotes Secretary of the Defense Robert Gates urging U.,S. Government to commit more money to 'soft power tools', including diplomacy, economic assistance and communications. U.S. military spending, he pointed out, was more than \$36 trillion. Joseph Nye has coined the phrase 'smart power' to describe a nation's capacity "to combine hard and soft power into effective strategies in varying contexts."

An interesting example cited by the author in the context of Pakistan going nuclear runs as follows:

In the mid-1970s, France agreed to sell Pakistan a nuclear reprocessing plant that could extract plutonium, a material that could be used either for civilian purposes or for bombs. Concerned about the spread of nuclear weapons, the Ford administration tried to stop the plant by buying off Pakistan with high-performance aircraft, but Pakistan refused the deal. Both Fort and Carter administrations tried to prevail upon France to cancel the sale, but the French refused on the grounds that it was a legitimate sale for civilian purposes only.

Nothing seemed to work until June 1977, when I (the author) was in charge of Jimmy Carter's nonproliferation policy and was allowed to present French officials with new evidence that Pakistan was January 16-31, 2012 O 23

preparing a nuclear weapon. A top French official looked me in the eye and told me that if this were true, France would have to find a way to cancel the completion of the plant. Subsequently, he was as good as his word, and the plant was not completed.

"How did the United States accomplish this major objective? No threats were issued. No payments were made. No carrots were dangled or sticks brandished. French behavior changed because of persuasion and trust. I was there and saw it happen. This hardly fits the usual model of power that is prevalent in most editorials or in recent foreign policy books that do not consider persuasion a

form of power because it "is essentially an intellectual or emotional process".

BJP asks China to probe incident involving Indian diplomat S Balachandran

The BJP on January 3, 2012 condemned the treatment meted out to Indian diplomat S Balachandran in China and demanded that authorities there conduct a thorough inquiry into the incident and ensure that it is not repeated as several Indian businessmen visit the neighbouring country. "The Chinese Government must conduct a detailed enquiry into the deplorable incident and take appropriate action against those responsible for ensuring that the Indian diplomat was provided adequate security and other facilities while he was on duty," BJP spokesperson Shri Tarun Vijay said. He pointed out that though it was known that Balachandran is diabetic, he was not provided any food for six hours. Moreover, he was reportedly heckled while he was leaving. "A lot of Chinese goods come to India and our traders go there often. They are provided documents only in Chinese without any interpreters, and not given appropriate legal assistance or food. In some instances family members were also reportedly harassed," Vijay alleged, demanding that such grievances be addressed. He said 30 Indians are in Chinese jails and government should make efforts to free them. "Such incidents do not contribute to the stated Chinese intention to strengthen bilateral ties particularly people-to-people ties and are completely contrary to the declared desire for friendship," Vijay said. The BJP also demanded that India should increase its consulates in China from three to ten, insisting that even smaller countries like Indonesia and Malaysia have eight and six missions respectively. Presence of Indian media in China should also be enhanced, he said.

Agri growth rate of State reached in double digits due to farmer oriented schemes : Prabhat Jha



BJP State president Shri Prabhat Jha MP has greeted the farmers of the State for the rise of agricultural growth rate. He said, "The agriculture growth rate of the State has reached in double digits due to the farmer oriented schemes of the Shivraj Singh Chouhan led Government."

Shri Jha further said that the national agriculture growth rate has registered a negligible hike of 0.4 per cent while Madhya Pradesh not only registered a record growth of 9 per cent in the field but also buried the BIMARU tag affixed to it since long. KARNATAKA

State is developing fast like Gujarat : Sadananda Gowda

On attracting investment, Karnataka is fast outpacing developed states like Gujarat, which was the role model at president, Chief Minister Shri D V Sadananda Gowda said.

Addressing the gathering at a two-day coastal business development summit, organised by Federation of Karnataka Chamber of Commerce and Industries (FKCCI) in Mangalore, he





emphasised that this was possible with focus on industrialization in the last four years. The second Global Investors Meet (GIM) planned in Bangalore in June aims to attract an investment of Rs 6 lakh crore for Karnakata, he said.




Art and science of stillness

he path of Evolutionary Enlightenment, like all enlightenment teachings, is a path of ego-transcendence. Here, transcending ego is not an end in itself - it's a means to a higher end. The reason we want to have the liberating experience of transcending our personal fears and desires and our culturally conditioned values is to open up some space within the self - space for evolution to occur.

It's important because being inspired by the idea of conscious evolution is one thing, while actually engaging in the process of evolution is something else altogether. Many people are moved by the notion of evolutionary becoming. But within themselves they are not free. They are trapped in psychological hang-ups and attachments, with little or no space for that which is new. Their souls are not liberated, and their choices and actions are still being shaped by unconscious adherence to values and perspectives that have nothing to do with being a liberated vessel for the evolution of consciousness and culture.

Merely being inspired by the potential for conscious evolution does not automatically give us access to the fearless inner freedom to actualise that potential. In order to find that freedom, to open up that space for the new, it is



essential that you liberate yourself to a significant degree from your personal fears and desires and your culturally conditioned values.

Inner freedom is not different from the goal of traditional enlightenment. In Evolutionary Enlightenment, the attainment of spiritual freedom is not the end of the path but, ideally, becomes the foundation from which to engage in conscious evolution. So the foundation of the path and practice of Evolutionary Enlightenment is nothing less than the position of traditional enlightenment itself. In order to release your own consciousness and psyche for the wider and deeper embrace of the life process that Evolutionary Enlightenment demands, you must disentangle yourself, you must significantly free yourself from your karma, history, culture and personal ego.

There are two ways to discover enlightened awareness: spontaneously, or through making noble effort... Spontaneous

experience often happens in the company of a spiritual master who has access to this unmanifest ground, or among a group of inspired individuals who have come together to share mystical truths. You can also, however, assume the posture of freedom and experience enlightened awareness simply disciplined through effort. Traditionally, the metaphor for this radical freedom has been the image of the seated Buddha, perfectly still, eyes closed, his awareness focussed within, his attention on the infinite nature of his own consciousness.

So the way to practise this radical position is to literally take the posture he is taking - to engage with what i call "the art and science of stillness" or the traditional practice of meditation... In learning how to be still, you are choosing to stand for and express that deepest part of yourself - that empty no-place before the beginning of time, before anything ever happened.

That formless ground of Being is always the deepest dimension of who we all are, and it is the ultimate source and wellspring of all that is. In that ground, nothing ever moves, because there is no time, form, subject or object. There is only One, eternally at rest and at peace.
