JPC report leak a ploy to save Manmohan Singh & P Chidambaram : BJP

The leak of the draft report of the joint parliamentary committee (JPC) is being seen as Congress ploy to create confusion in the public mind and as an attempt to shift the responsibility of the 2G spectrum allocation scam away from prime minister Dr. Manmohan Singh and finance minister Shri P Chidambaram. The BJP's deputy leader in the Rajya Sabha Ravi Shankar Prasad expressed concern over the leak of the draft of the report before the copies had reached the members of the committee. The parliamentary office of the committee had despatched the copies on Thursday night and Prasad said he got his copy around 10 am on Friday. He said this was a violation of parliamentary propriety and that his party would state its opposition to the report when the JPC meets on Monday. It will also express its protest against the leak. The BJP had decided not to guit the JPC despite the manner in which Chacko blocked the demand for summoning Singh and Chidambaram, and to concede to Raja's demand to appear before the committee. The BJP members wanted to give their dissent notes because they apprehended that the majority report will not nail the government's complicity in the scam. The BJP did not want the Congress members to get away with the majority report. The BJP was clear that it could not block Chacko from giving in his 'soft' report in the way the Congress members blocked PAC chairman Dr. Murli Manohar Joshi from giving in the real report on the 2G issue in 2011. Lok Sabha Speaker Meira Kumar had to reject the report which was forwarded to her by Dr. Joshi because it was not endorsed by the other Congress members of the PAC.

Union govt. lauds Narendra Modi govt for projects with best land use

The Ministry of Urban Development lauded Gujarat govt. on April 11 when it showcased two key projects from the state as one of the best models to be followed. The praise for the state came during a presentation on Land Economics at the Royal Institution of Chartered Surveyors International Conference 2013 in Delhi. The meet was attended by delegates from the United Kingdom.

At the meet, which was also attended by minister Kamal Nath, Urban Development Secretary Sudhir Krishna highlighted the best of use of land by two Gujarat projects, Sabarmati Riverfront Development Project and the Surat City Ring Road Project. He also mentioned a Hyderabad project and Bhopal lake project as other two examples of better land use.

"Not one bit of land has to be acquired and commercial land use is made available to parties. Land can pay for itself," said Krishna while talking about Surat City project. He said the Sabarmati project has helped promote the local market.

A month ago, the ministry had advised states to follow the Surat model. Though the project is yet to start, the model has impressed the ministry officials so much that they have asked the states to identify ways to replicate the model for overall development of cities.

The project aims to encourage highrise buildings, toll plazas, commercial spaces along the proposed road, thereby filling the state coffer. The state has also been praised for the best utilisation of Centre's flagship urban scheme, the Jawaharlal Nehru National Urban Renewal Mission.

At the meet, minister Kamal Nath said India's land economics was based on historical errors and there was no scientific approach to it. "India has one of the lowest floor area ratios. Delhi is surrounded by states and cannot expand. Share of the formal land market is declining and informal one catering to EWS category, lower middle class is on the rise. Towns are becoming hub of economic activities and one of the biggest challenge is infrastructure. It is imperative we plan our cities with futuristic vision," he said.

'Vikasa' all the way; BJP is the only way in Karnataka

before Karnataka goes to polls, the State assembly elections are being watched with a great deal of attention throughout the country. An estimated 2,295 candidates have entered the fray for the Assembly polls in the State, as the process of filing nominations ended on April 17. Chief Minister Shri Jagadish

Shettar was among those who filed nominations on the last day from the Hubli-Dharwad Central constituency. April 20 was the last day for withdrawal. In 23 of the total 224 segments, the number candidates is more than 16, which means that the authorities would

have to deploy additional ballot unit as one can have a total of only 16 names, in the event of them remaining in the fray beyond that number.

At the moment, it appears to be a straight fight between the ruling Bharatiya Janata Party led by Shri Jagadish Shatter and the Congress with the Janata Dal-Secular probably ending up at the third spot. The Bharatiya Janata Party has made its good administration an example to

attract voters and the people of the State are subscribing the view of the party. The BJP is also focusing on the rampant corruption, law and order situation and sky rocketing price rise under the Congress led United Progressive Alliance government at the Centre.

Noteworthy is the fact that the elections to the 224-member Karnataka legislative assembly uninterrupted power supply to the nook and corner of the State and a project to teach good and correct English in Kannada medium schools would all be a reality. Leader of opposition in Rajya Sabha Shri Arun Jaitley released the manifesto in the presence of State Chief Minister Shri Jagadish Shettar, Karnataka BJP President Shri Prahllad Joshi, BJP National General

The party manifesto also promised free laptops for students and better waste management in the state, 25 kilograms of rice to 98 lakh poor families at Rs 1 per kg, 50 per cent reservations to women in local bodies and compulsory yoga in schools.

Lessons on "cultural



nationalism" and moral values are part of promises held out in the field of education on which the party assured the people it would increase the spending from 1 per of GDP to 3 per cent. The party promised 50 per cent reservation of seats to women in local bodies and eradication of child labour.

Priority for Kannada medium students in higher education and employment, free Wi-Fi and internet for all schools and colleges, introduction of Yoga as part of the syllabus in schools and colleges are among the many promises made.

Defending the rice scheme Shri Arun Jaitley said the promise to provide rice and laptops could not be construed



BJP-led NDA is bound to return to power: Rajnath



Launching BJP's election campaign from Belgaum district of Mumbai-Karnataka region, BJP National President Shri Rajnath Singh said the BJP-led NDA is bound to return to power at the Centre and the Congress-led UPA government will

pay the price for its "failures" in the next parliamentary elections. He said the first step in this direction will be the BJP getting a clear majority in the Assembly elections in Karnataka, he said at an election meeting.

BJP national president said only the BJP was capable of providing good governance. The development model of Gujarat, where Shri Narendra Modi is the Chief Minister, should be emulated in the entire country, he said.

as populism. Providing the right to food to the deprived sections would make right to live more meaningful, he said. He said it was also not populist, "It is a reality that there is a huge economically weaker section in the country and it is an obligation of every government to ensure them their right to food," he said. He said BJP had succeeded in installing the party's first-ever government in the South five years ago and "we have governed and completed full term taking up challenges for the cause of people." He also said that BJP had honored most of its promises made in the 2008 manifesto.

Shri Jaitley said whenever BJP faced difficult challenges; it stood by values and ideals rather than individuals. "Politically, we have emerged cleaner, stronger and more cohesive." "We are now entering with the hope of another mandate to serve the people", he said.

Reacting sharply to the clean chit given by the Joint

Parliamentary Committee to Prime Minister Manmohan Singh in the 2G spectrum allocation scam, Shri Jaitley alleged that the Congress was "using the JPC to cover the truth." The former Telecom Minister, A. Raja's correspondence with the Prime Minister made it amply clear that Dr. Singh and P. Chidambaram, as the then Finance Minister, were "fully in the loop" and knew what Mr. Raja was doing.

Expressing dissatisfaction over "authors of the draft report" leaking the report to media instead of presenting it to members, he said JPC members would be hauled up for breach of privilege. "The entire country knows that 2G is a monumental scam."

He said, "If the JPC considered Dr. Singh and Mr. Chidambaram innocent, he was afraid; the JPC report would meet the same fate as the report on Bofors. The JPC under B. Shankaranand came out with a fictional report, describing bribes in the gun deal as winding-up

charges, because middlemen and agents were asked to wind up their business. Nobody believed what the JPC said about Bofors and its report was trashed. "It is a scar on the country's parliamentary democracy."

Noting that history repeats itself, once as tragedy and again as farce, Shri Jaitley said it was the second time in the history of the Congress and the United Progressive Alliance government, which were neck-deep in corruption, that the party subverted the truth using the JPC mechanism.

Addressing the gathering and referring his tenure of nine months and 11 months of his predecessor Shri DV Sadananda Gowda, Karnataka Chief Minister Shri Jagadish Shettar said, "We have provided good governance and a corruptionand transparent government". Shri Jagadish Shettar said, "We are 100% sure that BJP will come back to power and we will implement the assurances made in the manifesto as soon as possible".



The party's government in Chhattisgarh had implemented the "best" public distribution system and the BJP-governed Madhya Pradesh was ahead on the development front compared with Congress-governed States, he said.

Owing to its "wrong" economic policies and rampant corruption, the Congress governments had failed to address several issues, including poverty, he said. Shri Singh said the Joint Parliamentary Committee, headed by a Congress MP, instead of showing its willingness to listen to the former Minister A. Raja, an accused in the 2G spectrum allocation scam, had pointed fingers at the former Prime Minister Atal Bihari Vajpayee. The BJP would not leave the Congress to go scotfree on corruption and would continue its fight both inside and outside Parliament, he said.

He rued that former CM Shri BS Yeddyurappa, who made the BJP a power to reckon with in this southern State, did not see reason in party's decision and chose to end his decades-old association with the BJP. "Ideally, Karnataka should have seen one CM for full five years. Under different circumstances we had to change our CM here. I apologise to people here for not being able to give political stability to Karnataka," Shri Singh said addressing a massive rally in Chikodi.

The BJP President said the BJP has always given priority to probity in public life. "We did not force Shri Yeddyurappa out of the party. He should have understood party's compulsion. There was an allegation against him by the Lokayukta. We could not have continued with him as the CM. We have a precedence of LK Advani who did not contest election until cleared by court in the Hawala scam. It would have been better if Yeddyurappa had stayed back in the BJP and strengthened it. He did not see reason," Shri Singh said.

The BJP president said the party, however, found an honest Chief Minister in Shri Jagadish Shettar, and he would continue to provide good administration if the BJP returned to power, he said. If the BJP returned to power, Shri Singh said he would advise Shri Shettar to increase the limit of interest-free crop loan from the present Rs. 1 lakh to Rs. 2 lakh.

Critical of the Congress led UPA for its misgovernance Shri Rajnath Singh threatened the Congress of dire consequences if the JPC led by its MP PC Chako "dares" to drag the name of former PM Shri Atal Bihari Vajpayee's name in the 2G

scam.

"What joke is this? Clean chit is given to the PM and the Finance Minister but Vajpayeeji, who is indisposed, has been dragged into it. We will not remain silent if the JPC dares to do this. The Government will face our fury both inside Parliament and on the streets," he said.

Shri Singh appreciated the performance of BJP Governments in other States and reiterated poll promises made in party's election manifesto. "Even Government agencies have lauded the performance of the BJP-ruled States. We are committed to good governance. Vote us to power, the BJP will deliver promises made to people of Karnataka," he added.

Whatever the consequences, we will not compromise on corruption: Advani

BJP parliamentary party chairman Shri LK Advani in his whirlwind tour of the State started his campaign from Ranebennur in Haveri district on April 21 and said his party won't tolerate corruption. Shri Advani further said, "Whatever the consequences, we will not compromise on corruption. We will not tolerate corruption. Within the party there will be zero tolerance for indiscipline and within the Government there will be zero tolerance for corruption," he added.

He said Karnataka Chief Minister Shri Jagadish Shettar has done a great job and everybody praises his performance. He said, after the May 5 Assembly polls, BJP's position will be excellent. He also said the party has zero tolerance for terrorism. "When I was talking to General Musharraf I told him you can wage a war on us directly. We will not hesitate to fight back. But if you encourage terrorism we will not tolerate, Shri Advani added.

Speaking at a massive gathering Shri Advani said though two party system has not evolved in India, bipolar polity has developed with the BJP and the Congress emerging as two poles in national politics. "No Government can be formed in New Delhi without the support of either the BJP or the Congress. Asking for votes for BJP candidates, Shri Advani expressed confidence that his party will come back to power.

Congress trying to exonerate Manmohan Singh & P Chidambaram in 2G scam: Sushma Swaraj

The ruling Bharatiya Janata Party in Karnataka officially launched its election campaign with rallies by its national and state leaders across the state on April 22.

Leader of Opposition in the Lok Sabha Smt. Sushma Swaraj addressed a huge rally in Bangalore, where in a scathing attack on the ruling UPA, she accused the Congress-led government of being steeped in corruption and passing the blame on allies whenever it comes under attack for



irregularities.

She said the Congress had failed to stop corruption and terrorism and done little to make women more secure, and asked if Karnataka's voters wanted the same kind of government in the state. "Congress sarkar ka bhrashtachar hawa, zameen aur pataal tak hai (The corruption by Congress govt. has reached air, land and underworld)," Smt. Swaraj said at the BJP rally. She was referring to the alleged irregularities in 2G spectrum, CWG projects and coal block allocation.

She accused the Congress of trying to exonerate Prime Minister Manmohan Singh and Finance Minister P Chidambaram in the alleged 2G scam through the JPC report. The ruling party also tried to blame former Prime Minister Atal Behari Vajpayee and ex-ministers Arun Shourie and Jaswant Singh in the spectrum scam, she said.

"The Congress has crossed its limits of shamelessness by targeting the cleanest of Prime Ministers of India (Vajpayeeji) and exonerating Manmohan Singh and Chidambaram in 2G scam," she said, referring to the JPC draft report.

On terrorism, she said BJP had demanded that the Congress -led UPA government stop talks with Pakistan unless the neighbouring country roots out terror camps there.

"In spite of incidents like 26/11 Mumbai attacks, Bangalore bomb blasts and beheading of an Indian soldier at the border, the UPA government continues to engage talks with Pakistan," she rued. Smt. Swaraj also alleged that the Congress has adopted a strategy of shifting blame on its allies whenever it came under attack for corruption.

Sadananda urges Moily to quit 'scam-riddled' Union government

Addressing a rally at Mangalore Bharatiya Janata Party National Vice-President and former Karnataka Chief Minister Shri D.V. Sadananda Gowda on April 21 challenged the Union Minister for Petroleum and Natural Gas Shri M. Veerappa Moily to resign on moral grounds.

Criticizing the reported statement of Mr. Moily that he was ashamed to call himself a former Chief Minister of Karnataka in view of the disrepute brought to the State by the ruling party, Shri Gowda pointed out that Mr. Moily was part of a government that was accused of a string of scams.

Shri Gowda said that the 2G spectrum allocation, helicopter purchase deal and coal block allocation were only a few in a series of scandals that the Congress was riddled with. If he (Mr. Moily) had any sense of morality, he should resign at least now. Wondering why Mr. Moily was not ashamed of being part of such a corrupt Union government, Shri Gowda said the Union Minister's statement only reflected his personality. Shri Gowda said he was proud to have been Chief Minister of Karnataka and he considered it a rare opportunity that came his way. There was nothing to be ashamed of it, he added.

The former Chief Minister said BJP had released a realistic manifesto which had programmes that could be implemented. He said the party was sure to find the resources required to supply 25 kg of rice to the poor at Re 1 a kg. It would need Rs. 6,000 crore.

As the mark of protest against the brutal rape of 5 year old Gudia, Delhi BJP led by President Vijay Goel along with 3000 workers marched towards the Parliament on 22nd April 2013. The protesters had black ribbon tied around their mouths and wore black caps as a token of protest against the Delhi Government's failure to provide security to women. 

Nitin Gadkari concludes first phase of BJP Suraaj Sankalp Yatra in Rajasthan

Lauding the party's commitment for development oriented politics, former BJP President Shri Nitin Gadkari on April 17 hailed good governance and development accomplished by the BJP led governments in Madhya Pradesh, Gujarat and Chhattisgarh. Addressing a public meeting at the conclusion of the first phase of the party state unit's Suraaj Sankalp Yatra in Udaipur, Shri Gadkari also slammed the Congress-led Government in Rajasthan for 'stalling development process, unduly increasing debt burden liability and failure in maintaining agriculture growth that was achieved during the previous BJP regime'.

May, 2013 would mark the first anniversary of the presentation of this important document. It would be in place first to recall what made Government to present this White Paper, and what has been the follow up till date.

For the last five years now, the BJP has been consistently raising this issue of black money. When it was first raised in 2008, Congress Party spokesmen had ridiculed it. However, on April 6, 2008, I personally addressed a letter to Prime Minister Dr. Manmohan Singh in which I wrote:

Recently, the German Government launched a massive investigation drive against taxevaders in their country, and, in this process, the German

intelligence is reported to have procured from the LTG Bank in Liechtenstein confidential data on more than 1400 clients of this bank. Of these, 600 are Germans and the rest belong to other countries.

wanted it without charging any fees for the information.

Some countries of Europe like Finland, Norway and Sweden have already shown interest in getting this data.

Along with this development, there are also reports that pressure is building on Switzerland to treat black money entrusted to its banks from tax evasion to be treated as a crime and modify its internal regulations to cooperate with other countries in tracking such funds.

I think the Government of India, through its appropriate agencies, should request the German Government to share the data of the clients of LTG. Our Government should also be proactive in supporting the possible future steps to be initiated by European governments in bringing in more transparency in banking system of Switzerland and other tax havens particularly related to deposits from other countries.

If we ask for the data from Germany regarding the clients of the LTG group it will re-enforce our position as a responsible member of the comity of nations who stand for financial integrity



and transparent regulations. It will also facilitate our future participation in cleaning up the world financial system from some of the pernicious aspects of the functioning of these tax havens.

Presumably, at the instance of the Prime Minister, the Finance Minister Shri Chidambaram replied to me in May, 2008, that his government was seized of this matter and was pursuing it with the German Tax Office.

In March 2010, I wrote a blog on the matter in which I recounted this LTG Bank of Liechtenstein episode, and urged formally that Government come forth with a comprehensive White Paper on Black Money.

Meanwhile the BJP set up a 4-member Task Force to study the matter. This Task Force after studying various sources came to the conclusion that Indian wealth illegally stashed abroad may be anywhere between 25 lakh crores and 70 lakh crores.

So long as the West dominated world economy was doing well for the US and other Western nations, the entire world seemed reconciled to the banking secrecy of these tax havens. It was felt nothing could be done about the laws of these countries. But the global economic crisis made not only President Obama, but also several European countries like UK, France and Germany change their attitude, and join hands to make a determined effort to have banking secrecy laws in these countries changed.

In 2009, Washington forced the Swiss banking giant UBS to disclose the names of 4,450 American clients suspected of hiding assets in Switzerland. The economic crisis in U.S. and other western countries made these nations acutely conscious of the fact that corruption, black money etc. had become issues that were a problem not just for individual nations, but were a challenge for democracy, the rule of law and good governance in the whole world. Way back in 2004, therefore, the United Nations Office on Drugs and Crime adopted a comprehensive Convention against Corruption. This 56-page document carries a powerful foreword by Kofi Annan, UN Secretary General

who says:

- Corruption is an insidious plague that has a wide range of corrosive effects on societies,
- It undermines democracy and the rule of law,
- Leads to violation of human rights,
- Distorts markets,
- Erodes the quality of life, and
- Allows organized crime, terrorism and other threats to human security to flourish.

Article 67 of this Convention against Corruption requires all member countries of the UN to sign the convention by December 2005, have it ratified by the respective countries shortly thereafter and deposit its instrument of ratification with the secretary general of the United Nations.

In 2010 the UPA Government took formal note of the issue and in the President's customary address to that year's Budget Session of Parliament affirmed that "India is an active part of the global efforts to facilitate exchange of tax information and take action against tax evaders".

The Jan Chetna Yatra organized by the BJP in the last guarter of 2011 had focused attention on three issues: Inflation, Corruption and Black Money. But since Commonwealth Games of 2008, corruption and price rise had dominated all political discourse both in the media as well as in Parliament, I found the audiences at the meetings I addressed during this last yatra extremely responsive to all that I spoke about Black Money.

The Jan Chetna Yatra of



2011 has been my most recent vatra. It stretched over 40 days. I visited every single state of the country as also all Union Territories. The general impression has been that my first yatra of 1990 - planned from Somnath to Ayodhya, but cut short at Samastipur - had evoked the greatest response. It is also said very often that the enthusiasm aroused because the core issue was religious, namely, the Rama Temple. But I would like to affirm here that my latest two yatras, the Swarna Jayanti Rath Yatra of 1997, and the Jan Chetna Yatra of 2011 have evoked the maximum response till date. Both these were related to good governance and economic well being of the people!

In his foreword to the White Paper on Black Money presented to Parliament on May 16, 2012, Finance Minister Pranab Mukherjee admitted that in 2011, "the public discourse on the issue of corruption and black money has come in the forefront."

In this Introduction, Shri Pranab Mukherjee also said:

"I would have been happy if I could have included the conclusions of reports of three premier institutions that have been tasked to quantify the magnitude of black money. These reports are likely to be received by the end of this year. However I have chosen to present this document now in response to an assurance given to the Parliament".

Pranab Da did present this White Paper as BJP had demanded and in this, very rightly affirmed:

"There is no doubt that manifestation of black money in

social, economic and political space of our lives has a debilitating effect on the institutions of governance and conduct of public policy in the country. Governance failure and corruption in the system affect the poor disproportionately. The success of an inclusive development strategy critically depends on the capacity of our society to root out the evil of corruption and black money from its very foundations".

My only regret is that the follow up of the White Paper has been disappointing.

The three premier institutions tasked to quantify the magnitude of black money have still not submitted their reports. Not only the more

powerful nations like U.S., Germany etc. but even smaller countries like Nigeria, Peru and Phillipines have got back their illicitly lost wealth from the tax havens. We in India, on the other hand, have seen some reports about names who are supposed to have accounts in Swiss Banks or such other tax havens, but have not heard of even a single paisa illegally stashed abroad having been repatriated to our country. I wish to urge Shri Pranab Mukherjee who is today in a far more exalted position than he was when he presented his White Paper to ensure that the promise made to the people in this document is fulfilled by Government both in letter and spirit.

"My Call Detail Records and A Citizen's Right to Privacy"

In the past few months I have been closely monitoring a series of news reports which deal with surveillance of my mobile phones. An effort has been made to get access to my call detail records. On two occasions senior officers of the Delhi Police have met me to keep me informed of the progress of the case. The Facts

On three occasions the Delhi Police has officially asked for the call detail records of the mobile phone which I regularly use. These details have been asked for by the South District, the Central District and the Crime Branch of Delhi Police. The reason for officially seeking the call detail records are both curious and ridiculous. On two occasions for two different periods the Call Detail Records were sought ostensibly on the ground that they were required for a verification in relation to the crime of multiple murders which had been committed in a farmhouse in Delhi. On the third occasion a Head Constable of Delhi Police sought the details and successfully obtained them on the ground that he was returning from the Saket Courts, an anonymous source advised him to check up the call detail records of my telephone number since the same may provide some evidence in relation to a fake currency racket. Obviously, both the pretexts were palpably false. Even for the wildest

imagination there would not be any evidence available in my phone details in relation to these offences. I hardly have any familiarity with the persons involved in these crimes or in relation to the subject matter of the offence.

In another incident the Delhi Police unearthed an effort to a constable of the Police acting at the behest of a private detective agency to get the Call Detail Records of some of the phones which are used by persons around me. Two phones in my name are used by two drivers whom I alternatively use and the third one is used by my son. When I am in my car or at a meeting, I do receive calls on my driver's numbers. The Delhi Police claims that this attempt was foiled by a vigilant employee of the Service Provider who suspected foul play in these transactions.

The details of these calls being observed through official and illegal channels were for the periods November-December, 2012 and January 2013. It was junior officers of the police including the officials at the level of Head Constable and Constables who could get access to these Call Detail Records.

It is obvious that somebody during this period was desperately trying to look for some evidence in my call details. The combined effort has covered the phones which I regularly use and some phones of persons who accompany me which I may incidentally use. Regrettably the Delhi Police believes that each of these efforts are unconnected



and there is no pattern in the fact that an attempt was being made both successfully and unsuccessfully to monitor the persons with whom I am in touch with during the critical period. I find it difficult to accept this explanation of the Delhi Police that it is unable to find out the master-mind behind this operation and it is merely coincidental that so many activities

of his personal liberty. Interference in the right to privacy is an interference in his personal liberty by a process which is not fair, just or reasonable. A person's Call Detail Records can throw up details of several transactions. In the case of an average citizen it can reflect on his relationships. In the case of a professional or a business person it can reflect on

were taking place at the same time to get at my Call details.

The Delhi Police would have me believe that these were unconnected developments. The inability of the Delhi Police to find out the master-mind behind this operation does not mean that there is no master-mind. Either the investigation is extremely incompetent to discover the identity of the master-mind or the Police finds embarrassing to name the master-mind. My guess is still wide open. This could be an outsourced operation to Government agency or a private rogue operation.

The Effect

My object in raising this issue is not to play a victimhood card. I raise this issue because some larger questions of public interest are involved.

Firstly, every citizen in India has a right to privacy. His right to pirivacy is an inherent aspect

his financial transactions. In the case of a journalist it can reveal the identity of his sources. In the case of a politician it can reveal the identity of the person with whom he has regular access. Every person has 'a right to be left alone'. In a liberal society there is no place for those who peep into the private affairs of individuals.

No one has a right to know who another communicates with The nature communication, the identity of persons being communicated and frequency communications would be a serious breach of privacy. If Constables and Head Constables of police officially (even though on false pretexts) or unofficially can get access to Call Detail Records of an individual (in this case Leader of Opposition in one of the Houses of Parliament) the personal liberty of an individual would be in peril.

In the case of a Member of Parliament, this raises an additional issue. A Member of Parliament like a media person receives information from various sources. It is in public interest that the identity of the sources is to be concealed. Most scams are exposed by insiders. If identity of sources are revealed there is a danger of the sources drying up and public interest A Member of suffering. Parliament has undefined privileges. Nobody has a right to know who communicates with him. If those who communicate with him are exposed nobody would be willing to provide information to a Member of Parliament. This will be detrimental to public interest.

If the privileged phone records of the Leader of Opposition can be accessed so easily, one shudders to think as to what would happen to an ordinary citizen.

This incident throws up another legitimate fear. We are now entering the era of the Adhaar number. The Government has recently made the existence of the Adhaar number as a condition precedent undertaking several activities; from registering marriages to execution of property documents. Will those who encroach upon the affairs of others be able to get access to bank accounts and other important details by breaking into the system? If this ever becomes possible consequences would be far messier.

hile isuuing a press statement on FTA ,Lok Sabha MP and PAC chairman Shri Murli Manohar Joshi said, Manmohan Singh while announcing his road map for restoring the country's economic health in the coming year, had stressed that the UPA government would vigorously pursue the reforms economic amounted to open several economic sectors to foreign and multinational capital financial agencies. It may be recalled that several financial experts and also political parties have questioned these measures which in the opinion of BJP need to be discussed through an informed debate in and outside the Parliament. The economy is already suffering from acute anaemia and it will not be prudent to allow it to bleed further.

countries and whatever little gains, if at all, India is likely to gain will erode fast due to the same country's treaties with other countries. In the process India also looses the policy space which it will never get back. As UNCTAD notes, "the gains for developing countries from improved market access through FTAs are not guaranteed, and may be short lived, but the loss of policy space is certain." Through the current negotiations on FTA with EU India will certainly lose the policy space in several sectors of its economy.

According to reports in the First Post, India stands to gain very

little from this FTA, because close to 69 percent of its agricultural exports and 65 percent of its nonagricultural export already enter the European markets without duties, whereas it allows only less than six percent of the former's products without duty. Under the proposed FTA, India has to remove 90 percent of the tariff, but there is no assurance that the EU will lift subsidies that are disadvantageous to Indian agriculture. No, there is no provision to discuss subsidies in the FTA. So, in the short and long run, it will be bad for both farmers and agro-industries in India."

Once the FTA becomes active, the EU will flood the market with products in dairy, poultry, sugar, wheat, confectionary, oilseeds, plantation products and fisheries, some of which are strategic for This will compromise India's agricultural sovereignty and its food security. Obviously, an FTA which talks only about tariffs, and not about tradedistorting tricks such as subsidies other incentives detrimental to our agriculture.

Incidentally, access to food is a human right under the Universal Declaration of Human Rights and the International Covenant on Economic, Social and Cultural Rights (ICESCR) of the United Nations (UN).

Another area that will impact India is opening up of procurement in central and state government institutions. This is the lifeline of many of Indian industries and



medium and small enterprises, including small businesses run by women and other disadvantaged communities. If this is opened to the EU, the SMEs will find it extremely hard to survive.

Imagine a situation when our small vendors have to compete with EU for contracts in Railways other or public sector undertakings. India hasn't so far given this facility to any other FTApartner, and acceding to the EU will lead to demands by others. Small town India vendors competing with a high-tech vendor in Japan or Germany for government contracts doesn't sound like level-playing field. It's not about exclusive, technologically demanding area, but routine contracts.

India already has increasing trade deficit since 2000-01 with the EU, which stood at 3309.3 million USD in 2008-09. Projections (CEPII-CIREM 2007) show that after the FTA even in the industrial sector India will make gains only in textiles & garments, and leather. The only significant variation in value for India is in textiles (3573 mln USD) and in industry and manufactures (807 mln USD). Even in the latter, India's market share in EU will remain unchanged. In addition, EU NTBs in the textile sector is a problem for India. However EU's bilateral trade will increase significantly in industry and manufactures, primary products, vehicles, textiles, leather and clothing, and in agro food. In fact EU's gain in industry and manufactures (7947 mln USD) alone is almost double the gain India will have from textile, garments, and leather.

MSMEs feel they are not given a 'level playing field' in competing with developed countries if the

reported conditions are accepted. Since infrastructure in India including that of marketing, storage and transportation are weak, entrepreneurs feel their competitors in the developed countries have huge advantage in terms of basic facilities. In addition they get significant support from the government. The UK government just released a new document in support their SMEs. In India, while certain policies are supposed to encourage MSME exports and production, almost all the entrepreneurs feel that they are not able to avail these facilities in reality.

Another important concern is: investment provisions in FTA not only provide post investment protection but also establishment rights including market access commitments. Such commitments in FTAs would lock in India and may take away the opportunity to review the foreign investment in certain sectors in certain circumstances. For instance, India is now facing challenges from pharmaceutical MNCs due to their aggressive acquisitions of Indian generic companies. This may compromise access to medicines to people of India at an affordable price. One of the most discussed policy response is to put a cap on FDI in pharmaceutical sector. Such response may not be possible if India locks in certain sectors for foreign investment without any safeguards.

The intellectual property rights chapters proposed in this FTA goes beyond the TRIPS Agreement, which will also give European companies considerable market power. Further, EU is also demanding liberalization of FDI through FTA and thus establishes

linkage between trade and investment, which was successfully opposed by India during the WTO Cancun Ministerial Conference in 2003. These will also undermine the space of the government to enact policies to redress development inequalities.

Several media reports have suggested that EU is pressuring India to liberalize many sensitive areas which India cannot commit. The EU wants India's commitments in retail where millions of small businesses are dependent. The EU also wants India to open up sensitive areas such as banking, insurance, postal services, and energy which India can not afford.

BJP demands:

- ▶ A comprehensive debate in parliament during the second half of the Budget session on all FTAs entered and especially on EU-India FTA.
- Immediate release of negotiating text and impact assessment studies of FTAs particularly EU-India.
- ▶ Government should not go ahead on the Bilateral Trade and Investment Agreement (BTIA) with EU without a political consensus and a conference of all stake holders be immediately convened.
- ▶ FTA with EU should not be allowed to endanger the Indian retail in general and agriculture and dairy farming in particular.
- ▶ All Treaties which impinge upon the sovereignty of the country and the fundamental rights of the people including food security and health, and the federal structure of the country should be ratified after the scrutiny of the Parliament.■



Of borrowed ideas and empty phrases

either does Rahul Gandhi have any ideas of his own on how to lead India into the future nor does he have any understanding of the country's glorious past. His speech at the CII was proof enough

Can a leader, suffering from an embarrassing disconnect with the country's glorious past, lead it to realise its full potential? Congress vice president Rahul Gandhi's speech at a recent Confederation of Indian Industry meet only confirmed what most Indians always suspected: That the Gandhi scion's understanding of India is shallow and his opinions are based on borrowed ideas. Even the Congress was embarrassed by Mr Gandhi's failures and mistakes at the CII meet. Nothing else explains why it edited out several portions of his speech in the version that was posted

For example, Mr Gandhi said: "They used to look at India and say, boss, the Hindu rate of growth! They have been saying this for 3,000 years. Now the Hindu rate of growth has become the European rate of growth." The Congress vice president had borrowed the pejorative phrase 'Hindu rate of growth' from Raj Krishna, who first used it to describe India's dismal 2.5 to 3.5 per cent growth rate in the decades after independence, thanks to the country's centralised socialist economic model. With the collapse of the Soviet Union in 1991, the

socialist model lost its legitimacy. Prime Minister PV Narasimha Rao junked the Nehruvian mindset and with that ended the 'Hindu rate of growth'. The rest, as they say, is history.

Ideally, Mr Gandhi should have compared India's dismal economic performance in recent years with the country's precolonial past when it was a global leader. After all, there was a time when scholars and travellers from around the globe

Europeans learned it from the Arabs through their trade relations and then called it the Arabic numerals. The system was in place far before that, as can be seen from the numerals used in hundreds of ancient Hindu texts.

The picture of India as a semi-barbaric nation where babies were thrown into the river as sacrifice, was created by European colonisers and missionaries to justify their occupation of the Eastern

As one can see from the Roman numerals, it was a cumbersome line-up of numbers till the Indian system came into vogue. The Arab traders learnt the Hindu system and modified it. The

countries through subterfuge. And then they bled India white through administrative and economic measures that destroyed local industry at a time when the economy worked through village-based self-sufficient institutions.

Volumes have been written by various foreign historians about the prosperity and abundance of ancient India right up to the middle of the 18th century. Paul Bairoch, a Belgian economist, in his well acknowledged study proved that in 1750 India's share of world GDP was 24.5 per cent, China's 33 per cent and the combined



share of Britain and the US just two per cent. Angus Maddisson, a great economic historian, later confirmed Bairoch's study. He further said that India was a leading economic power till 1700. Congressmen may claim that each of these mistakes was a mere instance of a slip of the tongue. But how could they hide the naivete of their leader which the latter laid bare, when he pleaded for a change in the system from the Pradhan Mantri the village pradhan? Essentially, Mr Gandhi was promoting the decentralised system of governance that prevailed in India before colonial rule destroyed it. However, instead of referring to Mahatma Gandhi for empowering local Governments, he made much of the Constitutional Amendment that his father Rajiv Gandhi had brought about to confer power on panchayat heads.

The simplistic rhetoric that Mr Gandhi spouted about taking the people's voice to the Centre of power was really a condemnation of his own party's policies. He should ask himself

how and when the Congress changed from being a vigorous mass movement under Mahatma Gandhi to the family heirloom that it is today. Also, if Mr Gandhi is talking about decentralisation when he himself derives legitimacy from dynastic heritage (or "political DNA", as he mentioned), then it poses the question whether he was condemning his own heritage or merely playing to a gallery consisting of a new generation of young people, that now dominates the electorate.

And that is not all. The Congress scion also wants exponential growth, not the incremental growth that India has registered so far. But surely he is aware that in the last nine years that his party has been in power, India's national growth rate has dropped from nine per cent to five per cent. In this context, his praise for Prime Minister Manmohan Singh, under whose leadership growth came down from 'incremental' to in effect 'negative' (when 10 per cent inflation is taken into account), is just absurd.

Ultimately, Mr Gandhi's much hyped speech proved to be just another well-rehearsed show, liberally laced with borrowed sound expressions. Also, he pointed to Mr Sam Pitroda several times, revealing the man who is quite possibly responsible for all the fancy phrases he used like growth", "exponential "Pradhan's voice" and "out-ofthe-box thinking". A leadership that is divorced from the past and merely mouths borrowed phrases, holds little hope for the country.

Annual GDP Growth

1.Inspite of economic sanctions on India due to nuclear test NDA regime touched GDP figure of 8.1% but now GDP is 4.5%.

Inflation

2. Another measurement for the health of any economy is the rate of inflation. During the NDA regime the rate of inflation was 3.8% when NDA left the power. Which has more than doubled during the UPA regime to 9% on an average and touching 11% in the year 2010-2011. High

During NDA regime, 1998 -2004, the trade deficit was ranging between 0 to 2 billion dollars, but after the UPA took over in 2004-till date the trade deficit has increased alarmingly with deficit touching nearly 20 Billion Dollars (Rs 1086.12 billion) in 2012-13.

India's External Debt

5. Another factor that affects economy is the external debt which is the money a country owes to its creditors. India's external debt has increased significantly from 2004. This

> highlights that our borrowing has increased which could signify higher investment in developmental activities but at the same time it also highlights that despite massive rise in forex reserves since 1991, huge FII and FDI inflow and increased domestic savings, we have not been able cut down on our external borrowing. Industrial production

> 6. Industrial production is often referred to as the engine of economic growth with respect to job creation. The industrial growth during NDA rose from 4% in 1998 to 9% in 2004, while during UPA's rule the industrial production after a touching 20% in November 2006 set a new

record low of -7.20% in February 2009 and is now again in negative with -0.6% in 2013. Agricultrure production

7. India is known as an agro based economy.From the Planning Commission data released in 2012, it is revealed that the share of agriculture in the GDP has dropped from 26% in 1998-99 to 13% in 2012-13. Further, the CAG report on Farm Loan Waiver Scheme made by UPA govt in 2008, clearly points at misappropriation of 54,000 Cr which was meant for waiver of farmers. The Scheme was aimed at providing relief to farmers in States like Maharashtra and AP reporting large farmer suicides because of large credit or loans. Further it has been reported that there has been 14 million jobs lost in agriculture and 5 million manufacturing jobs lost from period (2004-05 to 2009-10).

7. Malnutrition

The CAG report has been tabled in the Parliament in March, except for Bihar which saw 82% malnutrition, all other states that topped were Congress ruled states like AP (49%), Delhi (50%), Rajasthan and Haryana (43%), while Gujarat, which was most targeted on this front recorded the most improved figures down from 70% in 2007 to 38% in 2011, which shows how BJP has worked in the state. Even the BIP ruled MP which till a decade back was not known for development is now at 28%, NDA ruled Punjab at 33%. Uttarakhand, ruled by the BJP from 2007 to 2012 saw a drop from 45% to 27%.

8. Unemployment

The Union government (*Times of India* reported on April 22,2013) has admitted to lack of

substantial increase employment between 2004-05 and 2009-2010, with the selfemployed workforce shrinking from 56.4% to 50.7% of the total workforce. In absolute numbers, the self-employed decreased from 258.4 million to 232.7 million in this period while regular salaried workers rose from 69.7 million to 75.1 million. The ranks of casual labour rose from 129.7 million to 151.3 million. Collectively, the total workforce increased from 457.8 million to 459.1 million, a rise of just 0.3% over this period.

9 .NDA or BJP ruled states vs UPA ruled states

1. The Union government discontinued the practice of ranking states annually on the implementation of the Twenty-Point Programme, the Centre's key initiative to eradicate poverty, a move that came after the states ruled by the opposition BJP dominated the list for three consecutive years. Gujarat, Himachal (When the State ruled BJP led by Prem Kumar Dhumal Govt.) Pradesh and NDA ruled States fared better than most Congress-ruled states.

2.As far as Devolution of powers to panchayati raj institutions is concerned, report shows that Himachal (BJP ruled), Gujarat, MP, Chhattisgarh, Karnataka, Bihar and Uttarakhand fared well under BJP. In contrast, there was minimal devolution of powers to the panchayats in Congress-ruled Haryana and Rajasthan.

3. The BJP-ruled MP tops the list on food security, drawing maximum grain allocated for the targeted PDS with 104% offtake while Congress-ruled Delhi

comes second with 102%. Congress-ruled Andhra and Nagaland are on a par with Himachal, with 100% offtake of grain under another scheme — Antyodaya Anna Yojana.

4. Right to Service legislation are meant to reduce corruption among the government officials and to increase transparency and public accountability BJP ruled Madhya Pradesh became the first state in India to enact Right to Service Act on 18 August 2010 and Bihar[BJP - JD(U) coalition Government] was the second to enact this bill on 25 July 2012.

5. Revolutionary reforms brought by BJP ruled Chattishgarh government to the public distribution system that focused on extending coverage, improving delivery and increasing transparency have led to its remarkable revival. The Reforms in PDS became torch bearer for other states.

6. According to a draft report regarding implementation of MGNREGA released by Central government that includes 5 states Andhra Pradesh, Rajasthan, Karnataka, Sikkim and Madhya Pradesh. Madhya Pradesh secured first rank among these satets in implementation of MGNREGA.

7.BJP ruled Gujarat has ranked on top for attracting maximum private investments across India as of December 2012, according to a sector specific analysis titled 'Composition of Outstanding Investments Across States,' carried out by The Associated Chambers of Commerce and Industry of India (ASSOCHAM).■

Era of the educated terrorist

Pakistan-based militant outfit Lashkar-e-Tayyeba has emerged as a trusted ally of both Islamabad and Rawalpindi, and is one of the lethal tools in the hands of its handlers to torment India. And, it's only getting more informed by the day

With the impregnable American fortress having breached on Monday when two high-intensity bombs ripped through the finish line at the Boston Marathon, killing three and injuring several others, notice has been served that no one is ever really safe. While US federal authorities are yet to determine who caused the attack, there is no doubt that it was an incident of terrorism — the first on American soil since September 11, 2001.

In hindsight, the fact that the Boston Marathon was targeted makes complete sense. It is a major international event that marks an important patriotic holiday and conveniently brings together thousands of people into a relatively small place. Yet, it is safe to say that few would have realistically expected an attack to happen. In fact, there was no prior intelligence input even, at least from the information available at this point.

Clearly, in times such as these there is no scope for complacency; even when the situation seems to get better, when there is a feeling that one may have turned a corner; beware the shadowy figure that lurks in the corner.

There is a lesson in this for India too. While unlike the US, this country has suffered a series of terror attacks both before and after the Mumbai carnage of 2008, supposedly India's '9/11', the situation has been markedly different in Jammu & Kashmir. The past three years especially have brought peace dividends to the State and insurgency in Kashmir is no longer at the levels that it was in the late 90s. Many counter-terrorism and regional experts believe that this drop in insurgent activity in Kashmir has much to do with the war in Afghanistan. According to them, when the US-led Nato forces landed in Afghanistan, they hogged much of the attention of Pakistan-trained militants who were earlier pre-occupied with Kashmir.

More than a decade later, now that those forces are preparing to leave Afghanistan, there is good reason for the militants to re-focus on Kashmir. Add to this mix Pakistan's deteriorating domestic situation and it becomes increasingly evident that Islamabad might turn up the heat in Kashmir, so as to re-direct attention from domestic problems. In fact, regional observers are still trying to decide if the flare-up along the Line of Control in January that saw Pakistani soldiers kill two Indian soldiers, one of whom was beheaded, could be a sign of things to come. If this is indeed the case, and the Pakistani establishment sees more value in re-igniting the conflict in Kashmir, then it is pretty much a given that Islamabad will turn to terror organisations such as the Lashkar-e-Tayyeba and others to do its bidding.

The LeT especially has emerged as a trusted ally of the Pakistani establishment, and is one of the lethal tools in the hands of Islamabad and Rawalpindi. It was only earlier this month that Admiral Samuel Locklear, Commander of the US Pacific Command, American lawmakers during a Congressional hearing that the "Lashkar-e-Tayyeba remains one, if not the most operationally capable, terrorist groups through all of South Asia." This should be a matter of deep concern for India. Not only did the LeT mastermind the 26/11 attack, it has historically been the primary fighting force in Kashmir. Even today, LeT militants are trained to fight in Kashmir which is also where most eventually die, as a recent US military report has found.

In fact, there is now increasing consensus that the LeT is planning to go big and global. The spectacular manner in which it laid a three-day siege upon the city of Mumbai and coordinated from a safe distance a complex terror attack that included multiple high profile targets, is just one example of how the group is looking beyond the low-level war of attrition that



it has been waging in Kashmir. In recent years, the LeT has also been linked to some international plots and is known to recruit Westerners to its campaign as well. It is against this backdrop that the study conducted by Combating Terrorism Centre at West Point, a US military thinktank, profiling LeT militants, makes compulsory reading for anyone trying to gain a more organic and intrinsic understanding of this militant organisation, and shape an appropriate response towards it. The study, titled, 'The Fighters of Lashkar-e-Taiba: Recruitment, Training, Deployment and Death', looks into biographical profiles of killed LeT militants, as available in four Urdu-language publications brought out by the LeT between 1994 and 2007, alongside media reports.

For one, it demolishes the myth that it is the poor and the illiterate from Pakistani society who join the Lashkar and shows that the opposite is more true. In fact, the LeT has been attracting the brightest and best minds of Pakistan, and Lashkar recruits actually have higher educational levels than the average Pakistani male. For example, 44.3 per cent of militants entering the LeT had completed matriculation or studied up to Class 10, whereas, nationally, only 17 per cent of the Pakistani population reached that level of education, according to Government estimates. Clearly, the time has come to revisit the commonlyheld equation between education and militancy.

Adding another twist to this tale is the matter of religious versus non-religious education.

The study shatters the myth that it is the madarsas in Pakistan that breed terrorists. Instead, it finds that most Lashkar recruits come from secular educational backgrounds. Of course, this doesn't mean that they received no religious education at all. All Pakistani schools include some form of Islamic study in their curricula; also, many students receive religious education outside their schools.

However, even taking these factors into consideration, the study found that, while madarsa education may complement a young militant's studies, it is not an effective substitution. In fact, in many cases it is only after the terror recruits have joined the Lashkar that they receive a high dose of religious education, which leads to their being

brainwashed.

Additionally, the study has also found that often LeT recruits were even connected to the Pakistani Army. In fact, there is an intriguing overlap in the districts (mostly of Punjab) that contribute the most number of LeT militants and those that produce the maximum number of Army officers. Now, factor into this equation the fact that according to the study, family members play a crucial role in a young recruit's decision to join the LeT, and the picture becomes increasingly dark and murky. What emerges before us is the shadow of an enduring terror organisation that attracts highquality recruits, appeals to their families and enjoys the trust of an entire country. ■

Terror strikes Banglore

Center failed to tackle terror, says Rajnath

Terror struck Bangalore on April 17 when a low-intensity bomb exploded near the bustling BJP city office in a busy residential area injuring at least 16 people, including 11 policemen.

The bomb, apparently strapped to a motorbike with a Tamil Nadu registration plate parked between a van and a car, went off around 10.30 AM about 100 metres diagonally opposite BJP office in Malleshwaram.

Karnataka Deputy Chief Minister and Home Minister R Ashoka said the attack was an act of "terror."

Sixteen persons were injured — 11 policemen and five civilians, including three women — in the blast targeted at BJP workers and its leaders, Ashoka said. The injured persons were stated to be "out of danger." Two of the injured were college students returning home after tuition.

In Delhi, BJP National President Shri Rajnath Singh said the central government had failed against terror. "Acts of terror are taking place across the country. It is a ground reality that there are several sleeper modules which are playing their roles in different places. The government is not making any effort to destroy these sleeper cells," Shri Singh said. ■



BJP will give a tough fight to Congress in upcoming General election : Dhumal

The two-day executive meeting of Himachal BJP started at Kullu with Chief Minister Dr. Prem Kumar Dhumal listing the achievements of BJP government in the Sate at the outset of the meeting.

Addressing the meet Dr. Dhumal said, "The BJP government during its four and half wars rule had

rule vears implemented various schemes for the welfare programmes, benefitting all sections of the people. The government not only implemented the party manifesto which it adopted as policy document, but gave benefits to the people beyond it," he said in his opening remarks. In recognition of its outstanding performance in different fields, the state was conferred 67 awards by reputed National International institutions and agencies, including government of India, he said while addressing the meeting.

Shri Dhumal said Rs. 353 crore Pandit Deen Dayal Kisan Baagwan Samridhi Yojna and Rs 300 crore Doodh Ganga Yojna which entailed 25 to 80 percent subsidy, had been implemented for upliftment of farmers and livestock rearers. The per capita income had also increased from Rs 43,900 during 2007-2008 to Rs 73,600 while the Gross Domestic Product has also increased from Rs 33000 crore to Rs 63000 crore, he added. Dr. Dhumal said the BJP government

had provided 50 per cent reservation to women in Panchayati Raj Institutions and urban local bodies to ensure their participation in formulation of schemes.

In the meeting the State BJP adopted two political resolutions one against maladministration, corruption of the United



Progressive Alliance and other against the working of the Congress government in the state. Almost all senior leaders and party's executive members, office bearers attended the meeting.

Briefing media persons after the conclusion of the meeting Shri Dhumal alleged that the Congress had been stating separate things in the Assembly and at public meetings. He claimed that the Revenue Minister told the House that 7,132.11 bighas had been given for government infrastructure and not to private universities in violation of Section 118, but Congress members had been misleading the public. Dr. Dhumal alleged that the Congress had decided to allot

3,000 bighas for a ski village to build 700 rooms without giving permission under Section 118 to the company Ford.

He claimed that the government had not taken the permission of the Defence Ministry and 300 huts would be built for foreigners. He said the ski village would affect 7,000 acres and artificial snow would consume megawatts of power. Dr. Dhumal pointed out that the Congress government had failed to get the share of Himachal Pradesh worth Rs 4,000 crore from the BBMB and 7.19 per cent from Chandigarh. He alleged that

the state government had settled for only Rs 1,500 crore from the BBMB. The former Chief Minister said that BJP will give a tough fight to the Congress in the upcoming General Election. Dr. Dhumal alleged that the United Progressive Alliance government was stuck neck deep in scams. He was accompanied by state unit president Satpal Satti and office-bearers of the state executive.
