Govt. must look into the matters of North-**Eastern students very seriously: Jaitley**

The news of the murder of a Manipuri student in Banglore and death of a Maghalaya student in Delhi have raised the question of safety and security of students from North-Eastern States coming to different parts of India for study and employment. There is an urgent need to redress the problem of students and people from North-Eastern States who live in other parts of India so as to ensure their safety and security. Raising the issues related to North-East students, Leader of Opposition in Rajya Sabha Shri Arun Jaitley raised many valid questions which need urgent attention. We are publishing the synopsis of his sppech delivered in Rajya Sabha on 2nd May 2012 for our esteemed readers:



r. Vice Chairman Sir, Home Minister has mentioned the three recent incidents which have increased uneasiness and caused a lot of disquiet in the entire country Two young lives of students from the North-East, in Manesar near Gurgaon, and in Bengaluru, were recently lost, and at the time of the BRICS Summit, a very large number of North-Eastern students studying in Delhi, as also employed in Delhi, has a serious grievance that they were being profiled and picked up even temporarily by the Police.

Sir, the Partition of this country in 1947, when we discuss it, certainly brought a lot of bloodshed in the Western region. Punjab suffered, other areas suffered. But North-East suffered virtually in perpetuity. Because of the carving out of East Pakistan, which later became Bangladesh, it moved away almost a thousand kilometres in terms of distance. Now, the impact of this was that the developmental activities in the North-East have considerably suffered. Despite the efforts of

various Governments, North-East has not grown in the same manner in which the rest of the country has. North-East also has a genuine complaint that certain Central Schemes and projects are endeavoured to assist them and various things have not really lived up to the mark.

My recent visit to some areas of North-East found that most of the States still do not have train service. Even in Assam where the facility is available, what we used to hear in the fifties' and sixties' in other parts of the country, the big issue is conversion of meter gauge into broad gauge, particularly to the Barak Valley. We have a highway project going on successfully in the rest of the country. The Mahasadak Yojana which was to really extend beyond West Bengal into the North-East, you can still see only built in patches and not useable. All this has considerably suffered. The educational infrastructure in the North-East has also suffered. I have been going through certain reports of studies which have been conducted with regard to

educational institutions which we have established in the North-East. Now one of the comments if I just read out, just the broad points. In which they have said syllabus has not been updated for more than ten years, number of new courses have not been added, institute-industry interaction is not taking place, flight of faculty is taking place and adequate faculty is not available, quality and quantity of qualified faculty is declining at an alarming rate, number of PhD holders have been reduced to minority in many cases, placement of students with industry becomes a weak thing. Now, all these factors have, therefore, contributed to really a large number of North Eastern students wanting to go to other parts of the country for education. Now while the reason for this is unfortunate but there is a sliver lining in this. Their interaction with the rest of the country contributes to national integration and it helps us really in understanding what their problems are. Sir, I remember when I was a student, the organization to which I belong



used to carry on a programme in relation to North Eastern students experiences at inter-State level. Some of them used to come, their structured tours used to be organized, not many were coming here to study at that time, they used to live here with families for a few days and we got to understand them. Now a situation is that we see it in the larger context and now we have dealt with hundreds and thousands of them. In fact, one recent study indicated that between 2005 and 2010, the number of people migrating for jobs from the North-East went up about 12 times. That was the figure. It was about 34,000 in 2005, and in 2010, it was 4,14,850. That is the pace at which it is increasing. The sliver lining in this is, and if we see

these students extremely charming personalities, polite, humble, very eager to Interact with the rest of the people, they have to be made to feel wanted in the rest of the society. They have left a great impact in educational institutions to which they belong. But, at the same time, most of them want to have the benefit of higher education institutions of quality in other parts of the country.

They want their educational profile and personalities to evolve and then they want to be a part of this great growth story which we talk about in the rest of the country. We have to admit and it is a genuine admission which everybody has to make that the growth in those regions has not been at the pace at which we would have expected it to be.

Therefore, in search of education, in search of better quality employment, they have moved to different parts of the country. Therefore, I must note that I find a line in the hon. Home Minister's statement, when he says, "I wish to categorically state that any citizen belonging to the North-Eastern States is free to travel and reside in any part of the country. They have a right to security and peace.' They also have a right to live free from any form of discrimination from any form of racial profiling. They have the rights to enjoy the fruits of development which in several other parts of the country people have now begun to enjoy, though to a limited extent. Under these circumstances, Sir, we need to assure all students and other citizens who have come from the

The news of murder of a Manipuri student in Bangalore and the death of a student from Meghalaya, in Delhi are shocking. News of the frequent harassment of youth from the North East in public places, like roads, shopping malls or educational institutions are of late being reported from different cities of our country. Some landlords encroach on their tenants' (those hailing from the NE) privacy and a few among the police harass even during inquiries. The BJP condemns the violence against and the harassment of people from North East in any part of our country.

It is heartening to know that there are so many youth from different states in North East studying or working in various parts of our country, which is theirs too. It is a positive and welcome development that has to be encouraged by all of us. Continuous and sustained interaction among youth from all parts



of the country will only ensure better understanding, sensitivity and appreciation among the citizens. Any economic resurgence of the country is only possible with greater sense of harmony and understanding amongst citizens.

All efforts should be taken in universities, colleges and also in organizations where youth from north eastern Indian States are enrolled to make them feel welcome. Facilitation and steps for better understanding should be pro-actively taken up. ■



North-East either in search of education or in search of jobs in this part of the country, that not only their safety and security is going to be maintained, even there is a lot that we have to learn from them.

Most of them are multilingual; they are multi-religious; they belong to different religious denominations. Therefore, we have a lot to learn from them. In this context, therefore, I would like the hon. Home Minister to consider, in addition to the steps that he has already taken, whether in these areas, where larger numbers of students are available whether in the Union Territories or in the States, a specific helpline for them can be created. We have data of surveys and studies done on the students of the North-East. One recent study says that 86 per cent of them have complaint, of some form or the other, of harassment. If the figure is as large as this, this is certainly alarming. This is an eye-opener. Therefore, must we not have a specific helpline in these major areas where these students are studying or these people are working?

It is not a very costly exercise. I think, any State Government, if properly advised, will be quite willing to do it. The Union Territories also can do it. I also think there is a need to sensitize the rest of the Indian society. When students from Jammu & Kashmir, from the North-Eastern States come and study here, or people come and work here, I think, it is extremely important for a larger national goal that their integration with the Indian society is further strengthened by virtue of the attitude of the society has for

them. Therefore, within universities, within workplaces and within the society, and, I think, media, particularly electronic media, will have a huge role to play. We have carried out campaigns how tourists have to be treated. We have carried out campaigns how weaker sections of the society are to be treated.

We have carried out campaigns how women are to be treated in the society. Therefore, in relation to this, I think, we need to canny out a campaign in India so that we can sensitize our own people on how, in such events, people who come from the North-East to study or

work in these places, are to be treated.

Finally, I would like to request the Government, through the hon. Home Minister that the areas where very obvious developmental activities, which have contributed to the neglect of the North-East, are pending - their roads, their railways, their connectivity, improvement in their educational institutions. etc. - the Government must, through the DONER, look into these matters very seriously. There are some areas which will take time, but there are some areas which are very easily doable. I think, top priority must be given to those areas.

Karnataka CM orders to register an FIR in Manipuri Student Richard Loitam's case

Karnataka Chief Minister Shri D Sadananda Gowda has ordered the State police to register an FIR in death case of Manipuri



Student Loitam Richard. Shri Sunil Deodhar, National Convener of BJP's North -East India Sampark Cell and many other representatives also called on Shri Gowda demanding a thorough investigation in the case. The Karnataka CM assured Shri Deodhar and others that the investigation will be foolproof and there will be no loopholes. Immediately after the CM's order the Inspector General of Police (Intelligence), has asked the local S.P. to file a case of

murder against unknown persons. It is noteworthy that Richard Loitam a Manipur student was found dead in his hostel room on 18th of May. During the discussion the Karnataka CM said there is a view in media that this is a case of racism but he asserted that one should wait for forensic report and completion of investigation by police before coming to any conclusion.

Interacting with media persons Shri Sunil Deodhar and other representatives of North-Eastern state said that the immediate action and support by the BJP government has given solace to the parents of the victim in particular and the North-East students in general in the city.





Cotton farmers not getting remunerative prices: Venkaiah

¬hri M. Venkaiah Naidu, MP and former President, Bharatiya Janata Party on April 27 raised in Rajya Sabha after the Question Hour, the issue of glut in the cotton market, falling prices and agitation of affected farmers. He demanded the Government to make a statement on why and at whose behest the ban on export of cotton was imposed in the first place on 5th March, then why was it lifted subsequently on 12th of March, and why again certain conditions were imposed on exports which resulted in no further exports.

Shri Naidu said cotton prices have fallen drastically across the country and farmers are not getting remunerative prices. Shri Naidu pointed out that cotton prices have come down to as low as Rs.3,500/-Rs.6,000 last year. He also said that the Cotton Corporation of India is not purchasing cotton at the Minimum Support Price (MSP).

Shri Naidu lamented that on account of ambiguity with regard to lifting of ban on cotton exports, the market is affected and prices continue to remain low. He said lakhs of bales of cotton have piled up in Andhra Pradesh, Karnataka, Maharashtra and Gujarat. Shri Naidu also pointed out that the other day a farmer from Maharashtra committed suicide.



Shri Naidu said that farmers are worried because the rainy season is coming up and lakhs of bales of cotton remain piled up. Hence urgent intervention by the Government is the

need of the hour. Shri Naidu demanded immediate removal of conditions with regard to export of cotton. Shri Naidu strongly protested over the indifference of the Government to the sufferings of the cotton farmers. As the Government is not giving any concrete assurance, Shri Naidu led a walkout from the House. All the BJP members accordingly walked out of the House.

Human rights violation against Hindu women must stop in Pakistan : Dr. Joshi

riticizing strongly the human rights violations against women belonging to the Hindu minority community in Pakistan, former BJP National President Dr. Murli Manohar Joshi demanded a statement from the Congress led Union government on the flight of over 400 affected families to India.

Raising this issue in the Parliament, Dr. Joshi alleged that young women were being kidnapped, raped and converted in the Sindh province of Pakistan and added that an average of 25 girls were falling prey to such crimes every month.

"When the local courts grant some relief to the victims, they are threatened," he said, adding that there has been an exodus of a large number of people from the province and over 400 affected Hindu families have fled to India.

"This is a gross violation of human rights as also of their cultural rights. There are many instances of religious persecution. Large scale atrocities are being carried out against minorities in Pakistan," Dr. Joshi said quoting reports.

Observing that the government termed these incidents as "internal matters of Pakistan", he said, "It is a matter of regret that the Congress led Union government has remained silent on the issue so far."

Raising the matter in the Lok Sabha, Dr. Joshi said that at the

time of Independence Hindus formed 15 per cent of the population in Pakistan but this has been reduced to 2 per cent today.

Dr. Joshi said the Prime Minister should assure the House that the government would

take up the matter at international human rights fora. After his speech several BJP members stood in support of Dr. Joshi and demanded an immediate



statement from the government.

Responding to the forceful plea by Dr. Joshi during the Zero Hour in Lok Sabha, Home Minister P Chidambaram said the matter required a detailed response.

"After consultations with the Prime Minister and the External Affairs Minister, government will make a statement", he said. (FOC)

Houses must debate Hindu women plight in Pakistan: Shahnawaz Hussain

The BJP has sought a structured debate in both the Houses of Parliament on the plight of Hindu women in the Sindh province of neighbouring Pakistan. A day after former BJP National president Dr. Murli Manohar Joshi raised the matter in the Lok Sabha, the BJP parliamentary party took serious note of the violation of human rights of Hindu women in the Islamic country and cases of forced conversion.

Shri Shahnawaz Hussain raised the issue in the BJP's parliamentary party meeting in New Delhi and also expressed concern over the plight of the minority Muslims in Pakistan.

BJP leaders were concerned that there has been a sharp decline in the population of Hindus in Pakistan. "Hindus living in Pakistan are not only facing undue harassment, their cultural, religious and human rights are also being openly violated," Shri Hussain said.

Chairman of BJP Parliamentary Party Shri LK Advani expressed concern over the matter and said that the issue needs to be debated in Parliament. Shri Hussain also argued if a parliamentary delegation could visit Sri Lanka to address the issues faced by Tamil, why both the Houses can't discuss the problems faced by Hindus in Pakistan.

In the mean time the BJP had lent support to a group of Hindus, who fled from Pakistan around a month ago and are staying at Jantar Mantar. They want the Indian government to provide them refuge and citizenship as they do not want to go back fearing more persecution.(FOC) ■

UPA Government in the Rajva Sabha over nonutilization of funds under 'Indira Gandhi Matritva Sahvog Yojana' by some States for pregnant women and said deserving States were not granted these funds. Minister for Women and Child Welfare Smt. Krishna Tirath admitted that States like Congress ruled Maharashtra had not utilized the cash incentive for pregnant and lactating women under a pilot project and the Central Government will not give funds to these States.

As Smt. Tirath tried to explain the reasons for non-utilisation and said she will get back to the House after finding out the exact position, Smt. Maya Singh and the opposition raised slogans and demanded an explanation from the Government. Some members also said even as Maharashtra had not utilised the funds, several other States desperately needed this scheme and Government did not implement this scheme there. The Minister said Matritva scheme was launched as a pilot project in 52 districts of the country and after reviewing the result of the scheme it may be extended all over the country.

Concern over dowry menace in Rajya Sabha

As I glanced through the Contents listing the hundred, Continent-wise, I was struck by the fact that India's capital, Delhi, was not included in this list. The two Indian cities



In this book titled Breakout Nations, the author, who is based in New

A sector in particularly bad shape these days is the airlines sector. You talk to any section of the Air India staff - pilots, airhostesses, or any other - and you will hear endless complaints. And this is in an airline which when I first traveled on when I become an M.P. way back in 1970, had an excellent reputation all around the globe. Even private airlines like Kingfisher are facing a serious crisis.

So, it was a delight to learn May 16-31, 2012 Q 16

that the newly constructed Indira Gandhi International Airport has been reckoned as the sixth best airport in the world, and in a certain specific category the second best. The evaluation has been done by the Airports Council International, a worldwide association of airports having 575 members operating over 1633 airports in 179 countries.

Passing through this newly built airport which caters both to domestic as well as foreign services, I was impressed by a beautifully sculpted tableau of the twelve postures which add up to the well known Yoga exercise of *Surya Namaskar*. The sculptor, I discovered, is one Ayush Kasliwal of Jaipur. Hearty compliments to G. Subba Rao of G.M.R. who must have conceived it, and the artist who has executed it.

It did remind me of the rumpus raised by some perverse politicos when Shivraj Singh Chief Minister of Madhya Pradesh initiated a massive programme of *Surya Namaskar* in the schools of the State. Those objecting to the exercise said that the State Government's proposal was anti-secular. It was hard to talk over the pulsating techno-beat, but I managed to engage in a chat with a twenty - something son of the farmhouse demimonde - he was a classic of the type, working for his dad's export business (it always seems to be "exports"), wearing a tight black shirt, hair spiky with grooming gel. After determining that I was a New York - based investor back in town to search for investment opportunities, he shrugged and remarked, "Well, of course. Where else will the money go?"

"Where else will the money go?" I left the Party around midnight, well before the main course was served, but the comment stayed with me. ■



Three years of UPA- II: A saga of deception, deceit and betrayal

Three years have passed since Dr. Manmohan Singh took oath as Prime Minister heading the Congress led UPA-II government at the Centre. As the Congress led UPA-II completes three years in office on 22nd May 2012, its report card registers failures on all fronts. United Progressive Alliance has failed to show any 'progress', leading country towards a mess created by policy paralysis and confused priorities. While the nation watches with shock and dismay the horrible degradation in functioning of the government, the UPA-II keeps itself busy with its only engagement which to somehow remain glued to the power. The work ethics and values in public life have become sacrificial lambs at the altar of power politics. In the last three years, the nation has witnessed Congress led UPA-II government touching new lows in public morality everyday. The Cash for Vote scam which took place just before 2009 general elections was one of the biggest expose of its time but the Congress was somehow able to hoodwink the nation. In its second term the Congress led UPA stands completely exposed as masks are slipping from its different faces.

A perceptible decline in political culture is getting reflected in the eroding credibility of the constitutional institutions. Attempts to safeguard politically vested

interests have 1ed politicization of these institutions. The increasing political interference in the functioning of these institutions and presence of pliable officials have led to a situation that people are fast loosing faith in the system. The tendency in the bureaucracy to stoop to any extent in pleasing the political masters is picking up and we rarely find any example of upright individuals standing up to challenge this politically oriented patrimonial system. The situation is further worsened by ever increasing corruption under the political patronage of Congress led UPA which has failed to take strong initiatives to restore people's faith in the system. The economy is mishandled and mismanaged, constitutional institutions devalued, federal structure assaulted and democracy is replaced by authoritarianism.

The politics of deception, deceit and betrayal played by Congress to mislead the nation is now boomeranging. People are now no more ready to buy its excuses, people can now see through its intentions and approach. Its politics of minority appeasement in the name of minority reservation has backfired and its leaders giving irresponsible statements during UP elections have backfired. The Congress has even lost in Goa where minorities have

preferred to vote for BJP as they were able see through its deceptive and deceitful character. In Punjab too they stand defeated while in Delhi and Mumbai municipal corporation elections it was forced to bite dust. The Congress led UPA is fast loosing the confidence of the people and in place of taking corrective measures it wants to cling to power by hook or crook.

Corruption & scams: A hallmark of UPA rule

If Congress led UPA can be credited for anything than it is for ever increasing corruption and scam which has become hallmark of its rule. In the last three years corruption, scam and loot of public money have become the order of the day. Not a single day passes when some kind of scam is not exposed. It seems as if the entire machinery is neck deep in corruption and surviving on a parallel economy of loot and plunder. Commonwealth Games scam, Adarsh society scam, 2G spectrum scam, ISRO-Devas deal, Coal block scam and many such minor and major scams symbolize the order of the day. The situation is turning from bad to worse with no serious attempt taken to weed out the growing cancer of corruption. While the people are used to corruption in daily life, the corruption exposed at the higher level seems to be enormous and the blatant manner in which it is going on is



not only condemnable but shocking. It seems that corruption has eaten into the vitals of our system pushing it to the brink of virtual collapse. The chief minster of Maharashtra Ashok Chavan has resigned due to his involvement in Adarsh society scam. Suresh Kalmadi, the Chairman of Commonwealth games Organising Committee had to be pushed out from his position in All India Congress Committee and his close aides have been arrested, telecom minister A Raja was forced to resign but these steps have not yet been able to restore public confidence in the system. All these actions appear merely a tokenism and taken under pressure. The Supreme Court has rightly questioned the silence of Prime Minister Manmohan Singh over all these scam for last eleven months. The lack of seriousness in issues related to corruption is very much evident for everyone to see. Corruption has become systemic taking everything under its sway and thus becoming an essential feature of our daily life. Some ministers may come and go, some high officials will be forced to leave their office but it seems that corruption is there to remain. A solution remains a far fetched dream as corruption appears overarching and deep rooted.

Corruption & demand for Lokpal

The burgeoning saga of corruption under Congress led UPA government has seen the common men hitting the street demanding action from the government. It is being said that the need of the hour is to think beyond tokenism. It is required to think of systemic correction

and systemic change. And for this a lot of political will and determination is required in our political leadership. The civil society demand for Lokpal bill to create an institution of citizens' ombudsman which can investigate into the cases of corruption against politicians and bureaucracy was met with opposition by the Congress led UPA government. The Congress led UPA which initially constituted a committee including Anna Hazare and his team members to draft the bill in the face of swelling support for the Lokpal later backtracked and arrested Anna Hazare in order to stop his agitation. But public support in favour of the bill forced the government to introduce the bill in the parliament but the bill was drafted in such a manner that it got mired into endless controversies. The Congress led UPA government was noncommittal from the beginning and was very reluctant in accepting the idea of Lokpal. It was clear that the government was resisting the demand to keep system patronizing corruption intact and was not willing to take any corrective measures.

Economic Policy: Mishandling and mismanagement

The mishandling of economic policies has not only slowed down the process of fiscal reforms but also stunted the economic growth of the country. While India was poised for a big leap forward under Shri Atal Bihari Vajpayee led NDA government, the rate of GDP growth has slowed down since then to 6-7% from 8.4% in

2003-04. The other indicators of the economy are also not encouraging and the country appears to be in the trap of stagnated rate of growth showing no sign of high growth **in near future.** A number of factors like drop in industrial output, hike in petroleum prices and cut in fertilizers subsidy, tepid tax collections, the problems of high deficit and rupee depreciation have affected the Indian economy adversely. The inability of the UPA to build consensus among political parties have blocked many a reform moves resulting in policy paralysis which has halted the economic growth. The policy logjam has severely affected the economy creating further pressure on economic growth.

Unprecedented price rise

Price rise is another permanent feature of the Congress led UPA government. It is not only that the UPA has failed to check price rise, it has many a time pursued policies which has directly led to spiraling prices and back breaking *mehangai*. What is more disturbing is the fact that even in the face of repeated protests and criticisms the UPA-II government callously remains oblivious of the hardship that the people are facing in the wake of unprecedented price rise. UPA can now be better described as Mehengai Badhao Sarkar. Despite the claim of the government to the contrary, it cannot be denied that today the government has left the prices at the mercy of market manipulators, fixers, fly by operators and corporate gamblers. It is not that the economic principles like production, distribution,



monsoon etc. determine the prices but commodity exchange like MCX and other like commodity exchanges are responsible for unprecedented price rise. While the black marketeers have been enabled to manipulate prices government remains a mute spectator allowing the profiteers and black marketeers to rule the roost. Such faulty policy of the government has led to increase of petroleum prices several times in the last three years creating inflationary condition in the country. Large scale corruption and taxation are also creating unbearable condition for people who are finding it difficult to cope with their household Unleashing budget. phenomenon of reversedevelopment, the price rise has widened the gap between rich and poor leaving a vast section of the society marginalized and deprived.

In such circumstances rising prices are causing great havoc to the people in general and those living below poverty line in particular. Can India move ahead with the phenomenon like price rise which is reversing all the efforts made to improve the quality of life in India? In fact, the manner in which the issue has been so far treated only indicates the myopic vision and stunted understanding of UPA-II government which has failed to calculate the damage the rising prices are causing continuously. It has become a factor in Indian economy setting in motion trends of "reversedevelopment" offsetting any step taken on the path of development. Not acting on the issue of price rise which the

UPA-II might describe as something akin "criminal-inaction" on its part robbing people of their food, health and quality life.

Federalism assaulted

Congress has always sought to undermine the federal structure of the constitution since the time of independence. It has always tried to usurp the powers of the States by hook or crook. In the last three years of Congress led UPA rule the policy of discriminating against non-UPA States has continued and selectively targeting them has become a rule. There are instances when legislations passed by State assemblies were held up either by the governors or for the lack of presidential assent. Gujarat, Madhya Pradesh and Chhattisgarh – all these States have been deprived of having a strong law to control crime and to deal with situations emanating out of terror activities.

The bills passed by these States are pending with the Union govt. while a similar bill is in force in Congress-NCP ruled Maharashtra. There are even discriminations in financial allocations for various projects while raids were conducted against black marketers and hoarders in non-UPA States in the name of controlling prices and IT notices are served to investors signing MoUs with Gujarat government. Coal produced in Madhya Pradesh is allowed to be taken out of the State while the State faces scarcity for its power generation units.

The attempt of the Congress led UPA government to infringe upon the powers of the State can

be seen from its insistence on imposing National Counter Terrorism Centre (NCTC) in the name of countering terrorism. So far strong resistance from States including the one ruled by Congress allies has thwarted the game plan of the Congress led UPA to encroach upon the power of the States.

Misuse of CBI and devaluation of institutions

CBI has become convenient tool in the hands of the Congress to coerce and control its political adversaries. Every time the Congress led UPA government is threatened by any of its allies, it misuses CBI to save its government. It has been seen on several occasions that those being investigated against by CBI become ready supporter of Congress led UPA in bailing out the government. In place of gaining the reputation of highly professional institution, CBI today under Congress led UPA rule stands shorn of credibility and perceived as a meek, incompetent and biased agency which can be easily arm-twisted politically at will. Whether it is the case involving 1984 Sikh riots implicating Congressmen like Jagdish Tytler and Sajjan Kumar or scams like CWG, 2G and Adarsh Society the role of CBI has not been above suspicion.

The most classic case is that of Quattorchhi, who is facing kickback charges in Bofors case, was arrested in Argentina against a red corner Interpol notice. The entire nation was shockingly kept in dark of the news of his arrest and when it ultimately got leaked in the press,



the CBI could not secure his extradition. The apparent 'bid' of CBI to secure Quatrocchi's extradition got exposed when it decided against appealing in Argentinian Supreme court after losing the case in a lower court. In 2005 also, he was allowed to withdrew the supposedly kickback money after the UPA government allowed the British authorities to defreeze his 21 crore account.

The manner in which CBI handled Quattrocchi affair smacks of a design to help the accused and CBI allowed itself to be consciously allowed itself to be politically misused. Now it is learnt that instead of taking follow up actions to bring the accused back home, CBI has facilitated withdrawal of Red Corner notice against Quattrocchi pleading for dropping all charges against him.

Apart from Quattrocchi case, CBI has much more to answer for the manner it has been handling the 1984 anti-Sikh riots case, corruption cases against Mayawati, Mulayam, Lalu, Rabri and others and in many other such politically volatile cases. If one moves beyond CBI, many other constitutional institutions like Election Commission, CVC and Office of the Governor were within the ambit of controversies. Such controversy may affect the democratic system which may lead to people's alienation from the constitutional institutional thereby creating a severe crisis of faith in the entire set-up. As long as our political class keeps prioritizing its short term goal of clinging to power by hook or crook, the long term national interest would get jeopardized.

Internal Security neglected

The recent kidnapping of two Italians and a BJD MLA in Odisha and a collector in Chhattisgarh has once again brought before the nation the growing menace of Naxal-Maoist outfits. Repeated attacks on security forces, their cold blooded killings in landmines and deadly ambushes have sent shock waves throughout the nation. Naxal-Maoist elements have been striking at their will and even with impunity. The brutal manner in which these killings have been carried out exposes the inhuman and barbaric aspects of communism as an ideology. Claiming to wage a war against the Indian state, Naxal-Maoists today hold sway in about 180 districts across ten states of India accounting for about 40 percent of India's geographical area. They are especially concentrated in an area known as the "Red corridor" extending from Nepal borders to Andhra Pradesh, where they control 92,000 square kilometers. In the recent years they have been arming themselves with latest weaponry and arsenal and consolidating their position by gaining new areas and recruits. Moreover they are extorting huge amount on account of levies and other form of extortions. They run their own kangaroo courts intimidating and punishing their opponents in the rural areas and thus exercising illegal control over the rural population. In fact they have been able to run parallel governments in a vast region.

Why the government has failed to effectively curb the Naxal-Maoist menace is a

question which remains difficult to answer. The left leaning intelligentsia has often sought to explain it in the neglect of rural area and lack of developmental initiatives among the poor who being left unto themselves have chosen to take the path of 'armed revolution'. But how far Naxal-Maoists are responsible for disallowing the implementation of government's development plans in their stronghold needs to be honestly assessed.

If the cause is poverty and lack of developmental initiatives then the Naxal-Maoists should have been strengthening these efforts instead of blocking them. But the case is different on the ground. In addition to these leftist outfits who claim to parliamentary democracy are seen to be garnering votes for the candidate/parties who prefer to pay them in elections. There is undoubtedly a politician-Naxal/Maoist nexus operating in these areas allowing these elements to strengthen and prosper. Perhaps, the lack of political will in tackling the menace is the result of such nexus in operation seriously undermining the safety and security of the country. While the brutal violence by Naxal-Maoist outfits has started to expose communism and its dangerous ideology, the government should decisively act to defeat and destroy this menace before it is too late.

Undemocratic and authoritarian

True to its colours the Congress led UPA government has shown most undemocratic and authoritarian character in



the last three years. Acting against the nationalistic spirit and fervor it had no qualms in forcibly stopping the *Rashtriya Ekta Yatra* organized by BJYM, the youth wing of BJP, to hoist tricolor at Lal Chowk in Srinagar. Responding to the call of BJYM a large number of youths were participating in the *Yatra* but they were stopped at Jammu & Kashmir border not allowed to proceed further. Thousands of youth were deprived of their right to hoist the national flag at Lal Chowk.

Similarly the participants in the camp organized by Baba Ramdeo in New Delhi were brutally attacked and assaulted in the midnight. The brutality of the police action may be gauged from the fact that even children and women were not spared and many suffered fatal injuries resulting in the death of one woman.

Anna Hazare who gave a call for a movement in support of the demand for Janlokpal was arrested and confined in Tihar Jail. He could only be released in the face of massive protest by people. The Congress led UPA government has tried to muzzle people's voice and used force to stop movement in the most undemocratic and authoritarian ways which is reminiscent of the days when emergency was imposed on the country.

Conclusion

Apart from the issues discussed above, there are numerous other issues which require to be discussed in detail. In the last three years it appears that major infrastructural projects have been shelved. Progress on all the infrastructure projects including National May 16-31, 2012 Q 21

Highway, opening of six AIIMS and interlinking of rivers have been either slowed down or put on the backburner. Despite the parliament having passed RTE bill, the determination on the part of the government is lacking and infrastructural development has not gained momentum to meet the requirements. In higher education too India lags behind many developing and developed countries but the Congress led UPA government has failed to show its inclination towards building and upgrading universities and educational institutions upto international standards. commercialization of education is in full swing and students are made to pay hefty fees while there is little opportunity for meritorious students from economically and socially deprived section of the society. The health sector is similarly ailing and sick.

The private sector is growing leading to complete commercialization of health where poor have no access. The condition of the government facilities is appalling with no sign of improvement. A large section of population is malnourished and particularly women among whom a huge section is ananemic.

India is said to be a nation which is getting younger with every passing day. The increasing share of young population is said to have led India to the threshold of demographic dividend. But so far the Congress led UPA government seems oblivious of this fact and continue to neglect the youth population.

The infrastructure required for reaping this demographic dividend is missing and the situation might be so that if the nation fails to nurture this youth population well, there may be chaos and anarchy. The unemployment condition in the country is alarming. The opportunities for farmers, youth, students and women are limited. The government has no special plan for these sections of the society. They remain a neglected lot.

The Congress led UPA-II government lacks vision and leadership which is capable of building a strong nation. India is now a confident nation but the irony is that its government is insecure with weak leadership and confused priorities. Political observers and experts have rightly said that the government suffers from 'policy paralysis'. It is incapable of formulating policies that could lead India confidently development and prosperity. Moreover, it is not 'policy paralysis' alone but owing to its intention and misplaced vote back priorities that the nation never comes first in its scheme of things but it is moved by considerations of power politics, myopic vision and stunted understanding about Indian culture, traditions aspirations.

The Congress led UPA has mostly relied on deception, deceit and betrayal seeking to make fool of the people but the people have now started responding back. In the recent elections Congress had to face humiliating defeat and it will not be wrong to say that its days are now numbered.

NHRC pulls up Omar Abdullah-led J&K govt in blocking tricolour

he National Human Rights Commission (NHRC) has pulled up the Omar Abdullah-led government in Jammu and Kashmir for 'disallowing' leader of opposition in Lok Sabha Smt. Sushma Swaraj, leader of opposition in Rajya Sabha Shri Arun Jaitley, BJP National General Secretary Shri Ananth Kumar and



a host of party supporters from hoisting the national flag in Srinagar's Lal Chowk on Republic Day last year. 'Every citizen enjoys the fundamental right to go to J&K and hoist the national flag in Srinagar on Republic Day.

This right is guaranteed by Article 19 of the Constitution. It is not the case of the state government that the petitioners (BJP) were trying to flout any provision of the Emblems and Names Act 1950 or the Prevention of Insults to National Honour Act 1971,' the commission said.

More than a year later, a full bench of the human rights commission, headed by retired Supreme Court Chief Justice K.G. Balakrishnan, said the State government violated an apex court order that 'hoisting the national flag was a fundamental right.'

Issuing a notice, it asked the State government to explain within two months why it defied the Constitution. The NHRC said the arrests or preventing anybody wishing to hoist the flag was tantamount to taking away his fundamental right.

The NHRC also wanted to know why no action was taken against those who threatened to stop the *Ekta Yatra*. ■

UPA government is anti-women

Coal block allotment will be the biggest scam: Javadekar

In 2006 and 2009, 1700 crore ton coal worth Rs. 51 lakh crores of 73 block was distributed among 143 companies. When election was due in 2009 than 15 mines were distributed only within 3 months. The coal mines were also allotted to those whose factory was only on paper and in applications. This is a scam. It should be investigated. We demand, if you order CBI inquiry under Supreme Court, every thing would come out. 316 Second scam is related to the allotment of mines to near and dear. It is a PB scam. There was loss of Rs.6,000 crores to NTPC. This was done to make profit of Rs.6,000 crores to a company. Therefore it should also be investigated. Third scam is related with the system. Coal India does e-auction of 10 percent coal. In fact small industries should get it. But a trader will take it and sell it to small industries on four times high prices. Mining expenditure of private companies is Rs. 400 per ton. While it is Rs. 800 in Coal India. Why is this? The corruption is the most in NSSIDC. You frame the quota policy. Implement it without any discrimination. Give only to the industries and don't involve middlemen in between. The Ministry of Coal should seek all kind of clearances. After that it should grant permission. First rehabilitate, than construct and than mining. I have told 2-3 scams. I want their answers and their investigation also. ■



Jungle Raj prevails during BJD rule in the State: BJP

He called upon the party Karyakartas to take the failure of the Government to the people and organize public movements against price rise, power tariff hike, The party also alleged that the ruling party resorted to large-scale bungling and use of money power and misutilisation of the administrative machinery in the last Panchayat elections.

BJP senior leader and former minister Shri BB Harichandan said the Chief Minister had no moral right to

Solar panels set up atop Narmada branch canal



A multi-benefit pilot project generating one-MW electricity from solar panels atop the Narmada branch canal was dedicated to the nation by Gujarat Chief Minister Shri Narendra Modi. Besides producing "clean energy" without causing any pollution, the solar panels would spare an enormous amount of land otherwise required if the solar power project was land-based. In addition, they save a huge quantity of water in irrigation canals from evaporation.

Under the project, set up jointly on an experimental basis by the State-owned Sardar Sarovar Narmada Nigam Limited (SSNNL) and the Gujarat State Electricity Corporation Limited, solar panels have been fitted over a 750-metre stretch on the Sanand-Kadi Narmada branch canal to generate 16 lakh units of clean electricity annually. As the canal will remain covered, it is estimated that the project will prevent evaporation of 90 lakh litres of water annually. Experts claimed that the trial run of the plant had indicated 15 per cent additional power generation compared to similar land-based solar panels for, the water flowing under the panel had helped to keep them cool.

Considering the total canal network of the Narmada dam project in Gujarat, even if 10 per cent of the 85,000-kilometre long main, branch and sub-branch canals were covered with solar panels, they would generate 2,200 MW, eliminate the need of 11,000 acres of land and prevent evaporation of about 2,000 crore litres of water annually, the experts claimed.

Shri Modi said the pilot project would put Gujarat and India on the world energy map, and it would also be a major contribution to the humanity in the field of clean energy and solving the problem of both water and power shortages.

Pointing out that he had already asked both engineering students and the experts to work on the pilot project further, Shri Modi said it would do wonders if installation of solar panels became feasible on the Narmada main canals also. It was because of the huge width of the main canals that the experts did not find it feasible to put up heavy solar panels without support, which in turn would restrict water flow. But he expressed the confidence that a solution would be found soon.

Chief Minister's Amritam Yojna for poor patients started

Gujarat leads in preventive medicine: Narendra Modi

Gujarat Chief Minister Shri Narendra Modi on May 03 said that Gujarat Government has



allotted Rs.200-crore in the budget for the timely treatment of serious diseases of poor patients Below Poverty Line (BPL) for assistance of Rs.2-lakh under the Chief Minister's Amritam Yojna. He said that Gujarat is also ahead in preventive medicine. While inaugurating Narayana Rudralaya Hospital in Ahmedabad, he said the government has allotted 37 acres land for the hospital just one-and-half months back and the 300-bed hospital began functioning from today taking a fee of Rs.10 from the poor patients.

Expressing satisfaction at the modern facility



for the poor, he said that the state government has taken many schemes for the well-being of children and expecting mothers. Delivery at institutional maternity has reached 97 per cent as 108 Emergency Service has reached far and wide.

Shri Modi wished the hospital expands to 5,000-bed capacity fast, start a medical college. The government has also started Chiranjeev Healthcare, CNG Transport for pollution free atmosphere, providing drinking water from the Narmada to the Sabarmati and nutritious food the needy to improve basic physical infrastructure, he said.

MADHYA PRADESH

Govt. will establish a solar park on Lines of Gujarat : Chouhan

Inspired by the solar park set up in Gujarat, the BJP Government in Madhya Pradesh is also



planning to open a similar park to get rid of the power woes concerning the State. A land bank will be created for the purpose to lay down the solar panels for the park. As an initial effort, 2,000 hectares of land not suitable

for farming or industry will be marked for the purpose.

Madhya Pradesh Chief Minister Shri Shivraj Singh Chouhan discussed the solar park project in detail in the meeting of the energy department on April 23. Shri Chouhan said, "Solar energy is a futuristic investment. The importance of solar energy will rise in future and there is a need for balanced initiative in this direction."

The Chief Minister said that land not suitable for agriculture or setting up of industries must be identified for developing infrastructure for the solar park besides studying the solar park set up by Gujarat. In the meeting it was said, a policy has been made for promoting modernisation of power. Many officials along with Chief Secretary Avani Vaish were present in the meeting.

He further said, "Our policy for setting up solar parks is under process still we have issued

tenders for 200 MW through tradeco, our prices would be finalise by May 10." He said that a 50 MW solar power plant has been transferred to NTPC and three 5 MW each plants to private companies. Five districts of Madhya Pradesh come under over 6.2 radiations while half of the State falls under 5.6 radiation levels. Hence there are very good possibilities of solar power generation in the State and "we are thinking of establishing many more solar parks," he added.

HIMACHAL

State will award one crore for winning Gold medal in Olympics : Dhumal

Himachal Pradesh Chief Minister Prof PK Dhumal announced to give one crore for the Himachali, who will win Gold Medal in the forthcoming Olympics in Great Britain. Silver



Medalist will get Rs. 50 lakh and Bronze Medal Winner will be reward with Rs. 25 lakh cash prize. He said it while inaugurated the threeday long 15th Dr. Y.S.Parmar Memorial Volley Ball Tournament.

He said that sports infrastructural facilities

were being created in rural areas besides providing each of the panchayats, nagar panchayat, municipal council and municipal corporation gymnasium to channelise energy of rural youth and making them health conscious. He said that Rs. 17 crore had been provided to achieve the objective. He said that synthetic athletic tracks were being constructed at Dharamshala and Hamirpur, at a cost of Rs. eight crore each, with a view to provide world class infrastructural facilities to budding athletes of the State. He said that additionally Rs. 7 crore astro-turf hockey ground was also being constructed at Una thereby adding to the world class sports infrastructural facilities within the State. He said that there were a number of programmes under implementation to give boost to sports activities in the State.

The Chief Minister said that the State Government had given three percent reservation in government service to the outstanding



sportspersons. He said that diet money of the players within and outside the state had also been increased substantially to ensure nutritious diet to sportspersons. He said that besides providing cash awards to the outstanding sportspersons, 'Parshuram Award' the highest sports award of the State was also being given to them. He said that nine sportspersons were conferred with 'Parshuram Award' on Himachal Day, April 15, 2012 while 83 sportspersons were also honoured for their excellent achievements in different sports events.

UTTAR PRADESH

Samajwadi Party government disappoints all in the State: Lakshmikant Bajpai

Addressing his second Press conference after assuming charge as the President of State BJP, Dr Lakshmikant Bajpai said that the core committee of the party held its meeting on May 03 and discussed its structural requirements. The five regional heads of the party also



participated in the meeting besides senior party functionaries. He said the revamping and overhauling of the organisation would take place after the completion of the local urban bodies' elections which is likely to be held in June.

Answering the questions Dr Bajpai criticized the Samajwadi Party government for failing to fulfill its poll promise of providing adequate wheat price to farmers and its utter failure to improve the law and order situation which has worsened ever since the SP took the reins of the State in March.

The State BJP president said that the Samajwadi Party had promised in its election manifesto that farmers would be provided 50 per cent plus to their cost price of wheat as the minimum support price but no panel has been constituted in this regard to give its recommendations.

"The entire wheat procurement in the state has been marked by rampant corruption and farmers are being exploited," he alleged. He said that BJP Legislature Party leader Shri Hukum Singh would visit Shahjehanpur and former state president Surya Pratap Shahi will go to Hamirpur

to see the ground realities of the wheat procurement process. He also attacked the SP government on the law and order front and said that 212 murders took place in UP during March-April and 39 rape cases have been reported. "In many of the murder cases SP workers and leader are involved and it seems doubtful whether the government could fulfill its poll promises and provide good governance," Dr. Bajpai said.

He said that though the SP government has been formed recently it does not mean that BJP would turn its back from its misdeeds because of this.

He said, "It has been decided that BJP would contest the forthcoming urban local bodies elections on party symbol and steering committees would be constituted at the district and regional levels to take care of the elections. The organizational changes would take place after the completion of the civic polls," Dr. Bajpai said, adding that a membership drive in rural areas would be launched soon but the same exercise in urban areas would be taken up after the civic polls.

Gadkari sends condolece message to grief striken people of Dhubri in Assam
