

#### Jayalalithaa urges Centre to declared Ram Setu as national monument

Tamilnadu Chief Minister Ms. Jayalalithaa has urged the Centre to declare the Historic Ram Setu, through which the proposed alignment of the Sethusamudram channel is planned, a national monument, without further delay. In a communication to Prime Minister Manmohn Singh, she stated that based on strong opposition to the earlier alignment 6 cutting across the structure, popularly known as Ram Setu owing to its "immeasurable historical, archaeological and heritage value," a number of writ petitions had been filed in the Madras High Court and the Supreme Court. She had also filed a writ petition in the Supreme Court in 2007 praying for a direction to the Tuticorin Port Trust and the Union of India, Ministry of Culture, to declare Adam's Bridge\Ram Setu as a national monument and take over, preserve and maintain it. Besides, it was appealed to the court to prevent the Union of India, Ministry of Shipping\Surface Transport and Sethusamudram Corporation Ltd from destroying\damaging the Ram Setu in the process of the execution of the project. In the meantime, an expert committee under R.K. Pachauri was appointed by the Union government in 2008 based on the directions from the Supreme Court. A summary of the panel's report had been forwarded to the State government for its remarks. "I have had the report of the expert committee examined by the departments concerned of my government and a letter is being sent separately to the Ministry of Shipping communicating the views of the State government." Ms. Jayalalithaa said that the case came up for hearing before the Supreme Court on March 27 and the judges directed the Additional Solicitor General to obtain the remarks of the Centre before March 29 on declaring the site as a national monument.

"In view of the strong objection raised to the earlier alignment... I request you to take necessary action to communicate the view of the Government of India to the Supreme Court that it will take immediate steps for declaring the site as a national monument without further delay. The State government will separately be filing a counter to express its stand."

#### BJP hails government stance

Bharatiya Janata Party state president Shri Pon. Radhakrishnan has welcomed the State Government's affidavit in Supreme Court that sought to declare the Ram Sethu as a National Monument. Speaking to reporters Shri Radhakrishnan said that the Sethusamudram project was approved during the National Democratic Alliance (NDA) Government at the Centre in 2002.

"But the United Progressive Alliance (UPA)that came to power in 2004 hurried the project due to intense pressure from its coalition partner Dravida Munnetra Kazhagam (DMK) and tried to damage the Ram Sethu or the Adams Bridge.

"Chief Minister's efforts now to preserve the historic bridge is welcomed by the people of the State," he added.



### Futuristic BJP Election Manifesto will take Himachal forward : Prem Kumar Dhumal

The BJP government in Himachal Pradesh in its Election Manifesto has promised a slew of measures for the rapid development of the State. Releasing the Election Manifesto on October 22 in Shimla Chief Minister Shri Prem Kumar Dhumal said, "People would get benefit from all these new promises made by BJP and like the previous manifesto we will implement this one with full dedication". He said this

manifesto will take Himachal forward.

The manifesto has promised to provide electric heaters for cooking gas users, free medicines in government hospitals, for daily wagers the BJP has promised to increase the daily wage to Rs.250 from Rs.150. Likewise, widow and social security pension will be increased from Rs.450 to Rs.650.

The BJP has promised to provide free induction heaters to all registered LPG users to answer the recent hike in cooking gas prices announced by the Congress led UPA government in the Centre. It is noteworthy, the decision of Congress led UPA government to reduce the number of

subsidized LPG cylinders to six in a year has turned people in rural areas of Himachal Pradesh towards traditional mode of cooking — using wood as fuel. Amid growing resentment against the UPA decision, the BJP has promised free induction plates (for cooking) to 16 lakh households. Chief Minister Shri Prem Kumar Dhumal said, "Providing subsidized LPG gas was the Union government's mandate and at a time when the

gas prices are getting out of reach for the common man, BJP in Himachal Pradesh would want to replace gas with electric cooking".

Chief Minister Shri Dhumal said, "I cannot reduce the price of LPG cylinders as decision has to be taken by the Congress led Union government. But I can assure that BJP government would definitely reduce the burden by providing induction cooker to every household which

would reduce the dependence on LPG. It would be a cheaper option as it would consume only 2 unit of power per day and in Himachal power is already available at cheaper rates."

He said, "BJP government in the State has been given go-ahead permission to more than 500 small hydro projects to make it the power surplus State. Even though the Himachal Pradesh Electricity **Regulatory Commission** has recommended that BPL families provided power up to 40 units at Rs 2.50 per unit and those above poverty line at Rs 2.85 per unit for up to 40 units, actually subsidized power to BPL for first 40 units is supplied at Rs





0.70 per unit and other categories get it for Rs 1 per unit. This has become possible with the state government paying Rs 190 crore to the State electricity board this year to compensate for the subsidy provided".

The Chief Minister added that the BJP government had fulfilled all promises it had made five years ago. "We followed the last manifesto like a policy document. Not only did we implement what we promised but also came up with new initiatives," he said, "Promises made in the manifesto are achievable. From the identified hydro power potential of 23,203 MW of power, the party would try to increase generation to 20,000 MW in the 2012-17. By the end of the year, the State's generation capacity would touch 12,000 MW", he said.

To attract investments, the manifesto has promised to establish Rohroo-Parwanoo and Una-Mandi economic zones, construct Express Highways with tunnels to link Jubbal with Kothai and Una with Belaspur, set up satellite towns and develop tourist hot spots, educational institutions and markets. Besides, it has promised to ensure a legitimate share in power projects under the Bhakra-Beas management.

In the education sector, the BJP promises opening of law and Sanskrit universities, free school bags with a dictionary to government school students and extension of free laptop scheme. It has also promised a medical college in Mandi, five new super specialty hospitals in various parts of the State and an engineering college in Shimla.

Other prominent promises

include ensuring solutions to public complaints within 45 days and posting a woman police officer at every district headquarters. The manifesto also promises jobs to all unemployed who are registered with employment exchanges by 2008.

The Manifesto promised per month reduction in the rate of interest for farm loans to 2% from 4%, 10 lakh jobs to the jobless and advancing loans to those opting for self-employment at 2% interest, among other measures. A small trader with a turnover up to Rs.10 lakh would be exempted from value added tax (VAT). Every unemployed youth would be given a loan up to Rs.1 lakh at two percent interest and pension of senior citizens would be increased by five percent for those above 65 years of age, 10 percent for those above 75 years and 20 percent for people aged above 80 years. For the senior citizens, the party has also promised free pilgrimages.

The hill State of Himachal Pradesh will go to the polls on 04 November and votes will be counted on 20 December, after the Gujarat assembly polls are over. This year's Assembly election is expected to witness a multi-cornered contest with 459 candidates remaining in the field for 68-member Himachal Pradesh State Assembly.


A maximum number of 16 candidates are in the fray from Dehradun, followed by Dharamsala 14, Arki 11 and Mandi and Gagret 10 each. Fifteen constituencies each would witness five-cornered and six-cornered contests while seven candidates are in the field in thirteen constituencies, ten in eight constituencies and four in

remaining constituencies. The ruling BJP and Congress are contesting all 68 seats while the BSP has fielded candidates from 66 constituencies, followed by Himachal Lokhit Party 36, TMC-25, LPJ-18, CPI(M)-16, SP, NCP and Swabhiman Party 15 each, CPI-7 and Shiv Sena -4.

#### Other Highlights of the Manifesto

- Ensure environment audit in areas facing environment degradation threat
- Promote use of solar heater and solar cooker by increasing subsidy
- Increase seats in two medical colleges at IGMC, Shimla, and Dr RPGMC, Tanda, in Kangra district
- Levy generation tax on power projects for mobilize resources
- Seek 12% free share of power from hydro projects set up in the state before 1990
- Ply 500 new buses in the state, especially in rural
- Implement Citizen Charter or Public Service Guarantee Act in all public dealing offices
- Create new districts according to need
- Extend 80% subsidy on construction of poly houses for next three years by providing Rs 190 crores
- Create 10 lakh jobs in the next five years
- Loan up to Rs 1 lakh on 2% interest to unemployed youth
- To promote sports, provide training to 500 players in each district; double sports budget; and build a stadium in each district.





Mr. Chairman,

At the outset, on behalf of the Indian delegation, I would like to congratulate you and other members of the Bureau on your election and for chairing this important Committee.

We would also like to thank the Secretary General for the various reports under this agenda item and the Under Secretary General for Economic and Social Affairs for his statement. India associates itself with the statement delivered by Algeria on behalf of G77.

Mr. Chairman,

Since the World Social Summit of 1995, progress has been recorded in all the three pillars of major Social Development, namely eradication of poverty, promotion of full employment and decent work and social integration. However, many challenges remain to be overcome in all three areas.

The Secretary General's report rightly points out that while many countries have

reduced income poverty, they continue to face significant challenges in ensuring access to education, food and other basic goods and services. Moreover, concerns on un-employment, food and energy remain high throughout the developing world. The continuing grim global economic situation has further undermined the limited capacity of developing countries to cope with shocks and vulnerabilities in the global economic system.

It is, therefore, of utmost importance that we collectively undertake growth stimulating policies to boost demand and create jobs. With over a billion people in extreme poverty and hunger, we cannot afford but to make inclusive growth our priority.

At the Rio+20 Summit, the international community renewed its commitment to sustainable development, recognizing poverty to be the greatest global challenge.

The post-2015 development agenda must continue to prioritize the eradication of poverty and all efforts in the next couple of years made to achieve the Millennium Development Goals.

Mr. Chairman,

We agree with the Secretary General that more practical efforts are required to address the domestic financing gaps faced by many developing countries.

They need to effectively mobilise domestic resources including, inter alia, through prudent management of natural resources, governance reforms, more effective taxation policies and strengthening financial inclusion.

Moreover, the issue of corruption needs to be tackled on a war footing and transparency and accountability ensured in the working of governments. While this problem afflicts both developing and developed world, its consequences are more severely felt in the developing countries where it undermines the delivery of services and impact the people directly. The generation of unaccounted wealth or black money also has a major debilitating impact on the economy limiting growth and investment in productive sectors. The UN Convention Against Corruption needs to be ratified by all countries and meaningful cooperation brought about at the international level to recover monies and assets stolen through corrupt practices stashed abroad.

Noting that closing the implementation and enforcement gap remains an important priority, G20 leaders resolved at their recent Summit in Mexico, to pursue those who receive and solicit bribes as well as those who pay them. They also agreed to tracing assets in G20 jurisdictions and denying safe haven to the proceeds of corruption and to the recovery and restitution of stolen assets.

Scaling up efforts to mobilise domestic resources must be complemented by official development assistance which continues to fall significantly below commitments made by developed countries.

Mr. Chairman,

In India, achieving inclusive growth underpinned by empowerment of people, especially women, governance, and investments in social sectors, education and health, skills training, affordable housing, are a major focus. Since 65% of India's population is located in rural areas, special emphasis has been placed on rural development initiatives. There are also programmes targeted to the needs of the women and vulnerable groups.

The Mahatma Gandhi National Rural Employment Guarantee Scheme is the world's largest cash for work programme, which responds to the needs of 53 million poor rural households by ensuring them 100 days employment per year. At least 50% of the work is reserved for women. This programme has helped break down social inequalities, empower rural people, build up rural infrastructure and revive economic growth.

Initiatives in the field of education has led to India attaining nearly full enrolment in primary grades of schooling for both boys and girls and narrowing of gender gaps in middle and higher education. Similarly, health interventions have led to increased life expectancy, increased rates of immunization of children, and substantial decline in infant and maternal mortality rates.

Our targets for economic growth are anchored in measurable performance indices relating to poverty, education, health, women and children. These targets, disaggregated State-wise which implement most programmes, have helped monitor, assess and improve them.

Mr. Chairman,

India has a comprehensive legal framework to assist persons with disabilities. We seek to create an enabling environment that provides them with equal opportunities, protection of their rights and full participation in society, including in the areas of education and employment. India was one of the first countries to sign and ratify the Convention on the Rights of Persons with Disabilities in 2007.

We have around 100 million persons, who are over 60 years of age. We believe that the elderly can contribute beyond retirement







### BJP rally in Guwahati to mark the 50th anniversary of India-China war BJP will seal borders, if returned to power: Gadkari

ccusing the Congress of playing "vote bank politics", BJP National president Shri Nitin Gadkari on 18 October 2012 said BJP would take steps to seal the country's international borders to prevent illegal immigration, if elected to power. "If BJP comes to power, our top priority would be to seal the borders of the country... If Israel, surrounded by hostile countries, can seal its borders, why can't we," Shri Gadkari said.

Flagging off a rally in Guwahati, Assam to mark the 50th anniversary of India-China war this morning, the BJP National President called upon India's leaders to learn from the experience of Israel in keeping hostile elements at bay.

Taking a dig at the Congress, he said, "To visit any country, one needs a visa, one needs to submit a number of documents. But here our country has totally opened up its borders and told (illegal immigrants) 'come and enter our country, buy land, buy property'."

Shri Gadkari said, "Even if you raise slogans against India, you need not worry because everything will be facilitated. Just keep in mind to vote for the Congress."

Accusing the Congress party of being responsible for the current state of affairs, Shri Nitin Gadkari said illegal immigration pose a threat to sovereignty. "Our borders are still insecure. That is why we need to learn from shortcomings of the 1962

war and ensure that such mistakes are not repeated," he said.

He alleged that Congress leaders in Assam, from Fakhruddin Ali Ahmed to Tarun Gogoi, have all encouraged illegal immigrants.

BJP National President said that while India and China can work together for peace and prosperity at the global and regional level, the country cannot ignore threats where they are present. He cited reports of China's

involvement in building infrastructure in Pakistan-occupied Kashmir. "Yet when we talk of defending our country, we are called communal... Has vote bank politics made us so indulgent that we have even stopped thinking about our country's national security?" Shri Gadkari argued.

The BJP President said that the recent problems in Assam were not the result of any communal discord, but a struggle between Indians and foreigners. The BJP, he declared, was determined to change the general state of the country in which the economy suffered from problems of unemployment, farmers' suicides and other issues.



### Congress ignores China's hawkish posturing

Fifty years back, on October 20, 1962, our neighbouring country China launched a multi-pronged attack on India across the Himalayas. Our nation suffered a military setback but the issues that led to that war have not been resolved till date and it continues to make an adverse impact on our national pride & Sino-India bilateral ties.

Pandit JawaharLal Nehru led Congress Government's inability to defend our borders inflicted an immense psychological and political shock on the country. It was so mesmerised with Nehruji's ambition of becoming an international icon of peace that many political and strategic blunders were committed. The government overlooked even the basic defence preparedness and substantially reduced Army's strength that resulted into the 1962 debacle. The Congress government not failed to safeguard India's strategic interests in 1962 but also suffered massive territorial loss.

Fifty years later another Congress led UPA Government continues to follow the same elusive and self-destructive course. Ever since the UPA Government has come to power China has been claiming the entire state of Arunachal Pradesh and certain parts of Ladakh region as its own.

Growing incidents of military incursions by Chinese troops on the Indian side of LAC (Line of Actual Control) have become a cause for grave concern. According to media reports instances of intrusion by the Chinese army have increased from 180 to more than 400 in 2012 till September alone. On many occasions direct engagement between Indian and Chinese forces has been averted at the last moment.

China's hawkish posturing in the entire South Asian and Asia Pacific region should not be ignored by the Government. China has a massive military presence in Aksai Chin area. It seems that it has encircled India through many strategic installations. It has also tested India's patience by issuing stapled visas to people living in J&K, repeatedly claiming the border lying territories and intervening in Gilgit-Baltistan region. The government's feeble response to these violations has further emboldened China.

The Congress made similar mistakes fifty years ago when it misread China's nefarious intentions. Pandit Nehru led Congress government's biggest diplomatic failure was its ambivalent China policy which resulted into a big strategic imbalance across the Himalayan region. The UPA Government's complacent China policy could turn out to be 'another historic blunder'.

China's aggressiveness and assertiveness along the LAC clearly indicate that the UPA government has not been able to assert India's sovereignty. The Government claims that it has initiated number of confidence building measures that are supposed to be the guiding principles in any dispute with China but the government's diplomatic endeavour has failed to yield anything substantial.

In independent India, the only government which dealt with China on equal footing and successfully resolved any border dispute through diplomatic channels in our favour was the NDA government led by Shri AtalBihari Vajpayee. During NDA regime, China forfeited its claim over Sikkim and recognised it as India's integral part in 2003 and several other steps like decision of opening of Nathula pass were taken to strengthen diplomatic and trade relations between both the countries.

The UPA government needs to adopt a firm stand with China on issues pertaining to border incursions and send a strong message through its diplomatic channels and international forums. The Government has also failed to come up with robust infrastructure in the northeastern states. There is an urgent need to strengthen existing strategic infrastructure especially in the states bordering with China.

## Why is there 'Negativism'

were winding up charges and not kick-backs. The CBI's approach in the case depended on the political colour of the government in power. Once the Congress led government was installed, the CBI decided to collude with the accused and provide to them a burial of the case.

It was on this day (October 07), 11 years ago that I had got the opportunity to serve the people of Gujarat as Chief Minister. I must share that even more memorable than being sworn in as CM are the times when I get the opportunity to take small children to school on their first day! This initiative has helped many youngsters in building a future for themselves and their families.

Behind the development of Gujarat is the power of our Nari Shakti! To make a difference in the lives of our women, the Chiranjeevi Yojana was born in 2005 with an aim to provide pioneering free of cost medical treatment to women in hospitals. The Chiranjeevi Yojana has left a major mark in improving maternal health and the health of the infant. For effective participation of women in the development process Nari Gaurav Niti was initiated in 2006. This is a first of its kind for the policy overall empowerment of women. In order to make women financially independent the Mission Mangalam initiative was launched in 2010. Today, I am proud to say that businesses worth Rs. 1,600 crore are in the hands of 2.5 lakh Sakhi Mandals. You can imagine the difference

## BJP committed to economic reforms which are in National interest: Arun Jaitley





Leader of Opposition in the Rajya Sabha Shri Arun Jaitley made some points on the FDI in multi-brand retail while moving the Resolution on the Economic situation in the country during the BJP National Executive and Council meeting from 26-28 September 2012 in Surajkund, Haryana. We are publishing the brief talking points made by Shri Jaitley for our esteemed readers.

The BJP is committed to economic reforms which are in national interest. Every change in not a reform. Some changes may end up hurting National Economic interests. The BJP opposes the proposal for opening the multi brand retail for several reasons some of which are stated below:

In the first instance manufacturing sector jobs will be lost in India. Domestic retail primarily sources locally. International Structured Retail sources internationally leading to a drop in domestic manufacturing. This is all the more significant since India has not carried out significant manufacturing sector reforms.

International structured retail doesn't create additional retail jobs, it merely displaces existing jobs.

Only 18% of the Indians are in structured jobs, 51% of India's working population is self-employed. Along with agriculture, retail trade constitutes the largest fountain of self employed jobs. Structured

international retail will be harmful to job creation in India.

Fragmented markets serve maximum interest much more than the consolidated markets. FDI in retail will consolidate the retail market and restrict only to end consumer interests. In the first 12 years of opening retail for FDI, Thailand had witnessed 38% of consumer market consolidate in favour of three large retailers.

The oft' quoted example of China is misconceived. China as a low cost economy is the predominant & the largest supplier to the big retailers. It can't be argued that goods manufactured in China will not be sold only in China.

International retailers proceed on the principle of "buy cheap & sell costlier". The initial low prices facilitated by the deep pockets result in eliminating competition & then raising prices.

It is a myth that the middlemen will be eliminated & the benefits will go to the producer/farmers. The benefits of elimination of middlemen goes

to the retailer & not the farmers/ producers. The International Farm Companies Network (IFCN) data shows that in the US a milk producer gets 38% of every consumer \$ spend. In the UK this figure is 36%. In India, riding on the strength of the cooperative movement, milk producers get 70% of every rupee spent by the consumer. If farmers in the USA & UK have become prosperous due to retailers, why does the USA or the EU subsidise their farmers to the extent of US \$ 400 billion annually? This is a staggering Rs. 5000-6000crores daily.

The argument that back-end operation such as cold chains & transport facility will benefit from international retailers is baseless. Building cold chain is not rocket science; why can't building cold chains, rural farm roads co-exist with MNREGA.

Basic principals of trade negotiations have been ignored while making concessions to the US & EU by agreeing to their proposal without any corresponding quid pro quo.

He also informed the Federation, through a letter dated 21st December 2002, that the matter regarding FDI in retail trade was raised in Rajya Sabha and that the Finance Minister gave an assurance that government had no proposal to invite FDI in retail trade. Who is adopting double standards? The Congress or the BIP?

The Prime Minister has confessed that a "1991 like" situation is emerging in the country. We would like to ask who is responsible for that. You and your party were in power for the last 8 years. When we handed over power to you in 2004, you inherited a robust economy from

us according to your own Economic Survey presented to Parliament in 2004. In its very opening sentence it said "the Economy appears to be in a resilient mode in terms of growth, inflation and balance payments, a combination that offers large scope consolidation of the growth momentum with continued macro economic stability". Your Finance Minister, while presenting the budget on July 8, 2004, admitted the achievements of the NDA government said. "The economic fundamentals appear strong and the balance of payments is robust." You have successfully ruled and ruined the economy in the last 8 years because of wrong priorities, policy paralysis and economic mismanagement.

The biggest failure of this government is on the price rise



front. Prices of every article peas, dal, coal, tel, sugar, rice, wheat - everything has gone up beyond the reach of common man. You have increased fuel prices 24 times. You have increased the fertilizer prices 12 times in 24 months. Farmers are not getting remunerative prices. Input costs have gone up. The prices of fertilizers, pesticides, seeds, tractor hiring charges have all gone up and then farmers are committing suicides. Farmers are weeping and your government is sleeping. In fertilizers, the DAP prices have gone up by 111% to 170% i.e., from Rs.517.40 to Rs.1315. Complex fertilizers have gone up by 176% to 205% from Rs. 472 to 1298. MOP prices have risen by 156% to 282%. Tractor hiring charges in 2010 was Rs.800/- per acre and now it is Rs.2500/-.

You have increased diesel prices by Rs.5 per litre. This is something which has never

happened after independence. You said diesel is used only by rich people. Do you mean to say farmers are all rich? The passenger carrying vehicles use diesel. Tractors run on diesel! The pump sets used by poor farmers need diesel! It will affect agriculture very badly. Farmers who are already in distress will be totally helpless.

Their input costs will go up further and large scale migration will take place. The cost of transportation will go up. Tractor hiring charges will also go up further. Already every State Government is moving towards increasing passenger fares of State Transport Corporation buses. This burden will amount to 40,000 crores of rupees. Road transport cost will also go up. All India Motor Congress has already announced an increase of 15%. What sort of a reform it is? First perform and then reform.

You have put a cap on LPG cylinders and said that more than 50% of people use only 6 cylinders a year. What a great statement? An average poor family needs 12 to 15 cylinders a year. If what you say is correct then whey the Congress President advises State Governments to give 9 cylinders per annum. You own President is contradicting you.

Compare the NDA regime with that of your UPA. During our regime prices were under control - no lines, no queues, no waitlists, no shortages, no blackmarketing. Connectivity revolution took place - rail connectivity, highway connectivity, rural road connectivity, port and airport connectivity. Telecom revolution and IT evolution took place. Kisan Credit cards, rural godowns and cold storages happened. Earlier, during the 50

He said that irrigation special economic plans should be implemented in North Telangana to reduce the poverty, unemployment and forceful migration from India to gulf countries.

Rural indebtedness increased enormously. About 50% of rural indebtedness is due to the expenditure incurred on medicare. The Government has completely withdrawn itself from medicare, thus indirectly shifting the entire burden of medical expenditure on people. Rural people are disposing their lands and other assets and are borrowing heavily to pay hospital bills. There is a large population of tribals in North Telangana. More than half of the lands owned by tribals were usurped unscrupulous elements. Even after the recent (2006) Central Tribal Rights Protection Act, there is no change in the situation.

Shri Nitin Gadkari also pointed out that thousands have been displaced by the Singareni open cast mine, but the government has not done the needful for rehabilitating them even after these many years. Shri Gadkari promised hundreds of the displaced people who attended the programme that the BJP will do all the needful for their speedy rehabilitation. The nation is facing serious problems related to agriculture including agricultural inflation, scarcity of electricity, no assured prices for farmers, increasing prices of fertilizers pesticides etc. He assured the farmers that NDA is evolving peasants' welfare schemes which will enhance their purchasing power and per capita income. The BJP will keep on the war on poverty and if voted to power in 2014, it will change the face of rural India by ensuring that prosperity reaches every individual.

The manner in which senior ministers of the government have jumped to defend the indefensible commercial transactions of a member of the Congress Party's First family indicates that the current controversy is being utilized to display loyalty rather than to enforce probity. Citizens Groups are being told that the State will not take any action. Loyalty is more important than probity. The citizens must go to court and establish a case. The citizens are mere whistle blowers; they have to bring these cases into public domain. It is the responsibility of the State to investigate these cases. If the State shirks from its responsibility, unconventional methodologies of exposure will

overtake the existing public discourse.

The Comptroller and Auditor General (CAG) is an established institution performing its functions. The government prefers to assault it rather than follow its' sage audit advice. The experience of the Joint parliamentary Committees (JPC) shows enormous clout of the government to prvent truth from surfacing on the mere strength of numbers. Even thee public Accounts Committee (PAC) is being prevented from doing its' job particularly in the case of 2G spectrum allocation scam. The Central Bureau of Investigation (CBI) statutorily created to investigate and prosecute cases of corruption. Its' credibility is today a suspect. The CBI is currently functioning on a premise that the UPA must be helped wherever it can be; the

opponents of this government must be framed and those in the middle such as the Samajwadi Party and BSP must be under a perpetual sword hanging on their head. This is the methodology for managing parliamentary numbers.

Yes, the Prime Minister is right when he says that there is an environment of cynicism or negativism. The poison which perpetuates this negativism therefore must be expunged from the system. That alone will create a positive environment. Banish corruption, investigate corruption cases honestly and punish the corrupt - that will create a more positive environment. If you put a lid on cases of corruption, the cynicism in negativism will grow. Popular anger has emerged because of lack of accountability. ## BJP exposes multi-crore irrigation scam in Marathwada region



interest litigation petition with the Aurangabad Bench of the Bombay High Court, seeking investigation of an alleged multicrore scam involving 11 barrages across the Godavari whose costs have escalated to Rs. 2,452 crore. The BJP also named the contractors who were beneficiaries and some of them are from the Nationalist Congress Party (NCP).

Shri Lonikar said the initial cost of the barrages was Rs. 20 crore in 2007 which went up to Rs. 200 crore and more. He raised the issue several times in the Assembly and in 2008 the then Water Resources Minister Ajit Pawar ordered a probe by a one-member commission, headed by the former Secretary, Water Resources Department, M.K. Kulkarni, whose report was submitted in 2009.

The report was never tabled in the legislature saying nothing came of it and the BJP produced the report on October 18, 2012. "The only action taken was that the government spent more money. Till 2009, Rs. 1,164 crore was spent on the barrages, but after the enquiry report the government spent another Rs. 1,300 crore," BJP Spokesperson Shri Madhav Bhandari said.

The Kulkarni panel report examined the 11 barrages and pointed to several irregularities, corruption and favours to contractors. However, no corrective action was taken nor were any of the offending parties punished. The barrages proposed around 2004-05 were aimed at increasing irrigation in the drought- prone region of Marathwada after the Governor's directives to mitigate the backlog in that region. However, BJP said that the barrages

were not based on any scientific design and there was no hydrological estimate of water flows or how much water would be impounded. Besides, the area was so low on electricity and high load shedding that farmers would find it difficult to lift the water.

The BJP demanded a special investigation team to probe the alleged scam. The High Court issued show cause notices to the executive engineers of all the divisions in the Marathwada region. However, recently Shri Lonikar filed complaints with the magistrate in Aurangabad asking the police to register criminal cases against the contractors responsible for the barrages.
