## Gadkari demands JPC probe into CWG; indicts PMO

ur sportspersons have made India proud at the recently concluded 19th Commonwealth Games-Delhi 2010 with their stupendous performance in various disciplines. A11 speculations about India's potential to develop a sports culture have come of age as a sporting nation have been put to rest by the first ever three figure medal tally. The opening as well as the closing ceremony was indeed spectacular and so were the foolproof security arrangements. I congratulate the entire Indian contingent for its outstanding performance and felicitate those who have won medals. I salute all the security agencies for making the Commonwealth Games a "security milestone" in the face of intelligence reports of threats by some groups to carry out terrorist attacks against the athletes. I also commend the flawless presentations by the performing artistes, school children and all others in making the games events a great success. But all was not well with the Commonwealth Games-Delhi 2010.

It all looked fine and on track till the bid was won. Then where did we fail and who all nearly let us down? The world community in general and the people of India in particular need to know.

India won the bid in November 2003, and it took 16 <u>months to put</u> the November 1-15, 2010 O 6 Commonwealth Games Organizing Committee(CGOC) in place and the 35-member committee included Rahul Gandhi, Kapil Sibal, Jyotiraditya Scindia, Ajay Makan, Jitin Prasad and Sandeep Dikshit.

The first meeting of the Infrastructure Coordination Committee held in Delhi on March 15, 2005 took note of the requirements of venues and their up-gradation and the construction of the Games

village giving all the government bodies like the Urb a n Development Ministry, the DDA, the Delhi Government & agencies other more than five years to accomplish the task without compromising on international standards. Their proposals were approved by a group of ministers and later ratified by

the union cabinet. The irregularities and bungling in the tendering process of these projects was scandalous involving several thousand crores.

The first story about malpractices and corruption in Commonwealth Games came to light on July 30, 2010 when the UK-based AM Films highlighted the case of payments with no written contract agreement. The CGOC is alleged to have paid AM Films, an Indian-owned firm in London, over 450,000 pounds (over ₹ 30 million) for services during last year's Queen's Baton Relay inaugural without proper tendering and paperwork.

Corruption was suspected in award of tenders for different projects of the games including the stadia and other infrastructure and granting of contracts in hiring or purchase

of equipment such as air conditioners and treadmills and even toilet paper.

The Comptroller and Auditor General of India commented adversely on the cost overruns for the stadium being built or refurbished for the Games.

Stung by corruption charges and allegations of substandard infrastructure and

inordinate delays made by the BJP leaders in parliament and outside, and amidst adverse media campaign, the central government went into overdrive to assure the participating nations that the stadium will be completed on time for the October 3-14 Commonwealth Games.

A panicky Commonwealth Games Federation (CGF) President Mike Fennel rushed to Delhi and said at a press conference that "We (CGF) do not and will not tolerate any corruption." Fennel said "reports of corruption should be investigated thoroughly and acted upon as per the law of the land".

Fennel met Delhi Chief Minister Smt. Sheila Dikshit to voice his concern over the issues related to the Games and infrastructure development.

But things did not improve. An under construction footbridge just outside the main venue Jawaharlal Nehru stadium collapsed, 27 people were injured and a false ceiling at the weightlifting arena caved in. It was left to the armed forces to salvage the situation.

All this infuriated the Supreme Court to remark that the Commonwealth Games projects have bred corruption and that it cannot shut its eyes on the "rampant corruption" and criticized the Indian government on its preparations for the international sporting event. There are numerous allegations of bungling and irregularity in the tendering process for all games contracts which need to be looked into.

Senior BJP leaders including Smt. Sushma Swa</u>raj, November 1-15, 2010 O 7 Shri Arun Jaitley, Shri Kirti Azad, Shri Navjot Singh Sidhu and Shri Anurag Thakur have been raising these issues in both houses of parliament. Senior BJP leader, Shri Vijay Kumar Malhotra, party general secretary, Shri Vijay Goel and Delhi BJP chief, Shri Vijender Gupta and the BJP Sports Cell Convener Shri Mahinder Lal have led the BJP's campaign against the games scandals in Delhi.

All these BJP leaders and Secretary, Shri Kirit Somiaya have worked relentlessly to marshal all the facts and figures about the games mismanagement and prepared a 'Report on Commonwealth Games Loot' along with a voluminous annexure highlighting the callousness and total apathy and insensitivity of the government agencies and sports bodies in unabashedly wasting the tax payers money which resulted in the games budget initially billed at ₹ 2000 Crores going up to a whopping ₹ 70,000 crores.

The Prime Minister's Office has instituted an inquiry to be conducted by the former CAG Shri V. K. Shunglu. Several government agencies like the Enforcement Directorate, the CVC, the CAG, the CBI, the Revenue Intelligence and other outfits are also engaged in their respective investigations into specific charges of corruption, irregularities and malpractices etc.

Now the Commonwealth Games dirty linen is sought to be washed in public by Sheila Dikshit, Suresh Kalmadi & others, with Kalmadi demanding probe not only into the CGOC ₹ 1,620 Crore budget but also into the ₹ 16,000 Crore budget of the Delhi Government.

The BJP strongly believes that all these inquiries and investigations must be expedited to reach some logical conclusions at the earliest so that the guilty could be punished without any further delay.

In view of the multiplicity of the agencies involved in this task, we demand that a highpower coordination committee headed by the cabinet secretary should be set up to ensure an effective and concerted effort to unearth the scandals.

The BJP will extend full cooperation to all the investigating agencies and make them available the information gathered by its leaders to facilitate an impartial and meaningful inquiry into all allegations of corruption and bungling.

It is high time to expose the nexus between the partners in the Commonwealth Games loot and those providing them political patronage by condoning this mess.

People of India have a solemn constitutional right to know who the real culprits of this national shame are.

The truth must prevail and shall prevail only if a comprehensive inquiry in the public domain is held and that is possible only through a Joint parliamentary probe.

The BJP demands the setting up of a Joint Parliamentary Committee at the earliest to probe into this monumental scam of Commonwealth Games Multi-Million Loot.



arnataka Chief Minister Shri BS Yeddyurappa won the second trust vote on October 14 in the state Assembly. The second floor test suggested by Karnataka Governor Hansraj Bhardwaj on the grounds that Trust vote held on October 11 was not in order was accepted by Chief Minister Shri B.S Yeddyurappa and BJP emerged victorious. One Independent MLA Varthur Prakash supported the BJP Government.

In the second trust vote, Shri Yeddyurappa gets 106 votes and the Opposition gets 100 votes.

Congress pressed for postponement of trust vote citing the court order but Speaker rejected the leader of the Opposition Siddaramaiah's request to postpone the floor test.

After the trust vote jubilant Chief Minister Shri Yeddyurappa said "This is a Victory for democracy. For the last one week Karnataka was in news for bad reason and the state's reputation was at a stake. Now that we have won the 2nd Floor test within three days, we will put our full efforts to work for the betterment of the six crore people of Karnataka. I have learnt many lessons in the last two and half years which cannot be taught by any universities in the world". He said he will meet the Governor, Prime Minister, President, Union ministers and senior party leaders cordially and thank all of them. He was enthusiastic while announcing that his government will again focus on the Development Mantra to serve the people.

Naidu described the victory "a slap on the face of the Governor".

Reacting immediatly after the second consecutive victory of the vote of confidence in the Assembly, BJP National spokesperson Shri Rajiv Pratap Rudy said: "We have come back again and this is indeed a historic moment for Karnataka and for the BJP. The floor test in the Assembly in Karnataka conclusively proves the BJP stand that it has a majority there."

Shri Rudy noted that even if the Karnataka High Court struck down on October 18 the disqualification of five independent MLAs, restoring their membership, Chief Minister BS Yedyurappa's government would still be in a majority in the Assembly.

He claimed that with 106 votes in its favour in the Assembly which now has an effective strength of 208, the ruling party was "far ahead and beyond" the majority mark of 104 and even if the disqualified MLAs were allowed to vote it would not affect the government.

"Two MLAs - one from the JD(S) and one from the BJP abstained from voting. If that is so, then the factual strength of the Assembly is 206 and the majority mark 103. Even if we presume that on October 18, the court allows the Independent MLAs to vote, we would still have 106 MLAs and the vote of the Speaker, giving us a majority in a House of 213 members," Rudy said. In the same breath, Shri Rudy renewed the demand for removal of the Governor for "acting as an agent of the Congress".



#### Ploy of Congress Party to misuse Governor's office exposed : Gadkari

**B**JP National President, Shri Nitin Gadkari has said the victory of BJP in Karnataka is the victory of democracy. For this the Chief Minister of Karnataka Yeddurappa and local party unit deserves congratulations.

In а statement he said despite the partisan

and the unconstitutional attitude adopted by Congress and JD(S), Bharatiya Janata Party has established its full majority in Karnataka Vidhan Sabha and proved that any undemocratic step taken against the democratically elected government would meet the same fate. It is the victory not only of BJP but of the entire Karnataka State.

The manner in which Congress and JD(S) used money and muscle-power for horse-trading of MLAs in Karnataka and tried to pull down the BJP government was like an attempt for murder of democracy and BJP gave a befitting reply to that.

He said the unconstitutional attitude adopted by the governor of Karnataka Hansraj Bhardwaj was totally wrong. The governor put pressure on the Vidhan Sabha speaker K G Bopaiah and advised him not to disqualify any MLA before the confidence vote and said the governor's decision would be final in the event of any change in the numbers.

By doing so he had tried to interfere into the rights of the speaker. Instead of adopting the neutral attitude the governor had adopted partisan attitude which is most condemnable. He said BJP hopes that taking a strong lesson from Karnataka the central government would not adopt any undemocratic method in future to destabilize the democratically elected government.

#### Karnataka Governor has lost both legal and moral authority : Sushma

Ceeking recall of the Karnataka Governor DLeader of Opposition (Lok Sabha) Smt.

> Sushma Swaraj on said the BJP is shocked and outraged partisan and by the undemocratic behaviour of the Governor of Karnataka who has thrown all accepted norms to the winds by his highly objectionable communication to Hon'ble the Speaker of the State Assembly. In

а press

statement, she said the Karnataka Governor has, in effect, threatened that if the Hon'ble Speaker does not act as directed by his office, the outcome of the Vote of Confidence in the Assembly will not be acceptable.

It reveals that the Governor has been acting in a manner prejudicial to constitutional governance in the State of Karnataka and the BJP has repeatedly pointed out his overt political partisanship.

She said the Karnataka Governor's latest diktat is almost reminiscent of the illegal actions of former Uttar Pradesh Governor Romesh Bhandari in 1996, which had to be overturned by the then President of India as well as the Allahabad High Court.

In view of this blatantly unconstitutional threat to a constitutional functionary and interference in the domain of the legislature, it is clear that the Governor of Karnataka has demonstrated he is unfit to hold the high constitutional office.

Smt. Swaraj said the BJP appeals to Her Excellency the President of India to forthwith recall Shri HR Bharadwaj who has lost both legal and moral authority to discharge his role as the President's appointee.

Nothing short of the immediate recall of the Governor will restore faith in constitutional governance in the State of Karnataka, she said.

## Recall Karnataka Governor

Karnataka Governor Shri H R Bharadwaj's extra-constitutional methods in destabilising the State government has set as yet another example of misuse of Governor's office under Congress led UPA rule at the Centre. Text of memo :

13 October 2010

Dear Prime Minister,

On behalf of the Bharatiya Janata Party we seek the recall of the Karnataka Governor, Shri H.R. Bhardwaj. The developments of the last few weeks have clearly demonstrated that notwithstanding his appointment to a constitutional office of a Governor, Shri Bhardwaj has utterly failed to politically detach himself from his political past and proved himself completely unworthy of the high constitutional office that he holds. Even when he was appointed a Governor, his appointment did not inspire confidence. Notwithstanding the ministerial offices he held in the past he was never perceived to be a respecter of democratic and constitutional institutions. Extra-constitutionalism was his firm belief and the use of extra constitutionalism to demonstrate loyalty was always his political strategy.

Upon his appointment as a Governor he embroiled himself in several controversies with political leaders of the State including Ministers. The Raj Bhawan provided an easy access to politicians of the Congress Party, the JD(S), some preferred businessmen including those who were aggrieved with the policies of the State Government. His public spat with the State Government and its ministers was considered unworthy of the office that he holds and yet many people chose to ignore it despite criticism because of his uncontrollable temperament. However, in recent weeks he converted the Raj Bhawan into the epicenter of political conspiracy to encourage horse trading and destabilize the State Government.

After having allowed the use of the Governor's office for political purposes he now embarked upon a political confrontation with other constitutional authorities of the State. When some members of the legislative assembly purportedly withdrew support from the BJP government led by Shri B.S. Yeddiurappa, the Governor asked the Chief Minister to seek a vote of confidence. He simultaneously wrote to the Speaker not to invoke his powers under the Tenth Schedule and disqualify any defector. Any person elected as a member of the Legislative Assembly on the symbol of a political party if he relinquishes the membership of the party is liable for disqualification. By the very act of withdrawing support from the BJP government these MLAs had relinquished the membership of the political party on which they were elected. Similarly, some independent members had acquired the membership of a political party and therefore lost their character as independent members. They were also liable for disqualification. It is incumbent upon the Speaker to disqualify such persons with immediate effect. However, the Governor wrote to the Speaker asking him not to exercise his powers under the Tenth Schedule. An advice by the Governor to the Speaker of the Assembly should never be against the Constitution. He further warned the Speaker that in case he exercised his power under the Tenth Schedule, the verdict of the Legislative Assembly would not be acceptable. He was acting with a pre-conceived mind to destabilize the State Government.

The strategy of the Congress and JD(S) clearly was not to allow a vote of confidence to be recorded in the House by causing disturbances. When the motion was approved by a voice vote with nobody seeking a division, the Governor now, as per his game plan, chose to send a report to the Central Government recommending action under Article 356 of the Constitution. His recommendation was perverse and motivated. 105 members of the Legislative Assembly, a majority who were present in the House had supported the motion. Yet the Governor chose to recommend President's

#### Rule.

Within twenty four hours of recommending President Rule, he volte face and asked the Chief Minister to seek a fresh vote of confidence on 14th October, 2010 calling the earlier vote a farce. If the recommendation for imposing President's Rule under Article 356 was based on good and cogent grounds, how did he implicitly over-rule himself within a day? Even though the Chief Minister agreed to the request of the Governor in order to avoid needless confrontation with a constitutional authority, could the Governor have asked for a second vote of confidence within a period of three days? His public utterances while accusing the State Government and the BJP of baseless charges extended to calling his gesture an act of charity against the Chief Minister. The decorum and the restraint required in a constitutional authority was completely missing.

The history sheet of extra-constitutionalism indulged by the Governor, Shri Hans Raj Bhardwaj disentitles him to occupy a worthy constitutional office. The essence of constitutionalism is restraint, convention, and not confrontation.

We have been, therefore, constrained to approach you to seriously introspect whether persons with a preference for extra-constitutionalism and lack of restrain should at all be appointed or continued as Governors. We urge you to recall Shri H.R. Bhardwaj as the Governor of Karnataka. His continuation is at variance with the constitutional requirement of that high constitutional office.



## Anti-defection law needs to be strengthened : Venkaiah Naidu

Former National President BJP Shri M Venkaiah Naidu wants the Centre to strengthen the antidefection law to prevent defection by elected representatives.

Speaking to reporters in Hyderabad on



October 16 he said that the antidefection law need to be amended to give more clarity and shun the present ambiguity.

In the wake of Karnataka crisis, the law

should be further amended to disqualify elected representatives who speak against the party, even though they did not violate the whip.

Changing loyalties from one party to other

was nothing wrong, but such leaders should first quit their posts and seek fresh mandate, Shri Naidu said. He mooted a nation-wide debate on the anti-defection law and even suggested parties not to offer any Constitutional posts for at least five years, to those who desert their parties in preference to others. "Defections are like cancer to the society. Unless timely action is taken it will weaken the polity of the country and democracy," he observed.

"The defectors have been taught a lesson in Karnataka and it is a step in the direction of providing stability in polity. It was also a big defeat for horse-traders," he said.

Criticizing the governor for allegedly behaving in an extra constitutional manner, Shri Naidu demanded that he be recalled immediately. "It is shocking to note that the governor even now is continuing with extra constitutional political acts," he said.

"The evil of political defections has been a matter of national concern. If it is not checked it is likely to undermine the very foundation of democracy," Shri Naidu said. ■



## Give NDA second chance, will turn Bihar prosperous : Gadkari

# An Unpardonable Gaffe

mar Abdullah, Chief Minister of J&K State has indeed made history. No other Chief Minister of Jammu and Kashmir has ever taken exception to anyone saying that J&K State is an integral part of India. Omar has not only chided the BJP for doing so but has gone further to make an assertion over which both the separatists in the State as well as the Pakistani media have gone into raptures.

In a recent statement in the State Assembly, Omar has said: Jammu and Kashmir State has acceded to India; it has not merged with India.

Fact is that all the over 500 princely states, including Hyderabad and Junagarh which Omar specifically mentioned as being different from Jammu & Kashmir, have become integral parts of India after independence and had signed the same Instrument of Accession that Jammu and Kashmir signed. And over the last six decades, it is not the BJP alone that has described Jammu and Kashmir as an integral part of Indian territory but every single leader of the country from Pandit Nehru to Smt. Indira Gandhi to our present External Affairs Minister, Shri S.M. Krishna who have affirmed this.

In fact, Pakistan's DAWN of Oct. 8 front paged S.M. November 1-15, 2010 O 14 Krishna's assertion by pitting it against Omar's speech in the Assembly.

It would be in place to recall that the unanimous resolution on J& K adopted by both the Houses of the Indian Parliament way back in 1994 has affirmed:

"The state of Jammu and Kashmir has been, is and shall be an integral part of India and any attempts to separate it from the rest of the country will be

resisted by all necessary means". It is this same resolution

which goes on to state :

"Pakistan must vacate the area of the Indian State of Jammu and Kashmir, which they have occupied by aggression".

The demand for Omar Abdullah's resignation that was being made till recently was on the ground that he had totally failed to deal with the situation in the valley created by stonepelting mobs. There were elements willing to attribute it administrative to his inexperience. But this latest speech of his reveals that he is not just an administrative failure, but that in so far as J&K is concerned, he is totally out of tune with the national mood. The earlier he quits the better it would be for Jammu and Kashmir as well as for the nation.

In his Assembly speech, Omar Abdullah also referred critically to BJP's demand for

repeal of Art. 370. Since the days of Dr. S.P. Mookerji, we have been committed to Ek Pradhan, Ek Nishan and Ek Vidhan (One President, One Flag, and One Constitution).

The Kashmir movement launched by Dr. Mookerji and his death in detention accomplished the first two objectives, namely One President and One Flag. The third objective, One Constitution, is still to be achieved. And we are determined to achieve it.

But not many may be aware that even in the separate Constitution that J&K State has by virtue of Art. 370, Sec. 3 reads as follows :

Relationship of the State with the Union of India-The State of Jammu and Kashmir is and shall be an integral part of the Union of India

In his book, The Constitution of Jammu and Kashmir, former Chief Justice of India Justice A.S. Anand has commented on the above section :

In 1951 the State Constituent Assembly was convened to give "its reasoned conclusions regarding accession". The dispute regarding Kashmir had come to a standstill at the U.N.O. The Assembly in Kashmir, in order to end the uncertainty about the future of the State, after due consideration, ratified the State's accession to India in 1954.

In 1956, when the drafting of the State Constitution was being finalized, it was deemed necessary to incorporate the ultimate position of the State in respect of the sphere of its accession as a "permanent provision" in the State Constitution. It was with this idea that section 3 of the Constitution was adopted.

The words used in this section are "is and shall be". These leave no ground for thinking that the people of the State ever had a doubt about their affiliations with India. #### Omar lost moral right to continue : Anurag Thakur



### Laudable RSS role in national reconstruction

The RSS, founded in 1925, has emerged as a strong national force. It has tirelessly worked for the service of the nation making all Indians proud of their common civilisational heritage. In keeping with the highest traditions of Hinduism, the Sangh does not discriminate on grounds of caste, creed and religion. It celebrates pluralism. Yet it suffers from false propaganda and prejudicial mindset against it. In this piece, Shri Ram Lal has tried to remove the mist of many misgivings about this great nationalist organization.



ashtriya Swayamsevak Sangh (RSS) to day is a wellknown name and organization. Not only in India, RSS swayamsevaks are spread all over the world. Programmes of shakhas are held regularly from Ladakh to Andaman Nicobar islands. The country has 50,000 shakhas at 35,000 places (villages and towns). 9500 weekly and 8500 months get-togethers are also organized. For the uplift of the neglected sections of society, to instill a sense of self-confidence and infuse a sense of nationalism in them, more than 1.5 lakh service works are being organized by the swayamsevaks. In association with various social organizations, numerous

swayamsevaks are running organizations to cater to various areas of social activity in the country.

At the time of natural calamities the swayamsevaks have created new milestones of providing aid and succour to the people in distress. This selfless service rendered by the swayamsevaks has drawn wide appreciation even from those sections of society which otherwise oppose the RSS.

By conducting daily shakhas which virtually mean daily sadhna for the nation, by organizing various social welfare and assistance programmes and by expressing its stand on various issues, RSS has emerged as a strong national force. It is necessary that people get factual information about such an organization.

RSS came into being on the auspicious Vijay Dashmi day in Vikrami Samvat 1982 (1925 AD). Its founder was Dr. Keshavrao Baliram Hedgewar. He was a born nationalist. When a dona (plate) of sweets was given to every child in school on the occasion of the birth of British Queen Victoria, the child Hedgewar threw the plate in the dustbin. When his brother asked him, he explained, "Why should we celebrate the birthday of a Queen who is ruling over us by force?" His life is full of such incidents.

Because of this bent of mind, as he grew up, he got more and more attached to the national movement. He was turned out



of the school when he said, "Vande Mataram". He went to Kolkata for his medical education because this place was the main centre of revolutionary activities. There he worked shoulder to shoulder with different revolutionaries. On return, he worked with many leading revolutionaries of the time. In the 1920 Congress session at Nagpur Dr. Hedgewar pleaded for de-

mand for full independence for the country, but his suggestion was turned down. When ultimately in 1929 the Lahore Session of Congress resolved for full freedom, Dr. Hedgewar made every RSS shakha to pass a resolution in support of this resolve of the nation. Twice he was imprisoned during freedom

movement. Many other swayamsevaks also followed him in jail. In spite of all this, a false propaganda is made raising questions where was RSS during freedom struggle.

Dr. Hedgewar was greatly pained by the fact of India's political slavery. While administering an oath to every swayamsevkas "......I have become Sangh swayamsevak for securing country's freedom...."

Another pain tormenting Dr. Hedgewar's mind was that this country's largest society, Hindu society, gone bereft of national self-respect had drowned itself into oblivion and was suffering from the feeling that "what can I do all alone?" If the country's majority society continued with this feeling, how can the country stand up to face the challenges? History is witness to the fact that whenever this country has been in disarray, November 1-15, 2010 Q 17 it has landed itself in the bonds of slavery of foreigners. It was in this background that to instill a sense of national pride, selfless service and unity in the country's oldest society, the Hindu society became the aim and objective of the Sangh.

It needs to be made clear that this idea was the outcome of Dr. Hedgewar's constructive thinking. It was not the outcome



of any instant reaction to momentary thought or in opposition to anybody. To construe it as anti-Muslim or anti-Christian would be betraying the very basic concept and objectives of the organization. Those who suffer from prejudice against the very word of Hindu organization cannot understand Sangh and what it stands for. In these circumstances there is nothing unusual if such people call such a nationalist organization devoted to the nation as "narrow, communal" etc. Because of the liberal and sympathetic mindset of Hindus the faiths from all over the world got entry and protection in the country. Faiths from other countries came to India and settled there. They assimilated themselves with the culture of the country and yet they maintained their identity. Hindus accepted it because our education and upbringing is such. Shiv

Mahima states:

रुचीनां वैचित्र्याद्जुकुटिलनानापथजुषाम्। नृणामेको गम्यस्त्वमसि पयसामपर्णव इव।।

The Hindu believes that the manner in which rivers having different sources of origin merge with the sea, people following different paths merge into the creator of all. This view allowed people of different faiths to live in India. And this in turn led to the creation of a plural society.

> The pluralism we see today is not despite of but because of Hindus and Hinduism. If Hinduism were to be weakened, then neither India would remain India nor would pluralism survive. Can plural-

ism be imagined in Pakistan?

In this background the RSS is a national necessity of this country. Swayamsevaks of Sangh are discharging their national duty by organising Hindus. In the daily shakhas of the Sangh efforts are made to develop the body, mind and soul of Swayamsevaks and to instill national feelings in them.

After going through the prayer, pledge, solidarity source, solidarity mantra, which Swayamsevaks reiterate daily, one can understand the thoughts of the Sangh, what is taught in the Sangh and how the mind of Swayamsevaks works. Swayamsevaks worship the Motherland and pray for peace and prosperity of the nation. At the conclusion of every event, Swayamsevaks chant Bharatmata ki Jai. There is no room for caste, creed, provincialism, untouchability in the minds



of Swayamsevaks.

Hence, at moments of crisis and in times of tragedy, Swayamsevaks do not bother about who are the victims. They are the first to organise relief work. This was evident during the devastating tsunami of 2004. Before that, Swayamsevaks were the first to reach out to the victims of the Super Cyclone in Odisha.

It would be worthwhile to remember that Swayamsevaks toiled day and night after two airliners crashed into each other, resulting in the death of more than 300 passengers. The accident occurred in Haryana. Nearly all the dead were Muslims, and Swayamsevaks recovered their bodies, put them into coffins and handed them over to their relatives who were provided with board and lodging. Later the Swayamsevaks were felicitated at the local masjid.

Whenever there is a natural disaster like an earthquake, floods cyclone, or Swayamsevaks across the country collect relief material and rush to the disaster site. Destroyed houses are rebuilt, ruined survivors are rehabilitated. The Swayamsevaks do all this and more because they see everybody in India as children of Bharat Mata and deserving of their assistance. Swayamsevaks who migrate to other countries carry this spirit of selfless service and sacrifice with them. The good work being done by the Swayamsevaks in Mauritius, Trinidad & Tobago, the US, Europe and across the world bears testimony to this fact.

Thousands of Swayamsevaks have mobilised <u>resources and set up S</u>eva November 1-15, 2010 O 18 Bharati, Seva Prakalp Sansthan, Banvasi Kalyan Ashram and various other trusts and institutions to look after the welfare of disadvantaged sections of our society. Their purpose is to instil self-confidence among the poor and the under-privileged, those living on the margins, by empowering them educationally and economically. The results of these initiatives have been spectacular.

The Swayamsevaks have in the forefront of organising civil support for the armed forces during wars and conflicts. Whether on the frontline or in cities, towns and villages, Swayamsevaks have toiled tirelessly during the 1947, 1962, 1965 and 1971 wars. They were also active during the Kargil conflict. Many Swayamsevaks have sacrificed their lives also. Others have suffered injuries. They have neither sought nor received either compensation or medals of bravery from the Government. For them it was service to the nation, to be performed with utmost dedication and without

any selfish motives. It is such selfless service that makes the Sangh and its Swayamsevaks stand tall and proud.

The Rashtriya Swayamsevak Sangh is a national asset. It should be treasured and its services used for national reconstruction and making India stronger.

A lot more can be said about the good work being done by the Swayamsevaks and the Sangh, especially in the field of social reform and empowerment. This is being done without any publicity; often the Swayamsevaks remain in the background. That is the essence of selfless service. The Sangh is rooted in the soil of the motherland and seeks inspiration from its cultural identity and civilisational history. # Punish Teesta for perjury, Godhra accused requests SC

uring the process of framing of the Con stitution of India, the Constituent Assembly first wanted to abolish the office of Governor which the alien British government had been using to twist the arm of the local administration to enforce its designs. But after a detailed discussion it came round to continue with the institution. The framers of the Constitution thought that under a democracy the institution would, in the process, get democratized with the governor acting as the agent of the Government of India in the State and functioning as a friend and a guide to the

gress continued to rule at the Centre, many non-Congress governments were formed in various States. It was here that the institution of Governor began to be exploited to protect and promote in the States the interests of the ruling party at the Centre. It was the period when the phenomenon of *aayaramsgayaarams* raised its head. The governors, with a few exceptions, be-

came an instrument in the hand of the party ruling at the Centre to destabilise non-Cong r e s s

#### **Governors honourable**

During the first quarter of a century in Independent India, there was hardly a problem or complaint. Although the incumbents who held this constitutional office in the State were the gentlemen mainly drawn from the ruling party or senior civil servants, yet these men of eminence maintained the dignity and impartiality of their office. Till about 1967, no conflict or controversy arose because the ruling party at the Centre and in the States used to be the same the Congress. But in the aftermath of 1967 general elections, the situation changed. While Con-November 1-15, 2010 O 20

governments in States and installing in their place Congress or Congresssupported puppet governments. Since then the constitutional institution of governor started losing its sheen. It. has failed to regain the pride and glory it once commanded. The downslide continues. Since the dawn of the UPA in 2004 and its new avtar as UPA-II the malaise continues its downward slide unabated.

#### UPA misusing institution

On coming into power in 2004, the first thing the Congress-led UPA did was to remove the governors appointed by the BJP-led National Democratic Alliance (NDA) government taking the specious plea that their ideology was in conflict with the UPA's "ideology". Later, when this diktat was challenged in the Supreme Court of India, the highest court of the country decried the UPA action not in consonance with the word and spirit of the Constitution.

As time passed, the instances of a governor acting as a friend and guide to the State administration and acting as per the word and spirit of the Constitution became few and far between. Instead of being the agents of the Union Government in the State, they are gradually turning into saboteur agents of the ruling party when the State is run by a political party other than that at the Centre.

During the last six years of UPA government, the conduct of governors has hardly enhanced the prestige and honour of the incumbent governors. Instead they have become the target of jeers and of adverse comment by the courts. The legal luminaries and constitutional experts have deprecated their conduct as unbecoming of the office they hold. Without going much back into the past, what the likes of Shri Buta Singh, Shri S. C. Jamir, Shri. Sibte Rizvi, etc. have done has only sullied their image in the eyes of the people. It is now being widely felt that the common tax-payer is being burdened to maintain a while elephant institution to promote and protect only the ruling party interests in the States.

#### They brought shame

There seems to be a definite design in the selection and appointments of governors. All the gentlemen occupying the august offices of governor in the non-UPA States are among the galaxy of the diehard

Congressmen more committed to 10, Janpath than the word and spirit of the Constitution. They are adept at contriving the law and the Constitution to make it bend to serve the narrow political and electoral objectives of the ruling party. Though under oath to uphold the law and the Constitution, the likes of Shri Buta Singh, Shri Jamir, or Shri Sibte Rizvi have been more loyal than the king -- the political party they came from and which had showered the luxury of a Raj Bhawan on them. They have stood the litmus test of their loyalty to their leader and the party at the cost of the interests of the nation. Even when Shri Buta Singh had to go following his indictment by the Supreme Court for his dubious role as Governor of Bihar. he was in no time prized for the service he rendered to the Congress with another constitutional honour of the post of the Chairman National Commission for Scheduled Castes at the national level.

The present Karnataka governor, Mr. H. R. Bharadwaj, proved no different. He seems to have turned the Raj Bhawan into the camp office of the ruling party at the Centre from where, it is alleged, the Operation Destabilise the Yedyurappa government was hatched and launched. When the 16 MLAs (11 BJP, 5 independents) met the Governor H. R. Bharadwaj informing him that they had withdrawn their support to the BJP government, there was nothing wrong in directing the CM to prove his majority on the floor of the House which is the ultimate place, as per directions of the Supreme Court, to determinate whether a government enjoys the majority or not. But what was intriguing is his direction to the Speaker a day before the floor test: "In the interest of a free and fair floor

Governor should have been aware that the very plea before him by the rebel MLAs amounted to an offence under the Anti-Defection Law enacted with the sole objective of preventing floor crossing and destabilizing elected governments.

The Speaker was right in taking offence to the Governor's letter as amounting to interference in the discharge of the functions of the Speaker. He, however, assured the Governor that he would maintain absolute impartiality and act in accordance with the Constitution and obvious reasons. But the Governor's partiality got exposed when he ignored the vote of confidence by voice vote and within hours shot off a hurried recommendation to the Union Government for dismissal of the Yedyurappa government and imposition of President's rule keeping the assembly in suspended animation.

BJP was quick to condemn the Governor's action and demand his recall charging that Shri. H. R. Bharadwaj had acted "as the leader of the Opposition".

#### Bharadwaj's volte face

The legal and constitutional experts were quick to question the haste with which the Governor had recommended the imposition of President's rule. Congress which in association with JD(S) was calling the shots to ensure the fall of



Yeddyurappa government found itself at the receiving end. So it changed track. It said that the Party had nothing to do with what Shri Bharadwaj had done and that it was a matter between the governor and the Centre. But soon it realised that it had left Mr. Bharadwaj in the lurch to fend for himself while he was only promoting the political agenda of Congress. So it changed its stand after two-three days and came out the whole hog in support of the Governor's action.

What is surprising - and intrigu-

ing too - is that while the Union Cabinet met on the evening of October 12 to consider Governor Bharadwaj's recommendation for imposing President's rule in Karnataka, there was no word later whether it actually did and what was the decision. It continues to be a mystery whether the report was considered at all or what decision was taken - the recommendation was rejected or has it been kept pending for use at a later stage.

The next day Governor Bharadwaj staged a *volte face*. He called a Press conference by taking everyone surprise by asking the Yeddyurappa government to take the floor test once again on October 14 calling the trust secured by him on October 11 as "improper", "unacceptable", "a farce" and "not in accordance with the law". As the voting was carried by voice vote, he argued, "the proceedings were reduced to a farce." A veteran lawyer November 1-15, 2010 Q 22 of morality and upholding probity in public life." Shri Bharadwaj was only trying to hide his own embarrassment. If asking for a second trust vote "within days" was, as he said, "a friendly gesture", he did not explain in which category did he put his recommendation for Yeddyurappa government's dismissal and imposition of President's rule.

Chief Minister B S Yeddyurappa was quick to accept the challenge thrown to his government by state Governor H R Bhardwaj to face a fresh trust vote on October 14.

The Opposition, as also the Governor himself, seemed to have been banking on the course the petition of the 16 (particularly the 5 independent) MLAs took in the High Court which, later, extended no relief to them. The court even rejected the plea of the 5 independent MLAs to allow them to enter the House and cast their vote in a sealed cover to be taken into consideration after a final decision on their plea.

Both the Opposition and the Governor had a red face when in the second trust vote each vote was individually counted, Yeddyurappa government won with 106 votes for and 100 against. The Speaker had not cast his vote. Even if the five independent MLAs were allowed to vote, yet the BJP government would have survived.

The Opposition tried to conceal its embarrassment claiming that the outcome of the second trust vote too was subject to the decision of the Karnataka High Court expected on October 18 on the disqualified MLAs' petitions The Governor too seemed to be hinging his hopes on that. But their hopes were dashed to the ground when the High Court referred the matter to a larger Bench delaying the court verdict.

#### A precedent unhealthy

Whatever may be the judgement of the High Court - and ultimately, the Supreme Court, as the matter will ultimately land there - the arbiter would remain the floor of the House subsequent to the court verdict.

It has been a practice, precedent and rule in the legislatures, both at the Centre and the States, that no leader of the house could be made to face another vote of confidence within less than six months. But thanks to the intrigues of the Opposition and ingenuity of the Governor playing into their hands, a new precedent - and an unhealthy one, indeed - shall be set up when the present Karnataka government may have to face a third floor test within a month or so.

## Terrorism can't be tolerated in any form : Rajnath Singh

ormer BJP National President Shri Rajnath Singh raised the issue of terrorism on October 06, 2010 while delivering his speech in the 65th Session of the UN General Assembly at United Nations Headquarters, New York.

He has also expressed hope that the UN will recognize Hindi as one of its official languages in the near future. As this will be the acknowledgement of the aspirations of the world's largest democracy in its true sense.

Shri Rajnath Singh said attaches highest India importance to the agenda item relating to "Measures to Eliminate International Terrorism" presently under consideration before this Committee. Terrorism is a crime against humanity. It is the most vicious amongst international crimes. It affects us all equally. It is a scourge that open democratic societies have to contend with and the challenge is to maintain our openness, November 1-15, 2010 Q 23

safeguard individual rights, and at the same time, give no quarter to terrorists. The international community therefore needs to marshal all its efforts and resources to combat this scourge.

As you are aware, India has

been a victim of terrorism for decades. The people of India continue to pay a heavy price in our fight against terrorism. The haunting memories of horrific terrorist attacks in Mumbai in the year 2008, which was planned and executed from across the border, and witnessed by the whole world on television, are still alive. We are determined to confront these challenges unshakably and decisively.

He said we align with the statement made by Iran on behalf of NAM. No cause could ever justify the indiscriminate killing of innocent peoples. unjustifiable, whatever the considerations or factors that may be invoked to justify them.

He said the Declaration on Measures to Eliminate International Terrorism adopted by UNGA Resolution 49/60 condemns international terrorism in all its forms and manifestations. The Declaration also unequivocally condemns all acts, methods and practices of terrorism as criminal and unjustifiable, whenever and by whoever committed. States are also obliged to refrain from organizing, acquiescing in or encouraging activities within their territories directed

towards the commission of such acts. States are also obliged to ensure that their territories are not used for terrorist installations or training camps or for the preparation or organization of terrorist acts intended to be committed against other States or their citizens. If this happens, then the UNGA or the Security Council must take strong action.

Shri Singh said terrorism poses a grave threat to all States and all societies. It undermines peace, democracy and freedom thus endangering the very foundations of the continued democratic existence of societies. Terrorism is a global threat and requires а coordinated and concerted global response to combat it. In this context in addition to the urgent need to conclude and adopt the draft Comprehensive Convention on International Terrorism, we support the recent second review of the Global Counter Terrorism Strategy and the institutionalization of the CTITF.

Shri Rajnath Singh further said, "At the National level we have taken many steps to strengthen international cooperation in combating Apart terrorism. from strengthening our strategic and operational framework to combat terrorism effectively, we have also amended and strengthened our national legislation entitled Unlawful Activities (Prevention) Act, 1967 by integrating in it a mechanism for the effective enforcement of the measures adopted by the Committee against 1267 designated individuals and November 1-15, 2010 Q 24

entities. The Unlawful Activities (Prevention) Act incorporates provisions that deal with all aspects of terrorism including incitement. The Act also criminalizes raising of funds for terrorist activities, holding of proceeds of terrorism, harbouring of terrorists, unauthorized possession of any bomb, dynamite or hazardous explosive substance or other lethal weapon or substance capable of mass destruction or biological or chemical substance of warfare. We have concluded bilateral treaties with many countries in the areas of combating terrorism, organized crime, money laundering, terrorist financing and illicit drug trafficking. We also have in place treaties on extradition and mutual legal assistance in criminal matters to further strengthen and enhance international cooperation efforts in this regard. These treaties facilitate transfer of fugitive offenders and suspected terrorists to stand trial in the State in which the offence is committed and in their effective prosecution. These treaties also facilitate exchange of operational information and development of joint programs among concerned States.

At the international level, India has become party to 13 sectoral conventions on terrorism that have been adopted under the auspices of the United Nations. In relation to a specific activity, these conventions remain fundamental tools in the fight against terrorism. India has also become an active member of the Financial Action Task Force (FATF). We have always



fulfilled our obligations under international and regional conventions and relevant Security Council resolutions on international terrorism.

He said now coming to the draft Comprehensive Convention against International Terrorism, I am happy to note that the Ad-Hoc Committee that met in April this year witnessed some forward momentum as some delegations shown have better understanding and flexibility. Reflecting on the general sense of the debate that time, the Chairman of the Ad-Hoc Committee also advised delegations, and subsequently made a personal appeal to the Legal Advisers of the Ministry of Foreign Affairs to come prepared to take necessary decisions and move forward.

He said during the General Debate in the 65th Session of the General Assembly last month, many States have reiterated their support for the successful and early adoption of the draft CCIT. The Secretary General's report on the review of the Global Counter Terrorism Strategy is very important. The Secretary General very aptly pointed out in paragraph 139 of "the his report that comprehensiveness of implementing the Strategy will not be complete without the conclusion of the comprehensive convention on international terrorism. As committed in the Strategy, Member States should make every effort to reach an agreement on the text and conclude the convention in order to unite behind the global counter-terrorism efforts. The



recent Security Council Presidential statement also encourages Member States to make every effort to conclude the negotiations of the draft Comprehensive Convention on International Terrorism.

All these appeals and expectations expressed at various levels only remind us that we have already lost invaluable time in taking a concrete decision on this important issue and that the international community cannot afford to wait any longer at a time when there is the most urgent need to show solidarity and collective global action against international terrorism and to send a clear message that terrorism cannot be tolerated in any form or manifestation for whatever cause.

The negotiations over the years have by and large got a near full text of the proposed Convention with general agreement. There remain just a few outstanding issues in Article 18. We look forward to the Chair of the Ad Hoc Committee to guide us in agreeing to a full text that can be recommended by us for adoption in this Session itself. We would also strongly urge delegations to show flexibility and reach common а understanding on the text so that we can move forward and fulfill the expectations of the Secretary General, the Security Council, and of the international community as a whole.

## J&K CM wants to internationalise a domestic issue: Dr. Joshi



Taking a strong view about Jammu and Kashmir Chief Minister Omar Abdullah questioning the state's accession into Indian Union in the State assembly, former BJP National President Dr. Murli Manohar Joshi on October 8 warned that people would not tolerate the efforts of the Chief Minister to internationalise a domestic issue.

Dr. Joshi who as BJP president took out a countrywide 'Bharat Ekta Yatra' in early 1990s said newspersons that the Chief Minister had sought to speak the language of the separatists by differentiating between accession and merger of J&K with India after independence which was inappropriate for any incumbent CM especially that of J&K. The Chief Minister should have known that all kingdoms and dominions in the country had joined the Indian Union through the Instrument of Accession like Maharaja of Kashmir Hari Singh. Mr Abdullah must know the Constitution of India had listed Jammu and Kashmir as the 15th state of the country and Section 3 of Kashmir's own Constitution too had explicitly stated that it shall be integral part of India. "If Mr Abdullah is seeking to differentiate between 'accession and merger' of the state like the separatists, it would mean that he was speaking the language of the separatists. He was not only violating the Constitution of India but his own Kashmir State which proclaimed that it was part and parcel of India," he said.

If the Chief Minister wanted to internationalise the issue he could do so by asking Pakistan to vacate the PoK region, Dr Joshi remarked. Indian Parliament under the Congress regime had passed a unanimous resolution asserting that the territories of Pakistan occupied Kashmir (POK) as integral part of India and the BJP did not expect "irresponsible statement" from a person holding a constitutional position, Dr Joshi said.

While there could be no question of azadi, the demand for devolution of funds and political power for J&K could be considered by the country on the recommendation of Justice Sarkaria Commission. The demand could be considered for all states not just for Mr Abdullah's state, he remarked. Dr Joshi criticized the Congress led UPA Government for diluting the hard earned diplomatic gains of the country by conceding Pakistan as a victim of terror and agreeing to hold talks despite cross border terror and attacks from Pakistan side.

This advice given to a British Governor who wielded considerable executive authority, underscored the fact that even in those days, a Governor was not expected to interfere with the functioning of a popular government. During early independence days when Governor Jairam Das Daulat Ram, a veteran and much respected Congressman, criticised the functioning of Chief Minister Dr Sri Krishna Sinha, the latter took up the matter with the Centre and offered to resign. At that time both Pt. Nehru and Shardar Patel decided to honour the mandate of the people of the State. Jai Ram Das Daulat Ram was transferred to Assam.

There was a strong opinion against continuing with the institution of Governor after independence. Biswanath Das a former Chief Minister of Orissa, during the debate in the Constituent Assembly stated, "Now we are going to have democracy from toe to neck and autocracy at the head."

But in the post independence period India's six-decade-old Constitutional history is replete with instances of misuse of the office of Governor and indiscriminate use of Article 356 by the Congress Party to destabilize states ruled by non-Congress parties. This Article was used for the first time to dismiss the democratically elected Communist government of Kerala in 1959. In 1970s and 1980s it became common practice for the Congress led Central government to dismiss the state governments under opposition parties on flimsy The Indira Gandhi's grounds. regime became infamous for this practice. The Congress party has misused this provision to impose President's rule because it means a government run as per the wishes of the ruling party at the Centre without a mandate of the people. # Holistic approach required to tackle Naxal menace : Munda

#### Centre discriminating against State : Prabhat Jha

BJP State president Shri Prabhat Jha MP said the Centre's discrimination against the State Government is visible across the spectrum. He said the Centre is giving Madhya Pradesh much less than the allotted quota for coal and sugar.

In a statement issued on October 10 he said that electricity production in the State was getting affected, as the coal

provided by the Centre was not of a very good quality.

He said that of the 67.70 lakh Below Poverty Line (BPL) families in the State, ration cards were issued only 41.25 lakh families by the Centre.

Shri Jha said that even in the case of sugar, the quantity that was given to the State was 55,000 MT less than the allotted quota. This almost works out to allotment of sugar for six months, he said.

He said that the allotments made to the State under the Indira Awas Yojana were much lower than those made for other States. For example Madhya Pradesh is much bigger than Kerala, but the latter got much larger allotment under the Yojana. He said that the electricity given to the State had been cut by 680 MW and demanded that the allocation of electricity to various States should be rationalised.

He said this discrimination against the State is being done at every stage. This may be the result of the Congress fear caused by the development taking place under the BJP Government in the State.

# BJP govt. plans law to provide essential services within time



Himachal Pradesh Chief Minister Prof. Prem Kumar Dhumal on October 15 said the State Government would consider enactment of an Act to provide delivery of services to the people of the State within the stipulated time limit and for matters connected therewith and incidental there to.

The Chief Minister said that it was common man's Government in the State, which was accountable to them in all its actions. He said that common man had been the focal point of all the policies and programmes of the Government and efforts were being made to ensure delivery of best services to people within stipulated time-limit.

He said that the State Government was committed to protect the interests of common man and



cater to his basic necessities. He said that the government was considering a proposal to fix a time limit for providing electricity connections, financial incentives under various welfare schemes, disbursement of relief as per relief manual, providing of documents required under Revenue Department, different types of certificates, settlement of social security pension, issuance of BPL/APL ration cards etc.

Prof. Dhumal said that such a provision was already in force in Madhya Pradesh where the State Government was delivering time-bound essential services to people. Efficiency, transparency, accountability and prompt delivery of services would be ensured with the enactment of the proposed Act after taking all related aspects into consideration and getting the same legally examined. He said that the Act would guarantee the delivery of public service in stipulated time limit and every citizen, if eligible, would have legal right to demand that the notified public service be provided to him within the prescribed period of time.

He said that it would be a path breaking legislation, which empowers the citizen in relation to public service delivery and would also include systematic responsiveness and accountability in public administration.

#### Hike relief amount to disaster-hit areas : Chufal

Interacting with media persons in Haldwani on October 15 State BJP Presi-



dent Shri Bishan Singh Chufal asked the Congress led UPA government to substantially increase the relief amount granted to the victims of natu-

ral disasters. According to the standing rules only Rs 2000 per acre in plains is given for loss to the crops by the natu-

ral disasters, while in the hilly areas the relief amount per 'naali' is only Rs 40 for crop loss.

He said it is quite unperceiving what kind of relief we are extending to the needy with this fixed <u>amount and criticized the</u> Opposition Congress November 1-15, 2010 O 29 party of playing politics in the name of disaster in the State.

He said we have urged the Centre to substantially increase the relief amount given under different heads to the natural disaster-hit victims. But no one is listening, he alleged while criticizing the Congress party and its five MPs from the State. Our main concern is that these Congress MPs have so far done nothing to impress upon the Central Government to provide maximum relief to the people of the hill State, Shri Chufal said adding a large number of houses were destroyed and more importantly a sizable number of houses were damaged beyond repairs. But the amount fixed as compensation for house damage is quite less, he said.

We have already demanded Rs 21,000 crore as relief package from the Centre. Even the Central team has justified our demand. But our concern is that this relief package should be released soon and the Central Government should also revise the existing relief amount rates under different heads.

He said the BJP government suspended all party engagements and directed Ministers, MLAs and office bearers and workers of the party to help the people. He also sought the support of the Congress led Union Government so that State could put the pace of development on track.

across Gujarat. The results, no doubt, reaffirm the fact that Shri Modi remains the tallest leader in Gujarat and his popularity transcends caste, class and community. This is as much on account of his undiminished charisma as the development-driven, growth- oriented governance that has come to be identified with Shri Modi. Gujarat remains a shining example of what a State Government with maximum governance can achieve, apart from the positive impact that corruption-free administration has on society.

After completing nine years in office, Modi remains untouched by the slightest hint of anti-incumbency. There's a lesson in this for the Congress which has come to believe that trickery and deceit, coupled with gross abuse of power, can help dislodge State Governments over which it has no control.
