BJP led government formed in Jharkhand

JP has formed a new coalition government in Jharkhand under the leadership of Shri Arjun Munda with the support of Jharkhand Mukti Morcha, All Iharkhand Students Union (AJSU) and JD (U). On September 11, 2010 the senior BIP leader and former chief minister of the state Shri Arjun Munda MP took oath as the new chief minister of Jharkhand. AJSU chief Sudesh Mahto and IMM leader Hemant Soren, son of former Chief Minister Shibu Soren, were also sworn in at the ceremony as ministers. The State was under president rule since June 2010.

It is Shri Munda's third stint as chief minister in the state. He first served the state in 2003 and then in 2005 when BJP led NDA government was formed in Jharkhand. The 42-year-old BJP leader, Shri Munda has the support of 45 MLAs in the assembly with an effective strength of 81.

Governor Shri M.O.H. Farook administered the oath of office at Raj Bhavan. In the 81-member Assembly, BJP and JMM have 18 MLAs each, five AJSU, two Janata Dal (United) legislators and two independents are supporting the BJP led coalition government.

Munda proves majority

Governor MOH Farooq who invited Shri Arjun Munda to form the government on September 09, had directed him to prove his majority on the floor of the House within a week. Chief Minister Shri Arjun Munda following the governor's directive proved his majority on September 14 by winning the vote of confidence in the assembly. Shri Munda notched a victory in the confidence motion with a margin of 15 votes – 45 in favour and 30 against in the House of 81.

Immediately after proving his majority Shri Munda called an all-party meeting to discuss the issues connected with drought situation in the State. Due to the deficit rains this monsoon, the state administration during President's rule, had declared all 24 districts of the state as drought hit. He said we wanted to take everyone along in dealing with the crisis. He re-affirmed his commitment to work for the welfare of the people of the State by providing good governance while working actively for the development.

President Shri Rajnath Singh, BJP National chief spokesperson Shri Ravi Shankar Prasad, Chhattisgarh chief ministers Dr. Raman Singh and Uttarakhand chief ministers Shri Ramesh Pokhriyal besides JMM chief Shibu Soren and his wife Rupi Soren attended the swearing-in ceremony.

It is noteworthy that the BJP and the JMM had formed a coalition government December 30 last year under Shibu Soren. But it lasted only five months. Iharkhand was under central rule since the BJP withdrew support to Shibu Soren government in April 2010 and the President's rule had been

imposed on June 1 with the Assembly being put under suspended animation. The BJP and the JMM came back together after three months of parting company and the central government recommended lifting of the President's rule in the state. Speaking to the mediapersons after taking oath at Raj Bhavan, Shri Munda said his priorities were to deal with the grave drought situation in the state and address the grievances of farmers and the poor. Supporting the decision of the party BJP National General Secretary Shri Ananth Kumar told reporters that BJP has formed the government in

alliance with Shibu Soren's JMM and other outfits as part of its endeavour to keep the Congress out of power in the politically fragile state.

He said all the constituents of the BJP-led government headed by Shri Arjun Munda decided to come together at their own free will not only to keep the Congress out of power, but in the larger interests of providing good governance for the remaining four years of the term of the state legislature in Jharkhand. He said the BJP-led government will provide a good governance and development in the mineral-rich state over the next four years. ■

Thumping victory for BJP in Gujarat and Karnataka bypolls

In Gujarat BJP on September 17 broke into the Congress bastion bagging the Kathlal assembly seat for the first time in five decades winning the by-poll, giving Gujarat Chief Minister Shri Narendra Modi a victory gift on his 61st birthday.

Shri Kanu Dabhi won by over 21,000 votes defeating his nearest Congress rival Shri Ghelabhai Zala. Shri Dabhi got 62,120 votes while Shri Zala polled 40,573 votes.

With this win, the strength of BJP in the 182-member state assembly increased to 122. Expressing happiness on the victory, Shri Modi said the people of Gujarat have defeated every conspiracy of Congress and CBI. This is people's support for the development oriented politics. Even the Congress and the CBI together, could not defeat BJP in what was considered a Congress

bastion," he said. He said those indulging in secular vote bank politics have been given a befitting reply by the people of Gujarat. The victory has come from an area which is represented by two Central ministers. Clearly people have rejected the Congress," he added.

In the prestigious by-election held in Karnataka on September candidate Shri Y C Vishwanath a medical practitioner, won Kadur, held earlier by the Congress. In Kadur BJP's Shri Y C Vishwanath notched 55,796 votes, Shri YSV Datta of the JD(S) got 41,899 votes and Shri K M Kemparaju of Congress got 30,330 votes. The Congress suffered a huge jolt as it not only lost Kadur but also its candidate Ajay Singh failed to taste success in elections for the second time despite Gulbarga being considered Dharam Singh's stronghold. The bypoll victory keeps the BJP MLA count at 116 while the Congress drops to 78 in the 224-member Assembly. The Congress has over three phases of bypolls in the state in recent times dropped seats while the BIP has made incremental gains. ■

Modern technology needed for effective communication : Gadkari

Sushma Swaraj and BJP Parliamentary party Chairman Shri L K Advani delivered the valedictory talk.

Addressing on the occasion



BJP National President Shri Nitin Gadkari underlined the need to study and improve content of matter while speaking or writing on issues. He also emphasized on how the cadre should use modern technology for effective communication.

Shri Gadkari said two ways consultation between centre and state parties is utmost important in order to keep strong vigil on various developments.

Addressing the gathering

Leader of Opposition in the Rajya Sabha Shri Arun Jaitely gave a comprehensive picture on media and politics today. He built on how news is being redefined by the emphasis being placed on camera-based electronic media.

He said news as it breaks is watched on TV but the content may be read on the net. "News is what the camera can capture," he said. However, he cautioned the spokespersons from getting 'media-driven'. Election



campaign abroad are being played through TV debates. He emphasized the need to use the local media, regional media and every other platform.

Shri Jaitely laid emphasis for placing developing news within the framework of our ideology and analyzing them and then understanding our position.

BJP National General Secretary and Chief Spokesperson Shri Ravi Shankar Prasad elaborated on how to build on an issue to underline its political importance. He elaborated using several contemporary and current examples such as Ram Setu, price rise, Amarnath, Naxal and 'My Name is Khan'. He emphasized on understanding the 'party line' and speaking with confidence and credibility.

The day also saw eminent television journalists Smt

Navika Kumar, Shri Deepak Chaurasia and Shri Pankaj Pachauri talking from their perspective.

Delivering his Valedictory address on the second day of the workshop BJP Parliamentary party Chairman Shri L K Advani said we live in a media-driven society. There is no field of social activity that remains untouched by the media. And this is true about politics, too.

I have often reflected upon the sea change that has come about in the impact of the media on politics since I became a political activist of the Bharatiya Jana Sangh nearly 60 years ago.

He said from wall-writing to websites, I have seen all the transformations that have taken place in the way political parties communicate to the people. With each new development in technology, the power of the media to reduce the distance between the political establishment and the people has increased. Technology can change the nature of the carrier, and also its power to carry the message faster and wider. However, technology cannot change the message itself. He said the message is determined by the thoughts and conduct of the political establishment.

Shri Advani said the over one hundred media in-charges and spokespersons assembled at this conclave must realize that a very important responsibility has been assigned to them by the party. "Your function is to ensure that in the eyes of the people, your communication with the media is such that people come to accept that BJP is really a trustworthy nationalist party, committed to good governance and clean politics," he said.

Setback for J-K Congress, 5 ex-councilors join BJP

Ladakh Union Territory Front merges with BJP

In a major setback to Congress, five of its former councilors have resigned and joined BJP in Ladakh region of Jammu and Kashmir on September 20, 2010.

The former councillors - Shri Mohmmad Khan, Shri Haji Abdul Qadir, Shri Gulam Mohmmad Chattapa, Shri Gulam Haider Majun and Shri Ahmed Shah - joined the BJP at a function in Nobra belt of Leh in presence of Nobra MLA Shri Tsetan Namgial and Nobra block President Shri T Namgial.

Reacting on this development State BJP spokesman said BJP got an opportunity to strengthen its position in Jammu and Kashmir in general and Ladakh in particular as five former Congress councilors of Ladakh Autonomous Hill Development Council (LAHDC) joined BJP.

Lacs of rotten foodgrain bags found at FCI godowns

BJP team makes surprise visits to Kurukshetra, Karnal & Ambala godowns

JP team on 09 September 2010 paid surprise visits to FCI's Kurukshetra, Karnal & Ambala godowns and exposed the rotten foodgrain scam. Lacs of wheat bags were found to be lying in the open. Fully rotten and insect infected foodgrains were found at the Ismailabad FCI godown at Kurukshetra.

BJP leaders Shri Navjot Sidhu, Dr. Kirit Somaiya, Shri Prakash Javdekar, Capt. Abhimanyu, Dr. Harshvardhan visited FCI godowns at Karnal and Ambala. More than half of the foodgrains stored in these godowns were lying in the open. No proper plinth, tarpaulin and other norms were followed for the scientific storage of food grains. This is the 24th FCI godown visited and exposed by BJP team led by BJP National Secretary, Dr. Kirit Somaiya in the last 6 weeks. It is observed that more than 180 lac tons of foodgrains are stored in the open. These are mainly in Haryana, Punjab, Rajasthan and UP.

BJP National Secretary Navjot Sidhu has charged that it is sheer criminal negligence on the part of UPA-Congress Government which has allowed Rs. 58,000 crores worth of foodgrains to go waste. BJP spokesperson & MP Shri Prakash Javdekar stated that a Parliamentary Committee should inquire indepth into the rotten foodgrain scam. Government is misleading the Parliament in stating that only Rs.6 crores worth foodgrains have been wasted. The godown visited by

that since it is a question of national prestige and national honour hence the BJP will raise the issue of corruption and other irregularities after conclusion of Games. He told that due to the Games entire Delhi has been dug up. Diseases like Dengue etc. are spreading due to water logging in the potholes. The BJP will compel the Government to account for every act of corruption committed in the name of the Games.

The BJP will see that the corrupt persons are sent to jails. Referring about the two rounds of floods in Delhi, he told that he himself visited the flood affected areas alongwith BJP team. The people were facing the problem of drinking water and attend nature's call. The BJP workers provided relief to the flood victims. Government machinery remained idle. Delhi has become a centre of criminal elements. The clouds of terrorism is also hovering on the Games.

Shri Gupta told that the condition of rural areas and slum clusters is very bad in Delhi. Mrs. Sonia Gandhi and Sheila Dikshit had distributed provisional certificates to the people of unauthorized colonies on the eve of Assembly elections two years ago, but not a single colony has been regularized till date. The Lokayukta has also summoned Delhi Government on this issue. Even after the orders of the DERC the power tariff has not been reduced. The Congress Government is deliberately avoiding the hanging of Afzal Guru. Due to this the incidents of terrorist activities are being seen in Kashmir and naxal areas. The



The importance of September

ersonally for me, today's is a memorable date. It was exactly on this day in 1947 that I left my birthplace Karachi for good. In these last 63 years since, I have visited Karachi only twice – first time in 1978, and the second time in 2005.

Gen.Musharraf of Pakistan was born in Delhi. When he visited Delhi in 2001 he had come here for the first time since independence. I referred to this in my very first interaction with him at the Rashtrapati Bhavan.

"Don't you think it unfortunate" I said, "that in these over five decades after 1947 you are visiting your birthplace for the first time, and that I have also been able to visit Karachi, my home city, only once (my second visit as indicated earlier came later)!"

I challenge Soniaji to provide women reservation within Congress: Smriti Irani

Smt. Smriti Irani, the legendary "Tulsi" of a popular TV serial that created history, needs no introduction. As the new national President of BJP Mahila Morcha her vision is to keep the flag of India's rich culture and hoary traditions fluttering high at all the times. Even in films, she has remained grooved to the Indian culture and samsakaras. Her roles have always depicted the life, trials and tribulations of a truly Indian woman. Initiated into Sangh ideology when just 7 years old, she has plans to involve more and more women into politics and BJP.

Amba Charan Vashishth interviewed her last week in Delhi. Some excerpts:



What is your vision of an empowered woman?

Every woman in the country should be aware of her rights and be vigilant to exercise and protect them. She should be aware of the rights bestowed to her under the Constitution of India. She should be the master of her own destiny and lead a fuller life. At the same time, she should devote her life to the service of the society and the nation.

What made you to jump into politics?

My grooming into politics was as natural a process as my upbringing. My maternal grandfather (naanaji) was a swayamsevak of RSS. My mother was a Jana Sangh karyakarta content with working at an election booth. I was groomed into this nationalistic ideology; so my joining BJP was like being in my own family. My elders in the family did not get any office; they remained committed to the ideology. When I got a responsibility in the BJP organization, they were all very happy. It is an opportunity for me to prove myself and march forward. It is an onerous responsibility for me.

A woman has a very important role in her home. How important is her role in politics?

Men and women are the two wheels of the same

cycle of politics. Without either of the two, the cycle can't move forward. At present grant of only 33 percent reservation to women is being talked about though we women deserve 50 percent reservation. Women and men are equal partners and play a role complementary to each other. The task of reconstruction and rejuvenation of society can be accomplished only by the combined efforts of both.

As Mahila Morcha President, what are your immediate plans to involve more and more women into politics and BJP?

As per our party constitution, about 100 women get office at the *mandal*, *tehsil*, district and State level. During my tours to the States I exhort women to involve themselves more and more in politics and tell them that they can get no platform better than BJP to serve the society and the nation best. Male *karyakartas* are there at every election booth. I wish to involve more and more *mahila karyakartas* at every booth. I wish to associate more and more women from respectable families as do I wish from the dalit and downtrodden families to give them a position of respect in the BJP. During my tours my only anxiety is to reach the women at the



lowest level of society. I appeal to women in villages to involve themselves more actively in politics.

We are planning to organize a workshop to ensure political training to women. Nari Shakti *Kendras* are being constituted. Through these kendras we shall launch a campaign for health, education and employment for women. We are also campaigning for permanent commission to women in the army. It is a matter of regret that the government is ignoring even the court verdict. Women are being deprived of their right of parity with men. We are taking up this issue on priority. Demands of women are pending for long. Government has given a deaf ear to these. We are also extending free legal assistance on our own. I wish to state that BJP is the only party which has been trying to solve the problems of women even while being in the opposition. Women want results, their rights and justice. They are not interested in empty rhetoric.

Since becoming the President about six months back, which are the States you have visited in the country?

I have extensively toured the country from Kanyakumari to Jammu and Wagha to Dimapur I have visited Punjab, Delhi, Gujarat, Tamilnadu, Kerala, West Bengal, Jammu-Kashmir, Karnataka, Arunachal Pradesh, Assam, Meghalya, Nagaland, Mizoram, Madhya Pradesh etc. I wish to cover the whole country, including Andaman and Nicobar islands by the end of the year or by January. Extensive touring has made me understand the ground realities of politics. This will help me in formulating next programme of action.

Passing the Women Reservation Bill in Rajya Sabha has proved to be a hoax played on women. Despite tall claims government has failed to prove its sincerity by getting it passed in Lok Sabha.

Women have seen through the Congress game. It stands fully exposed in the eyes of women. For Congress the Women's Reservation Bill is just a slogan. It is trying to befool women on the issue. On the contrary, BJP stands fully committed to women reservation. In Rajya Sabha the Bill was passed only because of

BJP support. By amending its constitution, BJP has shown how honest is it towards this matter. BJP is the first and the only political organization which has granted 33 percent reservation to women at all levels in the organization. I challenge the Congress to follow the BJP example and grant 33 percent reservation to women in the organization. Congress has reserved only the post of Congress President to Smt. Sonia Gandhi only because of dynastic considerations till her son takes over.

In politics, who is your role model?

Atalji is my role model. He commanded great hold over the organization; people love him the most. He proved to be a world statesman. He did not come off a political family but from an ordinary one. He rose by dint of his hard work and intelligence. He made a place for himself in the country and the world. Besides him Advaniji is also my *margdarshak*. I also derive inspiration from Sushmaji and Arun Jaitleyji. Presently, I am working under the guidance of our national President Shri Nitin Gadkari from whom we have to learn a lot.

India is passing through twin problems of female foeticide and ever-increasing population. Despite best efforts the results are not encouraging. What, in your view, should be done?

For us in the BJP female foeticide is a social sin and we are in the forefront to fight it. In Gujarat a social programme was launched against this curse. It was ensured that those who indulged in this crime were punished and imprisoned. In Madhya Pradesh innovative schemes like *Ladli Laxmi Yojna* have had a positive impact We need to strike at this evil from all angles.

And to control population?

We have to come forward with bold steps We have to stop playing politics on the issue. If China and other countries can do it, why can't India? Otherwise this population bomb is going to explode on our face.

The society and government owes a lot to do to prevent atrocities and crimes against women. Is there anything that women need to do at their level to prevent such shameful incidents?

other senior officebearers of the party's West Bengal unit.

The Parliamentary Delegation visited areas affected by serious communal disturbances earlier this week. They surveyed the disturbed

2010. Although the State Police, RAF and even the Army have since been deployed, an atmosphere of fear and uncertainty prevails. The Army conducted a flag march only along

the main highway, while the police apparently claimed that they were under orders not to use force against the rioters. Only on Tuesday, after sustained violence against the targeted community spread

to interior villages did the RAF swing into action and manage to bring the situation under tenuous control.

The disturbances began with a deliberate attempt to disrupt erection of a Durga Puja pandal at Chattal village although the site has been used for performing a community puja for the last 40 years and a permanent temple also stands there. The site adjoins a Muslim graveyard and recently attempts have been made to stop the Durga Puja at its traditional site on the ground that ownership of the land is disputed.

Taking advantage of the disturbances unleashed by Haji Nurul Islam's goons, the rioters mounted a mike atop the Deganga Bazar mosque



in violation of a High Court order prohibiting the use of a microphone at the shrine. The local Hindu community is seriously aggrieved and agitated over this action especially because the police have not intervened to dismantle the mike despite its promise to the community leaders. The BJP Delegation was also taken to the Kali temple at Kartickpur which has been severely vandalized by the miscreants.

The Delegation visited the Deganga thana and interacted with I-G Sanjoy Mukherjee and SP Rahul Srivastava. While appreciating the police's concern to restore normalcy first, the MPs demanded that the miscreants be promptly apprehended in order to restore confidence.

The BJP has demanded immediate arrest of TMC MP Haji Nurul Islam who, from all accounts, incited the mob into communal frenzy and has been named in the FIR lodged by local people. The Party Delegation also demanded prompt compensation for people whose houses and shops have been looted and burnt, in many cases beyond recognition. The BJP leaders sought proactive intervention by security forces to ensure that the

terrified local populace feels secure once more. It pointed out that many people, particularly young women, had been forced to flee the locality fearing molestation and worse. Conditions for their return to their homes must be created forthwith, the Delegation demanded.

Anatomy of a riot foretold

ome readers may think this is cynical, but riots and violence have rarely moved me to get emotional. Covering Punjab in the late-1980s and early-1990s was a numbing experience. I saw so much blood spilt all around me that I became somewhat blasé about it. Almost at the same time, I travelled frequently to Bihar in connection with mounting caste-related massacres and the rise of private armies. Then came the build-up to Ram Janmabhoomi and its aftermath. Maybe it was the long gap between the years of riot coverage and my new role as a party MP that caused a somewhat different reaction when I spent last Thursday at the Deganga Block in West Bengal's North 24 Parganas district to witness the savage fallout of pre-planned communal violence.

Arguably, the disturbances were relatively minor by Indian standards. I had witnessed more cathartic violence earlier. But it shocked me to discover the deliberation and diabolical planning that went in behind the stirring of communal frenzy in an otherwise peaceful part of West Bengal. The linkage between the motivated triggering of the rampage and the forthcoming State Assembly poll was so palpable that it shook my sensibilities as a human, notwithstanding the fact that I am now mostly a After decades of communal harmony, as the violence in Deganga shows, West Bengal could be imploding due to competitive vote-bank politics

political person who is not supposed to have such feelings.

Deganga is approximately 50 km from Kolkata's Dum Dum airport, past the busy suburban town of Barasat. As our motorcade veered off onto the road to Basirhat, urban bustle yielded place to rural serendipity — lush paddy fields with the crop almost struggling to keep its head above the standing water, thatched huts, goats and hens frolicking on the roadside, curious bystanders watching a procession of vehicles zipping past, noisy buses and motorised rickshaws seeking to pick up passengers from the middle of the road, and the ubiquitous teashop, the hub of village gossip and political argument: In other words, typically agrarian Bengal.

As we approached Deganga, the scenario changed rapidly, disturbingly. Rows of burnt shops, ransacked kiosks, burnt scooters and shuttered commercial outlets lined the highway, town after town. Deganga thana resembled a

fortress. Army trucks were lined, with men in fatigues, cocked rifles in hand patrolling furiously. We saw at least three police vehicles charred almost beyond recognition close to the sprawling police outpost. We proceeded without stopping to the epicentre of the violence, Deganga Bazar, a big cluster of shops and pucca houses. As we descended from our vehicles, crowds gathered not quite knowing if we were sarkari inspectors, since three police jeeps were part of our convoy. After understanding that it was a BJP team that had come to inspect the ravaged town, the crowd virtually burst out in pain, anguish, hatred and anger.

We were the first political delegation to reach the violencetorn region. Surprisingly, none of the three major political forces in the State - ruling CPI(M), challenger Trinamool and also-ran Congress - had ventured here since the trouble began last Monday. At times, we had to face the wrath of angry locals who demanded to know what took us three days. Some even hurled abuse asking if we had arrived merely to milk their misery for political gain. Many eventually calmed down, realising the BJP was too small an entity in the State as of now gain significantly by exploiting the situation even if it wanted to. So anger gave way to appreciation and plaintive appeals for help. That two MPs had come all the way from Delhi



and the party's State leaders had accompanied them aroused hope that their sufferings could be addressed at last.

Particularly poignant was the shrill intervention by a young woman, not more than 18 years old, who said her family wanted to send her out to a distant relative's place, but she refused because this was her home and she had a right to stay there and defend it. Between sobs she said her mother (who stood stoically Kali temple lay mutilated on the floor. We were virtually dragged into the interior by a frenzied crowd that wanted us to see the wanton burning of houses and hutments by mobs who came from outside to "teach a lesson" to members of a community.

The journalist in me looked for the "root cause". It was extremely frivolous. community Durga Puja has been held on a patch of land close to the thana for the last 39 years. This plot happens to be next to a graveyard. The Durga Puja pandal is erected annually in front of a pucca Shiv Mandir. Apparently the land originally belonged to the legendary Rani Rashmoni, patron Ramakrishna Paramahans, mentor of Swami Vivekanand. Haji Nurul Islam had promised his core constituents that (a) he would expand the graveyard and (b) a mike would be installed atop a mosque in Deganga Bazar in defiance of an express Calcutta High Court order. When he faced resistance at the puja site, he unleashed wanton destruction and taking advantage of a demoralised police, a cowering CPI(M), and terrified Hindus, executed his mike installation agenda.

As we left Deganga on our way back to the Kolkata Airport, I wondered if my beloved Bengal was on the verge of being torn asunder by communal frenzy in the years to come.

The State, which has been remarkably free of caste and communal passion, despite the bitter legacy of partition, seems headed for an implosion. West Bengal is at the crossroads: And every choice seems fraught with dangerous and bloody consequences. The future indeed augurs ill.

Declare Uttarakhand as Disaster struck state

Release relief package of Rs five thousand crores as demanded

Memorandum submitted to Hon'ble Prime Minister Dr. Manmohan Singh on 20th September 2010 regarding the unprecedented disaster Uttarakhand faces.

Uttarakhand has been struck with an unprecedented disaster with incessant rains. In the last twenty-four hours more than 61 people have died from Almora (more than 34 casualties) to Rudraprayag, Chamoli, Nainital and other far-flung areas.

In the last one month massive landslides, floods, water logging, flash floods and cloud burst have resulted in the loss of one hundred & fifty human lives, damaging private and public properties to the tune of more than Rs. five thousand crores. Last month 18 children had died in a cloud burst rendering hundreds homeless in Pithoragarh.

More than one thousand roads have been devastated making all the border areas unapproachable.

Communication systems and contacts have been seriously jeopardized in this sensitive border state neighbouring Nepal and China and the only way left is to use wireless system.

The transport and communication network in the entire state has been disrupted. The generation and transmissions of power, water supply has also been completely disrupted. All state roads, national highways and BRO roads have been washed off at thousands of places. The access to international borders also stands jeopardized. Incessant rains, together with disruption of basic infrastructural network have seriously hampered the pace of relief and rescue efforts. Many areas of the State are cut off from rest of the world and the administrative machinery is facing serious challenge in maintaining the supply of essential commodities in these areas. At the same time large number of pilgrims and tourists are stranded at various places due to blockade of transport network.

The State Government is taking all possible steps for immediate management of all the disaster situations. Large number of people in Haridwar, Tehri, Garhwal, Nainital, Almora and Udhamsingh Nagar districts have already been evacuated and accommodated in temporary relief camps but much more is yet to be done. Apart from ITBP, SSB, the Army has been deployed for relief and rescue work. Three companies of NDRF have already reported to help support the relief and rescue efforts.

The Tehri dam has attained its maximum permissible level, i.e. 830 mts. incessant rains in the upstream of river Bhagirathi and Bhilangana with their tributaries have presented serious threat in the downstream areas where river Ganga has already crossed the danger level. The other major rivers in the state like Yamuna, Gomti, Koshi, Saryu, Kaali, Dhouli, Sharda etc. all have also been flowing above the danger level and are still rising. Agriculture, horticulture, industry and other important service sectors are also badly affected.

The most emergent measures to be taken are requested as below:-

- 1. Rs. Five thousand crores be immediately released.
- 2. Additional support, manual, material, technical and financial, to strengthen and reinforce to Border Road Organization (BRO) be immediately put in place. Similar action is required



- to be undertaken with respect to NHAI.
- 3. A team of experts from Central Water Commission be stationed to oversee the status of Tehri dam and to manage the consequential outcomes if Tehri dam goes in auto mode.
- 4. The Uttarakhand sub-area of Indian Army, which is already rendering immense assistance to Govt. of Uttarakhand, may please be directed by MOD to continue to extend such help as and when requested by Govt. of Uttarakhand. Similar action is required to be taken by MHA with regard to ITBP and SSB.
- 5. Western Command of I.A.F. be directed to provide four helicopters i.e. 02 Chetak and 02 MI 17 to Govt. of Uttarakhand for a fortnight for food, medical and other relief related aids.
- 6. Monitoring of the flood situations be carried out by CWC and NDMA and additional companies of NDRF be provided to the state to assist the relief related efforts.
- 7. A central team may immediately be sent to Uttarakhand to assess the disaster induced losses.

Hundreds of villages have to be relocated, homeless people have to be given houses and new roads, communication system, schools, and hospitals have to be built immediately. In this regard the Chief Minister Dr. Ramesh Pokhriyal Nishank has already written a letter to you. We fully endorse that letter. Already the winter is setting in. The misery of the people, who have been bringing laurels to the nation winning Victoria Cross to Param Vir Chakras and hundreds of other medals for their brevity and martyrdom, the state must be helped immediately in this hour of unprecedented crisis.

# Change for whose sake?

In the course of a debate in the Lok Sabha on Kashmir recently, some MPs pleaded for autonomy for the state as if it was a panacea for all the ills that have been plaguing the Valley. To a large extent, the current turmoil in the Valley owes its origin to the vested interests in J&K that want to related stories.

New rising hardliners to reject J&K concessions exploit the issue of autonomy to build a power-base for themselves. More often than not, these interests have erased the line between autonomy and azadi.

After the execution of the Instrument of Accession in 1947 adoption of Constitution in 1950, J&K was brought under the jurisdiction of India. Article 370 provided for special relationship but it was temporary. The sum and substance of this Article 370 is that, in addition to the items included in the Instrument of Accession, the Parliament can make laws with regard to the subjects of the Union and Concurrent Lists, but only with the concurrence of the state.

To define these constitutional legal, financial and administrative relations, the Delhi Agreement was signed in 1952. Soon thereafter, unfortunately, Sheikh Abdullah started changing colours. Whatever provisions of the Agreement suited him, he got them implemented. But with regard to items that related to October 1-15, 2010 O 24

the linkages between the Union and the State, he adopted an obstructionist attitude. Those who accuse the Centre of 'breach of promises' will do well to ponder over the events of 1953. If they do so, they would discover that the real breach occurred at that time and it was caused by the excessive ambition of Sheikh Abdullah and his proclivity to hob-nob with foreign powers.

It was only after the coming into being of the new state government, headed by Bakshi Ghulam Mohammad, that the Minister of J&K became anachronistic. It was, therefore, considered necessary to change the nomenclature and mode of appointment of 'Sadar-e-Riyasat' and also the nomenclature of the PM and the necessary changes were made in 1966.

In the changed circumstances arising out of India's triumph in the Bangladesh War, Sheikh Abdullah threw hints for returning to the mainstream and an agreement, known as the 'Kashmir Accord', was signed

process of implementation of the Agreement began. # **Doubting Thomas**

hen the Palmolein import scandal rocked Kerala in the early-1990s, he was the Secretary, Food and Civil Supplies, and a member of the Kerala State Civil Supplies Corporation which signed the controversial deal with a Malaysian firm. Later in his career he was Telecom Secretary in the Union Government when the 2G Spectrum scandal broke out. The role of Telecom Minister A Raja and others in this scam, involving under-pricing to the tune of '70,000 crore, is currently being probed by the Central Bureau of Investigation under the aegis of the Central Vigilance Commissioner and the matter is before the Supreme Court.

It has also come to light that just a month ago the Telecom Department he headed secured legal opinion that institutions like the CVC and the Comptroller and Auditor-General cannot probe policy decisions like the allotment of spectrum licences. He has now been appointed the CVC and he 'supervise' investigations into what is arguably India's biggest scam which happened during his tenure as Telecom Secretary. As they say, this can happen only in India! Meet Mr PJ Thomas, the Kerala cadre IAS officer, who has been chosen by the United Progressive Alliance In another age and another time, a civil servant in PJ
Thomas's shoes would have declined the CVC's job given the controversy

Government to head the statutory anti-corruption body, the Central Vigilance Commission.

This decision of the Government not only betrays its scant respect for norms but for judicial verdicts as well. The Central Vigilance Commission, which came into being in 1964, acquired statutory status following the judgement of the Supreme Court in Vineet Narain vs Union of India. The court declared that the commission would supervise the work of the CBI and the CVC would henceforth be selected by a committee comprising the Prime Minister, the Home Minister and the Leader of the Opposition in the Lok Sabha. The procedure prescribed by the court for appointment of the CVC was incorporated in Section 4(1) of the Central Vigilance Commission Act, 2003.

But, as the controversy surrounding Mr Thomas's

appointment as CVC shows, the Government has merely ensured technical compliance with the court's order by making Ms Sushma Swaraj, the Leader of the Opposition in the Lok Sabha, a member of the committee. The spirit of the judgement was lost when the Prime Minister and the Home Minister used their 2-1 majority in the committee to overrule Ms Swaraj's objections regarding Mr Thomas' candidature.

The decision to ignore the opinion of Ms Swaraj, who had no objection to any of the other short-listed candidates, is not only graceless but unlawful as well if one cares to understand the principle underlying Section 4(1) of the Act. The process of selection would have been credible only if the Government had included Ms Swaraj in the decision-making process in the real sense. Heavens would not have fallen if someone other than Mr Thomas had been chosen for that office because there were other worthy candidates.

This brings us to the issue of 'inclusiveness' that the Congress keeps talking about. As this episode shows, it does not mean taking everyone along or respecting other shades of opinion, even when the apex court directs the Government to do so. 'Inclusiveness' has a different connotation in the Congress's lexicon. In matters of governance, it means the



inclusion of persons whose adherence to the party's policies is not in doubt and whose allegiance to the Nehru-Gandhis, who own and control the party, is never in doubt.

On the policy front, 'inclusion' just means inclusion of religious minorities in Government schemes and programmes. It is strange that leaders of the Congress fail to comprehend that religious diversity is not the only form of diversity that exists in this country. The concept of diversity extends far beyond religion. It includes linguistic diversity, gender (read the Delhi High Court's brilliant exposition of this idea in its judgement on Section 377 of the Indian Penal Code), race and most important of all - politics.

Taking the last point first, it must be noted that social diversity has translated itself into political diversity in a big way over the last 25 years. The number of political parties in the Lok Sabha (12 in 1957 and over 40 in 2007) bears eloquent testimony to this phenomenon. The growth of political parties has also reduced the Congress's vote base by about 15-20 per cent during this period. In recent years, the party's share of the national vote hovers around 28 per cent and it is a well established fact that around

72 per cent of the electors do not support this party. Yet, the system allows this party to put together a coalition, control the Government and carry on with its age-old policy of inclusion of supporters and exclusion of non-supporters.

As we have seen since the days of Mrs Indira Gandhi and

the Emergency, the Nehru-Gandhis and the Congress have never accorded space to persons who disagree with them politically. In this party's scheme of things, unless you are a Congress partisan and a certified Nehru-Gandhi family loyalist like Mr Navin Chawla, Mr HR Bhardwaj or Syed Sibte Razi, you stand excluded. This is the Congress's 'inclusiveness' in practice.

Returning to the issue at hand, since the Prime Minister and his Government have displayed such contempt for the opinion of the Leader of the Opposition and announced the appointment of Mr Thomas as CVC, the former Telecom

In another age and another time, a civil servant in Mr Thomas's shoes would have declined the appointment given the controversy surrounding it. That is why citizens like this writer display such skepticism. So, sorry Mr Thomas for being a Doubting Thomas! ■

relating to the Ayodhya dispute will pronounce its verdict on September 24, just on the eve of my visit to Somnath.

Everyone is keenly awaiting what the three-judge Bench of the High Court decides in respect of the several title suits before the Court. At a Parliamentary Party meeting some days back, I advised all MPs not to indulge in any speculations about the possible verdict and whatever be the outcome, let the party reaction be restrained and low-key. Partymen have generally heeded this advice.

For me personally, 9/12 and 9/25 may be important. But for the world, no other date this month can be more important than 9/11, namely, the 11th of September, 2001.

A year earlier, on the 14 September, 2000, Prime Minister Vajpayee in his address to the Joint Session of the U.S. Congress had said:

"No region is a greater source of terrorism than our neighbourhood. Indeed, in our neighbourhood -in this, the twenty-first century-religious war has not just been fashioned into, it has been proclaimed to be, an instrument of state policy. Distance and geography provide no nation immunity against international terrorism. You know, and I know: such evil cannot succeed. But even in failing it could inflict untold suffering."

How prophetic were Vajpayee's remarks!

In the ugly history of terrorism there has been nothing as earthshaking as the horrendous terrorist attack on the World Trade Centre, New



York, and on the Pentagon, executed by hijacked aircraft used as missiles, causing the death of nearly 3000 people, more than one hundred of them Indians.

Yet another hijacked plane was intended to target the White House, but thanks to the valour and patriotism of the passengers on board, the terrorist designs were thwarted and the plane crashed in a field in rural Pennsylvania.

In January 2002, I undertook a trip to the United States of America. During my stay in New York, I visited Ground Zero commemorating 9/11, and paid tribute to the unflinching determination of the Americans to defend their nation in the face of the worst ever terrorist attack in human history.

Later addressing a Press Conference at the Indian Embassy in Washington DC, I described India and USA as the twin towers of democracy and added: "The terrorists may have destroyed the steel and concrete structures of the World Trade Centre, but they can never harm the structures and the spirit of our two democracies."

Further, the proponents of autonomy do not care to address certain questions. Do the Kashmiris not have all the fundamental rights that are available to individuals in modern liberal democracies? Has their identity, culture, religion or language been undermined by the constitutional arrangements that have been in existence for the last several years? How would the common Kashmiri be benefited by changing the nomenclature of Governor to Sadar-e-Riyasat and of chief minister to prime minister? How would requirements of national security be met and how would certain other contingencies be dealt with if Article 356 is not applicable?

If all issues concerning Kashmir autonomy are subjected to considerations, it would be found that no material change in the existing arrangements is warranted. The nation is already paying a heavy price for the mistakes made in the past under pressure. Let us not add another one to them by falling into a trap of those who, for their own narrow ends, are out to exploit the constitutional illiteracy of the masses on the subject of autonomy.

# Prabhat Jha slams Union Govt. on Kashmir issue

State Bharatiya Janata Party

He further contended that separatist leaders, who were engaged in anti-national activities and demanding the lifting of the AFSPA, were playing in the hands of Pakistan. Referring to the goal, for which Home Minister Mufti Mohammad Saeed in VP Singh Government brought the AFSPA in force in Jammu & Kashmir, was not yet fulfilled.

He said that while the ruling BJD Government mobilised and misused Government machinery for holding rallies in Lanjigarh for its publicity, its failure in controlling epidemic situation is quite unfortunate. Flaying that the medical delivery system has completely failed in Odisha, he said the people of the affected areas have not received PDS items since long. "The State Administration is only giving lip service to the stricken poor. The situation demands relief and rehabilitation on a war footing," he urged.
