**Protests, fasts across nation** against Congress Dictatorship

# Barely two months after the midnight crackdown on Swami Ramdev's supporters to choke their voice raised against black money stashed abroad, the Congress led UPA government repeated the same repressive steps to crackdown another popular movement led by social activist Anna Hazare for a strong anticorruption Lokpal Bill.

In an early morning swoop, the Delhi Police picked up social activist Shri Anna Hazare from east Delhi on August 16 just as he was preparing to leave for Gandhi Samadhi at Rajghat ahead of his fast at JP Park to protest a toothless anticorruption bill approved by the cabinet and to press for a strong anti-corruption Lokpal Bill.

Activist Arvind Kejriwal who was also detained along with Shri Hazare was also taken to Civil Lines, Police Officers Mess in north Delhi. "We have orders from higher up," said the detaining officer when Shri Hazare during his arrest asked him what his crime was.

# NDA strongly supports Anna's cause

» protests. As news of Hazare's arrest spread, sporadic protests broke out across the capital, leading to the detention of more than thousands of supporters, including Kiran Bedi and lawyer Shanti Bhushan.

In one hand the entire nation including the BJP strongly criticized the brutal suppression of peoples' voice by the Congress led UPA government. On the other hand Congress spokespersons tried to justify the Delhi Police action on Shri Anna and said such type of police actions is required to maintain the law and order.

The second thing he has mentioned in the 11th paragraph of his statement that the Government acknowledges the rights of the citizens. There cannot be anything untrue than this. On the night of 4th June, who lathi charged the supporters of Swami Ramdev? Was it protection of citizens' rights? Recently, on August 9, the workers of the BJYM were also lathi charged on the day of 'Quit India Movement'. Was it also an attempt to protect the rights of the citizens? Was it also protection of citizens' rights to arrest Shri Anna Hazare from a residence in Mayur Vihar who did not even violate the section 144? Some Hon. the statement made by the Prime Minister is good but I would like to very emphatically say that this is the pack of lies. This nation has framed the Constitution and the Constitution has given the right to protest. As far as the Bill is concerned we also have some reservations about various provisions of the Jan Lokpal but now this fight is not for Lokpal or Jan Lokpal but the greater issue is that of citizen's rights. The kind of undemocratic attitude the government adopts outside the House, the same attitude it adopts inside the House to muzzle the voice of the Opposition. This Government has brazenly attempted to undermine and malign the dignity of the Constitutional Institutions. The CAG is attacked both inside and outside this House. The Members the ruling Party create unnecessary din in the PAC. But by the evening you saw the enormity and the magnitude of the protests, therefore, you make a statement. India is already exasperated with you. It is fed up of corruption and those who are covering up for corruption. You went begging him to come out of the prison. This is not a confrontation between the civil society and India's Parliament. We are clear in India's Parliament that Parliament alone will draft the law. But if citizens' group wants to tell us something, we will listen to them.

The laws drafted by your NAC will come up before the Government or the Parliament. The effective issue today is that Shri Anna Hazare, his group and lakhs and lakhs citizens of this country have a right to say what they want to say. They have never indulged in violence; they have not disrupted the public order; they have not been a threat to peace.

If the Government becomes so dictatorial, so oppressive, then a citizens' group may well say that it is willing to offer satyagraha and even go to listen to them. We may or may not accept what they say. But they have a right of peaceful protest. Please develop a political will to fight corruption; you will solve most of your problems. Release each one of the persons that you have arrested. Allow them the right of peaceful protest at a reasonable place. If anybody violates the law, invoke your police powers. But don't invoke them against peaceful protestors because, then, you will be threatening the right of dissent which is the very essence of Indian democracy. ■





# We need a judicial vision and a legislative statesmanship: Jaitley

The Rajya Sabha on August 18 passed the impeachment motion against Justice Soumitra Sen of the Calcutta High Court, clearing the first stage for his removal. This is the first time in the country's history that an impeachment motion against a judge has been passed by either House of Parliament.

As many as 189 members voted in favour of the motion to impeach the 53-year-old Judge after a two-day debate on the issue, in the second case in Parliament's history and the first-ever in the Upper House. Seventeen members voted against. The members belonging to BSP opposed the motion. Trinamool Congress MPs were absent during voting. The impeachment motion will come up before the Lok Sabha next week. If passed by a two-thirds majority in the Lok Sabha, the motion will be referred to the President who will order Justice Sen's removal as a judge.


Leader of the Opposition in Rajya Sabha Shri Arun Jaitley made a strong pitch for Justice Sen's removal, noting that right through his tenure as receiver and then a judge of the high court, he never rendered account of the money entrusted to him, and in fact created encumbrances and misappropriated the money, "as an in-house committee appointed by judiciary had found."

Stating that a judge needed to be transparent, he said, notwithstanding his persuasive arguments placed before the Rajya Sabha the entire basis of Justice Sen's defence was completely at variance with facts. "You said you materially operated the account between 1993 and 1996 and that no statements were available?...but the Rajya Sabha inquiry directed the bank to file a statement.

We are publishing the synopsis of the speech delivered by Leader of Opposition in Rajya Sabha Shri Arun Jaitley on the motion for the removal of Justice Soumitra Sen on August 18, 2011.

Today is an occasion which is both sad and historic. We have all assembled here in an alternative capacity of Parliament where it performs a judicial function. We are conscious of the fact that the power of impeachment is intended to be exercised in the rarest of the rare cases. The power of impeachment of a holder of a Constitutional

office is an authority or jurisdiction given to us to remove a man in order to save the dignity of his office. The office gets precedence over the man who



occupies. We impeach him so that we can ensure that the dignity of the office of judge. A

Judge can be impeached either on proven misbehaviour or incapacity. In this, case is proven misbehaviour. When these articles were being drafted by the constituent assembly, Shri Gopalaswamy lyengar had expressed the hope that perhaps, these powers would never be used. We have made two efforts in the past. One at the preconstitution stage and second occasion was in 1993. We have an independent Judiciary. We have the concept of separation of powers. And this power of removal of a judge is given to the



legislative body which conducts an inquiry in accordance with the Judges Inquiry Act.

It is only a very rare case which comes to this House for consideration. The judges will also have to realize that judiciary is no longer an Institution which lives on ivory towers. Their conduct is also going to be watched very closely. This is not to say that we can make unfounded allegations against a Judge. Therefore, we have to be

very cautious about every word. When a Judge says that first prove the allegations against me only then I will let you know what my response is. That is not the case of an ideal Judge facing an inquiry. A Judge by his very character must be 'unsuspectable'. We have heard the presentation of the learned Judge at length. He was trying to say that I

must get away from this offence as there were instances when other people who have committed offences while being Judge and got away with. The case in a nutshell is that Steel Authority of India, brought certain goods. There was a dispute over those goods and its qualities between SAIL and supplier. The Steel Authority of India moved the Calcutta High Court and the Calcutta High Court on 30 th April, 1984 appointed the then Mr. Soumitra Sen, an advocate as a receiver. Court also asked him to make an inventory of the goods. There was a direction of the Calcutta High Court that he had to file a return in every six months with the Calcutta High Court about the goods. From 1984 till 2006, 18 years have passed, not once is the return filed. Calcutta High Court asked him to sell the goods and also said whatever you sell, open a bank account, keep the money in that bank account and the court will decide what is to be done with this money. The goods are slowly sold and finally an approximate sum of Rs. 33,22,800 is received against these goods. Mr. Sen, opens two bank accounts, one account in the ANZ Grindlays Bank and the

other account in the Allahabad Bank. He deposits Rs. 4,68,000 in Allahabad Bank and the balance of about Rs. 28 lakhs in the ANZ Grindlays Bank. He gives four cheques in the names of private individuals. Law books are purchased. The money go from that account. Calcutta High Court appoints him as a special officer in the case of Calcutta Fans. That case has nothing to do with this case. He is paid Rs. 70 lakhs so that workmen of Calcutta fans could be paid. He opens another bank account and puts the Rs. 70 lakhs there. Of this Rs. 70 lakhs, he quietly withdraws Rs. 25 lakhs and makes a deposit in the name of one company, Links-India. When he is paying the workmen he realized that he is short of money because M/s links India went into liquidation. He deposited the money by removing Rs.22 lakhs from the SAIL's money and deposited in the Calcutta Fans Case. The first thing that should have struck him when he becomes a judge was that he was a receiver in some cases and he got somebody else's money and he has to clear that first. He just keeps quite and keeps sitting on it. So, during his tenure, as a judge from 2003

onwards, this misappropriation for 'alternative' purpose continues. The Calcutta High Court noticed him repeatedly to file an affidavit regarding the status of money. He was holding it for the benefit of some other parties. He does not file any affidavit or response to the court. The court finally delivers a judgment. He has paid

back to SAIL Rs.5 lakhs. With regard to the balance amount, with interest, the court then passes a decree against him saying that Rs.52,46,454 be paid. Only on a coercive direction of the court he pays Rs.40 lakhs. Then, he asks his mother to move an application before the Calcutta High Court praying for giving some more time to pay the balance amount. So the court passes a judgment by giving him time and makes some adverse remarks against him. When these adverse remarks are reported in newspapers, the Chief Justice of Calcutta High Court writes to the Chief Justice of India, saying that this case has come to notice and this is a conduct unbecoming of a judge. The Chief Justice of India calls him and ask about the



money. He files an appeal through his mother again before the Division Bench, after taking time from CJI.

Division Bench removed the observations against him. The Chief Justice of India constituted a Committee comprising two very eminent Chief Justices of High Courts, and a Judge. He gets a detailed hearing from them. He puts up his defence. They asked him what he did with this money. The three senior most Judges of the Supreme Court call him and ask him to submit his resignation because prima facie

when there were a compulsion of a judicial order, you claim it to be a virtue that now, at least, I have returned the entire money with interest. Even today, he did not tell us where the money of the Steel Authority case went? All we were told was this money was used for fixed deposits, this went to workmen etc. He kept misleading the in-house inquiry, the judges' inquiry, even today, the House that I honestly deposited the money. The impression which any person who has not read the record would get is, that he deposited

there is a serious material against him. The inquiry said that the charges were serious. And, since he does not agree to resign, fiftyeight Members of Parliament submit a motion, for his removal. The hon. Chairman constitutes a Committee under the Judges Inquiry Act. He appears through an advocate. The first thing he does is, raises an allegation of bias against Mr. Nariman, a member of Committee. He did not enter the witness box. In a nutshell, the first misconduct is that you misappropriated the monies. The misappropriation started when you were an advocate. It continued after your elevation. You didn't cooperate with the judicial institution in telling them the truth. Finally, September 1-15, 2011 O 16

this money with a company and that company went into liquidation. This House, in exercise of its Constitutional jurisdiction to remove a judge, will look at the kind of evidence which has come out. We are not relying on any judgment in the course of this impeachment proceeding against him. We are relying on the report of the Judges Inquiry Committee. Full opportunity has been provided to him by the Inquiry Committee and by this House. He is a judge who stands stigmatized by repeated reports and those reports have a strong basis. Those facts are borne out by the fact that monies have been diverted for collateral purposes. I strongly support the motion

that an address be sent to the President supporting the fact that this judge is unfit to be in the Office of Judge.

The case against the Judge is that from his tenure as an Advocate-Receiver to his tenure as a Judge, he never rendered accounts for monies which came into his possession as Receiver. The second charge against him is that before various authorities, he misrepresented the facts and misled them. The hon. Judge said that he was being hanged because the Committee attributed a bank account to him which was in the name of some other Soumitra Sen. The Committee did not make this charge of this account against him. He told the single judge of the Calcutta High Court that he had kept money obtained by sale of goods in the Steel Authority of India, in account no.01SLP0156800 and this money was invested in Lynx India. This account number that he himself gave was the account of the other Soumitra Sen. All investments made by the erstwhile Receiver in the company were by way of cheques drawn on ANZ Grindlays Bank from bank account no.01SLP0156800. In this charge given to him it was said that from this account no money was paid to Lynx. So, the defence is false. The truth is otherwise. He passed off a false account as his account. This fraud was detected with the help of the bank. He misled the House yesterday saying that bank statements are not available. The bank statements are available. As per statement of Allahabad Bank all cash and cheque withdrawals were for himself. In 2006, when he got caught, he says, "Okay, I



will pay with interest". The third thing he said yesterday was that he did not misappropriate the money. As per record all these cheques were cut out 'self' and cash withdrawn. He used and utilised the money which was case property. This money was misappropriated. misappropriation continues till 2006. He said that he returned the money. But the explanation to section 403 of the IPC states dishonest misappropriation for a time only is a misappropriation. As a Judge between 2003 to 2006 he continues the misappropriation and misrepresents to every authority. Can we afford to have a Judge whose conduct is of this manner?

He is held guilty for his misconduct of misappropriation and stating incorrect, inaccurate facts during his tenure as a Judge. Therefore, I am reaffirming that, I support Mr. Sitaram Yechury's motion that his is a fit case of proven misconduct where the Judge concerned must be removed from office. When the Constitution was framed, we had a system where Judges were appointed by the Executive Government in consultation with the Chief Justice of India. In 1993, that system got changed. Today we are living in a system where Judges appoint Judges. The Government, at best, has only a very marginal say. This is a nontransparent process. suggestion to the alternative is about setting up a National Judicial Commission. It must have Judges, the participation of the Executive and people selected by a collegium of some eminent citizens. There must be some objective criteria for appointment of judges. Judges judging judges and nobody else participating in this is also an issue which requires a serious review. When appointments are made we have to seriously consider how the institution functions. It should be free from any pressure and biases. Almost every retiring judge, barring a few honourable exceptions, holding a belief that he is entitled to a job after retirement. The desire of a job after retirement is now becoming a serious threat to judicial independence.

The separation of powers is one of the basic features of our Constitution. And if every institution works in its own spheres, it has to lay down the lakshman rekha of its own jurisdiction. The only ideology that courts can have is commitment to the rule of law and that law is made by Parliament. The Government has to decide the policy. Courts cannot decide that policy. We need a judicial vision, a legislative statesmanship and vice-versa in this country so that the correct balance of separation powers can itself be maintained. The conduct of the Judge leaves much to be desired. It is without doubt

that it's a fit case for removal of this Judge and we must make a recommendation of the address to the President of India.■

# **Corruption and indecision proving to be biggest drags on development : Murthy**

India Inc's anger over governance and ethical deficit in the Manmohan Singh government burst out in the open yet again, with NR Narayana Murthy, Infosys Chairman Emeritus, saying that corruption and indecision were proving to be biggest drags on development.

Shri Narayana Murthy said the UPA-II has failed to take any major economic decision since coming back to power.

"The main reason is the lack of clear leadership and quick decision-making what with two people being in charge — Congress President Sonia Gandhi and Prime Minister Manmohan Singh," Shri Murthy told a private television channel. He said dual leadership was not good for the nation. "I understand that we have two leaders.

These things slowdown decision-making. My request to the prime minister is to take quicker decisions," Murthy said. Murthy was equally critical of the government's failure to tackle corruption. He said if the government reduces graft, "we could clock a GDP growth rate of 8.5-10%."

He said economists had established that corruption was likely to reduce the GDP growth rate by 0.5-1.5%. He had emphasised this while delivering the 32nd Vikram Sarabhai Memorial lecture on "Towards a Corruption Free India". ■

# BJP stalls House, demands PC resignation over action on youth workers

## A bill patently unconstitutional

## Injurious to unity - integrity and fraternity of the people

t is astonishing that a bill like **PREVENTION** .COMMUNAL AND **VIOLENCE** TARGETED (ACCESS TO JUSTICE AND REPARATIONS) BILL, 2011 which is flagrantly violative of the right to equality and patently discriminatory being violative of Article 15(1) could have been even thought of by the National Advisory Council under the chairmanship of Sonia Gandhi who has taken oath to uphold the constitution and the Government headed By Dr. Manmohan Singh who is also under similar and introducing it in the Parliament.

To put it in a nutshell the bill is intended to give immunity to religious minorities against serious criminal offences committed by violent groups among them against the life and property of majority and penalize the majority for the crimes committed by such militant groups among minorities and in addition to reward the culprits providing compensation at the cost of exchequer.

Therefore if it were to be passed into Law; though it is difficult even to imagine that it will be passed by the Parliament; it would be void ab-initio. Therefore this is one such bill which should not be permitted even to be introduced in the Parliament.

The bill is more disastrous

than the partition of India on communal lines as it is intended to divide us the people of India on communal lines; for by partition India lost a portion of its territory but by this ill-conceived bill the citizens who are all children of Bharatamata, stand divided on communal lines and providing instigation to the militant and violent sections of minorities to indulge inviolence against majority with impunity.

A reading of the definition of the word GROUP and of Communal targeted violence in the BILL which disclose the entire mischief of the bill read –

"group means a religious or linguistic minority in any state in the union of India or scheduled castes and scheduled tribes within the meaning of clauses (24) and (25) of Article 366of the Constitution of India

## **Definition of the Communal Targeted Violence.**

The communal target violence means and includes any act or series of acts whether spontaneous or planned, resulting in injury or harm to the person and or property, knowingly directed against any person by virtue of his or her membership of any Group, which destroys the secular fabric of the nation.

The above definition read with the Various provisons of the Bill indicate that only minority

group can be the victim of communal and targeted violence and only the majority indulge in or instigating communal violence.It is preposterous to presume, that themajority instigates violence against minority and not vice versa in view of the two definitions. It is needless to analyse the various provisions of the Act to show how unreasonable and arbitrary they are, and how they are designed to destroy the unity and integrity of the Nation and fraternity among the people which are the noble principles enshrined in the preamble to the constitution of Indiafurther the provisions of the bill are designed to destroy the federal structure and render the states subordinate to the center.

I conclude this article by stating that the bill is unconstitutional relying on the constitution bench judgment of the Supreme Court of India in which an exactly similar classification was struck down as voilative of Article 15 of the constitution (state of Rajasthan Vs. Thakur Pratap Singh; AIR 1960 SUPREME COURT 1208)

Shortly after the commencement of the constitution congress government of Rajasthan issued a notification under Sec. 15(5) of the police Act afterhaving levied the cost of additional police force stationed in certain Villages, granting exemption to



Muslims and Harijans from such levy. The constitution bench of the supreme court of India struck down the said notification. Relevant portion of the judgment reads:-

The state of Rajasthan in defence of the exemptionstated thus ....

"TheHarijan and Muslim inhabitants of these villages have been exempted from liability to bear any portion of the cost of the additional force not because of their religion race or caste but because they were found to be peace loving and lawabiding citizens, in the 24 villages where additional force has been posted"...

The SupremeCourt rejected the defence thus:-

"It would be seen that it is not the case of the state even at the stage of the petition before the High Court that there were no persons belonging to the other communities who were peace - loving and law-abiding, though it might very well be , that according to the state, a great majority of these other communities were inclined the other way, If so, it follows that the notification has discriminated against the law- abiding members of the other communities and in favor of the Muslim and Harijan communities, - ( assuming that every one of them was ' peace loving and law-abiding") on the basis only of "caste" or "religion". If there were other grounds they ought to have been stated in the notification. It is plain that the notification is directly contrary to the terms of Art. 15 (1), and that Para 4 of notification has incurred condemnation as violating a specific constitutional prohibition. In our opinion, the learned judges of the High court were clearly right in striking down this paragraph of the notification.


Addressing the Senior Citizen *Mahasammelan* on August 14 in New Delhi Shri Gadkari said Anna Hazare was being

# Centre should ask States to suspend land acquisitions: Rajnath

President Shri Rajnath Singh asked the Centre to issue an advisory to all States to stop land acquisitions till the legislation in this regard is passed by Parliament even as it alleged that the Haryana government had leased acres of land illegally to Rajiv Gandhi Charitable Trust.

"The government should bring the Land Acquisition Bill in Parliament in this session itself and not delay it further.

Also the Centre should issue an advisory to all state governments that till this Bill is passed all land aquisition should be stopped," Shri Singh said.

He said injustice towards farmers is being done by state governments in Uttar Pradesh, Haryana, Andhra Pradesh and Maharashtra among others. Some of the State Governments were acquiring land to benefit builders and this should be checked.

"Forcible and unfair land acquisitions are taking place. In the blind race for development, destruction of land and natural resources is taking place. There is misuse of authority by the state governments. This is a form of corruption," Shri Singh added.

He made a special mention of Haryana where he had visited Ullahawas and other adjoining villages on August 5 to meet farmers agitating against land acquisition.

"In Ullahawas, I met

farmers who said in 2005-06, land was acquired with just Rs 12.5 Lakh compensation per acre and given to the Rajiv Gandhi Charitable Trust," Shri Singh said.

Shri Singh said that no work was

done on the land and it was again sold to a private builder. Even after five years no building plan was made by those builders.

He maintained that there were many farmers in the region who were facing problems of livelihood and unemployment.

Shri Singh alleged that the land has been leased to Rajiv Gandhi Trust for a period of 33 years. It further said the land



belonged to the Gram Panchayat but given on lease to the Trust without taking the Gram Sabha's opinion.

"The Haryana government is misusing its powers. A judicial probe should be

ordered into this land acquisition.

It is unfortunate that this land was acquired in the name of serving a public purpose. The land of farmers is being looted," Shri Singh said.

He alleged that while farmers are in a state of panic, government seems to be acting hand in glove with corporate builders.

Shri Jagat Prakash Nadda jumped into the student politics through ABVP in his teens. He was also elected President of Delhi University Students' Union. In 1991 he was appointed the National President of the Bharatiya Janata Yuva Morcha. He quit this post when in 1993 BJP asked him to contest the Himachal Vidhan Sabha elections which he won and was also elected Leader of BJP group in Vidhan Sabha. When BJP was voted to power in 1998, he became the Health Minister in Prof. Prem Kumar Dhumal government and Forest Minister in his second government in 2007. The moment he was appointed a National General Secretary of Party he instantly quit his cabinet minister's job which is a bit unusual in the present political environment in the country. He gladly opted to work for the organization.

BJP National Convener of Literature & Publication Cell, Amba Charan Vashishth interviewed Shri Nadda last week at his office in New Delhi. Excerpts:



# What are your experiences during the last one year of your working as BJP's National General Secretary?

I like the new responsibility very much where my primary responsibility is to strengthen the party and broaden its base and reach among the people. The field is wider; the scope is extensive. I am fortunate to work with senior leaders. My sphere extends to the whole country. The environment too is very cordial and to my liking. I am enjoying the new responsibility. I am grateful to the Party to have given me this opportunity. Working for the party is equally the service of the nation.

# Quitting the office of a Cabinet minister in Himachal to take up an organizational responsibility was a big decision. Did it present a predicament for you?

I am not the one who thinks that the only way to serve the people and the party is by becoming a minister. I have come here by option, by choice. For me party organization is supreme. I feel that to run a good government and provide good governance, organizational strength of the party is of great importance. The Party is there to realize

the dreams of the people and serve the nation. In my view there is no other means better in serving the country than the organization. I have tasted power from a very young age. I have been a Cabinet minister for seven-anda-half years with 2.5 years yet to go. I was Leader of the BJP Legislature Party for five years. As a minister one does get a chance to put his vision into practice, but that is not the be-all and end-all. If we strengthen the Party, we simultaneously strengthen the government. I am thankful to the Party President Shri Nitinji Gadkari who has given me this chance

## Which of the two jobs – of a minister or general secretary – did you enjoy better?

For me serving the organization is better than holding the office of a minister. For me it is more a priority to make the party stronger than enjoying the fruits of power. Every action taken in the organisation is a positive step with a national impact.

## Does your moving over to Delhi mean your shifting to the politics at the Centre?

I volunteered to come to the Centre. I would like to concentrate in the organization. For good



governance you need a good, strong party and organizational support. Organisational work is more a priority for me. Left to me, I would like to continue at the Centre. I am a disciplined soldier of the party. Wherever I was asked by the Party to work, I did it smilingly.

#### What about the anti-incumbency?

If there is any anti-incumbency, it is not against the government but against certain individuals and that too to a very little extent. We are going to overcome it by evaluating the performance of the sitting MLAs, their commitment to core ideology, their rapport with the people and winnability. As a result

some changes could take place and antiincumbency, if any, will be overcome

There is great infighting in the main opposition Congress. But, at times, there are reports about dissidence in BJP also. What do you say?

The dissidence and infighting in the Congress is very evident, very prominent. Strong posturing has been visible on various

occasions. On the other hand, BJP is a party with a functioning internal democracy. We have given our workers the freedom to vent their views. We want to encourage a healthy discussion on issues and problems facing the government and the organization. The free expression of opinion should not be construed as dissidence or infighting. Yet, if *Lakshman rekha* is crossed, party does take a very strict action

With a BJP government in Himachal and a Congress-led UPA at the Centre, are you getting your due share of help and assistance from the Centre?

Frankly speaking, for political and electoral reasons the intention of UPA is not to help the State.

But it goes to the credit of Dhumal government that through statecraft, administrative skill with proper home work and personal rapport at the Centre, we have been able to get much from the Centre. Yet, the problems remain.

# What change do you perceive Shri Nitin Gadkari has brought in the BJP during the last eighteen months as President?

Shri Nitin Gadkariji has infused a new outlook in the party. He has injected a new enthusiasm among youth and women. He has taken many bold steps. By raising the issues agitating the minds of the people, like price rise, hike in petroleum products,

> internal security, etc. at every forum - village, Vidhan Sabha and Parliament, he has made the party stand shoulder to shoulder with the people and won their heart. He has made BJP a party of the masses. The spirit of antyodya and good governance has been made the hallmark of the organization and government. More initiatives have been taken with commitment for change. He has involved every party leader and

karyakarta in the organisation. His handling crises in the Party is a pointer to his political vision, maturity and sagacity. He has given momentum to the party and energized it with a team spirit. He has infused fresh blood by involving new faces in the party, by giving younger people a chance, full freedom to work He is result oriented and wants concrete results, not just khana-poorti. #### BJP stages 'Maha deeksha' for Telangana

# Immediately introduce bill to carve out separate Telangana State: BJP

The BJP staged a dharna as part of "Maha deeksha" programme in front of Collectorate at Karimnagar; AP on August 17 demanding that the Congress led Union government must carve out separate Telangana State by introducing a bill in Parliament.

# Mining scam in Goa much bigger than other states: Parrikar

He further said the Opposition BJP has raised its voice several times against theses illegal mining trade during Digambar Kamat led Congress Government. But surprisingly no action has been taken by the State and Central government yet.

Shri Manohar Parrikar said BJP will definitely try its best to expose the corrupt faces of Goa ministers and will go to people's court to give fitting punishment to these anti nationals.


apex level investment promotion empowered committee at Bhopal on August 17.

# Panel to probe Congress charges against govt.

The Government of Gujarat on August 17 announced setting up of an inquiry commission under a retired Supreme Court judge Mr M B Shah to enquire into 17-point charges that the State Congress party submitted to the President of India a




few months back. The decision was taken at the cabinet meeting headed by the Chief Minister Narendra Modi.

When it came to the notice of the Government of Gujarat as also published in newspapers that the Congress leaders gave a representations to the President of India on June 3, 2010 regarding 17 allegations against the functioning of the so-called malpractices of the Government of Gujarat, the latter suo moto took this historic step with good intentions and set up this Commission of Inquiry. The state government formed the MB Shah Commission under the Commission of Inquiry Act-1952, said government spokespersons Mr. Jay Narayan Vyas and Mr. Saurabh Patel. Government of Gujarat is of the opinion that it is necessary in the public interest that the people of Gujarat must know whether there is any substance in the allegations, particularly at the time when a strong public opinion is building against corruption in public life. The Government of Gujarat is also of the opinion that it is necessary to bring to the knowledge of the people of Gujarat the factual position obtaining on each of the allegations referred to above.

This has been necessitated to bring the 'truth' to the people over the allegations made by the Congress. The State government is committed to have a transparent inquiry into whatever allegations have been made, they said

# UPA's consistent neglect of road sector shows its dismal performance on governance record

BJP-ruled Madhya Pradesh, which wrote to the Centre asking that 10 muchtravelled intercity roads in the state be de-notified, arguing that State government would do a better job maintaining them than the Centre. back up their



assertion, they attached photographs of the roads — potholed, flooded and jammed.

The pathetic condition of highways prevents the modernization of agriculture, preventing farmers in remote areas from accessing markets that would fund capital investment. They make worse unevenness in development, forcing the clustering of industrialisation. They make it expensive to haul materials cross-country, bolstering inflationary pressures along the supply chain. Despite many promises by UPA, little has been done to advance highway-building, or even maintenance.

Highway-building has been plagued by cost and time overruns. As the MP photos make clear, these are not necessarily caused by land acquisition problems but by genuine inefficiency and badly designed contracts; indeed, recent government numbers suggest that when the private sector is implementing publicly funded and internationally funded projects, almost all suffer over-runs. This is not the case for projects being constructed on a build-operate-transfer basis, in which the private partner is penalised for delays.

The UPA's consistent neglect of the road sector is one of the blackest marks on its governance record. These problems in the implementation of construction projects have been understood for years, but little effort has been made to correct them.
